

PETITION FOR ORGANIZATION OF VILLAGE OF LONGVILLE.

To the Honorable Board of County Commissioners of Cass County,  
State of Minnesota:

The undersigned, being twenty five and more, voters within the territory, lying and being in said county, hereinafter described, do hereby petition your honorable body to call an election of the voters within said territory for the determination of the organization of a village comprising the territory hereinafter described.

Your petitioners have caused to be taken a census of the resident population of said territory, and find that said territory contains a population of less than three thousand and more than one hundred people actually resident therein, to-wit: 114  
with census is herewith presented in writing and filed herewith.

That said territory and its boundaries are as follows, consisting of platted lots and blocks comprised in the Plat of Longville, on file and of record in Book B, of Plats, number 15, in the office of the Register of Deeds of said Cass County, which said plat has been duly and legally certified, according to the laws of the State of Minnesota, and filed in said Register of Deeds office as aforesaid, and said territory is also comprised of unplatted land adjoining and adjacent to said platted land, and all of which is so conditioned as properly to be subjected to village government. The platted land comprises all of the land covered by said Plat of Longville and said unplatted land comprises Government Lots One (1), Two (2), Three (3), Four (4), Seven (7), Eight (8), Nine (9), Eleven (11), Thirteen (13) and Fourteen (14), in Section Thirty Four (34), in Township One Hundred Forty One (141) North, of Range Twenty Eight (28) West in said county, and Lots One (1) and Ten (10) in Section Thirty Three (33) in said town and range.

The boundaries of said territory are as follows: commencing at the quarter post on the south side of <sup>said</sup> Section Thirty Four (34), running thence east along the south line of said Section Thirty Four (34), to the southeast corner of the South West Quarter of the South East Quarter thereof, thence north on the 1/16th line to the northeast corner of Lot Twelve (12), thence east to the northeast corner of said Section Thirty Four (34), thence south to the south east corner of Lot Eleven (11) of said Section Thirty Four (34), thence northwesterly along the south line of said Lot Eleven (11) continued to the south east corner of Lot Thirteen (13), thence north along the quarter line to the north line of said Section Thirty Four (34), thence west along the north line of said Section Thirty Four (34) to the northwest corner thereof, thence south to the northeast corner of Lot Ten (10) in Section Thirty Three (33) in said town and range, thence northwesterly along the northerly line of said Lot Ten (10) in said Section Thirty Three (33) to the northwest corner of said Lot Ten (10), thence south along the 1/16th line to the northerly side of Girl Lake, thence following the shore of said Girl Lake easterly and southerly along the southerly line of said Lot One (1) in said Section Thirty Three (33), and the southerly line of Lots One (1) and Two (2) in said Section Thirty Four (34) and the westerly line of Lots Three (3) and Four (4) in said Section Thirty Four (34) to the meander corner between Lots Four (4) and Six (6) in said Section Thirty Four (34), thence south along the 1/16th line <sup>South line of said Section thence east to the</sup> to the place of beginning.

And the quantity of land embraced within said boundaries is three hundred seventy eight and 39/100 acres, more or less.

The number of actual residents in said territory is 114

The name of the proposed village is Longville.





Notice of election of the incorporated village of Longville.

I, the undersigned, do hereby certify and return as were duly appointed by the Board of County Commissioners of said county, and substitutes duly elected to fill any vacancy caused by the absence of any such appointed inspector, to conduct an election at Ed Johnson's Hotel at Longville, Missouri, on the proposed incorporation of a village called Longville, on the 28th day of February, 1941, between the hours of 9 A.M. and 4 P.M. do hereby certify that at the time of opening of the polls at said election, to-wit: 9 A.M. of said day L.W. Orton & Ralph Fuller and W. C. Mitchell appointed as such inspectors as aforesaid were present and qualified by taking the oath required of judges of election at town elections for town officers in said state, and that Ray Tabaka each appointed as one of said inspectors as aforesaid were not present at said time, and that the voters within the proposed incorporation then and there present elected Ray Tabaka and Ray Tabaka to fill said vacancies, who also duly qualified as aforesaid, and that said election was held at the place in the notice thereof specified, to-wit: at Ed Johnson's Hotel in said Longville, and at and during the time herein specified, to-wit: on the 28th day of February, 1941, between the hours of 9 A.M. and 4 P.M., and that ten minutes before the closing time of the polls at said election, notice was given by one of said judges that the polls would close in ten minutes, and at the end of said ten minute period Ray Tabaka one of the voters in the territory proposed to be incorporated moved that the polls be closed, and said motion

was reported by George Kline one of the voters in said territory, and said election being held by the voters of said territory and there present by a majority the matter was carried and the polls declared closed.

That 61 voters were cast at said election.

That said judges proceeded to canvass and count the votes cast at said election and did count the same and found that 32 votes were cast in favor of incorporation and 29 votes were cast against incorporation of said territory as a village, and the incorporation of said territory as a village was declared incorporated.
