

Ordinance No. 11

Section 1. Village Limits Extended. -- That the territorial limits of the Village of Hendricks, upon the territory within its said limits in said County of Lincoln and State of Missouri, described as follows:

Commencing at the stone at the southwest corner of Section seventeen (17), Township One Hundred Twelve (112) North, Range Forty-Six (46) East of the 1st Principal Meridian, thence north along the east line of said Section seventeen (17) and being the center line of Division Street to a point at the intersection of Lincoln and Division Streets which point is thirteen hundred sixty-two (1362) feet north of said southwest corner of said Section, thence east on and along the center line of Lincoln Street to the southwest corner of Outlot "A" a distance of nine hundred thirty-five (935) feet, thence eastward along said South line of Outlot "A" a distance of three hundred eighty-five and four tenths (385.4) feet, for the point of beginning, the above description being in the Village of Hendricks in said County and State as shown on plat of said Village on file in the office of Register of Deeds in and for said County, thence south forty (40) feet, thence east seventy-five (75) feet, thence south forty-two and five tenths (42.5) feet, thence east one hundred seventy-two (172) feet, thence north one hundred sixty-five (165) feet, thence west one hundred seventy-two (172) feet, thence south forty-two and five tenths (42.5) feet, thence west seventy-five (75) feet, thence south forty (40) feet, to the point of beginning.

The territorial limits of this Village are hereby extended to include the aforesaid territory within its said limits and the aforesaid land shall hereafter be a part of the Village and shall be governed as other territory of the Village is governed.

Section 2. Copy to be filed with Register of Deeds and Secretary of State. -- The Village Clerk is directed to forward a certified copy of this ordinance to the Register of Deeds and the Secretary of State.

Section 3. Effect. -- The aforesaid territory shall be annexed to the Village upon the adoption hereof.
