I do further certify that thereafter the OLty Oouncil of said Gity duly submitted to the legal votens thereof at the annual xity election held on the 7th dsy of April, 2942 the question whether on not the proposed charter anendrent should be adopted and ratified or rejected, all in compliance with the statutes of the Stete of $\mathrm{H}_{\mathrm{i}} \mathrm{nnesota}$ with reference thereto and the Municipal Charter.

I do further certify that the election judees and olexks of election at eaid anmal city election duly made their return or the ballots cast at such eleation upon said guestion and thet the Oity Council of said Oity at a speoial meeting thereof hela on the 9th day of April, 2.942 duly ealled for the purpose of cantassing the returns of votes cast at such election and to declare the result thereof, duly canvassed the votes so cest at such amual election upon said question and duly determined that three-ifiths and nore of those lawfully voting at such election had deciared in favor of the amendment so proposed and thet by reason thereot hed adopted and retified the same; that thereupon seid City Council duly ordered and directed the Weyor and Chief Magistrate of said Gity to forthwith execute duplicate certificates setting forth the proposed arendment and its ratification authentioated by the coxporate seal of the City and directed that one of said certificates be deposited in the office of the Secretary of State in and for the State of Einnesota and that the other, after being recorded in the office of the Register of Deeds in and for the County of Otter Tail, State of $\mathrm{finnesota} ,\mathrm{be} \mathrm{deposited} \mathrm{among} \mathrm{the} \mathrm{archives} \mathrm{of} \mathrm{the} \mathrm{city}$.

I do further certify that I make and execute the within certificate pursuant to authority in ne vested by the said Oity Council and in accordance with Section 1286 Mason's Minnesota Statutes of 1927 and laws supplementary thereto and amendatory thereof and Section 36 of Artiole 4 of the Constitution of the State of Minnesota.
