I, Paul J. Stender, Mayor and Chief Magistrate of the City of Fergus Falls, said County and State, do hereby certify that the Board of Freeholders of said City, after due proceedings, duly proposed that a new sub section to Section 94 of Chapter 5 of the Municipal Charter of the City of Fergus Falls, Otter Tail County, Minnesota be adopted so as to read as follows, to-wit:

> "The Equipment Fund is created to provide for the purchase of all equipment of any kind or nature needed by any department of the City for municipal purposes. It shall be maintained by an annual tax levy made by the Council in such amount as the Council may deem necessary upon the taxable property of the City. The proceeds of the sale of any equipment shall also be placed in said fund."

I do further certify that thereafter the City Council of said City duly submitted to the legal voters thereof at the annual city election held on the 7th day of April, 1942 the question whether or not the proposed new sub section should be adopted and ratified or rejected, all in compliance with the statutes of the State of Minnesota with reference thereto and the Municipal Charter.

I do further certify that the election judges and clerks of election at said annual city election duly made their return of the ballots cast at such election upon said question and that the City Council of said City at a special meeting thereof held on the 9th day of April, 1942, duly called for the purpose of canvassing the returns of votes cast at such election and to declare the result thereof, duly canvassed the votes so cast at such annual election upon said question and duly determined that three-fifths and more of these lawfully voting at such election had declared in favor of the new sub section so proposed and that by reason thereof had adopted and ratified the same; that thereupon said City Council duly ordered and directed the Mayor and Chief Magistrate of said City to forthwith execute duplicate certificates setting forth the proposed new sub section and its ratification authenticated by the corporate seal of the City and directed that one of said certificates be deposited in the office of the Secretary of State in and for the State of Minnesota and that the other, after being recorded in the office of the Register of Deeds in and for the County of Otter Tail, State of Minnesota, be deposited among the archives of the City.

I do further certify that I make and execute the within certificate pursuant to authority in me vested by the said City Council and in accordance with Section 1286 Mason's Minnesota Statutes of 1927 and laws supplementary thereto and emendatory thereof and Section 36 of Article 4 of the Constitution of the State of Minnesota.
