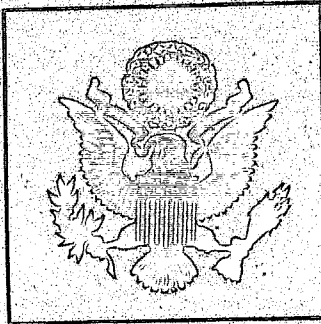

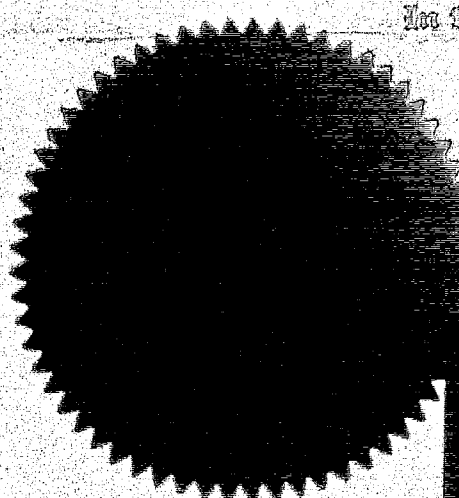

To all to whom these presents shall come, Greeting:

I Certify That Mr. Ulrich Beusch is recognized by the Government of the United States as Vice Consul of Switzerland at Chicago, Illinois, by exequatur dated July 20, 1932; that his consular jurisdiction includes northern Illinois, Iowa, Michigan, Minnesota, North Dakota, South Dakota, Wisconsin and Wyoming; and that he is Acting Consul of Switzerland for this jurisdiction in the absence of a recognized Consul.
