CERTIFICATE OF CONSENT BY THE STATE OF MINNESOTA
TO THE ACQUISITION OF CERTAIN LANDS BY THE UNITED STATES IN HENNEPIN
COUNTY, MINNESOTA.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS the United States of America became vested with a valid title to approximately 9.12 acres of land in Hennepin County, Minnesota, on July 2, 1943, pursuant to a Declaration of Taking filed on that date in the United States District Court for the District of Minnesota, in the case of United States of America v. 8.92 acres of land in Hennepin County, Minnesota, Ella May Kindom, et al., said land being more fully and particularly described as follows:

PARCEL "A"

All of Block 1, Guy Cummings, Nokomis Park Addition to the City of Minneapolis, together with all of Block 1, Cummings Nokomis Homes Addition to the City of Minneapolis, and that portion of 38th Avenue South, lying between the herein described lands and lands previously acquired by the United States of America by Declaration of Taking filed September 28, 1942, in the United States District Court, District of Minnesota, Fourth Division, containing 4.56 acres, more or less.

PARCEL "B"

All of Block 13, Minnehaha Falls, Fourth Addition, and that portion of 41st Avenue South, lying between said lands and the lands of the United States of America acquired by Declaration of Taking filed September 28, 1942, in the United States District Court, District of Minnesota, Fourth Division, containing 4.56 acres, more or less.

Containing in both above described parcels, 9.12 acres, more or less, and

WHEREAS, said land was acquired under authority of an Act of Congress approved December 17, 1941, for use in connection
