KNOW ALL MEN BY THESE PRESENTS That whereas the Governor, on recommendation of the Legislative Advisory Committee, has transferred to the Department of the Attorney General the sum of Three Thousand Two Hundred (\$3200) Dollars, of which Three Thousand (\$3000) Dollars shall be used as compensation of an attorney to be assigned to work to be done for the Land Exchange Commission and the Department of Conservation, and Two Hundred (\$200) Dollars of which sum has been allowed for expenses in connection with said legal work, and

WHEREAS, pursuant to the transfer of such funds, the Land Exchange Commission and Department of Conservation has requested the appointment of an attorney for the Land Exchange Commission and Department of Conservation to examine land titles, and to perform such other legal work as they may request,

NOW, THEREFORE, I, J. A. A. Burnquist, Attorney General of the State of Minnesota, by virtue of the authority vested in me by statute, and on request as aforesaid, do hereby constitute and appoint Seth Lundquist as Special Attorney in the Department of the Attorney General for the purpose of examining the title to the lands hereinafter described, to-wit:


