



ORDINANCE NO. 166

AN ORDINANCE TO ANNEX CERTAIN CONTIGUOUS TERRITORY TO THE CITY OF WORTHINGTON

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW WHEREAS, the territory hereinafter described is now owned by the City of Worthington; and whereas, said territory is situated outside of, but contiguous to, and abutting on the corporate limits of said City;

AND WHEREAS, it is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, the following described territory is hereby declared to be a part of the City of Worthington; to-wit,

Commencing at the northeast corner of Section Twenty-two (22), in Township One Hundred and Two (102) North and Range Forty (40) West of the 5th P.M., County of Nobles and State of Minnesota, thence south along the easterly line of said section to the north shore line of West Okabena Lake; thence westerly along the northerly shore line of said lake to a point directly south of the intersection of the easterly line of Liberty Drive and the Northerly line of Lake Avenue, as the same are shown on the Plat of Cherry Point Park on file in the office of the Register of Deeds in and for said County; thence north to said point of intersection; thence northwesterly along the northeasterly side of Liberty Drive, seven hundred twenty-three and three-tenths (723.3) feet; thence north, five hundred fifty-five and seven-tenths (555.7) feet; thence east, nine hundred seventy-four and five-tenths (974.5) feet; thence northeasterly to a point twenty-six (26) feet west of the northeast corner of said Section Twenty-two (22); thence east, twenty-six (26) feet to the place of beginning.

Passed by the City Council of the City of Worthington, Minnesota, this 23rd day of May, 1945.
