An ordinance providing for the annexing of certain territory to the Village of Walker, on petition of Synva Quam.

THE VILLAGE COUNCIL OF THE VILLAGE OF VALUER DO OPDAIN AS FOLIOWS:

Section 1. That the following described unplatted land abutting upon the Village of Walker, to-wit; all that portion of the southwest quarter of the southeast quarter (SW) of SM) of Section twenty two (22), Township one hundred and forty two (142), Eange Thirty one (31) described as follows, to-wit: Commencing at the southeast corner of Block Three (3), in Quam's Addition to the Village of Talker, according to the duly recorded plat thereof, thence south on a line which is a scutnerly extention in a straight line, of the west side of Fifth Street in Quam's Addition to the Village of Malker, to a point on the south line of said Section Twenty two (23), thence west along the south line of said Section a distance of one hundred and fifty (150) feet, thence north, parallel to said extended line of said Fifth Street, to the southwest corner of Lot Six (6) in Block Three (3) of said Quam's Addition to the Village of Walker, thence east one nundred and fifty feet along the south line of said Block Three (3) to the roint of beginning, containing four acres, more or less,—be and the same hereby is annexed to, included within and made a part of the incorporated Village of Walker.
