

Ordinance No. 90.

An ordinance providing for the annexing of certain territory to the Village of Walker, on petition of Synva Quam.

Whereas Synva Quam has presented to the Village Council of the Village of Walker a petition as follows:

"TO THE HONORABLE VILLAGE COUNCIL OF THE VILLAGE OF WALKER:
I, Synva Quam, of Walker, Cass County, Minnesota, respectfully represent that I am the owner of the following described unplatted land abutting upon the Village of Walker, to-wit: all that portion of the south west quarter of the southeast quarter (SW¹ of SE¹) of Section twenty two (22), Township one hundred and forty two (142) Range thirty one (31) described as follows, to-wit: Commencing at the southeast corner of Block Three (3) in Quam's Addition to the Village of Walker, according to the duly recorded plat thereof, thence south on a line which is a southerly extension in a straight line of the west side of Fifth Street in Quam's Addition to the Village of Walker, to a point on the south line of said section twenty two (22), thence west along the south line of said section a distance of one hundred and fifty (150) feet, thence north, parallel to said extended line of said Fifth Street, to the southwest corner of Lot Six (6) in Block Three (3) of said Quam's Addition to Walker, thence east one hundred and fifty (150) feet to the point of beginning, containing four acres, more or less"
Dated November 19, 1945 Synva Quam".

which said petition is duly verified by oath of said Synva Quam attached to said petition;

And whereas said Village Council has, by resolution duly passed, decided to grant said petition; now therefore,

THE VILLAGE COUNCIL OF THE VILLAGE OF WALKER DO ORDER AS FOLLOWS:

Section 1. That the following described unplatted land abutting upon the Village of Walker, to-wit: all that portion of the south-west quarter of the southeast quarter (SW¹ of SE¹) of Section twenty two (22), Township one hundred and forty two (142), Range Thirty one (31) described as follows, to-wit: Commencing at the southeast corner of Block Three (3), in Quam's Addition to the Village of Walker, according to the duly recorded plat thereof, thence south on a line which is a southerly extension in a straight line, of the west side of Fifth Street in Quam's Addition to the Village of Walker, to a point on the south line of said Section twenty two (22), thence west along the south line of said section a distance of one hundred and fifty (150) feet, thence north, parallel to said extended line of said Fifth Street, to the southwest corner of Lot Six (6) in Block Three (3) of said Quam's Addition to the Village of Walker, thence east one hundred and fifty feet along the south line of said Block Three (3) to the point of beginning, containing four acres, more or less,---be and the same hereby is annexed to, included within and made a part of the incorporated Village of Walker.

Section 2. This ordinance shall be in force from and after its passage and publication and the filing of a certified copy thereof in the office of the Secretary of State of Minnesota.
