ORDINANCE NO. 38.

ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF KASOTA.

The Village Council of the Village of Kasota-Minnesota do Ordain as follows:

Section 1. The boundaries of the Village of Kasota are hereby extended as to include within said Village and its corporate limits the hereinafter described real estate situated in the County of Le Sueur and State of Minnesota, which tract of land is depicted and contains less than two hundred acres and now abuts upon said Village of Kasota and upon its present corporate limits-to-wit:-

All that portion of the southeast quarter of Section 16, Thirty-three in Township 16, One Hundred and Ten North, of Range 16, Twenty-six West-which is described as follows-to-wit:-

Commencing at a point in the westerly line of State Trunk Highway No. 169 where the same is intersected by the northerly line of the right of way of the Chicago-Milwaukee and St. Paul Railway; thence one hundred and fifty feet northerly along the westerly line of said State Trunk Highway No. 169 to the point of beginning; thence running northerly along said westerly line of said State Trunk Highway No. 169 to the north line of said westerly half of said southeast quarter of said Section 16, Thirty-three; thence westerly on said line to the southwest corner of said west half of the said southeast quarter; thence southerly on said line to a point seven hundred and thirty feet north of the point of intersection of said line with the northerly line of the right of way of the Chicago-Milwaukee and St. Paul Railway; thence easterly to the point of beginning; said last named line and direction being the northerly line of the tract hereinafter conveyed to and John Wilson; by and recorded in Book 17 of Deeds at page 602- in the office of the register of deeds of said Le Sueur County.

Section 2. This Ordinance is passed upon the matters recited position of the corners of said tract of land-surveying to have said tract of land included within said Village and its corporate limits.

Section 3. This Ordinance shall take effect and be in force upon its passage and publication and upon the filing of a certified copy thereof with the secretary of state of the State of Minnesota.

The foregoing Ordinance was presented by Trustee H.R. Combs

After due consideration the adoption of the foregoing Ordinance was put to a roll call vote-and the following voted "AYES"; Trustees Silas H. Benjamin-H.R. Combs and Chas. Newman; and Recorder A. Mueller and President L.E. Davis and none against. Whereupon the President declared the Ordinance duly adopted.

#### LEGAL PUBLICATION

The Council of the Village of Kasota, Le Sueur County, Minnesota, was convened in a Special Meeting at the Recorder's residence in Kasota, Minnesota at 8 P. M. on March 25th, 1946 upon written legal notice by two of the Trustees of said village, called for the purpose (among other things) of acting upon a petition signed by J. J. Lynch & Grace Lynch, owners of a tract of land adjoining and abutting on the corporate limits of said village and praying that said tract of land be incorporated in the corporate limits of said village, and passed the following Ordinance, all members of the Council voting "AYE" upon roll call, and none against:

#### ORDINANCE NO. 38

#### ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF KASOTA.

The Village Council of the Village of Kasota, Minnesota, do Ordain, as follows:

Section 1. The Boundaries of the Village of Kasota are hereby extended so as to include within said Village and its corporate limits the hereinafter described real estate situate in the County of Le Sueur and State of Minnesota, which tract of land is unplatted and contains less than two hundred acres and now abuts upon said Village of Kasota and upon its present corporate limits, to-wit:—

All that portion of the southeast quarter of Section No. Thirty-Three in Township No. One Hundred and Ten North, of Range No. Twenty-six West, which is described as follows, to-wit:—

Commencing at a point in the westerly line of State Trunk Highway No. 169 where the same is intersected by the northerly line of the right of way of the Chicago, Milwaukee and St. Paul Railway; running thence one hundred and fifty feet northerly along the westerly line of said State Trunk Highway No. 169 to the point of beginning; thence running northerly along said westerly line of said State Trunk Highway No. 169 to the north line of said westerly half of said southeast quarter of said Section No. Thirty-three; thence westerly on said line to the northwest corner of said west half of the said southeast quarter; thence southerly on said line to a point seven hundred and thirty feet north of the point of intersection of said line with the northerly line of the right of way of the aforesaid Railway Company; thence easterly to the point of beginning; said last named line and direction being the northerly line of the tract heretofore conveyed to one John Willcox by deed recorded in Book 85 of Deeds at page 628, in the office of the register of deeds of said Le Sueur County.

Section 2. This Ordinance is passed upon the written verified petition of the owners of said tract of land, praying to have said tract of land included within said Village and its corporate limits.

Section 3. This Ordinance shall take effect and be in force upon its passage and publication and upon the filing of a certified copy thereof with the secretary of state of the State of Minnesota.
