

ORDINANCE NUMBER 72

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
VILLAGE OF GIBBON ON PETITION OF THE OWNERS  
PURSUANT TO SECTION 413.08 OF  
MINNESOTA STATUTES FOR 1941

THE VILLAGE COUNCIL OF THE VILLAGE OF GIBBON, IN SIBLEY  
COUNTY, MINNESOTA, DO ORDAIN AS FOLLOWS:

Section 1. That a majority of the owners of the land hereinafter described have duly petitioned the Village Council of the Village of Gibbon, to have said land annexed to said Village, and that said Petition has been duly granted.

Section 2. That the following described land, to-wit:

Beginning at the Northeast corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Eleven (11), Township One Hundred Twelve, (112) Range Thirty-one (31), thence running South One Hundred and Seventy and 58/100 (170.58) feet, thence west one thousand forty-two and 2/10 (1042.2) feet more or less to the East Line of State Aid Road Number Two (2), thence north one Hundred Seventy and 58/100 (170.58) feet, to the Section Line of said Section Eleven (11), thence East on said Section line, one thousand forty-two and 2/10 (1042.2) feet more or less to the point of beginning,

be, and the same is hereby annexed to said Village and is made a part of said Village as effectually as if said land had been originally a part thereof.

Section 3. This Ordinance shall be in full force and effect from and after its adoption and publication, and a certified copy thereof duly filed with the Secretary of State for the State of Minnesota as provided by law, and a certified copy of said Ordinance filed with the County Auditor of said County.

## PRINTER'S AFFIDAVIT OF PUBLICATION

Printer's Affidavit of Publication. (Chapter 128, Laws of 1939.)

Alice M. Olson, being duly sworn, on oath says; that he is, and during all the times herein stated has been the printer or the publisher of the newspaper known as THE GIBBON GAZETTE, and has full knowledge of the facts hereinafter stated; that for more than one year prior to the publication therein of the Ordinance No. 72 of The Village of Gibbon, Sibley County, Minnesota

hereinafter described, said newspaper was printed and published in the Village of Gibbon, in the County of Sibley, State of Minnesota, on Thursday of each week; that during all said time said newspaper has been printed in the English language from its known office of publication within the Village from which it purports to be issued as above stated and in newspaper format and in column and sheet form equivalent in space to at least 450 running inches of single column, two inches wide; has been issued once each week from a known office established in said place of publication and employing skilled workmen and the necessary material for preparing and printing the same; that the press work on that part of the newspaper devoted to local news of interest to the community it purports to serve has been done in its known office of publication; that during all said time in its makeup not less than twenty-five per cent of its news columns have been devoted to local news of interest to the community it purports to serve; that during all said time it has not wholly duplicated any other publication, and has not been entirely made up of patents, plate matter and advertisements; has been circulated in and near its said place of publication to the extent of at least two hundred and forty (240) copies regularly delivered to paying subscribers and has entry as second class matter in its local postoffice; and that there has been on file in the office of the County Auditor of Sibley County, Minnesota, the affidavit of a person having knowledge of the facts, showing the name and location of said newspaper and the existence of the conditions constituting its qualifications as a legal newspaper.

That the Ordinance hereto attached was cut from the columns of said newspaper, and was printed and published therein in the English language, once each week, for successive weeks; that it was so published on Thursday the 25 day of April 19 46;

and that the following is a printed copy of the lower case alphabet from A to Z, both inclusive, and is hereby acknowledged as being the size and kind of type used in the composition and publication of said notice, to-wit:
