

Ordinance No. 106

AN ORDINANCE TO ANNEX ADDITIONAL LAND TO THE VILLAGE OF LE ROY AND EXTEND THE BOUNDARIES THEREOF.

The village council of Le Roy do ordain:

Section 1. Additional land annexed and village boundary extended.—Pursuant to petitions duly signed by the majority of owners of land abutting the village, and being and lying in Mower County, Minnesota and described as follows:

Outlots one (1), two (2), three (3), four (4), five (5), six (6), seven (7), eight (8), nine (9), a tract or parcel of land described as follows: Commencing at the Northeast (NE) corner of the Southeast quarter (SE $\frac{1}{4}$) of Section thirty-three (33), Township one hundred and one (101), North range fourteen (14) west, running thence south twelve (12) rods, thence west thirteen and one-third (13 1-3) rods, thence north twelve (12) rods to quarterline of said section, thence east on said quarterline, thirteen and one-third (13 1-3) rods to the place of beginning, and also

A parcel or tract of land described as follows: Commencing at the Southeast (SE) corner of the Northeast quarter (NE $\frac{1}{4}$) of Section thirty-three (33), Township one hundred and one (101) and north range fourteen (14), west, thence west one hundred and ninety-eight (198) feet, thence north three hundred and sixty-eight (368) feet more or less, to the Southwest (SW) corner of Outlot nine (9), thence east, one hundred and ninety-eight (198) feet to section line, thence south on section line three hundred and sixty-eight (368) feet more or less to the place of beginning, containing one point six seven (1.67) acres. All of the above in Section thirty-three (33), Township one hundred and one (101) north range fourteen (14) west.

Outlots one (1), two (2), three (3), four (4), five (5), and a parcel or tract of land described as follows: Commencing at the Southwest (SW) corner of the Northwest quarter (NW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section thirty-four (34), Township one hundred and one (101) range fourteen (14) thence running east nine hundred and forty-seven (947) feet, thence north one hundred and thirty-

three (133) feet, thence west, nine hundred and forty-seven (947) feet, thence south one hundred and thirty-three (133) feet to place of beginning containing two point eight nine (2.89) acres. All of the above in Section thirty-four (34) Township one hundred and one (101), north range fourteen (14) west.

Said land is hereby declared to be annexed to and an addition to the village and the village boundaries are hereby extended to include the aforesaid land within the village limits, said land to be deemed a part of the village, as effectually as if the same had originally been a part thereof.

Section 2. Copy to be filed with Secretary of State and filed and recorded with register of deeds.—The village clerk is directed to file a certified copy of this ordinance with the Secretary of State and file and record same in the office of the register of deeds in and for this county.

Section 3. Effect.—This ordinance to be in full force and effect upon the aforementioned filing and recording thereof.
