ORDINANCE NO. 30

An Ordinance Annexing Certain Unplatted Lands to the Village of Backus.

The Village Council of the Village of Backus, do ordain as follows:

Section I. That the following unplatted lands abutting upon the incorporated village of Backus, to-wit:

All that portion of lots 2 and 3 of Township 139, Section 30, Range 30, lying west of the Minnesota and International Rail Road road of way, except that portion of said lot 2 heretofore conveyed to John W. Bailey, by deed appearing on record in Book II of Deeds, page 214 in office of register of deeds of said Cass County, Minnesota. The same is hereby annexed to such village as effectually as if it had been originally a part thereof.
