REMEMBER . . .

That your registration as Architect, Professional Engineer, or Land Surveyor expires December 31, 1946. This date and the amount due are specified by law, and the Board has no authority to make any change.

The renewal fee and penalty, if paid after December 31, 1946, is

\$5.00 for an Architect or an Engineer

2.00 for a Land Surveyor

5.00 is the aggregate fee for renewal in any two or three of the professions.

See Section 326.10, Subdivision 6, of the Act and the Board's Rules and Regulations — Rule 4 Fees (h).

At the 1943 session of the Legislature a bill was passed relating to renewals of registration by persons in the Armed Forces of the United States and those engaged in employment outside of the United States, essential to the prosecution of the present war and to the National Defense, and this bill provides that:

Any person is exempted from further payment of renewal fee or from making application for renewal during the period he shall remain in such Armed Forces or is engaged in such employment, and for six months after the date of release from the Armed Forces of the United States or from the date of termination of "essential" employment or return within the boundaries of the United States. Applicant may renew his registration any time within said six months without penalty.

If you claim exemption, will you please advise this Board of your position in the Service or of your location and work in an essential employment "outside the United States" so that we may have a complete record in our files.

If your fee or exemption claim is not received in this office on or before January 1, 1947, your name cannot be included in the Roster of Registrants.

**SECTIONS 326.02 TO 326.16 INCLUSIVE, AND SECTION 326.53,
MINNESOTA STATUTES FOR 1941, AS AMENDED BY
CHAPTER 380, LAWS OF 1945**

Sec. 326.02. Registration of Architects, Engineers and Surveyors. Subdivision 1. **Registration mandatory.**—In order to safeguard life, health, and property, and to promote the public welfare, any person in either public or private capacity practicing, or offering to practice, architecture, professional engineering, or land surveying in this State, either as an individual, a co-partner, or as agent of another, shall be registered as hereinafter provided. It shall be unlawful for any person to practice, or to offer to practice, in this State, architecture, professional engineering, or land surveying, or to solicit or to contract to furnish work within the terms of Sections 326.02 to 326.16, or to use in connection with his name, or to otherwise assume, use or advertise any title or description tending to convey the impression that he is an architect, professional engineer (hereinafter called engineer) or land surveyor, unless such person is qualified by registration under Sections 326.02 to 326.16.

Subd. 2. **Qualification Requirements.**—Any person shall be deemed to be practicing architecture, within the meaning of Sections 326.02 to 326.16, who holds himself out as able to perform or who does perform any professional service, such as planning, design, or supervision of construction for the purpose of compliance with specifications and design, in connection with any private or public buildings, structures or projects, or the equipment or utilities thereof, or the accessories thereto, wherein the safeguarding of life, health, or property is concerned or involved, when such professional service requires the application of the art and science of construction based upon the principles of mathematics, aesthetics, and the physical sciences, acquired by education or training.

Subd. 3. **Persons Qualified.**—Any person shall be deemed to be practicing professional engineering within the meaning of Sections 326.02 to 326.16 who shall furnish any technical professional service, such as planning, design or supervision of construction for the purpose of assuring compliance with specifications and design, in connection with any public or private structures, buildings, utilities, machines, equipment, processes, works, or projects, wherein the public welfare or the safeguarding of life, health, or property is concerned or involved, when such professional service requires the application of the principles of mathematics and the physical sciences, acquired by education or training.

Subd. 4. **Practice Defined.**—Any person shall be deemed to be practicing land surveying within the meaning of Sections 326.02 to 326.16 who makes any survey for the establishment or re-establishment of land boundaries, or for the subdivision and platting of land or for the determination of areas.

Subd. 5. **Limitation.**—The provisions of Sections 326.02 to 326.16 shall not apply to the preparation of plans and specifications for the erection, enlargement, or alteration of any building or other structure by any person, for his, or his lessee's exclusive occupancy or use, unless such occupancy or use involves the public health or safety or the health or safety of the employees of said person, or his lessee; nor shall they apply to the preparation of plans and specifications for any building, structure, or work, which is not public as defined in Section 326.03, the total cost of which does not exceed \$10,000; nor shall they apply to the preparation of plans and specifications for any single or two-family dwelling, nor to any farm building or accessory thereto; nor to any detailed or shop plans required to be furnished by a contractor to a registered engineer or architect, nor to any standardized manufactured product, nor to any construction superintendent supervising the execution of work designed by an architect or engineer registered in accordance with this Act.

Sec. 326.03. Registration Required.—No person, except an architect, engineer or land surveyor, registered as provided for in Sections 326.02 to

326.15 shall practice architecture, professional engineering, or land surveying, respectively, in the preparation of plans, specifications, report, plats or other engineering or architectural documents, or in the supervision of architectural, engineering, or land surveying work, for any public work or public improvement in this state, excepting any public work or public improvement the total cost of which does not exceed \$2,000, provided that plans and specifications for such work or improvement affecting water supply or waste disposal are approved by the appropriate state agency. Public work or public improvement is defined to mean work or improvement the cost of which is to be paid in whole or in part from public funds.

No plat, map, or drawing of any survey or subdivision of lands required by law to be filed or recorded with the register of deeds or registered with the registrar of titles of any county, shall be filed, recorded, or registered therein unless there shall be endorsed thereon a certificate by a registered land surveyor.

The provisions hereof shall not apply to any person holding an elective office when in discharging the duties thereof such person is required to do work or perform service of the character of work or service usually done or performed by an architect, engineer, or land surveyor.

Sec. 326.04. State Board Created—Terms—Appointment.—To carry out the provisions of Sections 326.02 to 326.15 there is hereby created a State Board of Registration for architects, engineers and land surveyors (hereinafter called the Board) consisting of seven members, who shall be appointed by the Governor. Three members shall be registered architects, three members shall be registered engineers and one member shall be a registered land surveyor. Not more than one member of said Board shall be from the same branch of the profession of engineering. The members of the first Board shall be appointed to serve for the following terms: two members for one year; two members for two years; two members for three years; and one member for four years, said terms ending on the first day of January of the succeeding years. On the expiration of each of said terms the term of office of each newly appointed or reappointed member of the Board shall be for a period of four years and shall terminate on the first day of January; except that each member shall hold over after the expiration of his term until his successor shall have been duly appointed and qualified. The Governor may remove any member of the Board for misconduct, incompetency or neglect of duty. Vacancies in the membership of the Board, however created, shall be filled by appointment by the Governor for the unexpired term.

Sec. 326.05. Qualifications of Members of Board.—Each member of the Board shall be a citizen of the United States and a resident of this State at the time of his appointment. He shall have been engaged in the practice of his profession for at least ten years and shall have been in responsible charge of work for at least five years. He shall be a member in good standing of a recognized society of architects, engineers or land surveyors, and except as provided in Section 326.06 shall be a registered architect, registered engineer or registered land surveyor.

Sec. 326.06. Powers and Duties of the Board.—Each member of the Board shall receive a certificate of appointment from the Governor, and before beginning his term of office he shall file with the Secretary of State the constitutional oath of office. Each member of the Board first created shall receive a certificate of registration under Sections 326.02 to 326.15 from the Governor of this State. The Board or any committee thereof shall be entitled to the services of the Attorney General in connection with the affairs of the Board, and the Board shall have power to compel the attendance of witnesses, may administer oaths and may take testimony and proofs concerning all matters within its jurisdiction. The Board shall adopt and have

an official seal which shall be affixed to all certificates of registration granted; and shall make all by-laws and rules not inconsistent with law needed in performing its duties; and shall fix standards for determining the qualifications of applicants for certificates, which shall not exceed the requirements contained in the curriculum of a recognized school of architecture or engineering.

Sec. 326.07. Meetings—Officers—Quorum.—The Board shall hold a meeting within thirty days after its members are first appointed, and thereafter shall hold at least two regular meetings each year. Special meetings shall be held at such times as the by-laws of the Board may provide. Notice of all meetings shall be given in such manner as the by-laws may provide. The Board shall elect annually from its members a chairman, a vice-chairman and a secretary-treasurer. A quorum of the Board shall consist of not less than four members, of whom two shall be architects and two engineers.

Sec. 326.08. Fees to Be Used for Expenses—Compensation of Members—Bonds of Officers.—All fees and other monies accruing from the operation of Sections 326.02 to 326.15 shall be paid to the Board and shall be used for the purposes of Sections 326.02 to 326.15 and 326.53. The expenses of the Board shall be paid by voucher made by the secretary-treasurer and approved by the chairman. Each member of the Board shall receive such compensation as the Board may direct, not to exceed \$10.00 per day for time spent in attending meetings of the Board. The members of the Board shall be reimbursed for actual expenses incurred in travel to and from meetings and for expenditures for hotel bills, meals, stationery, postage, printing, typewriting and the like necessary expenses incurred in the performance of their duties under Sections 326.02 to 326.15 and 326.53. The secretary-treasurer of the Board shall give a surety bond satisfactory to the State Treasurer conditioned upon the faithful performance of his duties. The premium on said bond shall be regarded as a proper and necessary expense of the Board.

Sec. 326.09. Records—Reports—Rosters.—The Board shall keep a record of its proceedings and a register of all applicants for registration showing for each, the date of application, name, age, educational and other qualifications, place of business and place of residence, whether or not an examination was required and whether the applicant was rejected or a certificate of registration granted, and the date of such action. The books and register of the Board shall be prima facie evidence of all matters recorded therein. A roster showing the names and places of business and of residence of all registered architects, engineers and land surveyors shall be prepared by the secretary-treasurer of the Board during the month of January of each year; such roster shall be printed out of the funds of the Board as provided in Section 326.08. On or before the first day of February of each year the Board shall submit to the Governor and file with the Secretary of State a copy of the report of its transactions for the preceding year together with a complete statement of the receipts and expenditures of the Board signed by the chairman and the secretary-treasurer, accompanied by a certified audit, and a copy of the said roster of registered architects, registered engineers and registered land surveyors.

Sec. 326.10. Certificates of Registration. Subdivision 1. Issuance.—The board shall, on application therefor, on a prescribed form, and the payment of a fee not to exceed \$10.00, issue a certificate of registration as an architect or engineer, and, on the payment of a fee of not to exceed \$5.00, issue a certificate of registration as a land surveyor;

(1) To any person over 25 years of age, who is a citizen of the United States or Canada, or who has made declaration of his intention to become a citizen of the United States; who speaks and writes the English language; who is of good moral character and repute, and has been actively engaged for eight or more years in architectural or engineering work, or engaged for

six or more years in surveying work. The character of such work shall be satisfactory to the Board. Each scholastic year of teaching or of study satisfactorily completed, of architecture, engineering, or land surveying in a school or college of architecture or engineering accredited by the National Architectural Accrediting Board or by the Engineers' Council for Professional Development, shall be considered as equivalent to one year of such active engagement, provided, however, that three years of actual experience of a standard satisfactory to the board shall be required in addition to school attendance.

An honorably discharged veteran of World War I or World War II shall be given credit for such experience or education gained in the armed services of the United States as meets the standards fixed by the board.

(2) To any person who holds a like unexpired certificate of registration issued to him by proper authority in the District of Columbia, in any state or territory of the United States, or in any province of Canada, in which the requirements for registration of architects, engineers, or land surveyors are equal to those fixed by the board and by the laws of this state, and in which similar privileges are extended to the holders of certificates of registration issued by this state;

Subd. 2. Examination.—The board may subject any applicant to such examinations as may be deemed necessary to establish his qualifications.

In determining the qualifications in such cases of applicants for registration as architects, a majority vote of the architect members of the board only shall be required; in determining the qualifications in such cases of applicants for registration as engineers, a majority vote of the engineer members of the board only, shall be required; and in determining the qualifications of applicants for registration as land surveyors, the affirmative vote of the land surveyor member and of one engineer of the board only, shall be required.

Subd. 3. Rules for Classification.—The board may make reasonable rules and regulations for classifying and registering engineers in divisions according to their qualifications to practice different classes of engineering work, and shall, in such case, register qualified applicants in one or more such divisions in which they shall qualify under the terms of Sections 326.02 to 326.16 and shall, in any event, provide one such division for highway engineers.

Any person so qualified may be registered in two or all of these three professions; but the aggregate fee for such registration shall not exceed \$15.00.

Subd. 4. Deposit Returned.—In case the board denies the issuance of a certificate to an applicant, the registration fee deposited shall be returned by the board to the applicant.

Subd. 5. Expiration — Notice — Renewal.—Certificates of registration shall expire on the last day of the calendar year for which they are issued and shall become invalid on that date unless renewed. It shall be the duty of the secretary-treasurer of the board to notify, by mail, every person registered of the date of the expiration of his certificate and the amount of fee required for its renewal for one year; such notice shall be mailed to the registrant at his address as shown on the records of the Board at least one month in advance of the date of the expiration of the certificate. Renewal may be effected at any time during the month of December by the payment of a fee of \$3.00 for an architect or an engineer, and \$1.00 for a land surveyor.

Subd. 6. Delayed Registration.—The failure on the part of any registrant to renew his certificate annually in the month of December shall not deprive such person of his right of renewal thereafter, but the fees to be paid

for the renewal of the certificate after the succeeding first day of January shall be \$5.00 for an architect or an engineer, and \$2.00 for a land surveyor. The aggregate fee for renewal of registration in two or three of the professions shall be the same as the single renewal fee for registration as an architect or an engineer.

Subd. 7. **Graduates.**—Any candidate for registration as an architect or professional engineer who is a graduate of an accredited school or college of architecture or engineering or who has had four years or more of experience in architectural or engineering work of a character satisfactory to the board shall receive from the board, upon successfully passing an examination in fundamental architectural or engineering subjects, a certificate stating that he has passed such examination and that his name has been recorded as an architect-in-training or as an engineer-in-training.

Sec. 326.11. **Certificates of Registration, Revocation, Re-issue, Duplicates.** Subdivision 1. **Revocation.**—The board shall have the power to revoke or suspend as hereinafter provided, the certificate of registration of any architect, engineer, or land surveyor, who is found guilty by the board of any fraud or deceit in obtaining a certificate of registration, or of attaching his seal or signature to any plan, specification, report, plat, or other engineering or architectural document not prepared by him or under his direct supervision, or of gross negligence, incompetency, or misconduct in the practice of architecture, engineering, or land surveying, or upon conviction of any violation of Sections 326.02 to 326.16 or amendments thereof, or of any crime involving moral turpitude or upon adjudication of insanity or incompetency, and in the case of such conviction or adjudication, such revocation or suspension may be made by the board on its own motion on the filing with its secretary-treasurer of a copy of the minutes of such conviction and judgment or adjudication, duly certified by the clerk in whose custody they are, the same to be conclusive evidence of such conviction or adjudication.

Subd. 2. **Charges.**—Any person may prefer charges of such fraud, deceit, misuse of seal or signature or of such gross negligence, incompetency, or misconduct against any person registered hereunder. Such charges shall be in writing, sworn to by the complainant, filed with the secretary-treasurer and submitted by him to the board; and, unless dismissed without hearing by the board as unfounded or trivial, shall be heard or determined by the board within three months after the date of such filing with the secretary-treasurer. A time and place for such hearing shall be fixed by the board.

Subd. 3. **Copy Served—Notice of Hearing.**—A copy of the charges, together with a notice of the time and place of hearing, shall be legally served on the accused at least 30 days before the date fixed for the hearing, and, in the event that such service cannot be effected 30 days before the hearing, the date of hearing and determination shall be postponed as may be necessary to permit the carrying out of this condition.

Subd. 4. **Hearing.**—At the hearing the accused shall have the right to appear personally and by counsel, to cross-examine witnesses against him, and to produce evidence and witnesses in his defense. If, after said hearing, five or more members of the board vote in favor of finding the accused guilty of any charge made against him, the board may revoke or suspend the certificate of registration of the accused.

Subd. 5. **Re-issue.**—The board may reissue a certificate of registration to any person whose certificate has been revoked, provided five or more members of the board vote in favor of such reissuance for reasons the board may deem sufficient.

Subd. 6. **Replacement of Lost Certificate.**—A new certificate of registration to replace any certificate revoked, lost, destroyed, or mutilated, may

Sec. 326.15. *False Impersonation.*—It shall be unlawful for any person to present or attempt to use as his own the seal or certificate of another, or to give false or forged evidence of any kind to the board, or any member thereof, or to falsely impersonate any registrant of like or different name, or to use or attempt to use as his own the certificate of registration of another issued by any authority outside of this state, or to use or attempt to use an expired or revoked or suspended certificate of registration.

Sec. 326.16. *Appeals to District Court.*—Any person aggrieved by any ruling or order of the Board made under the provisions of Sections 326.02 to 326.15, may appeal therefrom to any district court of the state by serving written notice of such intention upon the secretary-treasurer of the board, specifying such court, within 30 days after the same is made. The secretary-treasurer of the board shall thereupon file with the clerk of such court a certified copy of the order or rulings or findings of fact upon which the same are based, which shall be prima facie evidence of the facts therein stated. The trial of all issues on such appeal shall be de novo by the court and such appeal shall be heard and tried in the same manner as other issues of law and fact are heard and tried in such court, and the ruling or order of the board shall be stayed pending the said appeal.

Sec. 326.53. *Violations and Penalties.*—Subdivision 1. (1) Any violation of the provisions of Sections 326.02 to 326.23 shall be a gross misdemeanor.

(2) Any person violating any of the provisions of Sections 326.33 to 326.36 shall be guilty of a gross misdemeanor; and, upon conviction thereof, fined not to exceed \$100.00 or imprisoned in the county jail for not to exceed three months, or both, for each and every violation thereof.

(3) Every person violating any of the provisions of Sections 326.523 to 326.526, or assisting in such violation, shall, upon conviction thereof, be punished by a fine not exceeding \$1,000, or, in default of the payment of such fine, by imprisonment in the county jail for not more than one year. In the case of a corporation, the violation of these sections shall be deemed to be also that of the individual directors, officers, or agents of such corporation who have assisted in such violation, or who have authorized, ordered, or done the acts or omissions constituting, in whole or in part, such violation; and, upon conviction thereof, any such directors, officers, or agents shall be punished by fine or imprisonment as herein provided.

Subd. 2. (1) Any person violating any of the provisions of Sections 326.37 to 326.45 or who shall wilfully make any false representations to the board of health in applying for a license or permit shall be guilty of a misdemeanor.

(2) Any person violating any of the provisions of Sections 326.46 to 326.52 or who shall wilfully make any false representation to the industrial commission in applying for a license or permit shall be guilty of a misdemeanor.

RULES AND REGULATIONS

Foreword: In adopting and following these rules, the Board recognizes two important requirements it must meet: first, to respect the right to his means of livelihood of the individual who has conscientiously prepared himself to practice the profession of Architecture, Engineering or Land Surveying and, second, to do what is within the power of the Board to protect the Public against dangers arising from attempts of incompetent or unscrupulous persons to practice said profession.

Rule 1

There shall be three classes of Registrants as follows:

- Class 1. Those who were registered without examination prior to July 1, 1933.
- Class 2. Those registered under the reciprocal provisions of the law.
- Class 3. Those registered following examination.

Rule 2

There shall be a classification of Architect-in-Training and Engineer-in-Training.

Rule 3

Application for Registration:

- (a) Before making formal application for examination, the candidate is requested to submit to the Board, by typewritten letter, information relative to place and date of birth, time and place of schools attended and studies completed, whether he graduated or not, degree or degrees received, together with a chronological record of his employment, with all dates and with complete information relative to duties and type of work performed, and particularly outlining the applicant's responsibilities in charge of the whole or any part thereof. This information will be evaluated and if the candidate is found definitely ineligible for examination at that time, he will be so notified and no expense will have been incurred. If he is apparently eligible at the time for examination, he will be so notified and a form will be sent him on which to make his formal application for registration subject to the Rules and Regulations of the Board.
- (b) Applications for registration shall be made on forms prescribed and furnished by the Board and shall be filed with the Secretary-Treasurer of the Board at St. Paul, accompanied by the payment of the examination fee.
- (c) Applications for examination as Architect-in-Training or Engineer-in-Training shall be made on forms prescribed and furnished by the Board and shall be filed with the Secretary-Treasurer of the Board at St. Paul accompanied by the examination fee.
- (d) Application forms will be furnished to individual applicants but will not be furnished in quantities to intermediaries.

Rule 4

Fees:

- (a) Fees shall be paid to the State Board of Registration for Architects, Engineers and Land Surveyors.

- (b) The fee for examination is Ten (\$10.00) Dollars for Architects and Engineers and Five (\$5.00) Dollars for Land Surveyors, which in all instances must accompany applications. Where an applicant is apparently qualified for and requests registration in more than one profession, the examination fee will be Fifteen (\$15.00) Dollars if, in such instances, the appropriate examinations are taken at the same time. If a registrant desires registration in an additional branch of engineering subsequent to original registration, it may be granted if applicant passes the examination for which the fee will be \$10.00. In the event an applicant's examination is not completed within one year next succeeding the date of the application, a new application and examination fee shall be required except when a delay of more than one year is due to circumstances which, in the opinion of the Board, justify a different procedure. These fees will be retained by the Board regardless of the outcome of the examination. The examination fee for Architects or Engineers-in-Training shall be Five (\$5.00) Dollars. This fee shall be credited toward the total examination fee of Ten (\$10.00) Dollars for final registration as an architect or professional engineer.
- (c) The fee for registration in addition to the fees for examination is Ten (\$10.00) Dollars for an Architect or Engineer and Five (\$5.00) Dollars for a Land Surveyor and such payment shall be due when the application has been approved. Payment of this fee must be made prior to the issuance of the certificate of registration.
- (d) In cases where applicants are registered in two or more professions, the fee therefor is Fifteen (\$15.00) Dollars.
- (e) The fee for non-residents who are registered in Minnesota is Ten (\$10.00) Dollars for Architects or Engineers, and Five (\$5.00) Dollars for Land Surveyors. The aggregate fee for registration in two or all of the three professions is Fifteen (\$15.00) Dollars.
- (f) Fees for renewal of registration are due in the month of December of each year in the amount of Three (\$3.00) Dollars for each Architect or Engineer, and One (\$1.00) Dollar for each Land Surveyor. The aggregate fee for renewal in any two or three of the professions is Three (\$3.00) dollars. There is no annual renewal fee during period of applicant's status as Architect-in-Training or Engineer-in-Training. The renewal fees must be paid on or before December 31 of each year, otherwise the name of the Registrant will be deleted from the Roster. The postmark on the envelope containing the remittance will be accepted as the date of payment.
- (g) No fee will be charged for certifying to the qualifications of a Minnesota Registrant who applies for registration in another State. The cost of certified copies or photostats of other documents required by the State in which registration is desired shall be paid by the applicant.
- (h) The fee for renewal of registration after December 31, as fixed by the Act, is Five (\$5.00) Dollars for each Architect or Engineer, and Two (\$2.00) Dollars for each Land Surveyor. The aggregate fee for renewal in any two or three of the professions is Five (\$5.00) Dollars.
- (i) The fee for the issuance of a new certificate to replace one revoked, lost, destroyed or mutilated is One (\$1.00) Dollar.
- (j) It is the duty of the Secretary-Treasurer to notify each registrant by mail of the date of expiration of his registration. Such notice will be sent to the address filed with the Secretary-Treasurer, and failure to receive such notice at such address shall not exempt the registrant from the penalties required by Section 326.10, Minnesota Statutes 1941.

Rule 5

Certification of an applicant's technical qualifications by the National Council of Architectural Registration Boards or the National Bureau of Engineering Registration conducted by the National Council of State Boards of Engineering Examiners may be accepted by the Minnesota Board as establishing such qualifications and the applicant, in such instances, will not be required to pass further examination.

Rule 6

Rejections:

A person whose application for registration has been rejected shall be fully informed as to the reasons for the rejection. A new application, in such instances, may be filed at any time after the lapse of six months next succeeding the date of the previous rejection.

Rule 7

It is necessary for the applicant to convince the Board that he is qualified to practice in the field in which he seeks registration. The burden of proof is upon the applicant and he, therefore, should make every effort to present his qualifications fully and clearly. His qualifications shall be established by one or more of the following methods:

- (a) By passing a written examination. (Required of all architectural applicants and may be required from applicants for registration as Engineers or Land Surveyors.)
- (b) By passing an oral examination and by submitting satisfactory exhibits of his technical qualifications. (Required from Engineer and Land Surveyor applicants.)
- (c) By submitting a record prepared by the National Council of Architectural Registration Boards. (For Architectural applicants only.)
- (d) By submitting a Certificate of Qualification prepared by National Bureau of Engineering Registration. (For Engineering applicants only.)
- (e) Exhibits shall not be submitted until requested by the Board.
- (f) Architects registered by exemption desiring a change of status may apply therefor and his qualifications for such change will be determined by (1) written examination, or (2) by passing an oral examination and submitting satisfactory exhibits of his technical qualifications. (This examination shall apply only to those having ten (10) or more years of independent legal practice as a principal in the profession of Architecture.)
- (g) Written examinations will be given under conditions as nearly as possible like those under which an applicant works in his own office. Handbooks, textbooks, catalogs, and such other printed source of information as may be available will be allowed the candidate for all examinations except those on History of Architecture, Architectural Composition, and Architectural Design. By virtue of the candidate's apparent eligibility to be examined, it is presumed that he is well qualified in the theory of the different branches of architectural, engineering or land surveying practice.
- (h) The Board provides a place for the examinations and furnishes the questions, drafting board, tee square, triangles and tracing paper. The applicant must provide drafting instruments, pencils, codes, handbooks, etc., which may be used in certain sections of the examinations.

- (i) Examinations will be given each year at such times as may be designated by the Board. Persons who file applications for registration and are eligible for examination will be informed by letter of the date of the next examination.

Rule 8

Applicants for registration as an Architect will be examined in the following:

- (a) Qualifications and Preparation for Practice.
- (b) Structural Design and Materials.
- (c) Mechanical Equipment, Counselling and Administration, and Supervision.
- (d) History of Architecture and Architectural Composition, and
- (e) Architectural Design.

Rule 9

If an architectural applicant fails in not more than three sections of the examination, such sections shall be retaken within not less than two months or more than twelve months next succeeding the date of his application and, in any case, examination must be completed within one year next succeeding the date of the application, otherwise a new application and examination fee will be required. If failure in more than three sections of the examination occurs, the application will be considered obsolete and the applicant may file a new application and fee after the lapse of not less than twelve months next succeeding the date of previous failure.

Rule 10

- (a) The Board recognizes for registration under the Act the following divisions of the profession of Engineering, namely, Civil, Mechanical, Electrical, Mining, Chemical, Aeronautical, Highway, Structural, and Naval Architecture.
- (b) Applicants for registration as Engineers are required to submit exhibits of their work when they meet with the Board for the oral examination.
- (c) Mere experience in engineering work must be distinguished from the kind of progressive experience necessary to qualify an applicant for registration. When beginning his experience, an engineer, with or without the benefit of a college education, might be engaged in activities which may or may not qualify him to practice professional engineering under an accepted definition of such practice. It is, therefore, incumbent upon the Board to carefully scrutinize the applicant's record, the progressive nature of the tasks performed, the responsibilities assumed, and his ethical conduct in order to determine whether or not he is qualified to assume the title of Registered Professional Engineer.
In the evaluation by the Board of the experience record submitted in addition to education in a school with an accredited curriculum, responsible charge of important work as a subordinate will be considered as qualifying experience.
- (d) The applicant for registration as a Professional Engineer shall be required to pass an examination in the fundamentals of engineering.
- (e) The examination in practical engineering design and construction given for the purpose of determining proficiency in professional practice will

include questions designed to show the applicant's ability to use his fundamental training and his skill in planning, designing and supervising the construction of engineering projects. The judgment and resourcefulness shown in respect to appropriateness of design for the purpose intended, relative economy, and appearance of the structure designed, will be taken into account in determining the grade.

Rule 11

Registration as a Land Surveyor:

An applicant for registration as a Land Surveyor shall have a thorough knowledge of and pass an examination in the following:

- (a) Fundamental mathematics including square root, logarithms, geometry, algebra and plane trigonometry;
- (b) The history, principles and application of the U. S. system of public land surveys and elementary knowledge of the other systems used in the United States;
- (c) The instructions of the United States Land Office relative to the relocation of lost and obliterated corners and the subdivision of sections;
- (d) The legal essentials of resurveys including those involving disputed boundaries, defective deed descriptions, riparian rights and adverse possession;
- (e) The judicial functions of land surveyors.

Rule 12

CODE OF ETHICS

Technical work based upon the professional practice of Architects, Engineers and Land Surveyors has become an increasingly important factor in the progress of civilization and in the welfare of the community. These professions are held responsible for the planning, construction, and operation of such work, and are entitled to the position and authority which will enable them to discharge this responsibility and to render effective service to humanity.

That the dignity of his chosen profession may be maintained and that his obligation and responsibility to the public be impressed upon the applicant, it is required before registration is granted that each applicant subscribe to and agree to exemplify the following Code of Ethics:

- (a) To maintain interest in the public welfare and be ready to apply his special knowledge, skill, and training for the use and benefit of mankind.
- (b) To refrain from associating himself with, or allowing the use of his name in connection with, any enterprise of questionable character.
- (c) To carry on his professional work in a spirit of fairness to all concerned, fidelity to clients and employers, loyalty to his country, and to be devoted to high ideals of courtesy and personal honor.
- (d) To regard as confidential any information obtained by him as to the business affairs and technical methods or processes of a client or employer.

- (e) To discourage consulting practice by manufacturers and contractors, and endeavor to have all architectural or engineering plans, other documents, surveys and plats signed by the Architect, Engineer, or Land Surveyor directly responsible for them.
- (f) To inform a client or employer of any business connections, interests, or affiliations which might influence his judgment or impair the disinterested quality of his services.
- (g) To accept financial or other compensation for a particular service from one source only.
- (h) To advertise only in a manner supporting the dignity of his profession.
- (i) To refrain from submitting competitive bids for professional services or using other improper or questionable methods of soliciting professional work.
- (j) To avoid using unfair means to win professional advancement or to injure the opportunities of another to secure or retain employment.
- (k) To confine his professional service to the branch or branches in which he is competent to practice.
- (l) To refrain from associating, in a partnership, with a person not professionally qualified, and to refrain from lending his name or seal for the approval of plans or other documents for the preparation of which he was not directly responsible.
- (m) To refrain from using the advantages of a salaried position to compete unfairly with other Architects, Engineers, or Land Surveyors.
- (n) To cooperate freely with architectural and engineering agencies in advancing the architectural and engineering profession.

Rule 13

No person registered under Chapter 523, Laws of Minnesota for 1921, as amended, shall form a partnership with another person or persons to practice the profession of either architecture, engineering, or land surveying unless the person or persons with whom the partnership is formed is registered under said Act in either of the three professions.

Rule 14

No partnership formed to practice architecture, engineering, or land surveying, or all of said professions, shall contract with or accept employment for professional services of an architectural, engineering, or land surveying character as defined by the Act unless a member of the partnership or the employee of the partnership in responsible charge of the work is registered under the Act to practice the profession called for by such employment.

Rule 15

A person in responsible charge of architecture, engineering, or land surveying work as used in the Act is hereby construed to mean the person, or persons, who determines all technical questions of design and policy, advises with the client, superintends the work of subordinates and, in general, the person whose professional skill and judgment are embodied in the plans, designs and advice involved in the work.

Rule 16

It shall be misconduct for any registrant to practice or to offer to practice architecture, engineering, or land surveying unless he be registered as an architect, an engineer, or land surveyor.

Rule 17

It shall be misconduct for a registered professional engineer to practice or offer to practice a branch of engineering in which he is not registered.

Rule 18

It shall be misconduct in the practice of his profession for any registrant to violate the Code of Ethics by Rule 12 prescribed.

Rule 19

Certificate of Registration:

This Board will issue to each successful applicant a Certificate of Registration properly filled out, signed and sealed, giving the Registrant proper authority to practice the profession of Architecture, Engineering, or Land Surveying under the Registration Act of the State of Minnesota for a period ending December 31 of the year Certificate is issued, after which date the Certificate will expire unless renewed.

Rule 20

It is recommended that each registrant upon registration obtain and use a seal of the design approved by the Board, bearing the registrant's name and the legend "Registered Architect," "Registered Professional Engineer" or "Registered Land Surveyor." Plans, specifications, plats, reports or other documents issued by a registrant shall be stamped with his seal during the life of registrant's certificate.
