The **Minnesota Child Welfare Report for 2001** describes the state of children in Minnesota's child protection, outof-home care and adoption systems. This report provides an overview of how children in these systems are faring and presents information about Minnesota's performance on key child welfare indicators requested by the state and federal governments. This is the second year in which Minnesota has used the data collected through the Social Services Information System (SSIS) implemented in the last quarter of 1999, to report maltreatment and out-of-home placement data. Not all historical data from counties was converted to SSIS.

The key findings in this report are as follows:

Maltreatment

- Minnesota assessed 17,798 reports of maltreatment involving 25,692 children in 2001. Of these reports, 3,191 received an Alternative Response assessment, a strengths-based and family focused alternative to working with families in the child protection system where no determination of maltreatment is made. In 6,767 of the 14,607 traditionally assessed reports, maltreatment was determined to have occurred. Neglect accounted for 60 percent of the traditionally assessed reports. More than half of the reports were made to child protection by school personnel and law enforcement. The need for ongoing protective services was identified in half of all determined reports.
- Black/African American and American Indian/ Alaska Native children in the general population were over seven times more likely to be determined victims of maltreatment than were White children.
- Families who neglected children were more likely to experience multiple family issues including substance abuse.
- Just over 10 percent of all determined victims had at least one subsequent determined report of maltreatment within one year. Black/African American children had the highest recurrence rate, 12.9 percent. About 5 percent of all alleged victims were placed in out-of-home care during the child protection assessment. Eighty percent of these children were removed on an emergency basis.

Out-of-Home Care

About 17,600 children were removed from their homes and entered out-of-home care in 2001. More were boys than girls. The majority were adolescents. Black/African American and American Indian/Alaska Native children were represented in out-of-home care at a rate of more than four and seven times their representation in the Minnesota child population.

- Most children (87 percent) were in out-of-home care only once during the year. Additionally, most experienced no moves while in care. Most of the children were placed in a family type setting. About one-third were in care for one week or less. Children under eight spent an average of twelve fewer days in care than the average for all children. In 2000, the difference was four days.
- About 30 percent of the children who entered care in 2001 re-entered care one or more times within the year. There are no major differences in the re-entry status of the children by race. The most frequent reasons cited for entering care were related to the behavior of the child. Over 80 percent of the children left care to return home to a parent, primary caretaker or other relative.

Out-of-Home Care by Reasons for Entry

Different outcomes were observed for children when reasons for entering care were grouped into four categories: parent reasons, child reasons, child disabilities or two or more of these reasons.

- Slightly less than 50 percent of children entered care for reasons related to their parents. More Black/African American children and children belonging to two or more race groups entered care for parent-related reasons, had a longer out-of-home placement duration and were less likely to re-enter care. Almost all races had larger proportion of children in care due to reasons related to their own behavior, they were predominantly adolescents, they had shorter placement duration and they re-entered care more frequently. White children were the only exception, entering care almost equally for both parent related reasons and for reasons related to their own behavior.
- Children with disabilities stayed in care the longest, an average of little less than two years. The number of days they stayed in care declined by more than 150 days from 822 in 2000 to 660 in 2001.

Adoptions

- The largest group of children (50 percent) adopted under state guardianship were under age 6. Of these, slightly more were boys than girls.
- The average number of days in care, from the time they were available for adoption to the date of adoption, has decreased by 118 days since 1998.
- A child of color was nearly seven times more likely than a White child to be under state guardianship in 2001. Children of color were adopted at a lower rate than White children.
- Most siblings were adopted together.

Introduction

The report has five major sections. Each section begins with At A Glance that highlights key information. Tables, charts and graphs that support the report's findings complete each section. More detailed data are available in the Appendix of the report.

The first section, "Child Maltreatment Reports," covers information about alleged and determined reports of maltreatment

The second section, "Out-of-Home Care," gives overall statistics on children in out-of-home care.

The third section, "Out-of-Home Care: Category of Reasons for Entry," groups the reasons that children entered out-of-home care into four categories: parent reasons, child reasons, child disabilities and situations involving two or more of these reasons.

The fourth section, "Adoptions," provides information from the Adoptions Data System about children under state guardianship. It looks at disparities in race of children awaiting adoption and of those adopted, the number of children adopted, the adoption of sibling groups, and the length of time from when the children became eligible for adoption to finalized adoption.

The fifth section, "Performance Measures: Outcomes and Indicators," reports on how the state and counties are performing on established child welfare outcomes and indicators both at the federal and state level.

The last section of the report displays data by county.

This report is written in response to a legislative directive. Minnesota Statutes, section 257.0725 states: The commissioner of human services shall publish an annual report on children in out-of-home placement. The report shall include information by county and statewide on the legal status, living arrangement, age, sex, race, accumulated length of time in placement, reason for most recent placement, race of family with whom placed, and other information deemed appropriate on all children in out-of-home placement. Out-of-home placement includes placement in any facility by an authorized child placement agency.

Child Maltreatment Reports

The data in this section describe alleged and determined incidents of child maltreatment assessed in Minnesota in 2001. Specifically, the data show the number of maltreatment reports; the number of child victims; the types and severity of maltreatment; what services were recommended and what actions were taken. It also looks at other information such as the age and race/ethnicity of victims and their relationship to offenders.

Unless otherwise specified, children were counted as victims each time they were the victim of maltreatment in the year 2001. In other words, any individual child could have been counted as a victim multiple times. However, if the counts were specified as "unique," child victims were only counted once no matter how many times they were victimized in the year.

The 2000 census changed the way we report race and ethnicity data. Individuals may indicate they belong to more than one race. They may also be "Hispanic." This report organizes data in the same way as the census. For example, children may be counted in their racial group or as having more than one race. They may also claim Hispanic ethnicity.

Anyone can and should report a suspected incident of child maltreatment. Some professionals, such as those working directly with children, are **mandated reporters** and must report to local child protective services if they observe or receive information about an abuse and/or neglect incident. **Non-mandated reporters** voluntarily provide information of known or suspected child maltreatment to the local child protective services. Reports typically include information about the source of the report and the nature of the alleged maltreatment. Once a report of maltreatment is made, a screener reviews the initial information about a case to decide whether or not the report meets the statutory criteria for further assessment. If it does, the agency may decide whether to conduct an assessment in the traditional way or to assess it using an Alternative Response.

In a **traditional assessment**, a county child protection worker interviews persons involved with the report, including family members. If there is a preponderance of evidence that a child has been a victim of maltreatment and the harm was caused by an act, or failure to act, by a person responsible for the child's care, the county child protection worker makes a **determination** that maltreatment has occurred. In some cases, statutory authority is given to counties to use an **Alternative Response assessment**. In these situations, a county worker meets with all family members together to discuss and assess child safety concerns and review the family's strengths and needs. In an Alternative Response assessment no determination of maltreatment is made.

Child Maltreatment: Reports and Victims

AT A GLANCE

- Minnesota counties determined that child maltreatment occurred in 6,767 reports of maltreatment in 2001 and 9,876 victims were associated with those reports. The unique number of Minnesota children who were victimized was 9,316.
- Determinations of maltreatment and the number of child victims increased by 4 percent from 1998 to 2001.
- Minnesota counties assessed 17,798 cases of maltreatment. Of these, 3,191 received an Alternative Response assessment. Over half (60 percent) of alleged reports were for neglect. Allegations of physical abuse were the next highest category at 38 percent.
- Mandated reporters made over 75 percent of the alleged reports. Over 50 percent of all reports came from school personnel, law enforcement and courts.

Figure 1 shows the number of alleged and determined child maltreatment reports and victims by the type of assessment. Some children were assessed more than one time in the year. The "unique victims" column counts them only once. At the start of 2001, the Alternative Response program was being used in 20 counties; seven additional counties implemented Alternative Response during the year. Statewide approximately 18 percent of families were assessed through Alternative Response. No determination of maltreatment is made as part of the Alternative Response assessment. In 46 percent of cases assessed through a traditional approach, maltreatment was determined to have occurred. In the facilities investigated by counties, about 28 percent resulted in a determination of maltreatment.

Figure 2 shows the number of alleged and determined reports of child maltreatment between 1997 and 2001. For the years 1999, 2000 and 2001 Alternative Response reports are identified separately. Because the Alternative Response assessment does not result in a determination of maltreatment, the numbers of determined reports reflect only those made by traditional assessments. The figure shows a dramatic decrease in the number of alleged and determined reports as the number of those reports diverted to Alternative Response increases. The rate of maltreatment determination grew from 42 percent in 1998 to 46 percent in 2001. This increased rate is due, in part, to the gradual use of Alternative Response assessments. Those cases that are traditionally assessed tend to be higher risk and more likely to receive a determination of maltreatment.

Figure 2 - Reports of Alleged and Determined Child Maltreatment 1997-2001




Figure 3 shows the number of alleged victims for 2000 and 2001 and the number of child victims for whom maltreatment was determined between 1997 and 2001. Prior to 2000, comparisons of alleged victims are not possible for this report due to the implementation of the new Social Services Information System and differences in data reporting.

Figure 4. In 2001, neglect accounted for the majority (around 60 percent) of alleged reports. Physical abuse accounted for about 38 percent, sexual abuse for 13 percent and mental injury for less than 1 percent of the reports. Of the four maltreatment types, neglect had the highest determination rate (51 percent) followed by sexual abuse (43 percent), physical abuse (35 percent) and mental injury (30 percent).

Figure 4 - Alleged and Determined Reports by Maltreatment Type




Figure 5 - Source of Alleged Maltreatment Reports

Figure 5 identifies the specific sources of maltreatment reports. Nearly fifty percent of alleged reports came from law enforcement/courts or school personnel. Mandated reporters made over 75 percent of the reports of maltreatment to the local child welfare agencies.

Demographics of Child Victims

AT A GLANCE

- Younger children were more likely to be victims of neglect. Older children were more likely to be victims of physical abuse.
- Black/African American and American Indian/Alaska Native children continued to be significantly over represented in the child protection system. The incidence for all races statewide of child maltreatment was about seven cases per 1,000, compared to over 30 per 1,000 for both Black/African American and American Indian/Alaska Native children.
- The majority (74 percent) of offenders were the victims' birth parent(s).




Figure 6 - Determined Victim Age by Maltreatment Type

Figure 6 graphs the percent of child victims by maltreatment type and age of the child. The data show that younger children were more likely to be victims of neglect and teenagers were more likely to be victims of physical or sexual abuse. Children ages 6-11 were victims of physical abuse, sexual abuse and neglect in almost equal proportion. Note: A child may be the victim of more than one type of maltreatment.




Figure 8 - Race or Ethnicity of Alleged and Determined Victims in Relation to the Minnesota Population of that Race or Ethnicity

The reporting of race in Figures 7 and 8 reflect the new definitions of race adopted by the U.S. Census Department for 2000. In this table, victims per 1,000 were calculated by dividing the number of determined victims for each race by the 2000 census child population for that race then multiplying by 1,000. The data reveal that, in the total Minnesota child population, 7.2 children per 1,000 were victims of child maltreatment in 2001. Black/African American and American Indian/Alaska Native children were significantly over represented as victims of child maltreatment, 35.4 per 1,000 and 33.1 per 1,000 respectively. In other words, Black/African American children and American Indian/Alaska Native children in Minnesota were both about seven times more likely to be determined victims of maltreatment than were White children.

Figure 7 - Determined Victims by Race or Ethnicity

Demographics of Child Victims continued

Figure 9 shows the relationship between the victims and the offenders of determined maltreatment. Birth parents accounted for 74 percent of all offenders. They were responsible in 84 percent of neglect and 63 percent of physical abuse determinations. Extended family members (28 percent), birth parents (16 percent) and siblings (12 percent) were the most frequent sexual abuse offenders. Most negelct offenders were women and most sexual abuse offenders were men. About the same percent of men and women were physical abuse offenders.

Child Protection Assessment

AT A GLANCE

- Most victims were determined to have been "exposed to threatening or dangerous conditions" by the assessment worker.
- Families who neglected children were more likely to experience multiple family issues, including substance abuse and poverty.
- Individual and family counseling, child protection case management, parenting education, chemical dependency services and out-of-home placement were the most frequently recommended services to these families.
- The need for protective services was identified in half of all determined reports.

Figure 10 describes the severity of determined allegations by type of maltreatment. Most victims were determined to have been exposed to threatening or dangerous conditions. There were 16 determinations of death as a result of maltreatment in 2001.




Figure 11 - Prevalence of Family Conditions by Determined Maltreatment Type

Figure 11 graphs the prevalence of family conditions identified by the social worker during the assessment. With the exception of domestic violence, the identification of all other family problems was greater in neglecting families than in families with other maltreatment issues. Physically abusing families had a slightly higher apparent incidence of domestic violence than did neglecting families. Moreover, drug abuse appeared to be more than three times greater in neglecting families than in physically abusing and sexually abusing families. It is noteworthy that during the assessment, none of the family conditions were observed in 65 percent of sexually abusing families and in 43 percent of physically abusing families.






Figure 12 illustrates the types of services recommended by determined maltreatment type. At the end of each child maltreatment assessment, the social worker identifies necessary or potentially helpful services for the families. This is not an indication that the families actually received the services.




Figure 13 - Need for CPS by Maltreatment Determination

Figure 13 shows that the majority of alleged maltreatment reports were closed after the child protection assessment. The need for protective services was identified in 3,430 of the 6,767 (51 percent) of determined reports. About 11 percent of reports that did not receive a determination were identified as needing protective services.

Maltreatment Recurrence and Out-of-Home Placements

AT A GLANCE

- For all determined victims, 10.1 percent had at least one subsequent determined report of maltreatment within one year. Black/African American children had the highest recurrence rate – 12.9 percent.
- Just under 5 percent of alleged victims were placed out of the home during the child protection assessment. Eighty percent of removals were done on an emergency basis.
- The most frequent reasons cited for children entering care was neglect, followed by physical abuse and parental drug abuse.

Figure 14a reports that for all determined victims between January 1, 2001 and June 30, 2001 6.3 percent and 10.1 percent had a subsequent determined report of maltreament within six and 12 months, respectively. Black/ African American children had the highest rated of recurrence over a twelve month period with, 12.9 percent of determined victims identified as having experienced further maltreatment. A child is more likely to be re-reported within six months. This is likely due to Child Protective Services monitoring of the family or a heightened awareness of ongoing maltreatment by other reporters.




Figure 15 - Reasons for Out-of-Home Placement of Alleged Victims During the Maltreatment Assessment




Figure 16 - Emergency and Non-emergency Placements by Setting

Figures 15 and 16 describe the reasons victims were removed from home during the child protection assessment, as well as the setting in which they were placed. For the assessments concluded during 2001, 973 unique children were removed from their homes. Of these, 777 children or 80 percent were initially removed on an emergency basis. Emergency placement refers to the crisis placement of a child who is found to be at immediate risk of serious harm if remaining under parental/guardian care or for whom parental/guardian care is not available. Most placements ended with the child reunifying with the parents or primary caretaker (78 percent), or living with other relatives or a transfer of legal custody to a relative (11 percent). Eight percent of the children placed remained in placement as of July 1, 2002.

Note that the sum of placements does not equal the number of children placed, as some children were placed more than once or experienced multiple placement settings.

This section reports on the status of the children who were in out-of-home placement at any time in 2001.

Children are counted in the total number of out-of-home placements if they entered care in 2001 or if they entered care prior to 2001 and continued in care in 2001. Some left care in 2001 while others remained in care beyond 2001. A small percent of these children entered and left care multiple times.

In this report, unless otherwise specified, children were counted each time they were in care throughout the year. A small number of tables reflect a unique child count where the children were counted only once regardless of how many times they were in care.

A placement is defined as the period of time from when the child was first removed from home until the time the child left care. A child may experience many moves within a placement. For example, once a child is removed from home, he may be put into a temporary emergency setting and then moved to a long-term foster home setting. For the purposes of this report, each move is counted even if the child is moving to the same type of setting, e.g., one foster home to another foster home during a continuous placement. The 1998 Legislature authorized (Laws of Minnesota, chapter 406, section 2) the establishment of the Concurrent Permanency Planning Program (CPP) to facilitate placing children in permanent settings. The program aims to reduce the time children spend in out-of-home care through the achievement of permanency goals. This is accomplished by the simultaneous planning for two possible outcomes: the child's safe return home and the child's move to a new legal family. This preparation is necessary in case reunification with parents is not possible then an alternative plan for a new permanent home is immediately available.

AT A GLANCE

About 17,600 children were removed from their homes and placed in out-of-home care. These are unique counts of children. This figure is slightly lower than the approximately 18,400, which has been relatively stable the last five years.

Figure 17 reports that in 2001, 17,587 children experienced 20,635 placements in out-of-home care. These are unique counts of children. About 400 more children left care than entered care in 2001.

The number of children in out-of-home care is 4.7 percent lower than the previous year.

Out-of-Home Placement: Demographics

AT A GLANCE

- More boys than girls spent time in out-of-home placement.
- The majority of the children were adolescents.
- The majority of children in out-of-home care were White.
- Relative to their proportions in the child populations, Black/African American and American Indian/Alaska Native children continued to be over represented in out-of-home care.





Figure 18 - Gender of Children in Out-of-Home Placements

Figure 18 indicates that more boys (56 percent) experienced out-of-home care in 2001 than did girls (44 percent). This trend has remained aboutthe same since 1997.




Figure 20 shows the percent of children in three age groups (0-7 years, 8-12 years and 13 years and older). Over half (58 percent) of the children in out-of-home placement were adolescents. The median age continued to be between 13 and 14 years in 2001. Figure 21 shows the number of children in out-of-home placement by race. Although White children made up the largest number of children in care, the proportion of Black/African American and American Indian/Alaska Native children in care was about four and seven times their representation in the Minnesota child population. White and Asian children were under represented in out-of-home placements compared to their proportion in the child population.

Children with Hispanic ethnicity can be of any race and were represented in out-of-home placements similarly to their proportion in the Minnesota child population.

Number of Placements, Duration and Moves

AT A GLANCE

- The greatest percentage of children in out-of-home care (87 percent) experienced only one placement in 2001.
- All children with seven or more placements within the year entered care for reasons related to the child's behavior.
- Over half of the children in placement experienced only one placement setting while in placement.
- Over half of the children in care spent some time in a non-relative foster care setting.
- Over 70 percent of the days that children spent in care were in some type of family setting.
- About one-third of the children who left care in 2001 spent one week or less in placement.
- About 16 percent of all the children in care in 2001 spent one week or less in placement.
- Children under age 8 who entered care in 2001 on average spent slightly less time in placement compared to older children.



Comparing Figures 24 and 25 it is interesting to note that while 28 percent of the children were placed in residential/institutional settings at some point during the year, only 18 percent of the days were in those settings. Figure 26 describes the duration of placements that ended in 2001. Note that some of these placements began prior to 2001; thus some of them may have been in placement longer than 365 days. About one-third of these placements were one week or less and 17 percent were more than one year. The average number of days per placement was 240.

Figure 27 describes the number of days children spent in care within the calendar year. About 25 percent of the children spent 30 days or less in care and slightly over 40 percent spent at least half of the year in care. The average number of days in care in the calendar year was 169.

Figure 28 shows the number of days in care for children under age 8 whose families participated in Concurrent Permanency Planning. Consistent with Figure 27, about a quarter of the children spent 30 days or less in care and about 40 percent spent at least half of the year in care. The average number of days in care for these children was 158, slightly less than the average for children of all ages, 169 days. This average decreased from 166 days to 158 days between 2000 and 2001.

Re-entry into Placement and Reasons for Placements and Reasons for Discharge

AT A GLANCE

- About 30 percent of children who entered care in 2001 had been in care one or more times within the previous 12 months.
- The re-entry rate by race is between 28 and 32 percent. These figures were slightly different in 2000, 26 and 33 percent.
- The most frequent reason cited for children entering care was child behavior.
- Parental neglect was the second most frequent reason cited for children entering care.
- Most children, about 80 percent, left care to return home to a parent, primary caretaker or other relative.

Figure 29 presents the out-of-home re-entry rate for all children who entered care, by race and ethnicity. Re-entry means that a child was in placement in 2001 and was also in a prior placement within 12 months of the 2001 placement

The reasons why children enter care influence the paths children take while in care, as well as what happens to them when they leave care. This section examines where children were placed when they entered care, how long they spent in placement, their reunification rate and their re-entry rate within the year.

For the purposes of this section, the 15 reasons for entry have been divided into four categories.

- Reasons related to parents include physical abuse, sexual abuse, neglect, parental substance abuse, death or abandonment by a parent, parental illness, disability, inability to cope, incarceration or relinquishment of parental rights.
- Reasons related to children include a child's behavior, delinquency, status offenses and child substance abuse.
- Reasons related to a child's disability include children who are developmentally disabled or who have a diagnosis of serious emotional disturbance.
- Two or more of the above categories.

The demographics of children with disabilities who enter care seem to be representative of the general child population in Minnesota. The demographics of children who enter care for more than one reason look similar to the Minnesota child welfare population.

AT A GLANCE

- When reasons for entry are grouped into four categories: parent reasons, child reasons, child disability reasons or two or more of these categories, nearly 50 percent of children entered care for parent reasons.
- White children were more likely to enter care for parent reasons and reasons related to their own behavior, while Black/African American and American Indian/Alaska Native children were more likely to enter care for reasons related to their parents' behavior.
- Children who entered care for parent or child disability reasons were most often placed in non-relative family foster homes.
- Children who entered care for reasons related to the child's disability stayed in care the longest, an average of a little less than two years and the number of days they stayed in care declined.
- Children who entered care for child behavior reasons were most often placed in residential treatment facilities or institutions.
- Children who entered care for reasons related to their own behavior were twice as likely to reenter care than were children who entered care for reasons related to their parents' behavior.
- Children who entered care for reasons related to parent behavior stayed in care an average of nearly one year.
- Regardless of the reasons for entry, most children left care to live with their parent(s) or primary caretaker.




Figure 32 - Reasons for Entry by Category for Children in Out-of-Home Care

Figure 32 reports on the reasons why children entered care. It shows four categories of reasons: parent behavior, child behavior, child disability and two or more of these reasons. When reasons for entry were grouped together, most children entered care for parentrelated reasons, as compared to figure 30 where child behavior is the single reason most often cited for children's entry into care.

Figure 33 illustrates the distribution of children who entered care by race, according to the four categories of reasons for entry. White children entered care for parent reasons and reasons related to child behavior equally while the majority of Black/African American children entered care for reasons related to parents. Black/African American children are three times more likely to enter care for parent reasons than child reasons. More than twice as many American Indian/Alaska Native children entered care for reasons related to parent behavior than for reasons related to child behavior.




Figure 35 - Average Length of Stay Per Placement by Category of Reason

Figure 35 displays the duration of placements for all children who left care by category of reasons for entry. Note that some placements began prior to 2001 and thus the length of time in care for some children exceeded 365 days. Children who entered care for child disability reasons stayed in care on average the longest, a little less than two years. The average number of days in care declined by 162 days, from 822 in 2000 to 660 in 2001. Children who entered care for reasons related to parents stayed in care, on an average, less than a year.

Figure 36 reports where children went when they were discharged from care by the four categories of reasons for entry. Regardless of the reason for entry, reunification was the most common outcome for children. Children who entered care for child behavior reasons were most likely to be reunified with parents/primary caretakers. Children with disabilities were the least likely to be reunified with parents/primary caretakers.

Figure 37 reports the re-entry rate for children in care by the four categories of reasons for entry. Re-entry means that a child who had a placement in 2001 was also in a prior placement within 12 months. Children who entered care for reasons related to parent behavior were the least likely to re-enter care. However, these children also stayed in care longer on average and thus had less opportunity to re-enter care (see figure 35). Children who entered care for reasons related to child behavior or for multiple reasons had shorter placement stays but were more than two times as likely to have had a prior placement than children who entered for parent related reasons.

Adoptions

This section describes the number of children under state guardianship who were adopted. The information features their age, racial and ethnic identity and gender. It also reports on:

- The length of time from the date when a child became available for adoption, as defined by a court order, to the time of actual adoption
- The percent of sibling groups adopted together
- The racial disparity of children under state guardianship, who were adopted in 2001.

This section features data from the Minnesota Department of Human Services' Adoption Information System that includes data from court and county documents. At the time of their adoption, all children described in this section were under state guardianship. A child is under state guardianship when a court orders termination of parental rights and the Commissioner of the Department of Human Services assumes legal guardianship for the child's placement, health and welfare.

AT A GLANCE

- Fifty percent of the children adopted, who were under state guardianship, were under the age of 6, and 90 percent were under the age of 12.
- Slightly more boys were adopted than girls.
- The average number of days in care from the date available for adoption to the date of adoption decreased by 118 days since 1998.
- Children of color were nearly seven times more likely than White children to be under the guardianship of the Commissioner of Human Services and were adopted at a lower rate than White children.
- Most siblings (94 percent) were adopted together.

In 2001, 538 children under state guardianship were adopted. Figures 38 and 39 report the age group of these children at the time they were adopted. Fifty percent of the children adopted were under age 6 and over 90 percent were 11 and younger.



Figure 41 shows the number of children adopted in 2001 by race, the incidence of adoption per 1,000 children in the Minnesota child population, and the ratio of adoptions of children of color to White children. For example, in 2001 there were 27 American Indian/Alaska Native children adopted. According to the 2000 census, there were 20,607 American Indian/Alaska Natives under 18 in Minnesota. The incidence of adoption equals 1.3 per 1,000 American Indian/ Alaska Native children in the Minnesota population. In comparison, there were .28 White children per 1,000 adopted. Therefore the ratio of the incidence of adoption of American Indians and Alaska Natives to White children was 4.7. In other words. American Indian/Alaska Native children were almost five times more likely to be adopted than White children, relative to their proportion in the population.

Figure 42 compares the race of the 1,680 children under the guardianship of the Commissioner of Human Services as of January 1, 2001 and those adopted during the year. A child of color was nearly seven times more likely, than a White child, to be under guardianship in 2001. The figures also show children of color are adopted at a lower rate than White children.

Figure 43 - Days from Date of Authority for Placement to Adoption



Of the 538 children adopted 317 (59 percent) were part of a sibling group. Of the 317 children in sibling groups, 280 (88 percent) had their sibling group preserved in its entirety when they were adopted. Of the remaining 37 children in sibling groups, 19 were adopted with at least one brother or sister.

In 1998, Minnesota counties began to use performance indicators to measure how well the state's child welfare system was protecting children at risk of abuse and neglect and how well the system was providing permanent homes for children. This section of the report provides county specific baseline data on both federal and state indicators. Establishing baseline data serves as a starting point from which future performance can be measured. The focus of these indicators is primarily on the recurrence in the child protection system and on re-entry in the out-of-home placement system. Additional indicators identified as useful to measure the state's performance will be published in future reports.

This section reports statewide data for five federal indicators on safety and permanency and statewide data for two state indicators on safety and permanency.
