**SUBJECT:** *Notice of Reductions Pursuant to M.S. 16A.152, Subd. 4*

The purpose of this letter is to officially notify you, pursuant to M.S. 16A.152, Subd. 4, of the reductions made to balance the state's general fund budget for Fiscal Year 2003. The November 2002 forecast projected a deficit in the current fiscal year of \$355,540,000.

After receiving approval of the Governor, I have released \$23,900,000 from the state's budget reserve account reducing the deficit to \$331,640,000.

With further approval of the Governor, and after consultation with the Legislative Advisory Committee on February 7, 2003, I directed the reduction of \$273,452,000 in unexpended allotments of prior transfers and appropriations from the general fund. The attachments specify the amounts of the reductions, and the agencies and programs affected. One of the documents is in a format similar to the one originally released. The other two documents provide additional detail.

These reductions, along with \$50,000,000 in savings from administrative action by the Department of Revenue to delay payment of refunds of sales taxes on capital equipment and the voluntary cancellations of \$8,188,000 from the courts and the legislature, will balance revenue and expenditures for the biennium based on the November 2002 forecast.
