SECONDAMENDMENT TO PROFESSIONAL AND TECHNICAL SERVICES CONTRACT WITH NAVIS GROUP, LLC.

Recitals

This amendment is by and between the State of Minnesota, acting through its Legislative Coordinating Commission on behalf of the Electronic Real Estate Recording Task Force ("State") and Navis Group, LLC ("Contractor"), 7665 Commerce Way, Suite 101, Eden Prairie, MN 55344.

Recitals

- 1. The State has a contract with the Contractor identified as the contract dated February 4, 2003 and amended July 31, 2003.
- 2. The contract is being amended to provide for additional work as required by the Task Force.
- 3. The State and the Contractor hereby amend the contract as stated below.

REVISION 1. "Contractor's Duties." On Page 3, after Phase II, items 1-5, add paragraphs as follows:

2.2.1. Identified Improvements to ERERTF Schema Standards

Proposed changes have been identified for the version 3.0 ERERTF schema in use at pilot counties. These proposed changes will make it easier for existing and new counties and vendors to implement e-recording. The Task Force concludes that the easier the schemas are to work with, the faster public and private entities will adopt e-recording. Because the changes we have identified deal with schema design, they are global and they affect every electronic recording document.

Multiple Platform Portability

Version 3.0 of the Standard XML Schema is compatible with Microsoft platforms. In order to make the schema compatible with other platforms such as UNIX and Linux, stricter validation rules should be applied. Work to be completed by the contractor will allow for multiple platform use reflected in changes such as addressing case sensitive issues in the schema code.

Object Oriented Approach

Version 3.0 of the Standard XML Schema contains instances of Elements that mean different things in different places. In an object-oriented approach, elements should remain consistent throughout an XML document. Work will be completed by the contractor that will incorporate an object-oriented approach to all relevant elements in the schema.

2.2.1.1. Project Plan, Deliverables and Approach

Contractor will develop a project plan for schema review and update work. This plan will include the following elements:

- Detailed report of schema issues and update needs including portability issues and specific data and elements to be updated.
- Approval by ERERTF of identified work.
- Detail breakdown of work to accomplish changes for Phase I and Phase II documents.
- Approval by ERERTF of completed work.
- Change control document and updated schema version 4.0.

The project plan must include dates, timelines, milestones, and must be submitted to the Project Coordinator for review and approval within ten business days of execution of this amendment.

2.2.1.4 Change Control Report for v4.0 Presented to the ERERTF

Tasks: Contractor will create a version control report based on the updated schema code v4.0 generated from v3.0.

Deliverables: Change control report will be presented to the task force upon completion of updates.

The parties estimate that these reviews and the submission of version 4.0 will be conducted and completed by December 31, 2003.

REVISION 2. Page 3, paragraph 5.1 (A) "Compensation" is amended as follows:

(A) Compensation. Compensation for this work is \$20,500

REVISION 4. Paragraph 5.1. (C) "Total Obligation" is amended as follows:

(C) Total Obligation. The total obligation of the State for all compensation and reimbursements to the Contractor under this contract will not exceed \$118,500

REVISION 5. Attachment A is amended to add the following table as follows:
