

#### Dear Colleague:

We are very happy to provide you with a copy of the "Minnesota Hospital Patient Origin Study: Where State Residents Received Acute Hospital Care in 2000." The availability and geographical distribution of Minnesota's hospital resources are an important public health consideration in times of naturally emerging infectious diseases, threats of terrorism, and the aging of the Post World War II Baby Boom generation. Patient origin studies are a useful way to describe where valuable hospital infrastructure is located and which populations are using it. Knowledge of where a geographically defined population is typically hospitalized, and for what services, is the first step in informing policy makers as to whether the state as a whole, or designated areas within it, has needed health care resources in places where population is expected to grow over the next thirty years. Such a statewide report examining historical geographic patterns of hospital utilization by county has not been publicly available since 1980.

This report was made possible by 116 out of the 138 general acute care hospitals operating in the state during calendar year 2000, voluntarily sharing a subset of the information contained on their health insurance claims with the Minnesota Department of Health (MDH). The Health Economics Program at MDH conducted the analysis contained in this report. The report contains information for each county in Minnesota, detailing where county residents received care and from where patients cared for by all the hospitals located in a county originated. Also included is basic information on the demographic and insurance characteristics of each county.

Again, we are pleased to provide you with this report, and hope you find the information contained in the report to be valuable.

# Introduction

The availability and geographical distribution of Minnesota's hospital resources are an important public health consideration in times of terrorism, naturally emerging infectious diseases, and the aging of the Post World War II Baby Boom generation. Patient origin studies are a useful way to describe where valuable hospital infrastructure is located and which populations are using it. Knowledge of where a geographically defined population is typically hospitalized, and for what services, is the first step in informing policy makers as to whether the state as a whole, or designated areas within it, has needed health care resources in places where population is expected to grow over the next thirty years. This is of particular interest in Greater Minnesota where residents often travel longer distances to obtain hospital care and where population growth is anticipated as the Baby Boom generation retires to different areas of the state. Such a statewide report examining historical geographic patterns of hospital utilization by county has not been publicly available since 1980.

This report was made possible by 116 out of the 138 general acute care hospitals<sup>1</sup> operating in the state during calendar year 2000, voluntarily sharing a subset of the information contained on their health insurance claims with the Minnesota Department of Health (MDH). The data were collected by the Minnesota Hospital Association (MHA) and did not contain patients' names, mailing addresses, Social Security Numbers, insurance numbers or other means of personal identification. Postal Zip Code of residence was retained in order to assign each record to a specific, geographically defined population (county or state) for analysis. See Appendix A for details of the data collection process, data preparation, and other data-related issues.

Based upon the shared information, MDH found that during 2000:

- Sixty percent of hospitalizations in Minnesota were at facilities located within the same county as where the patient lived;
- Thirty-five percent of patients were discharged from hospitals located in a county other than where they lived;
- Eighty-two percent of all Minnesota-resident discharges were from hospital located in urban counties, while 18% were from hospitals located in rural counties.

- Urban Minnesota residents accounted for 73% of hospital discharges and rural state residents comprised 27% of all discharges.
- The hospitals located in each urban metropolitan area<sup>2</sup> discharging the largest volumes of patients were:
  - <u>Minneapolis/St. Paul/Bloomington Metropolitan Area:</u>
    - Abbott Northwestern Hospital 7.2% of all discharges;
    - Fairview University Medical Center 6.8% total discharges;
  - <u>Rochester Metropolitan Area:</u>
    - Saint Marys Hospital 5.3% of all discharges<sup>3</sup>;
  - <u>St. Cloud Metropolitan Area:</u>
    - St. Cloud Hospital 4.1% of total discharges;
  - o <u>Duluth Metropolitan Area</u>:
    - St. Mary's Medical Center –3.4% of total discharges.
- The rural hospitals<sup>4</sup> discharging the largest volumes of patients during 2000 were:
  - Immanual-St. Joseph's Hospital, Mankato 1.7% of all discharges;
  - St. Joseph's Medical Center, Brainerd 1.4% of total discharges;
  - Rice Memorial Hospital, Willmar and North Country Regional Hospital, Bemidji each 1% of total discharges.

• Sixty five percent of patients living in rural counties were discharged from hospitals located in rural counties, while 35% of rural residents were discharged from hospitals located in urban counties.

• Hospitals in Hennepin County cared for 33% of all discharges in the state; hospitals in Ramsey County 16.5%; hospitals in St. Louis County 7.5%; and those in Olmsted County 6.6%.

• Five percent of patients discharged from Minnesota hospitals originated from out-of-state, excluding the Mayo Clinic hospitals, Saint Marys and Rochester Methodist.<sup>5</sup>

• Of the patients originating from out-of-state, 30% discharged were from hospitals in Hennepin County; 27% from St. Louis County hospitals; and Ramsey County hospitals 19%.<sup>6</sup>

• Wisconsin residents were the major source of out-of-state discharges in the state (3% of all discharges), followed by North Dakota, Iowa, and South Dakota (less than 1% collectively).

### Why Is This Important?

In considering whether enough hospital resources will be available in the state as the Baby Boomer retire or to handle an infectious outbreak, it's important to estimate what the current rate of hospital use is for various geographically defined populations. Adjustments to these estimates are needed, however, to account for the use of out-of-area providers by local residents (outflow) and the use of local providers by out-of-area residents (inflow). An example of an *outflow* is a Twin Cities resident seeking care at the Mayo Clinic in Rochester instead of using a local metro facility. A patient living in Bagley and traveling to Bemidji for orthopedic surgery is an example of an *inflow* into Beltrami County to the community of providers located there.

Knowledge of these patterns is crucial for hospital bed need assessment because, oftentimes, the supposed need for local care delivery resources assumes that all local residents use local providers exclusively. Patient origin studies typically show that such assumptions are unrealistic due to the outflow and inflow to or from other areas. Information about why patients travel for hospital care is essential to understanding the dynamics of today's health care delivery system. Flows of patients can be affected by a number of factors, including insurer contracting practices and the availability of certain services

Proximity of specialty care is another reason for such travel. For example, while many residents of Wisconsin and Iowa come to Minnesota for care in Duluth, the Twin Cities, or at Mayo Clinic, it is also true that the residents of many western Minnesota communities travel to North Dakota or South Dakota for their hospital stays, because their local physicians are affiliated with the large care systems operating from those neighboring states. It is also common for rural residents to travel to Duluth, St. Cloud, Rochester, or the Twin Cities for specialty hospital services because not all specialty services are available at local hospitals. Patient origin studies are very useful in documenting these health service utilization patterns and developing an understanding of why they occur. Evaluation of these *flows* provides a means for estimating the actual rates at which local resident populations use local providers. Such estimates facilitate evaluations of the fit of a population's health services needs with the services actually available.

### Organization of Report

Following this descriptive section, three patient origin summary tables are presented for each county in Minnesota. The first table shows where county residents typically received their hospital care in 2000, listing, in descending order, only those facilities caring for the largest volumes of county residents. For example, some counties' residents tend to be hospitalized at facilities spread across a region, while others were concentrated at a few facilities located within the county where they lived. These tables also provide a measure of local resident outflow for care to providers in other counties. Given that at the end of 2000, there were seven counties with no hospitals located within them, it is useful to see where residents of those counties obtained their hospital care.

Since hospitals represent a significant component of a county's health care infrastructure and economic base, the second table shows where patients cared for by all the hospitals located in a county originated. For example, the analysis found that nearly two-thirds of patients discharged from all the hospitals located in Hennepin County lived there. The remaining one-third of patients originated from many other counties in Minnesota and several other states as well, a measure of inflow into Hennepin county for hospital care.

The third table presents demographic information about each county, including the size of the population and the proportion of it that was 65 years old and over in 2000. Also shown are the proportions of county residents without health care insurance, those covered by Medicare, state public programs, or private insurance.

Appendix A describes the data used for this report. It details how the data were collected and prepared, plus provides an estimate of the level of under-reporting due some hospitals choosing not to participate in the report. Appendix A concludes with a listing of report terms, abbreviations, and confidentiality considerations.

Appendix B lists all hospitals in Minnesota,<sup>7</sup> their location by county and municipality, and whether they volunteered to share their information for inclusion in this report. Under state law (Minnesota Statue 63J.321 Subdivision 5 e and f), hospitals were provided an opportunity to review their included data and comment on the report. Their comments are found in Appendix C. Several hospitals not sharing their 2000 discharge claims with MDH subsequently shared their information for 2001 or 2002.

# Appendix A Data Collection, Preparation, Terms and Abbreviations

#### Data Collection and Preparation

*Collection* - Data for this report were summarized from the Minnesota Department of Health 2000 Hospital Discharge Data Set. Hospitals in Minnesota voluntarily provided electronic copies of personally de-identified health insurance claims to the Minnesota Hospital Association for the calendar year. MHA edited the claims for completeness and clinical consistency, appended other valueadded information at the request of MDH, and provided the agency with a copy of the completed data file for a fee.

One hundred sixteen out of 138 hospitals operating in the state at the time participated in the 2000 discharge data collection, while 22 facilities did not. A list of participating and non-participating hospitals appears in Appendix B.

Non-participation of hospitals resulted in incomplete data for 20 out of 87 Minnesota counties and more, if the non-participating hospitals served patients outside their home counties. Seven counties currently have no hospital located within them. These are also noted in Appendix B.<sup>8</sup>

Only admission-thru-discharge claims were included in the analysis underlying this report. Outpatient claims, late charges, interim claims and duplicates were excluded, as far as possible. A few interim claims remained in the data file that were not declared as 'interim' by the participating hospital, but the number was very low relative to the total number. Normal newborns were flagged and excluded from the data set. Sick and premature neonates remained in the data categorized as pediatric discharges. Using diagnosis and procedure information appearing on each record, all discharges were classified into one of the following broad acute care condition categories: Medical/Surgical, Obstetrics, Mental Health/Chemical Dependency, or Pediatrics. Definitions of the these categories appear later in this section.

<sup>&</sup>lt;sup>8</sup> Six counties are listed in Appendix B as having no hospital, but Tweeten Lutheran Health Center in Spring Grove closed during 2000 with Houston County becoming the seventh with no hospital. Tweeten Lutheran Health Center did participate in this report.

*Data Preparation* – Upon receipt of the data, MDH's Health Economics Program (HEP) further refined it by correcting errors where possible and added pertinent geographic information derived from patients' Zip Code of residence provided at time of hospitalization. Zip Codes identified as valid by the United States Postal Service were mapped to primary counties using a table developed by the Census Bureau during November 1999. Zips Codes not mapped to a primary county were checked against the latest U.S. Postal Service listings, then either updated or marked as unknown if no county designation was found. In instances where a Zip Code crossed county lines, it was assigned to the larger county as primary. Because the de-identified discharge data did not contain a mailing address, nor did all records contain nine digit Zip Codes, HEP was unable to parse a Zip Code into more than one primary county.

Zip Codes are also associated with a state or territory. Discharges from out-of-state were mapped to the state or U.S. territory of patient residence and saved as a variable in the data file. Postal codes known to be within the range of Minnesota Zip Codes, but unknown with regard to the primary county, were classified as Minnesota in origin, yet unknown with regard to specific county of residence. A county identifier reflecting the location of the hospital at which the care occurred was also added to each record.

*Underreporting* - No attempt was made to compensate for missing hospitals' claims through sampling techniques. Counts displayed in the summary tables to follow reflect the volumes voluntarily reported by each hospital. When hospitals declined to contribute their claims to the data set, the event was footnoted in the tables affected.

An assessment of hospitals' over or underreporting is possible through comparison of discharge record counts with annual operational summary data submitted by each licensed facility to MDH's Health Care Cost Information System (HCCIS). Non-participating hospitals accounted for approximately 4% of total licensed beds eligible to participate in this report as well as 4% of the total volume of hospitalizations. Mayo Clinic's hospitals, Saint Mary's and Rochester Methodist, provided claims for Minnesota residents only, thus underreporting their actual discharge volumes.

For participating hospitals collectively, MDH received de-identified claims for roughly 94% or their total 2000-hospitalization volumes, as reported in HCCIS. This aggregate number does not apply to individual hospitals. There was substantial underreporting by some hospitals and overreporting by others. Overall, when including the patient volumes of non-participating hospitals, HEP estimates that the cleaned MDH Discharge Data Set roughly represents 91% of all hospitalizations in the state during calendar year 2000.<sup>9</sup>

<sup>&</sup>lt;sup>9</sup> This excludes all state-owned facilities, Veterans Affairs Hospitals, U. S. Public Health Service Indian Hospitals, Bethesda Rehabilitation Hospital, Valley Hospital at Hidden Lake, and the Shriners Hospital for Children. There were some definitional differences in the way births were counted within the two data sets that may slightly inflate the percentage.

#### Report Terms and Abbreviations

*Facility Naming Convention -* To distinguish facilities with similar names in the report, (for example, there are multiple facilities with the words Mercy, St. Joseph's, St. Mary's, or St. Francis in their names,) the municipality in which the institution is located was added for clarity. Consequently, the two Mercy hospitals become Mercy Hospital, Coon Rapids versus Mercy Hospital and Healthcare Center, Moose Lake, or St. Mary's Medical Center, Duluth versus Saint Marys Hospital, Rochester.

*County Names* - Labels other than County name appearing in the "Patients' County of Origin" column of the table have the following meaning:

- MN Unknown Zip Codes that were within Minnesota's USPS range (55101 56763), but remain unknown as to the county in which the patient lived.
- Out of State Refers to patients with a Zip Code outside of Minnesota's range but were mapped to other states, U.S. possessions, or territories.
- Unknown Zip Codes that did not map to any state, county, U.S. possession or territory.

*Care Conditions* - Abbreviations referring to broad categories of condition-related care appearing across the top of the enclosed table were created from codes provided by the Minnesota Hospital Association. The MHA categories consist of aggregations of Diagnosis Related Groups (DRGs) reflecting the patients' principal diagnosis and principal procedure on the claim. Abbreviations used in the MDH report include:

- Med/Surg Medicine/Surgery
- OB Obstetrics
- MH/CD Mental Health and/or Substance Abuse, Chemical Dependency
- Peds Pediatrics, children and less than 15 years of age, (MDH generated).

#### Confidentiality Considerations

Table cell sizes with less than 10 discharges were excluded from tables describing the origin of patients for hospitals collectively located within each county. Care condition categories were also combined and the origin of discharges from counties with small numbers of patients were aggregated into an All Other Areas category to minimize the potential for identifying individuals.

The Minnesota Department of Health Patient Origin Report, 2000, for Falls Memorial Hospital is incomplete and does not accurately reflect our inpatient statistics for that time period.

In 2000 the Minnesota Hospital Association obtained discharge data information from FMH's electronic claims vendor, Vmed. At that time, Vmed was only able to accept claims filed electronically which, for Falls Memorial Hospital, included claims for Medicare, State funded Medical Assistance, and Blue Cross patients. Falls Memorial Hospital inpatient claims filed for Medica, PMAP, BC Regence, Commercial Providers, and Workers Comp patients were not filed electronically. The inpatient data that was not filed electronically was therefore not included in the data that was obtained by MHA. As a result, the MDH Patient Origin Report 2000 represents only the electronic inpatient claims filed with VMed and is therefore incomplete.

The Minnesota Department of Health Patient Origin Report, 2000 erroneously has ZIP code 56304 placed in Stearns County rather than Sherburne County. In this case, assigning patient admissions to St. Cloud Hospital originating in Sherburne County to Stearns County understates the admission pattern from Sherburne County and overstates admissions from Stearns County by a significant amount. There are no ZIP codes in Sherburne County that could possibly be Stearns County residents (56304 overlaps Benton and Sherburne counties). The methodology of assigning individuals from certain ZIP code areas to specific counties introduces a significant statistical error into the data.

#### Recommendation: Provide the data by ZIP codes rather than by counties.

We also have a concern with the specialty services discharges being aggregated with the medical/surgical services discharges. This certainly will distort the picture of rural hospitals and may confuse people's perceptions of the hospital industry in Minnesota.

If the report remains as is, with no adjustments for Greater Minnesota hospital variations, it does not accurately reflect the true patient origin and should not be used to draw conclusions for future studies.
