# Appleton Receives A Small Cities Development Grant

The Department of Employment and Economic Development announced in early March that the city of Appleton was awarded a Small Cities Development Program (SCDP) grant. The city received the SCDP grant in its first attempt of submitting an application. SCDP grant applications are very competitive as only one-third of the applications in the state are typically funded each year. The UMVRDC prepared the successful application.

Appleton received \$793,650 in SCDP funds. The SCDP grant, combined with \$321,000 of other matching funds, will be used to rehabilitate approximately 40 owner housing, rental housing and commercial buildings in targeted areas of the community.

In addition to preparing the grant application, the UMVRDC is also doing the general administration for the grant. Prairie Five Community Action Council, Inc. will be doing the project administration for the commercial rehabilitation activities and the Swift County HRA will be handling the housing project administration.

## The Western Minnesota Revolving Loan Fund



Revolving loan fund dollars are available through the Western Minnesota Revolving Loan Fund (WesMN RLF) for new or expanding businesses in Region 6W. The WesMN RLF is a gap financing lender that requires local bank financial participation with each loan made. Secured loans ranging in size from \$5,000 to \$100,000 may be made for fixed assets and working capital. The maximum WesMN RLF participation rate is 33 percent on manufacturing projects and 20 percent on all other types of loans.

The emphasis of the WesMN RLF is to help finance business start-ups and expansions with a priority given to industrial/manufacturing businesses. Commercial/retail business projects, while eligible for WesMN RLF financing, must fulfill a local need for essential goods and services. Job creation is the

first priority of the WesMN RLF dollars while job retention is the second priority. The WesMN RLF has portfolio standards of one job created or saved for every \$10,000 of WesMN RLF funds loaned and a minimum of two private dollars borrowed to every one WesMN RLF dollar loaned.

In Fiscal Year 2006, the WesMN RLF made loans totaling \$242,000 to new and expanding businesses in Region 6W. These WesMN RLF loan dollars helped leverage nearly \$2 million in other public, private and owner funds for projects that created new business and job growth. These loans will result in 34 jobs being created and nine retained.

Loans are made by the WesMN RLF Loan Board with staff support coming from the UMVRDC.

# **Region 6W CEDS Update Completed**

During the summer and fall of 2005 the UMVRDC completed a comprehensive economic development strategy (CEDS) update for Region 6W. Updates to the CEDS are done annually with major revisions done every five years. A major revision to the Region 6W CEDS was completed in 2003.

A CEDS is required to qualify the region for United States Department of Commerce - Economic Development Administration (EDA) grants under its public works, economic adjustment and most planning programs. EDA funding supports the formulation and implementation of economic development programs designed to create or retain full-time permanent jobs, reduce unemployment and under-employment, and increase incomes in areas of economic distress.

A CEDS is the result of a local planning process designed to guide the eco-

nomic growth of an area. A CEDS process will help create jobs, foster more stable and diversified economies, and improve living conditions. It provides a mechanism for coordinating the efforts of individuals, organizations, local governments, and private industry concerned with economic development.

The CEDS must be the result of a continuing economic development planning process, developed with broad based and diverse community participation, and contain the following:

- An analysis of economic and community development problems and opportunities including incorporation of any relevant material or suggestions from other government sponsored or supported plans;
- Background and history of the economic development situation of the area covered, with a discussion of the economy, including as appropriate, geography,

population, labor force, resources, and the environment;

- A discussion of community participation in the planning efforts;
- A section setting forth goals and objectives for taking advantage of the opportunities of and solving the economic development problems of the area serviced;
- A plan of action, including suggested projects to implement objectives and goals set forth in the strategy; and
- Performance measures that will be used to evaluate whether and to what extent goals and objectives have been or are being met.

## Prairie Waters Enhances Region's Economic Development

The Prairie Waters Convention & Visitors

Bureau has completed the first six months

of the three year tourism funding program agreed upon by the five counties of Region 6W. Commissioners from each of the counties pledged the following amounts towards the area's tourism program each year for



Another \$27,000 is pledged from funding cities in the region: Montevideo, Granite Falls, Appleton, Benson, Madison, Dawson, Clara City, Milan and Clinton. These pledges generated another 20 percent towards the total rev-

enue for Prairie Waters FY2006. The UMVRDC contribution for Indirect Costs is \$10,000 or another 7.6 percent towards the revenue.

In addition, the private sector, in the form of

a newly developed membership sector, pledged to raise \$5,000, at \$100/member for 2006. We are currently at 43 members and continue to recruit to meet our projections.

PRAIRIE WATERS

To further support our marketing revenues, Prairie Waters undertook cooperative advertising partnership again this

year with Explore Minnesota Tourism. Forty percent of qualified ad and marketing costs were paid for by the state through this program. Additional support for ad costs came from several members who participated in national and regional campaigns.

Our two biggest marketing projects were moderately successful this year. Our visitor guide was able to generate revenue to produce

> a 28-page collateral piece to be used in response to all inquiries. Ad sales were lighter than expected as the region continues to understand the competitive need for such pieces.

> The regional "tear map" has been distributed and is being well received. It has been distributed throughout the five-county region and continues to be placed in new locations as its availability becomes known.

We continue to involve more private business in the development of tourism programs and continue to showcase our region in as many markets as possible.

# Meander - Upper Minnesota River Art Crawl

Preparations are being made for the third annual *Meander* ~ *Upper Minnesota River Art Crawl* to be held from Friday, September 29 through Sunday October 1. This self-guided tour of artist studios, galleries and shops will feature the work of more than 50 local artists and craft workers from Canby to Benson, Granite Falls to Ortonville and all points in between. The event is free and open to the public.

Visitors along the *Meander* route will have the opportunity to view the award winning work of professional artists such as Gene & Lucy Tokheim of Dawson, Karen Jenson of Milan and Katia Adnreeva of

Granite Falls. In addition, many lesser known but equally disstinguished artists such as Malena Handeen of Milan, Deb Connolly of Danvers and Torri Hanna of Canby will open their studios to the public.

The *Meander* is the result of a year-long

cooperative planning effort by a group of area artists convened by the

UMVRDC, Western Minnesota Prairie Waters CVB and Clean Up Our River Environment (CURE). "We consider this event as a great example of bottom up economic development that can happen when entrepreneurs, government agencies, nonprofit organizations and creative people work together," said Patrick Moore, one of the organizers of the Meander.

"The Meander is a great way to show-case the unique aspects of the Prairie Waters Region," stated Dawn Hegland, of the

UMVRDC. "We believe that events like this show visitors from the Twin Cities, Sioux Falls and the Fargo/Moorhead area

# Minnesota River Valley National Scenic Byway

The UMVRDC continues to coordinate L the efforts of the Minnesota River Valley National Scenic Byway as the Byway continues to work toward the goal of economic development encouraging through the promotion, preservation and protection of the historic, cultural and natural qualities of the Minnesota River Valley. The Byway Alliance has representatives from chambers of commerce, CVBs, historical societies, economic development associations, elected officials and state agencies. They collaborate with other organizations to promote the valley and work on projects to improve access and information distribution wonderful attractions about its resources.

The year 2005 was filled with many exciting events and projects throughout the beautiful Minnesota River Valley. The Valley was carved by the Glacial River

Warren 13,000 years ago with such tremendous force that it exposed the underlying granite bedrock that is 3.8



billion years old. Many visitors come to the 287-mile corridor to see these outcroppings and the plant species, some of which are rare, growing in their natural habitat. Visitors also come to camp in our parks, canoe our creeks and rivers, shop in our unique stores and savor our delicious meals often made from locally grown products.

The Minnesota River Valley Scenic Byway Alliance worked on a strategic planning session with assistance from Mark Anderson, MN State Byways Coordinator and Michelle Ethun, America's Byways Resource Center staff. The Alliance adopted an aggressive list of projects, set time lines and assigned primary responsibilities.

The Byway Interpretive Committee identified 16 sites throughout the Valley in

the first phase of interpretive sign construction, and identified sites for future information kiosks. Members of the Alliance gathered material and started the writing and layout design process. The guidelines created last year will allow for plenty of individual creativity in the sign, while at the same time creating panels that help tie our three themes together and create more awareness for the Byway. It is our hope that others developing interpretive signs along the Byway will use the same guidelines. These signs will be finalized and fabricated in late summer 2006.

The Byway Marketing Committee developed a new 24-page full color brochure packed with photos and information about the Byway. They are distributed throughout the River Valley and at state information centers and are sent in response to calls and email inquiries. The

committee also developed a postcard in celebration of national Tourism Week in May. The postcard announced the new byway guide.

As interest continues to grow in our historic sites and recreational amenities. Communities throughout the 287-mile corridor are sharing events, happenings, tours and projects with one another via email which is then related to all our respective networks. By looking at the Byway calendar on the website www.mnrivervalley.com, you will see events to please any family member or tour group.

Representatives of the Byway attended workshops and meetings during the year both on the state and national level. These opportunities are valuable to learn from other byways or learn more about how to effectively manage our Byway and ongoing projects.

Our membership drive has been successful. More than \$2,000 was generated for our projects through this effort. We very much appreicate the continued support of our members and hope that this will grow each year and allow further porjects to be completed.

The Minnesota Historical Society has resolved staffing needs at both the Lower Sioux Agency site and Fort Ridgely Historic



site due to heavy lobbying throughout the Valley and additional funding from the state. The Byway continues to be a voice to help our legislators understand the importance of interpretation of history

where it occurred.

A state recreational trail is being planned that will run throughout the River Valley bringing tourism dollars into the area and providing a healthy experience for families to get out and enjoy the Valley. Many of the Byway Committee members are actively involved with the development of potential segments of this state trail corridor.

"The Alliance remains dedicated to protecting the intrinsic values of the river valley. This will be accomplished in part through support of efforts to have historic sites open to help tell the story of our byway, developing further means of interpreting the sites without onsite information, and in some cases working directly on their preservation," stated former Byway President James Lundgren.

# Transportation Planning Assistance

The UMVRDC continues to provide L local transportation planning assistance to the region through a contract with the MN Department Transportation. The region's Transportation Advisory Committee meets quarterly to review, discuss and recommend transportation projects including the prioritization of millions of dollars worth of road, bridge, rail crossing, public transit and trail projects. Recommendations are given to the UMVRDC and to Area Transportation Partnerships (ATPs). ATPs develop prioritized lists of transportation projects for a multi-county area. Region 6W participates in two ATPs, each of which encompass a different 12-county area.

Transportation issues continue to be

critical issues for our rural, agrarian region. We rely heavily on the existing transportation system to get to work, school, medical appointments, vacation, and to get commodities into and out of the region. The UMVRDC would like to assist the local units of government to ensure its people and businesses of this region are adequately served by all modes of transportation.

Some of the transportation projects that were included in FY 2006:

- Participated on ATPs 4 and 8 as technical staff and as alternate voting members;
- Provided information to MnDOT on the statewide functional class study;
- Assisted Appleton, Granite Falls,
   Clara City, Benson and Ortonville as

that the Upper Minnesota River is a great 'trip on a tank full' destination for those seeking authentic culture, history and scenic vistas."

Recent studies conducted by the University of Minnesota Tourism Center and others have revealed an emerging trend toward this type of "nature and culture" tourist travel. In 2005, the U of M Tourism Center conducted 178 personal visitor interviews of *Meander* participants during the weekend event in an effort to measure the economic and attitudinal impact of this event on the region. The results were very positive.

- Average travel party size was 3.7 people;
- 74 percent are likely to return again to

the event;

- 50 percent were residents outside the five-county region;
- 44 percent were married with grown children;
- 16 percent were married with children under 18;
- 14 percent were married with no children;
- Average age was 55 years old;
   81 percent of those attending were female;
   and
- 51 percent reported income of more than \$50,000.

## AREA AGENCY ON AGING

The Minnesota River Area Agency on Aging (MnRAAA) will begin its third year of operation January 1, 2007. The MnRAAA Joint Powers Board is the designated Area Agency on Aging, consisting of two commissioners from each Regional Development Commission (RDC), a nonvoting chair and an ex-officio member from each Advisory Council on Aging located within each RDC. The MnRAAA planning and service area encompasses the 27 counties of southwest Minnesota. Offices are maintained in Appleton, Willmar, Slayton and Mankato. The Slayton office houses the Call Center, where all Senior LinkAge

Line<sup>TM</sup> calls go and the Mankato office is authorized to be the administrative and fiscal agent, also completing grants management duties.

Roles of the MnRAAA include administration of federal and state dollars for elderly services through grants or contracts, providing people with information and



assistance, advocacy and program development and coordination.

Each Economic Development Area (EDA) of MnRAAA has an Advisory

Council on Aging (ACA). Primary functions of the ACA involve serving as an advisory body on matters related to the Area Plan;

make formal recommendations to each RDC; identify the needs, concerns and issues of older adults (people 60+) in each EDA; consider alternatives and develop goals to address identified needs of older adults; assist in awarding Older Americans Act funding; and advocate on behalf of older adults at the local, state and federal levels.

## ElderCare Development Partnership

The Southwest ElderCare Development Partnership (SW EDP) is a collaborative funded by a state grant through the Minnesota Board on Aging (MBA). The SW EDP includes the counties of Region 6W. The following principles are used to provide direction for EDP activities:

- Focus on activities that achieve the re-balancing of Minnesota's Long-Term Care System.
- Foster development of community-based commitment and community-based approach to delivering long-term care services for elderly persons in their homes.
- Align technical assistance provided to Community Services/ Service Development grant applicants.
- Establish a broad range of quality service options for frail elderly, low-income persons.
- Focus local development strategies on achieving effective and efficient use of existing public resources, including the use of technological advancement in services.

## Final Medicare Part D Enrollment Numbers

The MN River Area Agency on Aging Call Center in Slayton recently reported on the number of people assisted with Medicare Part D enrollment. The Initial Enrollment Period began last November and ended on May 15.

In the five counties of Region 6W, 566 Medicare beneficiaries were assisted with low-income subsidy applications by Senior LinkAge Line<sup>TM</sup> staff. This program allows those with low income and assets to pay a reduced Medicare Part D premium and copays between \$1-5 for their prescriptions.

The Social Security Administration determines eligibility in this program and applications are continuously accepted.

Along with applying for the Low-Income Subsidy, there were 342 people that had the Senior LinkAge Line™ staff also assist them in enrolling in a Medicare Part D plan. There are 14 Benchmark plans that qualified individuals can enroll in to receive a subsidy.

There were 432 Medicare beneficiaries that were assisted with the enrollment process. These individuals did not qualify

for the Subsidy but wanted to enroll in a Prescription Drug Plan. This brings the total number of individuals helped with enrollment to 774.

The next Enrollment Period will begin on November 15 and go until December 31. There are some exceptions to this such as those new to Medicare. If you have questions related to Medicare Part D, please contact Berit Skurdahl at 320-289-1981 or berit.skurdahl@umvrdc.org.
