**Clause a: GENERAL STATEMENT OF BOARD ACTIVITIES**

This description should cover both FY 05 and FY 06 and include any changes (additions/deletions) in activities between those years.

The Minnesota Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience, and Interior Design has been established to safeguard life, health and property and to promote the public welfare. The Board meets its mission through the examination, licensure, certification and regulation of individuals who practice architecture, professional engineering, land surveying, landscape architecture, geology, or soil science or who use the title certified interior designer. In addition, the Board regulates the unlicensed practice of these professions.

The Board reviews and processes applications for examination by identifying those candidates who meet the education and experience requirements set forth in statute and rule. Board staff administered sixteen examinations per year to a total of 1,919 candidates. In addition, the examinations for architect, landscape architect, and certified interior design were given through their respective national licensing councils after approval that a given candidate meets the Board's requirements.

In the FY05/FY06 reporting period, the Board granted a total of 1,534 new licenses and certificates (by exam and by comity). The Board renewed approximately 14,286 licenses in FY06.

The Board, in cooperation with the Attorney General's office, processed and closed 140 complaints alleging violations of the Board's statutes and rules. During this period 167 new complaints were filed.

The Board generates non-dedicated revenue (license fees, examination fees, fines, civil penalties) into the General Fund. Fees are set to cover all direct and indirect costs.

The nature of the proposed rules is to provide clarity in general and to specifically and accurately reflect which types of projects are exempt from requiring a licensed design professional.

The Board published the Request for Comments for these proposed rules in the May 9, 2005 State Register. Although the Board will not have adopted these rules prior to the date this report is due, it anticipates doing so within the next year.

Annually the Board verifies to other states the status of approximately 1000 licensees and certificate holders. The completion of a verification does not mean that the individual necessarily follows through and receives a license or certification in the other jurisdiction.

It would be difficult to track licensure or certification in other jurisdictions. Non-home state licensure/certification is not always long term – it may be due to a single project. If all our licensees and certificate holders were asked to tell other jurisdictions in which they were licensed/certified, the data would become obsolete very quickly.

Licensees and certificate holders have a varying number of other licensing jurisdictions with which they can become licensed/certified. For example, architects and engineers could be licensed in 55 separate jurisdictions whereas soil scientists would find only 8 such jurisdictions.

The Board investigates complaints alleging unlicensed practice and because those individuals did not hold a license with the Board, the data is not included in clause m. Data for those complaints is set forth below:
