

Executive Branch Advisory Groups

This information brief provides general information on executive branch advisory groups and contains a table listing each executive branch advisory group created in statute. The table gives the citation for the statute creating each group and indicates each group's expiration date, if any.

This information brief identifies 156 executive branch advisory groups. This number includes only groups created or specifically authorized by the legislature. It does not include groups created by executive order or by action of a commissioner. The number also does not include groups that are so short-term that the legislation creating them was not codified in Minnesota Statutes.

Some of the groups created or authorized by law may not currently exist. For example, some of the groups are task forces that exist at the discretion of a commissioner. Other groups may have expired in 2003, but the enabling legislation has not yet been repealed.

General Laws Governing Advisory Groups

The legislature has enacted general rules governing advisory groups. Many of these are contained in [Minnesota Statutes, section 15.059](#), and apply only if the law creating the advisory group refers to [section 15.059](#).

Names of Groups

[Minnesota Statutes, section 15.012](#), establishes naming conventions for state agencies. The legislature does not always follow these conventions when it creates new groups.

Councils: Advisory groups in which at least one-half of the members must be representatives of specified industries, occupations, or other organizations are called “councils.”

Committees: Advisory groups in which less than half of the members must be representatives of specified organizations are called “committees.”

Task Forces: Advisory groups scheduled to expire within two years of creation are called “task forces.”¹

Membership Terms

Members of advisory councils and committees serve four-year terms. The terms of half of the members expire with the term of the governor. The terms of the other half of the members expire the following year. Members of advisory task forces serve until the expiration date of the task force (up to two years after the group is created).

Removal

Members may be removed at the pleasure of the appointing authority. Appointing authorities are given special authorization to remove members who miss three consecutive meetings.

Compensation

Members of an advisory group receive compensation and expense reimbursement only if authorized by the law creating the group.

¹ The law provides authority for the governor and state agencies to appoint additional temporary groups. [Minnesota Statutes, section 15.014](#), authorizes commissioners and state boards to create advisory task forces. A task force created under this law may have no more than 15 members. The members of no more than four task forces created in a department may be paid for their expenses. [Minnesota Statutes, section 15.0593](#) authorizes the governor to create advisory groups of no more than 15 members. Members do not receive per diem, but may be paid for expenses. The groups created by an agency or by the governor generally expire after two years, unless re-created.

When a law authorizes compensation and expense reimbursement, it usually refers to [section 15.059](#). That section provides that members of advisory councils and committees receive \$55 per day spent on group activity, when authorized by the group. Members of advisory task forces do not receive this \$55 per day. The provisions of section 15.059 governing expense reimbursement (as distinct from the \$55 per day payment) apply to advisory task forces as well as to councils and committees. Members are reimbursed for meals, travel, hotel, and child care expenses.

Reporting

[Minnesota Statutes, section 15.0599](#), requires advisory groups with statewide jurisdiction to register with and report annually to the secretary of state. By July 15 each year a group must report specified information about the purposes of the group, its membership, expiration of the group, the number of meetings held, and money and staff resources devoted to the group. If a group fails to report as required, its members are not eligible for compensation or expense reimbursement until the report is filed. By October 15 each year, the secretary of state summarizes this information in a report. Information on each agency also is available on the secretary of state's web site. Expiration

[Section 15.059](#), subdivision 5, provides that advisory *councils* and *committees* expire June 30, 2003, unless a different date is specified in law. This expiration date applies whether or not the law creating the group refers to [section 15.059](#). The legislature did not change the June 30, 2003 sunset date before or after that date. As a result, a number of groups expired on June 30, 2003.² For information on status of advisory groups after June 30, 2003, see the House Research publication *Advisory Groups: Status after June 30, 2003*. The legislature has not repealed the enabling legislation for some of the groups that appear to have expired in 2003. Thus, some of the groups are listed in the table at the end of this report, even though they may no longer exist. Also, the legislature has created some groups since 2003, and those groups are not covered by the June 30, 2003, sunset date.

In some other cases, it is not clear if a group was subject to the June 30, 2003, sunset date. For example, the law provides that an advisory council or committee does not expire if it:

- (1) is an occupational licensure advisory group to a licensing board or agency;
- (2) administers and awards grants; or
- (3) is required by federal law or regulation.

It is not always clear if a group comes within one of these exceptions. Also, from 2003 to 2006, the legislature amended the statutes governing some groups. Presumably, such an amendment,

² In some cases, the legislature overrode the June 30, 2003, expiration date in [section 15.059](#) by specifically providing a later expiration date.

session law, or appropriation referring to a group could be taken as an expression of legislative intent that the group not expire.

[Section 15.059](#), subdivision 6, provides that if a *task force* is mandated by statute, it expires not later than two years after creation. But a person or group with mandated or discretionary authority to create a task force may create another one to continue the work of a group that expires.
