- \$188,300.00 Special Revenue DWI (FY04 & 05)
   The buy-fund receives 1.6% of the DWI fund and the Lab receives 6.4%.
- \$ 50,000.00 General Fund Witness Protection (FY04-05)

A total of \$238,300.00 was expended for the 2004-2005 biennium. The Special Revenue account expended \$101,800.00 for FY04 and \$86,500.00 for FY05. The Witness Protection account dispersed \$36,629.00 for FY04 and \$13,371.00 for FY05. Enclosed is a report listing the expenditures from these sources.
