Dear Colleagues:

Pursuant to Minn. Statute §299C.065 Subd. 3, UNDERCOVER BUY FUND; WITNESS AND VICTIM PROTECTION, the Commissioner shall prepare and submit to the chairs of the committees in the senate and house having jurisdiction over criminal justice policy by January 1 of each even-numbered year, a report of investigations receiving grants under subdivision 1.

This report encompasses the statistical activities of the fund for fiscal years 2006 and 2007. Funding obtained from the following source was distributed to law enforcement agencies pursuant to M.S. 299C.065 Subd. 1(5)(6). The source is listed as follows:

- \$187,000.00 - Special Revenue DWI - (FY06 & 07)
The buy-fund receives 1.6% of the DWI fund and the Lab receives 6.4%.

A total of \$187,000.00 was expended for the 2006-2007 biennium. The Special Revenue account expended \$77,920.00 in FY06 and \$109,080.00 in FY07.

Beginning FY06, Witness Protection funds (MS 299C.065, Subd. 1a) were discontinued due to budget cuts.

The enclosed Legislative Buy Fund Activity Report is submitted for your reference in accordance with Subdivision 3. The Department views this correspondence as satisfying the reporting requirements as provided in Minn. Statute §299C.065 Subd. 3.
