Dear Colleagues:

Laws of 2008, Chapter 167 requires that "Each state agency that is assigned a role as a disaster or emergency response organization in the state emergency operations plan must have at least one employee who has completed the entire emergency management training curriculum..." that is maintained by the Minnesota Department of Public Safety Homeland Security and Emergency Management (HSEM) division.

Attached is a summary of the requirements to comply with this mandate as well as the report on the state agencies' compliance.

## 2008 Report to the Legislature On State Agency Compliance with Laws 2008, Chapter 167

Laws 2008, Chapter 167 requires that "Each state agency that is assigned a role as a disaster or emergency response organization in the state emergency operations plan must have at least one employee who has completed the entire emergency management training curriculum..." that is maintained by the Minnesota Department of Public Safety Homeland Security and Emergency Management (HSEM) division. Furthermore, "If an agency is not in compliance...the agency must immediately file a plan with the division identifying how and when the agency will be in compliance." The Department of Public Safety is responsible for tracking these records and reporting the results to the legislature.

In the furtherance of state agency compliance with the emergency management training requirement, on April 17, 2008, the Commissioner of the Department of Public Safety sent an informational memo concerning it to the affected 22 state agencies, offices and boards. In addition, the HSEM Training Officer summarized the new requirement, and the process for complying with it, during an April 30, 2008, meeting of the State Emergency Preparedness and Response Committee. In response, all of the affected agencies have informed HSEM that they understand the requirements associated with Chapter 167, and are complying with them.

A summary of state agency compliance with the training requirement is shown on the attached spreadsheet. That document reveals that 10 of the affected 22 agencies, offices and boards are currently in compliance with the training requirement (i.e., have at least one employee who has completed the entire curriculum). It should be noted that one of the compliant agencies (the Board of Animal Health) contracts with a Department of Agriculture employee to fulfill these duties. That individual is a certified Emergency Manager. Twelve of the 22 agencies are in the process of becoming compliant. All agencies are either compliant or in the process of becoming compliant. It should be noted that 256 training hours are required in order for an individual to become a certified Emergency Manager, and completing those training hours typically takes approximately 2-4 years. Other information pertaining to agency compliance with Chapter 167 requirements is as follows:

- a.) Several agencies have determined that they want to be in conformance with the Federal Emergency Management Agency's recommendation that their personnel be trained "three deep". Hence, there are multiple staff names listed for those agencies;
- b.) Most (17) of the 22 agencies subject to the requirement have determined that the staff member who serves as their (State) Emergency Preparedness and Response Contact/Coordinator will complete the curriculum; and
- c.) The 12 agencies that are in the process of becoming compliant with the training requirement have filed a plan with HSEM as to how they intend to become compliant.

Lastly, HSEM intends to shortly provide all of the affected agencies with a more formal plan template that they will use in the future to report their compliance with Chapter 167. The completed templates will serve as the basis for the compliance report that the Commissioner of Public Safety must submit to the Legislature by January 15, 2009.
