2008 BUSINESS ASSISTANCE REPORT

Introduction

The business subsidy law, Minnesota Statutes §116J.993 through §116J.995, provides a mechanism for taxpayers to learn about state and local funds used for business subsidies and financial assistance. The law applies to state and local government agencies with the authority to provide business subsidies including Job Opportunity Building Zone (JOBZ) and financial assistance. Grantors are required to submit a Minnesota Business Assistance Form (MBAF) to the Department of Employment and Economic Development (DEED) for each agreement signed since July 1, 1995 for two years after the benefit date or until all goals are met, whichever is later.

Under the law, local government agencies in communities with a population of more than 2,500 and state agencies with authority to grant subsidies must submit a report to DEED, regardless of whether they have awarded business subsidies. Local government agencies in communities with a population of 2,500 or less are exempt from filing the MBAF unless they have awarded a subsidy in the past five years. DEED is required to complete a report that summarizes submitted MBAFs every even-numbered year.

Data Collection

Reports can be filed to DEED by mailing a hard copy or using the online application launched in 2004. Because reporting requirements changed in 1999, for business assistance agreements entered into by agencies during the period of July 1, 1995 through July 31, 1999, agencies use the 1999 MBAF to fulfill reporting requirements. For agreements entered between August 1, 1999 and December 31, 2007, agencies use the standard MBAF form. Because a separate JOBZ MBAF reporting form was developed to address recommendations in the 2008 JOBZ Program Evaluation Report from the Office of the Legislative Auditor, an online application was not available and forms are still being analyzed. A report summarizing JOBZ MBAFs will be available in early 2009.

Forms summarized in the report cover non-JOBZ business and financial assistance agreements reached between July 1, 1995 and December 31, 2007 that were submitted to DEED by June 1, 2008. These forms and forms submitted by government agencies after June 1 are available on DEED's website.

Overview

Because the statute requires DEED to track each individual project awarded, grantors are required to submit information annual for each project for two years until project achieves its goals, whichever is later. This report summarizes business subsidy agreements signed in 2007; agreements signed in previous years are updated and summarized in Appendices (B-K).

Business assistance activity has varied significantly from year to year as reported by state and local government agencies. Non-JOBZ activity peaked in 2000 with 204 agreements, falling to 53 agreements in 2007.

Overview of Non-JOBZ Findings

The activity levels and total value of non-JOBZ business assistance have varied significantly from year to year as reported by state and local government agencies. There were 53 non-JOBZ business assistance agreements reported by government agencies in 2008 for 2007 activity, compared to 204 agreements for 2000 activity. The total value of business assistance agreements has also varied significantly from year to year, from a total value of \$612.6 million for 2000 activity to \$17.8 million for August 1, 1999 and December 31, 1999 (see Table 1).

2007 Non-JOBZ Activity

Of the 655 state and local government agencies that were required to file in 2008 either because of population size or previous business subsidy activity or current activity in 2007, 324 agencies submitted a MBAF and 331 agencies did not submit a form (see Appendix A).

Of the 324 agencies that submitted a form, 44 agencies reported on 53 eligible business assistance agreements that were reached between January 1, 2007 and December 31, 2007. The \$40.5 million of business assistance provided by those 53 agreements ranged from a \$26,000 lease subsidy to a \$26 million loan and tax abatement agreement.

Of the 53 business assistance, agencies reported that 17 recipients (32.1%) had achieved all stipulated goals and obligations, compared to 36 recipients (67.9%) that have yet to achieve all goals and obligations. All agencies reported that recipients had more time to meet their goals and obligations. The total value of the 17 agreements was \$5.9 million (14.6%) compared to \$34.6 million (85.4%) outstanding (see Appendix B).

2006 Non-JOBZ Activity

There were 54 eligible business assistance agreements reported by government agencies in 2007 and 2008 for 2006 activity. Of the 54 business assistance agreements reached between January 1, 2006 and December 31, 2006, agencies reported that 28 recipients (51.9%) had achieved all stipulated goals and obligations compared to 26 recipients (48.1%) that have yet to achieve all goals and obligations. The total value of those 28 agreements was \$10.0 million (23.2%) compared to \$33.1 million (76.8%) outstanding. The total value of business assistance provided was \$43.1 million.

There were also seven eligible financial assistance agreements reported by government agencies in 2007 and 2008 for 2006 activity. Of the seven financial assistance agreements reached between January 1, 2006 and December 31, 2006, agencies reported that three recipients (42.9%) had achieved all goals and obligations stipulated in the agreements compared to four recipients (57.1%) that have yet to achieve all goals and obligations. The total value of the value of those three agreements was \$.03 million (2.3%) compared to \$15.4 million (97.7%) outstanding. The total value of financial assistance provided was \$15.7 million (see Appendix C).

2005 Non-JOBZ Activity

There were 87 eligible business assistance agreements reported by government agencies in 2007 and 2008 for 2005 activity. Of the 87 business assistance agreements reached between January 1, 2005 and December 31, 2005, agencies reported that 58 recipients (66.7%) had achieved all stipulated goals and obligations compared to 29 recipients (33.3%) that have yet to achieve all goals and obligations. The total value of those 58 agreements was \$41.7 million (64.4%) compared to \$23.1 million (35.6%) outstanding. The total value of the business assistance provided was \$64.7 million.

There were also two eligible financial assistance agreements reported by agencies in 2007 and 2008 for 2005 activity. Of the two eligible financial assistance, one agency reported that the recipient had achieved all goals and obligations stipulated in the agreement and the other agency reported that the recipient had not yet achieved all goals. The total value of the agreement was \$500,000 (12.5%) compared to \$3.5 million (87.5%) outstanding. The total value of financial assistance was \$4.0 million (see Appendix D).

2004 Non-JOBZ Activity

There were 90 eligible business assistance agreements reported by government agencies in 2007 and 2008 for 2004 activity. Of the 90 business assistance agreements reached between January 1, 2004 and December 31, 2004, agencies reported that 62 recipients (68.9%) had achieved all stipulated goals and obligations compared to 28 recipients (31.1%) that have yet to achieve all goals and obligations.

There were also four eligible financial assistance agreements reported by government agencies in 2005 and 2006 for 2004 activity. The agencies reported that all four recipients had achieved all goals and obligations stipulated in the agreements (see Appendix E).

2003 Non-JOBZ Activity

There were 101 eligible business assistance agreements reported by government agencies in 2007 and 2008 for activity in 2003. Of the 101 business assistance agreements between January 1, 2003 and December 31, 2003, agencies reported that 63 recipients (62.4%) had achieved all stipulated goals and obligations compared to 38 recipients (37.6%) that have yet to achieve all goals and obligations. The total value of those 63 agreements was \$27.2 million (70.7%) compared to \$11.3 million (29.3%) outstanding.

There was also one eligible financial assistance agreement reported by a government agency in 2004 for 2003 activity. The agency reported that the one recipient had achieved all goals and obligations stipulated in the agreement (see Appendix F).

2002 Non-JOBZ Activity

There were 143 eligible business assistance agreements reported by government agencies in 2007 and 2008 for activity in 2002. Of the 143 business assistance agreements between January 1, 2002 and December 31, 2002, agencies reported that 93 recipients (65.0%) had achieved all stipulated goals and obligations compared to 50 recipients (35.0%) that have yet to achieve all goals and obligations. The total value of those 93 agreements was \$25.7 million (65.3%) compared to \$13.7 million (34.7%) outstanding.

There were also four eligible financial assistance agreements reported by government agencies in 2002 through 2008 for 2002 activity. Agencies reported that three recipients (75.0%) had achieved all goals obligations stipulated in the agreement and one recipient (25.0%) had yet to achieve all goals and obligations. The total value of the agreements was \$.04 million (45.0%) compared \$.05 million (55.0%) outstanding. The total value of financial assistance was \$.09 million (see Appendix G).

2001 Non-JOBZ Activity

There were 182 eligible business assistance agreements reported by government agencies in 2007 and 2008 for 2001 activity. Of the 182 business assistance agreements reached between January 1, 2001 and December 31, 2001, agencies reported that 105 recipients (57.7%) had achieved all stipulated goals and obligations compared to 77 recipients (42.3%) that have yet to achieve all goals and obligations. The total value of those 105 agreements was \$72.3 million (65.3%) compared to \$38.3 million (34.7%) outstanding.

There were also four eligible financial assistance agreements in 2002 through 2008 for 2001 activity. Agencies reported that one recipient had achieved all goals and obligations compared to three recipients that have yet to achieve all goals and obligations. The total value of that one agreement was \$49,088 (24.0%) compared to \$155,577 (76.0%) outstanding. The total value of financial assistance provided was \$204,665 (see Appendix H).

2000 Non-JOBZ Activity

There were 204 eligible business assistance agreements reported by government agencies in 2002 and 2008 for 2000 activity. Of the 204 business assistance agreements reached between

January 1, 2000 and December 31, 2000, agencies reported that 139 recipients (68.1%) had achieved all stipulated goals and obligations compared to 65 recipients (31.9%) that have yet to achieve all goals and obligations. The total value 139 agreements were \$587.7 million compared to \$24.9 million (4.1%) outstanding.

There were also 10 eligible financial assistance agreements in 2001 through 2008 for 2000 activity. Agencies reported that four recipients had achieved all goals and obligations compared to six recipients that have yet to achieve all goals and obligations. The total value of the four agreements was \$11.0 million (96.5%) compared to \$0.4 million (3.5%) outstanding. The total value of the financial assistance provided was \$11.4 million (see Appendix I).

August 1, 1999 – December 31, 1999 Non-JOBZ Activity

There were 73 eligible business assistance agreements reported by government agencies in 2000 through 2008 for 1999 activity. Of the 73 business assistance agreements reached between August 1, 1999 and December 31, 1999, agencies reported that 55 recipients (75.3%) has achieved all stipulated goals and obligations compared to 18 recipients (24.7%) that have yet to achieve all goals and obligations. The total value of those 55 agreements was \$14.9 million (83.4%) compared to \$2.9 million (16.6%) outstanding. The total value of business assistance provided was \$17.8 million.

There was also one eligible financial assistance agreement reported by a government in 2001 for 1999 activity. The agency reported that the recipient had achieved all goals and obligations stipulated in the agreement. The total value of the financial assistance provided was \$568,167 (see Appendix J).

July 1, 1995 – July 31, 1999

There were 404 eligible business assistance agreements reported by government agencies in 2000 through 2008. Of the 404 business assistance agreements reached between July 1, 1995 and July 31, 1999, agencies reported that 327 recipients (80.9%) had achieved all stipulated goals and obligations compared to 58 recipients (14.4%) that have yet to achieve all goals and obligations and 19 recipients (4.7%) that were missing data. The total value of those 327 agreements was \$143.8 million (80.0%) compared to \$28.3 million (15.7%) outstanding and \$7.8 million (4.3%) that was missing data. The total value of business assistance provided was \$179.9 million (see Appendix K).

Public Hearing and Adopted Criteria

According to M.S. §116J.994 business subsidies may not be granted until the grantor has held a public hearing and adopted criteria for awarding business subsidies. Grantors are also required to submit a copy of their adopted criteria policies to DEED if they award business subsidies.

There were 540 agencies required to hold a public hearing in or prior to 2007 in accordance with the statute because of previous activity (see Appendix L). The distribution of agencies that reported holding a public hearing is as follows:

- 417 agencies or 77.2 percent reported holding a public hearing in compliance with the statute; and,
- 123 agencies or 22.8 percent awarded business subsidies but did not report holding a public hearing on the MBAF.

Of the 540 agencies that were required to submit criteria to DEED, the distribution of the criteria submitted by agencies is as follows:

- 408 agencies or 75.6 percent submitted criteria; and,
- 132 agencies or 24.4 percent did not submit criteria, but awarded business assistance.

Recipients that Failed to Fulfill All Goals and Obligations through 2008

Under the law, DEED is required to report the number of business assistance agreements for grantors that did not meet their goals for two years after the benefit date or until the goals are met, whichever is later. As of 2008, there were 27 business assistance agreements reported by grantors during the period of August 1, 1999 and December 2007 that recipients had failed to fulfill all goals and obligations in the business assistance agreement (see Appendices B through K).

Public Purpose for Assistance Agreements

Minnesota Statutes §116J.994 requires that business and financial assistance agreements state a public purpose. Of the 53 business assistance agreements entered into in 2007, creating high quality job growth, 31 agreements (58.5%), and increasing the tax base, 30 agreements (56.6%), accounted for the highest share of public purpose reported by government agencies. Other types of public purpose included enhancing economic diversity, 25 agreements (47.2%), stabilizing the community, 19 agreements (35.8%), job retention, 16 agreements (30.2%), and other, 15 agreements (28.3%).

2007 Activity Findings

Forms summarized in this section of the report encompass business and financial assistance agreements reached between January 1, 2007 and December 31, 2007. Under the business subsidy law, agencies are required to submit a MBAF form for two years after the benefit date or until goals are met whichever is later.

Of the 53 business assistance agreements reported by government agencies in 2008, the manufacturing sector accounted for 23 agreements (43.4%), services, 13 agreements (24.5%), other, nine agreements (17.0%), retail trade, four agreements (7.5%), wholesale trade, three agreements (5.7%), and construction, one agreement (1.9%) (see Table 2).

Of the \$40.5 million in business assistance provided by government agencies, the manufacturing sector accounted for \$34.3 million (84.7%), other, \$3.2 million (7.8%), services, \$2.1 million (5.2%), retail trade, \$0.6 million (1.5%), wholesale trade, \$0.3 million (0.7%), and construction \$0.06 million (0.1%).

Distribution of Assistance Agreements

Cities accounted for most of the business assistance agreements reported in 2008. As Table 3 shows, the distribution of the 53 business subsidy agreements on the MBAF, cities accounted for 44 agreements (83.0%), counties for five agreements (9.4%), state for two agreements (3.8%) and other for two agreements (3.8%).

Of the \$40.5 million in business subsidies reported on the MBAF, county agencies accounted for \$26.2 million (64.7%), city agencies \$13.1 million (32.5%), state agencies \$0.8 million (1.9%) and other agencies \$0.4 million (1.0%).

Regional Distribution of Assistance Agreements

The Central and Southeast regions accounted for the most business assistance reported in 2007. As Table 4 shows, of the 53 business assistance agreements reported in 2008, the Central region accounted for 13 agreements (24.5%), Southeast for 13 agreements (24.5%), Twin Cities for 10 agreements (18.9%), Northeast for five agreements (9.4%), West Central for five agreements (9.4%), Southwest for four agreements (7.5%), and Northwest for three agreements (5.7%).

Of the \$40.5 million of business subsidies reported in 2008 by government agencies, the West Central region provided about \$26.8 million (66.1%), Twin Cities \$5.5 million (13.6%), Central \$3.3 million (8.2%), \$2.5 million (6.2%), Northeast \$1.9 million (4.6%), Northwest \$0.4 million (0.9%), and Southwest \$0.2 million (0.4%).

Type and Value of Assistance Provided

Of the \$40.5 million in subsidies awarded by state, county and local government agencies, amounts ranged from a \$26,000 in assistance for a lease to a \$20.0 million loan. The median value was \$152,460 for all agreements awarded.

Loans and TIF were the most common types of subsidies provided. Of the 53 business subsidies agreements reported by government agencies, there were 63 types of business subsidies reported because several agencies reported more than one type of assistance for each project. As Table 5 illustrates, of the 63 types of business subsidies reported by government agencies, loans were involved in 23 (36.5%) agreements and TIF was involved in 16 agreements (25.4%).

Loans accounted for the highest share of assistance by value, 60.5% (\$24.5 million), followed by tax abatements, 20.0% (\$8.1 million).

Goals and Actual Performance

Grantors are required to identify the types of goals that recipients receiving business assistance were expected to achieve. Grantors are also required to indicate the progress toward these goals.

Under the law, if the assistance agreement includes specific wage and job goals then those goals must be attained within two years of the benefit date. Assistance agreements can also include other goals. Of the 53 eligible business assistance agreements entered into by agencies between January 1, 2007 and December 31, 2007, 38 agreements (71.7%) established specific job and wage goals.

Of the 38 business assistance agreements that were reported by agencies that established specific wage goals, 14 agreements (36.8%) have attained specific job and wage goals; and 24 agreements (63.2%) reported that the recipient had not attained specific job and wage goals. All agencies reported that recipients had more time to meet their goals.

There were 23 business assistance agreements that were reported by agencies that established goals other than wage and job goals. Of the 23 agreements reported by agencies that established goals other than wage and job goals, 10 recipients attained their goals. All agencies reported that recipients had more time to meet their goals.

Actual Performance

Of the 53 business assistance agreements entered into by government agencies between January 1, 2007 and December 31, 2007, agencies reported 17 agreements where recipients had achieved all goals and obligations stipulated in the agreements. All agencies reported that recipients had more time to meet their goals and obligations. The total value of those 17 agreements was \$5.9 million out of the \$40.5 million of business assistance reported between January 1, 2007 and December 31, 2007.

Full-time Job Creation and Wages

Under the law, the business assistance, in addition to other goals, must include goals for the number of jobs created, which may include separate goals for the number of full-time or part-time jobs and wage goals for jobs created.

Of the 53 eligible business assistance agreements, agencies reported a full-time job creation goal of 450 jobs with an average hourly health and non-health benefit range between \$0.97 and \$4.00 (see table 6). Agencies reported 363 actual full-time jobs created. All agencies reported that recipients had more time to meet their job creation and wage goals. The distribution of full-time job creation and wage goals and actual performance was as follows:

Job Retention Goals and Actual Performance

Of the 53 eligible business assistance agreements, agencies reported a job retention goal of 1,172 jobs with an average hourly health benefit range \$1.20 and \$3.11. Agencies reported 921 jobs retained. The average hourly health benefit value was between \$2.21 and \$3.70 and non-health benefit of \$2.08 and \$5.91 (see Table 8). The distribution of retained job goals, wages and actual performance was as follows:
