



**OVERVIEW: 2008 Recycling Recovery Rates of Metropolitan State Agency Offices and Operations**

*Minnesota's public employees support waste reduction and recycle more than 60 percent of discards*

**Recycling Recovery Rate Reporting**


The Minnesota State Government Resource Recovery Program was established to promote the reduction of waste generated by state agencies, the separation and recovery of recyclable and reusable commodities, the procurement of recyclable commodities and commodities containing recycled materials, and the uniform disposition of recovered materials and surplus property. The Department of Administration, Plant Management Division's Resource Recovery Program administers the State Recycling Center and recycling rate reporting in accordance with Minnesota Statutes 115A.15. This statute requires that each state agency in the metropolitan area work toward individually achieving a 60 percent recycling goal. The recycling recovery rate is the percentage of total waste that is recycled. The rates are calculated using this formula:

$$\text{Recycling Recovery Rate} = \frac{\text{recyclables recovered}}{\text{recyclables recovered} + \text{solid waste discarded}}$$

**Achievement of 60 Percent Recycling Recovery Rate Goal**

The Resource Recovery Program assists metropolitan state agency and regional government locations in calculating the recycling recovery rates of 27,000 employees located in the counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington. The *2008 Recycling Recovery Rates of Metropolitan Offices and Operations* is published for state agencies, metropolitan regional government locations, the Pollution Control Agency and the legislature to facilitate recycling progress, opportunities, and accountability.
