Semi-Annual Appointment Report for 1-1-2009 through 6-30-2009

The semi-annual Appointment Report, required under Minnesota Statutes 43A.04, Subd. 7, is attached. The total number of appointments is a count of specific transactions tied to various appointment categories as indicated on the attached page. One person may have several different types of appointments throughout the year, and so the report does not reflect the actual number of new employees hired.

In keeping with the recent trend, the first half of 2009 continued to reflect a decrease in overall hiring activity. This is likely a result of the implementation of hiring restrictions as well as the forecasted and current budget shortfalls agencies are managing. Following is a snapshot of the overall hiring activity for the three most recent reporting periods.

The attached report displays activity that has occurred in several different appointment categories. Overall hiring numbers (all appointment types) are down with competitive appointments having realized the largest decline from the previous period (44%). The only category to show an increase was appointments from layoff lists (from 10 to 17 appointments).
