Reports Mandated by the 2009 Legislature

Each year the Minnesota Legislature mandates a variety of reports to be done by state agencies or other governmental entities. In 2009, the legislature mandated 185 reports. This information brief lists reports that were directed to be done for the first time by the 2009 Legislature. This list includes only reports that must be submitted to the legislature. The reports are listed alphabetically by topic, and within each topic, by order of enactment.

The 2009 Legislature amended the general law that governs filing reports with the legislature. Under the new law state agencies: must file two (instead of six) copies of the report with the Legislative Reference Library; must make reports available electronically to the Legislative Reference Library; and are no longer required to file copies with the Secretary of the Senate and the Chief Clerk of the House of Representatives.
