CONTRACTUAL AGREEMENT

- 1. Pursuant to Minn. Laws 1994, Chapter 641 (a copy of which is attached hereto as Exhibit A):
 - a. The authorization for the use of dry casks by the public utility operating the Prairie Island nuclear plant is not effective until a binding agreement (hereafter this "Agreement") is entered between the public utility and the Governor, on behalf of the State of Minnesota.
 - b. The signatory parties to the Agreement are Governor Arne H. Carlson (hereafter the "Governor") on behalf of the State of Minnesota and the public utility operating the Prairie Island nuclear plant which is Northern States Power Company by Edwin M. Theisen, President and Chief Operating Officer (hereafter "NSP").
 - The Mdewakanton Dakota Tribal Council at Prairie

 Island is an intended third-party beneficiary with

 standing to enforce the Agreement.
- 2. In compliance with Minn. Laws 1994, Chapter 641, the undersigned are hereby contractually bound to the terms of Chapter 641, Article 1, Sections 2 and 3 and the mandate for 200 megawatts of wind power and 75 megawatts of biomass required by December 31, 2002 in Article 3, Section 2, Subdivision 1; and Section 3.
