### REPORTING PER 138.911 MINNESOTA HUMANITIES CENTER.

### Subdivision 1. Establishment.

The Minnesota Humanities Center, a nonprofit organization, is established to advance the study of the humanities and enhance the work of schools, colleges, and cultural organizations throughout the state.

## Subd. 2. Reports.

The Minnesota Humanities Center shall report to the legislature by September 1 of each year on the use of state funds appropriated to the commission. The report shall include an itemized account of the programs and projects supported and the source of money for each. The report shall show actual expenditures for the fiscal year ending the preceding June 30 and proposed expenditures for the fiscal year beginning the preceding July 1.

#### Subd. 3. Humanities center.

- (a) The Minnesota Humanities Commission may establish a humanities center to ensure balance in public education and in the cultural life of the state, and to improve humanities education through the establishment of two institutes: the Minnesota Institute for Lifelong Learning and the Minnesota Institute for the Advancement of Teaching.
- (b) The humanities center may transport people and resources to small towns, rural communities, and urban settings to provide grants, technical assistance, and high-quality educational and cultural programs to schools and community organizations throughout Minnesota.
- (c) The Minnesota Institute for the Advancement of Teaching may conduct seminars and other activities for the recognition of the teaching profession and the advancement of teaching in Minnesota.

## NARRATIVE PROGRAM REPORT JULY 1, 2009- JUNE 30, 2010

During the last year, the Minnesota Humanities Center (MHC) programs served more than 150,000 citizens across the state of Minnesota. With support from the State of Minnesota, the Humanities Center was able to effectively respond to the growing needs of educators, literacy professionals, social service and cultural organizations seeking quality humanities education, training, workshops, and resources. The following is a short summary of the outcome achieved as a result of the important financial support from the Minnesota State Legislature.

#### Service Statistics

<u>Professional Development.</u> In the last twelve months MHC served more than 2,000 of Minnesota's premier educators, positively impacting the lives of more than 90,000 students in Minnesota:

- 1,915 teachers attended professional development seminars, impacting more than 74,000 K-12 students;
- 300 teachers and school administrators from across the state attended a two-day conference on Cultural Competency: Equity and Future of Black Education, impacting more than 15,000 children.
- 40 teachers from 21 states spent a week on Minnesota's Iron Range learning about its history, significance in the US Industrial Revolution and war efforts, and the people who came to live and work in the mines, impacting more than 3,000 students.

<u>Resources.</u> In the last twelve months MHC created, distributed and disseminated more than 50 new resources.

- Designed new website that is easier to navigate for teachers and the general public.
- Created new Audio/Video page that allows teachers and the general public to access more than 50 new audio and video pieces developed and/or produced by the Minnesota Humanities Center.
- Donated more than 9,300 Somali/English bilingual books to more than 100 schools and community groups throughout Minnesota.
- "Iron Range: Minnesota Building America", a documentary created by the Minnesota Humanities Center and Twin Cities Public Television, received a Regional Emmy Award for Best Cultural Documentary for the Upper Midwest.

<u>Community Partnerships.</u> In the last twelve months MHC helped conduct more than 250 events in Minnesota serving nearly 20,000 individuals.

- Hosted three Community Conversation and four Lunch and Learn events. These public programming events were attended by more than 300 people.
- Conducted 108 Reading with Dad events strengthening the literacy connection between dads and their children. These events served more than 3,800 fathers and children.
- Provided 22 grants totaling more than \$50,000 to organizations providing public humanities programming statewide. These grants helped fund more than 150 programs that served more than 7,000 individuals in more than two dozen towns.
- Helped coordinate 6 Museum on Main Street exhibits (Between Fences) that attracted more than 5,000 visitors to small museums in towns of less than 15,000.
