- VI: Evaluation: The success of these this project these projects could be measured by simply counting the (increased) number of users on the trail. The completion of these this vital trail connection will positively impact the health of the city by providing a comprehensive bicycle trail system for bike commuters. It will also help reduce reliance on motor vehicles and fossil fuels, as well as decrease noise and air pollution. This project will provide greater access to regional amenities for both city and suburban residents.
- VII. Context within field: Project will be completed on concurrence in conformance with existing trail standards.
- VIII. Budget Context: ISTEA funds have been committed for Stone Arch Bridge to Bridge 9 Section. No other funds have been committed at this time.
- IX. Dissemination: Design schematics will be presented to cooperating agencies, affected neighborhoods and adjoining property owners. When trail connection are is complete, user counts and other data will be made available to agencies upon request.
- X. Time: These this The Stone Arch Bridge to Bridge 9 project did not receive ISTEA funding when originally requested. They are now being resubmitted to ISTEA for consideration for 1999-2000. which is the soonest ISTEA funding round. ISTEA funds or other match will be sought for the Plymouth to 40th Avenue N. project.
 - Projects B, C, D for trails for Minnehaha State Park to Fort Snelling, the West River Parkway trail connection with North Mississippi Regional Park, and East River Road trail connection with Anoka were submitted for ISTEA funding, but not funded, see attached letters.

The Minneapolis Park and Recreation Board will resubmit the West River Parkway Trail
Connection to North Mississippi Regional Park and the East River Road Trail Connection for
future ISTEA Grants at such time as proposals are solicited. The Minnehaha Park to Fort
Snelling Trail is expected to be accomplished by Mn/DOT as mitigation for upgrading TH 55.

XI. Cooperation: For these This The Stone Arch Bridge to Bridge 9 trail connection does not require other agency cooperation the major cooperators will be the Minneapolis Public Works Department, Minnesota Department of Natural Resources, Minnesots Department of Transportation, adjoining property owners and attached neighborhoods. The Plymouth Avenue to 40th Avenue N. Project requires the cooperation of the Minneapolis Public Works Department.
