This was a collaborative project of the Department of Natural Resources and the Pollution Control Agency to provide public access via the Internet to natural resource, environmental and ecosystem information. The objective was to create and maintain informative, educational, entertaining, intuitive and easy to navigate web sites, that facilitate citizen involvement and encourage public participation, provide quick access to information needed by diverse customers, and promote ecosystem sustainability.

The web sites were developed in response to the needs of Minnesota citizens, educators, environmentalists, recreationists, and the business community, for a single point of electronic access to the natural resource and environmental information for which the cooperating agencies are stewards. Such access is now available on the agency web sites.

The web sites are dynamic, growing daily in both breadth and depth. Some broad categories of information available web sites include: aquatic resources (e.g. lake ecology and habitat, lake maps, fish population status reports, water quality and lake model summaries, Clean Water Partnership reports, Best Management Practices summary sheets); hunting and fishing seasons and regulations; State Parks and outdoor recreation; wildlife, mineral and vegetation resources; landscapes, watersheds, ecosystems, geologic features, and climatology; air and water quality; environmental fact sheets; and environmental education resources. This list is only exemplary.

This appropriation was for FY97 and the first 6 months of FY98. This 18 month period was planned as Phase I of a three year design and development process. Both DNR and PCA management affirmed their commitment to the project in the FY98/99 biennium by securing continued funding for the web development staff positions in each agency. Phase II of the project is now focusing on more tightly integrating the web sites, and reaching out to other environmental agencies.

## II. Project Summary and Results

This is a collaborative project of the Department of Natural Resources and Pollution Control Agency to design an electronic information system for public access to data and information about Minnesota's environment and natural resources. The system will be accessible via the World Wide Web. Existing print information including text, tables, maps, forms, satellite images, graphic images and photos, will be converted to electronic formats. Interfaces will be developed to access spatial and other databases.

Thematic categories of information to be incorporated include: aquatic resources (e.g. lake ecology and habitat, lake maps, fish population status reports, water quality and lake model summaries, Clean Water Partnership reports, Best Management Practices summary sheets); hunting and fishing seasons and regulations; State Parks and outdoor recreation; wildlife, mineral and vegetation resources; landscapes, watersheds, ecosystems, geologic features, and climatology; air and water quality; environmental fact sheets; and environmental education resources. New information products and services may also be developed to take advantage of unique publishing and communication opportunities provided by Internet technology. This list is exemplary rather than comprehensive. Development priorities will be established by the project steering committee.

Primary outcomes of the project are : (1) the formalization of a community-wide organizational framework and collaborative approach to electronic dissemination of environmental and natural resource information; (2) development of community-wide information distribution models; (3) design and delivery of content-rich web sites for natural resource and environmental information products and services; and (4) development of plans to evaluate, maintain and enhance the web sites created.

## III. Work Program Status and Accomplishments.

## Result 1. Formalization of Project Steering Committee and Web Site Design Teams.

The success of this project depends on enterprising levels of collaboration between the DNR and MPCA, and a wide community of public, nonprofit and private natural resource and environmental organizations. An interagency project steering committee will be established, chaired by the project coordinator, to provide policy level guidance and review, plan for long-term maintenance and enhancement of the web sites developed, direct an evaluation of the project, and support communication links with other agencies in the natural resource and environmental community.

Collaboration will also be needed among a team of people with diverse skills to develop high quality web sites. An assessment will be made to define the ideal mix of skills needed on a web design team. Expertise will be sought in the areas of functional design, technology design, navigational design, information design, and interface and graphical design. An internal skills inventory will identify expertise currently available in the agencies, and project consultants or additional staff will be hired to fill the gaps.

- 2. To manage the system hardware, operating software and security systems associated with the agency web servers.
- 3. To develop, recommend and implement standards and templates to ensure high quality design and content, and to achieve a consistent look in the web sites.
- 4. To design menus, screen layouts, buttons, typography, and visual, auditory and other sensory design aspects of the interaction between the user and web sites.
- 5. To consult with and support agency staff interested in publishing documents on the web, and to coordinate development activities to ensure that all information prepared meets agency standards and is integrated in the web site architecture.
- 6. To review and edit all information posted to the web site to ensure the accuracy of content and conformity with agency editorial and publishing stand ards.
- 7. To develop core web infrastructure applications, tools and database interfaces.
- 8. To develop a structured navigational design and index for the web sites,
- including criteria for linking to external sources.
  To identify links with other agencies in the environmental and natural resources community, and to present an environmental cluster on the North Star web site.

To evaluate the quality and value of the web site using informal web site visitor comments, as well as a more formal external evaluation.

## Aug 1996 Web assistants identified; roles and responsibilities defined.

Web assistants work with the core design staff to identify information and services from their area of expertise to be delivered via the web. Core staff meet with web assistants one-on-one, and meetings of all staff involved are scheduled periodically to present project updates, to set project priorities, and to offer opportunities for review and critique of web site development. Web assistants may become key contributors, responsible for creating HTML documents for publication on the web. Contributors will be trained to use web tools and technologies within the context of agency web design standards.

## PCA

To create and maintain a World Wide Web site that is intuitive and easy to navigate, provides quick access to prioritized information that is needed by our diverse customers, encourages public participation, and promotes protecting Minnesota's environment.

## DNR

To create and maintain a web site in the Minnesota Department of Natural Resources that is informative, educational and entertaining; facilitates citizen involvement; and promotes ecosystem-based approaches to natural resource management. ## Mar 1997 Steering Committee meeting.

Progress on developing integrated access to water-related data and information was assessed. This topic had been selected as a top priority by the Steering Committee. It was agreed that significant work remains to be done in this area. The committee felt that meetings of this interagency group were of value, and expressed a desire to continue meeting periodically.

# Jun 1997 DNR information technology initiative included funding for web positions.

The DNR FY98/99 budget initiative for information systems development included funding for the two web design positions created as part of the LCMR project. Permanent funding for the positions was approved. The PCA did not seek additional funding to continue two agency web design positions. It is hoped that the positions can be funded within existing resources.

- Sept 1997 New web staff hired at DNR. Following the resignation of web programmer Mike Salovich in April 1997, the position was vacant nearly six months until Steve Lime was hired in September. Lime, formerly with the FORNET project at the University of Minnesota, brings advanced application development skills to the team.
- Dec 1997DNR and PCA web design teams more closely aligned.Planning initiated to increase collaboration between the agency web teams with a goal of<br/>more tightly integrating the DNR and PCA web sites. A significant first step will be to<br/>create a shared office space for the team.

# Result 2. Development of an Information Distribution Model.

The universe of information and data concerning Minnesota's environment and natural resources is vast, and the list of information products and services that could be made publicly available via the Internet is likewise extensive. In order to prioritize development, the steering committee will complete an inventory of information products and services currently managed by the agencies, and develop criteria to determine which will be made available electronically in Phase 1 of the project. At a minimum, content will be selected and product development sequenced based on agency missions and the needs of users.

Design requirements are prerequisite to planning, developing and implementing a successful web site. The project steering committee and web site design teams will develop internal standards that identify technical, procedural, design and documentation requirements for publishing information electronically:

(1) define user requirements in the initial design phase and evaluate throughout development;

(2) develop an architecture and information distribution model showing how electronic documents are related to their sources, how documents are linked to one another, how information is linked between documents, and how all documents are linked to the agency "home page" or top-level menu;

(3) establish technology requirements for system hardware and software to achieve maximum reliability, accessibility and security, and develop Internet server administration policies;

(4) specify design requirements for electronic information and services published via the web sites that provide clear agency identification and a common "look and feel;"

(5) develop guidelines to facilitate cataloging, indexing, navigating and searching of electronic information;

(6) develop procedures to protect the integrity - accuracy and completeness - of data and information;

(7) establish a document review process to ensure that all published electronic information meets the requirements of public law and policy under the Minnesota Government Data Practices Act; and

(8) develop policies for monitoring, measuring reporting and evaluating system access and use.

# STATUS

While some progress has been made in this area, significant work remains to be done. A particular concern is the development of an indexed and searchable electronic archive to meet the record retention requirements of the Minnesota Government Data Practices Act.

# Oct 1996 LCMR Project: "Foundations for Integrated Access to Environmental Information."

DNR and PCA are cooperators in this FY98/99 LCMR project, the purpose of which is to "develop and implement an integrated design for cataloging, managing and providing Internet access to natural resources data and information maintained by state agencies." The results of this project, 1) to identify environmental and natural resource information access needs, 2) to develop design criteria and a framework for integrated access, and 3) to create data documentation and indexed directories, will further DNR and PCA interests in developing information distribution models.

## Nov 1996 Draft information inventory and site map created.

The information inventory and site map provided the basis for the initial organization of the DNR web site. A new site map is being prepared to reflect actual content development and site architecture.

## Dec 1996 Project priority setting process approved.

Overall project development and daily work priorities for the DNR web design staff are established as follows:

1. Emergencies

- web server failure
- breach of web server security
- 2. Unplanned Special Projects
  - emergency information, e.g. spring flood conditions
  - external funding and/or staff resources available for a special project Planned Projects

The Web Manager will annually compile as complete an inventory as possible of information and services to be added to the DNR web site. This inventory will be presented to the Web Design Team and the Information Management Team for review and approval. It will be reviewed as needed by the Design Team at regular meetings. Guidelines to sequence project development:

- public demand for information, e.g. hunting, fishing, outdoor recreation
- multi-agency collaborative projects, e.g. DNR / PCA water-related data
- management support for project, staff readiness to implement online
- readiness of information for web presentation
- long-term information maintenance commitment from unit
- 4. Research & Development
  - system enhancements; hardware and software upgrades
  - staff training and development (also included under Planned Projects)
- 5. Wouldn't it be nice!
  - great idea, but resources are not currently available; will add to list and look for opportunities to develop the idea

### May 1997 Participation in DNR enterprise framing business object model development.

The project coordinator participated in a training/development project in which selected DNR staff worked with Advanced Strategies, Inc. to learn the principles of business object modeling and to build an enterprise-wide framing object model for the DNR. As with the LCMR "Foundations for Integrated Access" project, involvement of the DNR web design staff in this effort will result in more closely integrated and hence more valuable information access points.

# Jun 1997 "Style Guide for DNR Web Pages" published.

The *Style Guide* is a tool to help DNR web page authors design high quality web pages. The goal is to provide standards for producing web pages that have a consistent and professional look. The guidelines evolved from an extensive review of the web design literature, and from the observations, experiences and preferences of the DNR Web Design Team. Emphasis is on how to select, organize, design and evaluate information and services for presentation on the web. The guidelines do not address general HTML authoring, as there are many excellent resources and training opportunities to meet this need.

Jun 1997 Analysis of public requests for information from the DNR. A database of 1,500 public inquiries has been compiled to assist in an assessment of public natural resource information needs and demands. The inquiries have been received via the DNR web site "postcard," and the data will be analyzed over the next two months.

**Nov 1997 Online User Survey implemented.** An online survey was added to the DNR web site to solicit feedback from users about their information needs and impressions of the site. Over 450 responses were collected in the first three months. This information, along with the results of the "postcard" data analysis, has been instrumental in the redesign of the site.

# **Dec 1997** Metadata standard adopted. The DNR adopted the evolving Dublin Core metadata standard to enhance discovery of information on the web site.

# Result 3. Design and delivery of high quality, content-rich web sites for natural resource and environmental information products and services.

The web design teams are responsible for designing and implementing integrated web sites based on the requirements, standards and guidelines adopted by the steering committee. Documents will be well designed and organized for ease of maintenance and user retrieval. Content organization will be well documented and managed through standard methods of cataloging and indexing. Web site design and will meet internal and statewide standards for electronic information dissemination.

# Oct 1997 Redesign of the DNR web site.

Based on citizen and staff feedback, the growing skill and experience of the web team, and enhanced technological capabilities, the DNR web team began planning an entirely new look-and-feel for the web site.

## Feb 12, 1998 New DNR web site open to the public!

### Result 4. Development of a plan for the evaluation, maintenance and enhancement of web site.

Internet publishing is not a one-time event. Information must be kept current, accurate and relevant to ensure its quality and value to users. A solid evaluation and maintenance strategy will be developed and implemented to prevent the accumulation of inaccurate, out-of-date information and information links. The agencies are committed to keeping the data up-to-date.

Mechanisms will be established for users to leave comments, inquiries and requests. Procedures will be developed and responsibility assigned to monitor and respond to requests in a timely manner. General user feedback will be actively solicited. Development and enhancements will be based on feedback.

Expected enhancements include linkages with the community of federal, state and local government, and private and not-for-profit organizations concerned with natural resource and environmental information; implementation of interactive license, registration and permit forms; technology upgrades.

Budget:\$ 16,250 (.25 FTE - Project Coordinator; consultant)Balance:\$ - 0 -Completion Date:December 31, 1997; ongoing evaluation beyond project end date.

# STATUS

As noted above, the DNR and PCA have committed resources to continuing the development of the web sites originally made possible by this LCMR project. Informal and formal assessments of the sites will be completed in the next six months.

#### IV. Context

A. Significance :

The Department of Natural Resources and the Minnesota Pollution Control Agency have invested significant amounts of time and money in developing information systems and services to manage and disseminate the natural resource and environmental data for which they are stewards. The citizens of Minnesota, and its business, education, environmental and recreation communities, now seek a single point of electronic access to these information systems, products and services. Such access is not currently available.

The advent of the World Wide Web caught most everyone by surprise. But in a very short time it has excited our imaginations with new possibilities for global communication and service provision. Among other things, the web has raised citizen expectations about how they might interact more effectively with public agencies. Federal, state and local units of government have responded by building "web sites" on the Internet to publish information, provide public services, and receive citizen feedback. The DNR and MPCA have taken initial steps to establish electronic access via the Internet. This project accelerates agency efforts in response to growing public demand.

# B. Time : FY97 is planned as Phase I of a three year design and development process. The natural resource / environmental community has submitted a collaborative LCMR Proposal for Phase II development in the FY98/99 biennium. A plan will be developed during Phase I for long-term maintenance and enhancement of Minnesota's integrated natural resource and environmental web sites.

#### 1 DNR Town Hall

Identify possible controversial or "hot topics" to feature at the Town Hall, and develop a strategy to involve appropriate managers and staff in responding to public comments and concerns. Based on user suggestions, Lynn began developing a Town Hall thread on "fishing tournaments/ice-fishing contests" in mid-October. Steve Hirsch will manage messages. Other possible topics include status of the timber wolf, white pine (Bruce ZumBahlen 11/13/97), recreational vehicle use on public lands, cross-country ski permit system (Paul Nordell 12/12/97), and virtually any issue on which managers are seeking public input.

Lynn worked with Mike Don Carlos on the new site Town Hall which features information on the wolf management planning process, an online wolf survey, and a link to the International Wolf Center's "Wolf Management Information Exchange."

#### 2 DNR web site redesign

Lynn began working on redesign 10/7/97 to include: new table of contents; removal of JavaScript from contents page; removal of splash screen and browser analyzer; removal of navigational frame; development of header information for navigation; more photos. Target completion date is January 15, 1997. Colleen developed comprehensive site index. Home Page demo for Internet Committee 11/18/97; home page and 2nd level pages demo for IMT 11/26/97. Steve completed migration of files to new structure 12/16/97. After 4 months of concentrated work, the new site went public 2/12/98!

#### 3 1998 DNR calendar of events

I and E prepares an annual Special Events Calendar. This includes dates for both internal and external events, such as the Boat Show, Black History Month, Home & Garden Show, MN Deer Classic, NW Sportshow, Take a Kid Fishing, Walleye Opener, Prairie Day, etc. Other DNR units also produce calendars, including the License Bureau (calendar is already on the web), Parks and the natural resource education programs. Need to decide how to integrate (or not) and best way to present. Jim Zandlo also interested in including climatological data on calendar. Steve Lime began development of a comprehensive DNR Calendar mid-October. Presented to Web Design Committee Oct 21. A subcommittee formed (NREC representatives) to continue design. First meeting scheduled 11/24/97. Steve has incorporated suggested changes and Brent will add some events to the database for each calendar during the week of 12/15/97. Brent added info to the database for State Parks, Hunting and Fishing dates, and some special events. He will train project managers to add info about their workshops in March. Events are also being forwarded too Robert Olson, when appropriate, for inclusion in the SEEK calendar.

#### 4 LCMR capital bonding project reports

Bill Becker and Colleen met with LCMR staff (John Vellin and Susan Thornton) 10/23/97. Goal is to post LCMR Capital Bonding Project Reports in time for the 1998 legislative session. LCMR will provide current list of projects (est. 31). DNR will design html page with links to project reports in PDF format. Colleen contacted Kim Hennings, John Strohkirch and Tom Danger 10/28/97 to request project reports in WP format. Received from Hennings and Strohkirch. Received html page from LCMR (Yvonne Fritchie 6-2668) 12/10/97. Project assigned to Brent 12/16/97. Brent completed interface page and PDF documents for 3 projects.

#### 5 Recreation Compass

Steve designed a PRIM type interface (based on the MapServer software) for access to recreational features including state parks, trails and forests, canoe routes, SNAs, and national parks and forests. Other features may be added.

#### 7 Lake contour maps

Most frequent request from DNR customers on the web. Significant work must be done to prepare the lake maps for presentation on the web. A company called lakemaps.com has purchased a license to produce electronic versions of the maps on their web site. They are charging a \$24.95 annual subscription fee. The map they show as a sample is very simple. We may want to discuss with them what technology and process they are using to create the maps. At this time of year, we should probably schedule roll-out of lake maps for Spring1998. Spoke with Kevin Zytkovicz 10/14/97 about map production. Follow-up with Bob Potochnik (DOW) about conversion of TIFF files. Steve Lime & Tim Loesch have been unable to convert for monitor display and printing. Steve and Bob will continue to explore options. Steve posted TIFF format lake files on line week of 2/9/98 along with links to plug-in viewers and instructions for use. Will continue to explore posting in PDF format. Have received many kudos from the public!

#### 8 State Park maps

High customer demand! Project requires redrawing maps (created in Freehand) that use custom lines not recognized by Acrobat. Possible funding available for a short-term mobility to complete conversion of State Park maps to PDF format. Kelly Randall maybe interested. Received Project Proposal from Suzanne Jenkins 8/25/97. No further work on project as of 12/15/97. Prototype map demo at 1/20/98 Internet Committee meeting. Kelly Randall and Steve Reed completed PDF format maps and Brent posted week of 2/23/98.

#### 9 State Forest information

Darwin Anderson, Steve Lane, Bill Pratt, Bryan Hargrave (Region 3 - Forestry), Meg Hanisch (Forestry - Info Officer), C.B. Bylander (Region 3 - Info Officer) and Colleen Mlecoch (MIS) met in Aitkin to discuss the development of forestry web pages on 4/4/97. Bill Dix, a retired friend of Darwin Anderson, is pulling together general information about forestry and State Forests. He completed an "Idea Draft" 6/23/97. The group met again 9/5/97 at the Cambridge Area Office. A Forestry committee will be designated to continue discussing development of the Forestry web pages. The committee has been appointed, and will meet after 1/1/98. Received prototype pages for state forest information from Darwin 12/22/97. The forestry web committee met 2/26/98. Colleen gave a demo of relevant features of the DNR web (forestry, recreation, ECS, DNR organization. Discussion followed about audience, priorities and content for Forestry web pages. Meg has hired a free-lance writer to begin developing content based on priorities identified.

#### 10 Wild, Scenic & Recreational Rivers

Met with Lyn Bergquist 7/3/97. Received Project Proposal 7/16/97. Lyn will be primary designer for these pages. The project purpose is to educate the public about Minnesota's specially designated waterways, and to encourage citizen involvement in future community-based planning processes involving these rivers. The community-based planning effort is a new approach to river resource management. Interactive forums and event calendars will help to establish and maintain communication between the DNR and the public. Colleen spoke with Lyn 2/20/98. She has not had much time to devote to this project 12/15/97-3/15/98.

#### 11 EBM guide

Met with Jan Wolff 7/15/97 to discuss continuation of the EBM scrapbook project in light of Laurie Sovell moving to another project. Received Project Proposal 7/16/97, and additional information 7/18/97.

3 project abstracts have been submitted to Lynn Wadsworth on WP files for HTML conversion. They include: 1) Eagle Creek Aquatic Management Area; 2) Big Sandy Area Lakes Watershed Project; and 3) Wells Creek Watershed Partnership. Two others are pending final approval by project coordinators: 4) Heron Lake Watershed Restoration Project and 5) Clay County Beach Ridges Forum. Jan estimates that it has taken Laurie Sovell about 100 hours to produce 5 abstracts. That time included compiling a master list of potential EBM efforts to include in the directory - 83 total in 7 different categories. The abstracts were submitted in Word Perfect files. A new staff worker could take the HTML training and write the abstracts. An estimated 25-30 hours per abstract is probably realistic, from inception to "on-line" completion, if the responsible staff worker is a quick learner, has some familiarity with the agency, and is self-directed. Otherwise, the time requirement would probably be closer to 35-40 hours per abstract. With a goal of establishing a base directory of 20 to 25 EBM efforts as soon as possible, a minimum estimate of labor needs is 500 total hours. Jan's opinion is that it would be helpful to have a good representation, both geographically and categorically, of Ecosystem Efforts online by the beginning of the next legislative session. This tool seems to have potential for not only promoting an ecosystem approach and increasing understanding of the principles behind EBM to that audience, but to also demonstrate the quantity of efforts underway where we are working successfully with many different partners towards sustainability goals. If this opinion is shared by others, then it will be important to accelerate the progress of this project. The time requirement per abstract will decrease as the staff worker becomes more familiar with the process, but writing and internal coordination are still labor intensive. Jan is in the process of hiring a student worker to continue the project. No progress report as of 12/15/97

The community-based planning effort is a new approach to river resource 3.3 management. #### EBM Directory 60

Met with Jan Wolff 7/15/97 to discuss continuation of the EBM scrapbook project in light of Laurie Sovell moving to another project. Received Project Proposal 7/16/97, and additional information 7/18/97. 3 project abstracts have been submitted to Lynn Wadsworth on WP files for HTML conversion. They include: 1) Eagle Creek Aquatic Management Area; 2) Big Sandy Area Lakes Watershed Project; and 3) Wells Creek Watershed Partnership. Two others are pending final approval by project coordinators: 4) Heron Lake Watershed Restoration Project and 5) Clay County Beach Ridges Forum. Jan estimates that it has taken Laurie Sovell about 100 hours to produce 5 abstracts. That time included compiling a master list of potential EBM efforts to include in the directory - 83 total in 7 different categories. The abstracts were submitted in Word Perfect files. A new staff worker could take the HTML training and write the abstracts. An estimated 25-30 hours per abstract is probably realistic, from inception to "on-line" completion, if the responsible staff worker is a quick learner, has some familiarity with the agency, and is self-directed. Otherwise, the time requirement would probably be closer to 35-40 hours per abstract. With a goal of establishing a base directory of 20 to 25 EBM efforts as soon as possible, a minimum estimate of labor needs is 500 total hours. Jan's opinion is that it would be helpful to have a good representation, both geographically and categorically, of Ecosystem Efforts online by the beginning of the next legislative session. This tool seems to have potential for not only promoting an ecosystem approach and increasing understanding of the principles behind EBM to that audience, but to also demonstrate the quantity of efforts underway where we are working successfully with many different partners towards sustainability goals. If this opinion is shared by others, then it will be important to accelerate the progress of this project. The time requirement per abstract will decrease as the staff worker becomes more familiar with the process, but writing and internal coordination are still labor intensive. Jan is in the process of hiring a student worker to continue the project. No progress report as of 12/15/97.
