# METROPOLITAN REGIONAL PARKS ACQUISITION, REHABILITATION AND DEVELOPMENT

4(I) \$2,000,000 tf for the acquisition, development and rehabilitation in the metropolitan regional park system, consistent with the metropolitan council regional recreation open space capital improvement plan. The results of the project will include the collection and digitization of all local, regional, state, and federal parks and all off-road trails with connecting on-road routes for the metropolitan area that is illustrated on a printed map available to the public.

**Sec. 17. ADDITIONAL APPROPRIATIONS** The following amounts are appropriated in fiscal year 1999 from the Minnesota Environment and Natural Resources Trust Fund referred to in Minnesota Statutes, section 116P.02, subdivision 6. \$495,000 in fiscal year 1999 is added to the appropriation in Laws 1997, chapter 216, section 15, subdivision 4, paragraph (b) metropolitan regional park system.

## Overall Project Outcome and Results

The key objective of these appropriations is to continue the acquisition, development, and rehabilitation of the metropolitan regional park system, consistent with the Metropolitan Council's regional recreation open space capital improvement plan. Funds from the State appropriation are matched on a 60/40 basis with bonds issued by the Metropolitan Council and then granted to regional park implementing agencies as subgrants. The subgrants financed the following capital improvements:

- 1) Design/engineering work to match a TEA-21 grant for a 3.3 mile trail in Hyland-Bush Anderson Lakes Park Reserve, Bloomington.
- 2) Complete the restoration of the Harriet Island Regional Park picnic pavilion, St. Paul
- 3) Rehabilitate parking/work areas, septic systems and garage at Baylor Regional Park, Carver County.
- 4) Design/engineering work for replacing the bicycle/pedestrian trails, street modifications, landscaping and signage at the Lake of the Isles portion of Minneapolis Chain of Lakes Regional Park, Minneapolis Park & Recreation Board.
- 5) Complete internal park roads, trails, enhance existing beach and picnic area at Rice Creek Chain of Lakes Park Reserve, Anoka County.
- 6) Correct the subgrade and pave a portion of the internal park access road in Lake Minnewashta Regional Park, Carver County.
- 7) Relocate and expand the boat launch at Lake Byllesby Regional Park, Dakota County.
- 8) Partially finance the historic/interpretive displays in the "Mill Ruins" portion of Central Mississippi Riverfront Regional Park, Minneapolis Park & Recreation Board

- 9) Partially finance lighting a 5 kilometer ski trail, constructing a trail bridge over Battle Creek Road plus new trails, parking improvements and restoring oak-savannah and prairie at Battle Creek Regional Park, Ramsey County.
- 10) Partially finance rebuilding 7 miles of paved bike/pedestrian trail in Baker Park Reserve, Three Rivers Park District.

## Project Results Use and Dissemination

With regard to the directive for the Metropolitan Council to collect, digitize and publish a map illustrating all local, regional, state and federal parks and all off-road trails with connecting on-road routes, the Metropolitan Council collected data in 1999 from local governments and other entities. The data was digitized and published in September 1999 by the Lawrence Group in 2000 King of Maps, Twin Cities Metro Street Atlas. This publication is available at bookstores and other map retail outlets. The park and trail data is contained in the updated versions of the atlas for 2001, 2002 and 2003. The partnership approach with a private map publishing company was the only way the data could be published in a format that was useful to the public, and published at an affordable price to the consumer.

ML 1999, Chap. 231, Sec. 16, Subd. 4(I), Metropolitan Regional Parks Acquisition,

\$1,000,000 the first year and \$1,000,000 the second year are from the trust fund to the metropolitan council for subgrants for acquisition, development, and rehabilitation in the metropolitan regional park system, consistent with the metropolitan council regional recreation open space capital improvement plan. This appropriation may be used for the purchase of homes only if the purchases are expressly included in the work program approved by the legislative commission on Minnesota resources. The metropolitan council shall collect and digitize all local, regional, state, and federal parks and all off-road trails with connecting onroad routes for the metropolitan area and produce a printed map that is available to the public. This appropriation is available until June 30, 2002, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

#### **II. PROJECT SUMMARY AND RESULTS:**

Continue financing highest priority acquisition, redevelopment and development projects in the Metropolitan Council's regional parks 1998-99 Capital Improvement Program (CIP) that were not funded in the 1998 Capital Investment bill and to finance highest priority projects in the 2000-01 CIP. The 1999 appropriation financed three park and one trail rehabilitation project, and five park development projects in Anoka County, Bloomington, Carver County, Dakota County, Minneapolis, and Three Rivers Park District. More detailed descriptions of funded projects are shown in section IV: Outline of Project Results.

With regard to the directive for the Metropolitan Council to collect, digitize and publish a map illustrating all local, regional, state and federal parks and all off-road trails with connecting on-road routes, the Metropolitan Council collected data in 1999 from local governments and other entities. ## IV. OUTLINE OF PROJECT RESULTS:

\$825,000 to finance the remainder of the Metropolitan Council's 1998-99 regional parks capital improvement program (CIP) that was not funded in the 1998 Capital Investment bill. \$550,000 of Metro. Council bond funds match the \$825,000. An additional \$1,175,000 of 1999 LCMR funds and \$495,000 added to the 1997 LCMR appropriation finance the highest priority projects in the 2000-01 CIP. No Metro. Council bonds could match the \$1,175,000 and \$495,000 because the Council's bonding capacity would be exceeded.
