Overall Project Outcome and Results

This project was highly successful in providing 170 forest management plans on over 17,000 acres of forests and 9 prairie management plans on 1251 acres of prairies. Management activities were cost shared on an additional 9,000 acres of forest. \$435,894 of matching funds were raised from private landowners, consultants and Global ReLeaf. The management plans set the stage for additional development activity to occur in the near future. This is large enough to a significant benefit to the Minnesota landscape. When a landowner gets involved with the program, the stewardship of that land greatly increases.

The only problem encountered with the program was the freeze on contracts which was imposed from February through May of 2002. This required all the prairie work to be done in June. The balance of \$2,312 would have easily been spent if not for this restriction.

Projects Results Use and Dissemination

The results of this project, be it the writing of a management plan or the cost share of a management activity, keep growing from the initial effort. Word of the benefits of sound natural resource management is spread between neighbors and families. This program has been written about in "Better Forests", the publication of the Minnesota Forestry Association.

Appropriation Language:

(a) Sustainable Woodlands and Prairies on Private Lands - Continuation \$225,000 the first year and \$225,000 the second year are from the trust fund to the commissioner of natural resources in cooperation with the Minnesota Forestry Association and The Nature Conservancy, to develop stewardship plans for private landowners and implement natural resource projects by providing matching money to private landowners. This appropriation is available until June 30, 2002, at which time the project must be completed and final products delivered unless an earlier date is specified in the work program.

No match is required. However, matching funds are used and documented below.

Result A matches will occur as the contracts are let to private sector and non-profit organizations to write the Forest Stewardship plans for the landowners. None of these matches can be quantified before the project begins since project proposals to apply against the LCMR funds will be bid out and the winning bid cannot be predicted.

Result B matches are with landowners implementing projects. Due to the inherent nature of the matches with landowners, many of the matches will occur over the entire time period of the project. All matches will be committed before any LCMR funds are expended. Result B matches will also result from donations from private sector organizations. (See attachment 1 when such matches are raised)

IV. OUTLINE OF PROJECT RESULTS:

Result A-1: Stewardship Plans on Forest Lands

Prepare Woodland Stewardship plans for approximately 350 landowners covering approximately 35,000 acres of forests, wetlands, and brushlands. Actual amount will be dependent on the bids of the plan providers. Plan providers may also bid to provide project plans associated with plan implementation. Project plans provide the detailed information while Forest Stewardship plans provide general, conceptual information and options for landowners.

The Minnesota Forest Stewardship Committee and the DNR will oversee professional standards and training. The Minnesota Forestry Association has requested assistance from the Forest Stewardship Committee for soliciting and selecting successful bidders. (MFA is a member of that committee.)

170 Forest Stewardship plans were written on 17,000 acres of land. The balance of this account was shifted to the cost share practices.

Result A-2: Stewardship Plans on Prairie Lands

Because of the success of stewardship planning in wooded portions of the state, the program will be expanded to the prairie ecosystem as a pilot project. Prepare plans on 50,000 acres of restorable or existing prairies and savannas for 1,000 private landowners. Prairie plan preparer standards and plan criteria will be developed by a coalition led by TNC and MFA in coordination with the Forest Stewardship committee and other qualified staff.

Prairie Stewardship plans, prescribed fire plans, restoration plans, grazing plans and other planning services were provided to 9 landowners in Isanti(1), Washington (3), Sherburne (1), Pope (2), Stevens(1), and Swift (1) Counties for a total of 1251 acres.

Minnesota Forestry Association has requested the Forest Stewardship Committee and the DNR-Division of Forestry establish cost share rates and standards. Historical federal and state program specifications and the desire to avoid competition between programs will be considerations in establishing the rates and priorities. The Forest Stewardship Committee will also specify the kinds of practices which will be priorities for matching funds.

Matching funds will be sought from private sector for-profit and non-profit organizations. These organizations may specify the county (or counties) and practice (or practices) where their funds and the matched funds will be targeted.

Selection and funding distribution to local landowners will be done by the DNR-Division of Forestry at no cost to the LCMR funding.

Match: None legally required, but matches of about \$370,000 are expected and will be documented.

Accomplishments on private lands were matched with a 50% cost share by the landowners. These accomplishments were as follows: tree seeding – 152 acres; tree planting – 2,090,281 trees planted on 3490 acres; timber stand improvement on 1683 acres; bud capping on seedlings on 175 acres; 735 tree shelters; 8662.5 feet of fencing; grass and forb seeding on 127 acres; nest boxes – 352; wildlife openings – 10 acres; prescribed burning on 79 acres; planting site preparation on 2109 acres; tree mats – 10,170; 6 acres of wetland restoration; 4 water facilities created; 6640 feet of trails created.

V. DISSEMINATION:

Each participating landowner will receive a personal Forest Stewardship plan or Prairie Stewardship plan for their property based on their goals and the capacity of the land. The partner organizations will play a big role in advertising and disseminating the information. Each landowner will also have the chance to rate the plan and service they receive in an effort to constantly upgrade such service. To date, landowners have been very happy.

VI. CONTEXT:

A. Significance:

Result A: Non-industrial private landowners own 40% of the forest land in Minnesota. A

goal of many organizations including DNR-Forestry, the Forest Stewardship Committee, and the Minnesota Forestry Association is to assure that the landowners of 50% of the land (in parcels over 20 acres) are receiving professional assistance as demonstrated by a Forest Stewardship plan. This 50% goal covers 2,500,000 acres and is aggressively set to be achieved by 2005. Over 800,000 acres of Forest Stewardship plans have been prepared since 1991. As a continuation, this funding will help maintain the 100-120 thousand acre per year level that is underway.

The prairie portion of the project is an expansion of the concept that has been so successful in the wooded landscape. It is hoped by all partners that the funding will initiate a pool of private sector professionals who can assist the ongoing efforts to advise landowners in the prairie landscape areas.

Result B: Since October, 1998, cost-share funding for forestry has taken a sudden drop when the federal Stewardship Incentive Program (\$200,000/yr) and the state cost-share (\$275,000/yr) were eliminated. There is also a high demand from the increasing number of program participants. The cost-share provided by this project will be a vital source of incentives to achieve desirable activities recommended in the plans.

B. Time: Project will be completed within 3 years of initiation.

VII. COOPERATION:

Gerald Rose -DNR-Division of Forestry field staff will provide day-to-day program assistance. About 30 full-time-equivalents (FTEs) work on private land assistance. No cost to LCMR. These 30 FTEs not included in budget context above.

Thomas Kroll -DNR-Forestry; Forest Stewardship Committee Chair; Committee will screen funding applicants. Kroll will work 15% on this program. No cost to LCMR.

Larry Himanga - DNR-Forestry Incentives Programs specialist; 35% of his time of this program. No cost to LCMR.

MN Association of Consulting Foresters, other consulting foresters, and private sector biologists and ecologists will bid to prepare plans. An estimated 6+ FTEs will be involved. \$240,000 of LCMR funds.

Jim Lemmerman - Board of Water and Soil Resources (BWSR) and Minnesota Association of (91) Soil and Water Conservation Districts agree to be involved

Dave Shad -DNR-Section of Wildlife staff will be involved. No cost to LCMR.

Peter Buessler of DNR-Wildlife will spend about 15% of his time on the project. No cost to LCMR.

Lee Pfannmuller of DNR-Ecological Services will be involved. No cost to LCMR.

Natural Resource Conservation Service (NRCS) and U.S. Fish and Wildlife Service (USF&WS) will be involved. No cost to LCMR.
