Overall Project Outcome and Results

The first objective of this project was to restore and develop up to 270 acres of habitat corridors suitable for whitetail deer and other wildlife through various management practices at an average cost of \$300 per acre. The second objective was to acquire 800 acres of habitat from willing sellers to expand/create habitat corridors suitable for whitetail deer and other wildlife. Acquired parcels would be donated to the MN DNR or other suitable public land management agency.

A total of 204 acres of land, for which the Trust Fund was a source, was restored in 8 of the habitat corridors utilizing \$40,540 in the restoration appropriation (2a) at an average cost of \$195 per acre. An additional 75.2 acres were restored in 2 habitat corridors utilizing matching funds of \$5,895 at an average cost of \$78 per acre. Total acres restored met projection with cost per acre below projected costs. These projects will provide improved habitat that will enhance both game and non-game wildlife well into the future providing an increase opportunity for recreational activities.

A total of 116.6 acres were acquired in 3 habitat corridors utilizing \$210,000 of the acquisition appropriation (4b) at an average cost of \$1,803 per acre. An additional 92.7 acres were acquired in 5 habitat corridors utilizing matching funds of \$140,014 at an average cost of \$1,504 per acre. Cost per acre was substantially higher than projected due to location of land being in areas of increasing development and value. This decreased the amount of land purchased with appropriated funds. These acquisitions have increased the public land available for outdoor recreation in the habitat corridors by placing this land in the public trust. This increased land base will provide protection of important habitat and continued recreational opportunities for the people of Minnesota.

\$5,873,000 the first year and \$5,872,000 the second year are from the trust fund to the commissioner of natural resources for acceleration of agency programs and cooperative agreements with Minnesota Waterfowl Association, Minnesota Deer Hunters Association, Ducks Unlimited, Inc., National Wild Turkey Federation, Pheasants Forever, The Nature Conservancy, Minnesota Land Trust, Trust for Public Land, U.S. Fish and Wildlife Service, Bureau of Indian Affairs, Natural Resources Conservation Service, and the U.S. Forest Service to restore and acquire fragmented landscape corridors that connect areas of quality habitat to sustain fish, wildlife, and plants. \$352,000 is for program coordination, corridor identification, and mapping. \$3,343,000 is for restoration and management activities in wildlife

management areas, wetland habitat, lakes, wild rice beds, grasslands, and fisheries habitat. \$2,650,000 is for conservation easement programs on riparian areas, big woods forests, native prairies, and wetlands. \$5,400,000 is for habitat acquisition activities on prairies, riparian areas, and other fish and wildlife habitat corridors. As part of the required work program, criteria and priorities for planned acquisition and restoration activities must be submitted to the legislative commission on Minnesota resources for review and approval. Land acquired with this appropriation must be sufficiently improved to meet at least minimum management standards as determined by the commissioner of natural resources. Any land acquired in fee title by the commissioner of natural resources with money from this appropriation must be designated: (1) as an outdoor recreation unit under Minnesota Statutes, section 86A.07; or (2) as provided in Minnesota Statutes, sections 89.018, subdivision 2, paragraph (a); 97A.101; 97A.125; 97C.001; and 97C.011. The commissioner may so designate any lands acquired in less than fee title. This appropriation is available until June 30, 2004, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

II. and III. FINAL PROJECT SUMMARY

The second objective was to acquire 800 acres of habitat from willing sellers to expand/create habitat corridors suitable for whitetail deer and other wildlife. Acquired parcels would be donated to the MN DNR or other suitable public land management agency.

A total of 204 acres of land, for which the Trust Fund was a source, was restored in 4 of the habitat corridors utilizing \$40,540 in the restoration appropriation (2a) at an average cost of \$195 per acre. A total of 116.6 acres were acquired in 3 habitat corridors utilizing \$210,000 of the acquisition appropriation (4b) at an average cost of \$1,537 per acre. An additional 92.7 acres were acquired in 5 habitat corridors utilizing matching funds of \$140,014 at an average cost of \$1,504 per acre. Cost per acre was substantially higher than projected due to location of land being in areas of increasing development and value. This decreased the amount of land purchased with appropriated funds. These acquisitions have increased the public land available for outdoor recreation in the habitat corridors by placing this land in the public trust. This increased land base will provide protection of important habitat and continued recreational opportunities for the people of Minnesota.

IV. OUTLINE OF PROJECT RESULTS

The Minnesota Deer Hunters Association originally had \$210,000 allocated for restoration projects for Phase 1. In January 2004, MDHA reallocated \$169,460 to the partnership for other projects.

Result 1: #1 Aspen Parklands Project Area

Appropriation used in restoration and habitat improvement efforts on Thief Lake WMA, Jacksnipe WMA, and the Higginbotham WMA.

The Higginbotham WMA project created a 10-acre food plot for wildlife. This plot will be maintained for wildlife in the future. The Jacksnipe WMA project regenerated a 20-acre overgrown brush community. The Thief Lake WMA project renovated 3 existing old fields into a wildlife openings planted with a grass legume mixture.

Result 2: #2 Mississippi Headwaters Project Area

No activity in this habitat corridor.

MDHA matched \$10,000 in trust fund money with \$10,000 in Hide for Habitat funds in partnership with Pheasants Forever to complete the financial commitment on the Eldorado WMA purchase. MDHA utilized \$50,000 to partner in the acquisition of an additional 300 acres for the Doran WMA. MDHA was one of 20 partners in acquiring the property.

The Eldorado WMA and the Doran WMA additions consist of cropland and wetland areas mixed with small woodlots. These properties will provide a variety of habitat for deer, pheasant, turkey, waterfowl, and non-game wildlife.

Result 4: #4 Central Lakes Project Area

Trust fund money was used to restore and improve the habitat on 35 acres of the Four Brooks WMA.

The Four Brooks WMA project included the seeding of 35 acres of a newly developed trail and field to a legume/grass mixture. The new seeding will provide high quality deer, turkey and grouse forage. This unit had no existing wildlife openings.

Result 6: #6 Upper Minnesota River Project Area

No activity in this habitat corridor.

Result 7: #7 Alexandria Moraine Project Area

Monies were used to assist in the purchase of a 300-acre parcel to be known as the Regal Flats WMA.

This parcel was purchased with \$10,000 in MDHA funds in partnership with other wildlife organizations. This land lies outside of the project area by 4.63 miles and is reported only as MDHA matching funds.

The Succonix WMA project included the restoration of 11 acres of older brome grass field within the Big Woods hardwood forest by planting bare root seedlings of white, red and bur oak. The Corinna WMA project included a similar restoration of 10 acres of grass field to the same oak species.

MDHA partnered with Pheasants Forever and MN DNR in purchasing an 80 acre parcel of land which added 120 acres to the Manannah Wildlife Management Area. MDHA used Hide for Habitat money to match partner dollars.

Matching funds were used to acquire and restore the Flatgard parcel in Jackson County, and add 32 acres to the existing Banks WMA in Cottonwood County. The Flatgard property will be owned and managed by MDHA, but open to public use (hunting, fishing, wildlife watching, etc.). The Flatgard and Banks WMA's are particularly important because it includes sensitive watershed areas, and protects the WMA from suburban encroachment.

MDHA had to pay \$5,534 in additional interest that accrued due to a prolonged acquisition process by the MN DNR. These funds could not be matched with trust fund monies.

The Sauber Woods project included direct seeding of oak acorns, walnuts, and green ash over 8 acres of a previously cultivated field. The seeding provides increased mast and woody cover for a variety of wildlife.

MDHA used matching money to purchase 2 acres, protecting approximately one mile of shoreline on Horseshoe Lake in LeSueur County. The 80 acre parcel also contains hardwood stands and old fields that will provide habitat for multiple species of wildlife.

The Gribben Valley project included timber stand improvement through chemical release. The Pease WMA project included the hand planting of 2,250 assorted oaks to develop a future mast crop for wildlife. The Hammel Tract (a) is part of the Richard Doerr Hardwood Forest. The project include the planting of 18,000 white oaks, 18,000 red oaks, and 5,000 black walnut on 52 acres. A second project on the Hammel Tract (b) was to release young red and white oak from competing woody vegetation through felling, girdling and herbicides on 14 acres. The project on the Whitewater WMA included planting 31 acres with 22,500 seedlings (bur oak, green ash, cottonwood, walnut, silver maple, and white pine) after the completion of a timber sale.

VI. PAST, PRESENT, AND FUTURE SPENDING

A. Past Spending

Since 1985 the Minnesota Deer Hunters Association has dedicated \$1.8 million dollars toward habitat acquisition, wildlife research, and habitat restoration. To date MDHA has not used any of our allotted CH-01 funding.

B. Current and Future Spending

The long-range goal for the Minnesota Deer Hunters Association was to restore and develop up to 270 acres (2a) and acquire 800+ acres of land from willing sellers to help create and expand wildlife corridors. All appropriated trust fund money totaling \$250,540 have been spent on projects. MDHA has matched the trust fund expenditures with \$135,909 for these same projects. MDHA has also used funds in the form of MDHA staff salary, mileage, and office logistics on projects dealing with LCMR CH-01 project areas.

Individual Chapters of Minnesota Deer Hunters Association, Ducks Unlimited, Inc., National Wild Turkey Federation, Pheasants Forever, local sporting/conservation and civic groups.

All projects were completed by June 30 2004.

VIII. LOCATION

Wildlife habitat was acquired and restored within the established habitat corridors for the purpose of developing and improving habitat for white-tailed deer and other wildlife and plant communities.

Progress reports have been submitted to the Legislative Commission on Minnesota Resources on May 31, 2002, November 30, 2002, March 30, 2003, and November 30, 2003. This is the Final Work Program Report.
