#### FY 2010: A Momentous Year for the East Central Arts Council!

This year, FY 2010, was not just the 30<sup>th</sup> anniversary of the East Central Arts Council advisory committee. The Arts Council also successfully undertook 2 major accomplishments in addition to providing existing services! ECAC initiated the Region 7E Arts and Cultural Heritage Legacy Fund, and the Arts Council committee with the East Central Regional Development Commission board, decided that the Council will become an independent non-profit organization.

## Arts and Cultural Heritage Legacy Fund -

The East Central Arts Council (ECAC), currently a program of the East Central Regional Development Commission, in FY 2010 as one of Minnesota's designated Regional Arts Councils, was entrusted with stewardship of new funding through the State of Minnesota's Arts and Cultural Heritage (ACH) Legacy Fund. Proceeds from the fund may be spent only on arts and arts access, arts education and arts and cultural heritage. The Legacy Fund is intended to create a strong arts legacy in Minnesota and will exist for a period of twenty-five years.

ECAC members felt it was incredibly encouraging to be able to offer support for worthwhile arts projects that were found by the grant review panels to all be of a very high artistic caliber and which also support the regional economy in these hard economic times. The awarding of the FY 2010 ECAC ACH grants, the first Arts and Cultural Heritage Fund grants, represented the culmination of a year and a half long process of gathering input from the public about the best use of the funds in our region, revising the Biennial Plan and developing the new grant programs. It also included extensive work with grant applicants during both the ECAC program planning and their grant submission processes. Non-profit organizations, community groups, units of government, public schools and individual artists were all eligible to apply. Of the 39 applications received 20 ACH projects were funded. A total of almost \$300,000 dollars were requested from ECAC in this grant program which exemplified a huge demand for arts programming. Funds granted were about \$130,000 and only the top ranked projects were funded. In addition, as part of the ECAC ACH program, the Arts Council initiated a public art program with Forecast Public Art. This partnership included 3 public art grants awarded to artists in Region 7E, 2 public art workshops in the Region, and work on a public art toolkit. Literally thousands of regional community members are benefitting from this ECAC ACH funding.

This new East Central Arts Council Arts and Cultural Heritage Legacy Fund programming was made possible by the Minnesota arts and Cultural Heritage Fund as appropriated by the Minnesota State Legislature with money from the vote of the people of Minnesota on November 4, 2008.

## East Central Regional Arts Council -

In FY 2010 the East Central Regional Development Commission (ECRDC) and the ECAC, as part an extensive planning process and consultant study with attorney Tom Triplett, decided that in order to better serve its mission the Regional Arts Council will no longer be a program of the ECRDC. The new East Central Regional Arts Council (ECRAC) will establish itself as a non-profit and will become independent of the ECRDC as of July 1, 2011. While ECAC will miss the leadership and collaboration it has had as a program of the ECRDC, the members are also very excited about the new

arts funding opportunities and arts programming this transformation will provide for Region 7E. ECRAC will have both a new location and website as of this date and will continue to provide grants and services to the arts community during the transition.

#### **ECAC Mission –**

The mission of ECAC is to improve the quantity and quality of arts experiences in Region 7E (the Minnesota Counties of Chisago, Isanti, Kanabec, Mille Lacs and Pine) by facilitating the production, presentation, and dissemination of art development for arts organizations and by promoting the growth of individual artists. ECAC accomplishes its mission through programs and special initiatives for artists and arts organizations. Goals of the ECAC include improving the arts experiences in the region, increasing awareness of the arts, making the arts available to those who desire exposure to the arts, and promoting greater communication among the community of artists and art organizations. Carrying out the responsibilities of a regional arts council, the ECAC was involved in work activities designed to meet these goals. The East Central Arts Council, is currently a program of the East Central Regional Development Commission, accomplishes its mission through the implementation of programs and services identified in its biennial plan.

#### **ECAC Activities –**

The FY 2010 work program of the Regional Arts Council included the following: revision of the Biennial Plan, approved in December 2009; the East Central Arts Council Arts and Cultural Heritage Legacy Fund grants for organizations and individuals; Art Projects Assistance; Art in Our Schools; Small Grants Program; Image-the annual regional art show hosted this past year by the Pine Center for the Arts and in 2010 by the Isanti County Historical Society; McKnight/ECAC Individual Artist and Fellowship Grant Programs; the Scholarship Program for K - 12 kids; started development of a new ECAC standalone website; and assistance was provided by hosting various grant workshops, providing technical assistance and arts resource information. ECAC's mission, vision and values are at the heart of the programs and grantees funded. ECAC's grantee partners are at the

forefront of the work to enhance the arts environment in Region 7E. It is the artist's and arts organization's daily work and commitment that expands arts opportunities, increases the quality of life, and enhances the community/economic development in the region.

In FY 2010 ECAC sponsored a series of 5 skill-building workshops led by Springboard for the Arts. ECAC also sponsored 2 Forecast Public Art Workshops in the Region. In conjunction with the Minnesota State Arts Board ECAC hosted 2 art grant information sessions. ECAC also had 43 art grant information sessions throughout the region. Many potential applicants were in attendance at these sessions and they learned more about ECAC arts funding sources and services. ECAC was featured on MPR after a "Rural Urban Connections" USDA/Minnesota Rural Partners videoconference highlighting the arts. Additionally, the Director of the East Central Arts Council also provided staffing services for the Forum of Regional Arts Councils of Minnesota (FRACM,) the statewide organization of Regional Arts Council Directors. This staffing was provided through July -October for both FRACM business meetings and best practices sessions.

The Arts Council also continues to provide other important services for the region. In FY 2010 ECAC finalized the arts needs assessment and using surveys, focus groups, and grantee input finalized the ECAC Arts and Cultural Heritage Fund program in Region 7E. The East Central Regional Development Commission newsletter was not published in FY 2010 but ECAC programming was highlighted on the ECRDC website www.ecrdc.org. This provides the region with information about the Arts Council's programs, constituent highlights, resources available to the arts community, and unique regional projects.

ECAC continued the *Essential Arts* e-newsletter. The e-newsletter is an e-mail focused on ECAC activities and opportunities but it also includes interesting arts issues and arts news. ECAC has an e-newsletter because of the distinct advantages over a printed newsletter: timeliness and cost. There are now 600 people on the e-newsletter mailing list which is an increase of 220 in the last two years.

ECAC is utilizing social media in addition to traditional media sources. In FY 2008 ECAC initiated both a myspace.com page and a blog and these were continued this year. In FY 2010 ECAC initiated a twitter.com and Facebook pages. It is felt that social media is an important way to get the word out about ECAC services especially to younger constituents. Work

also started on a standalone ECAC website in FY 2010. ECAC decided to work with Dan Moriarty Consulting on building this new resource.

ECAC, because of the increased workload in FY 2010, and per the Work Program did hire a part-time staff person to assist.

Individual Artist Grants & Artist Fellowships - The McKnight/ECAC Individual Artist grants are for artists in the region wanting to expand their artistry with a specific arts project. The Fellowship Program is designed to recognize, reward, and encourage outstanding professional artists. Funding for these programs are provided by The McKnight Foundation. This year ECAC awarded over \$17,000 in artist grants/fellowships to artists in Region 7E.

Art Scholarships for K-12 Students – Region 7E has a lot of young, talented, and energetic artists deserving recognition. As a result, the ECAC, with funding through The McKnight Foundation, offered students in grades K - 12 a scholarship opportunity to further their artistic skills. This year the Council recognized students with over \$1,800 in Scholarships. Due to funding priority changes at The McKnight Foundation this will be the last year of this current program. The Arts Council will be working toward re-establishing this popular program in the future.

Art in Our Schools Grants - Schools may apply to the East Central Arts Council to help fund special art projects related to the curriculum. The funds can support artist residencies, art related field trips, or any special school arts-focused project. This year ten grants were funded in schools throughout Region 7E. The total amount of grants was almost \$10,000 for school projects.

Art Organization Project & Small Grants - These ECAC programs award grants for local or regional arts and cultural projects sponsored/coordinated by organizations, schools, units of government, or non-profits. Funds are available for a variety of arts projects that develop or enhance local arts organizations, artists, or art audiences. Small Grants of up to \$500 and Art Organization Project Grants up to \$5,000 are considered. The grants are awarded only with a one-to-one financial match. The grants this year amounted to over \$45,000. The total project costs were over \$130,000.

Information on all of the ECAC grant funded programs can be found in the appendix.

Keep in mind that, per the May report, to MSAB ECAC does have some FY 2010 carryover funds. It is anticipated that these will be completely spent by the end of FY 2011.

## Special Thanks and Happy 30th Anniversary –

A special thanks this year went out to the East Central Arts Council advisory committee members and all the ECAC volunteers for a truly rewarding and productive year! All of the progress of the Arts Council in FY 2010, and throughout the last 30 years, would not have been possible without their commitment, support, and efforts. The Arts Council truly has been able to forward the mission of serving the arts community and all Regional 7E communities through the arts. It could not have happened without them!

The Legislative block grant funds with the Minnesota State Arts Board as our fiscal agent continue to be the cornerstone for the implementation of East Central Arts Council programs in Region 7E. The Arts Council thanks the Minnesota State Arts Board members and staff for this productive partnership.

## **EVALUATION/MONITORING OF GRANTS**

The East Central Arts Council follows a multi-step process regarding grant reviews and evaluation. As requested, staff initially works with applicants on their draft applications especially those grant applications needing revisions. Applications are then submitted to the Arts Council and are reviewed individually during the grant round. Applications are ranked/prioritized according to criteria published in the grant program information. Funding is allocated based on the ranking and program information. Art Organization project grants and Art and Cultural Heritage Fund grants approved by the Arts Council are then submitted to the East Central Regional Development Commission for final approval or review.

Grantees are required to submit a final report within 60 days of the completed project. The Arts Program Director and the RDC's Finance Officer or assistant conduct reviews of the final reports. Arts Program funding is included in the annual audit of the East Central Regional Development Commission.

# East Central Arts Council Final Report Fiscal Year 2010 Results of Work Program

# GOAL I - Provide Grant Programs that allow for the production or sponsorship of art by organizations, communities, schools, artists, and youth.

#### Work Elements:

- 1) Developed and implemented new program/s, for organizations and individuals, for the Arts & Cultural Heritage (ACH) Fund grant program. There were two grant deadlines.
- 2) Conducted two grant reviews for arts organization projects.
- 3) Conducted Small Grant program with four grant deadlines to fund projects that are sudden opportunities.
- 4) Provided the Art In Our Schools program, which provides funding for arts project within educational facilities (four grant deadlines.)
- **5)** Held three grant rounds for project applications from individual artists for project grants. (McKnight Funding)
- **6)** Conducted fellowship program to fund artistic fellowships on an annual basis. (McKnight Funding)
- 7) Sponsored annual scholarship program for K 12 students. (McKnight Funding in FY 2010)
- **8)** Provided technical assistance and funds for Image, the regional art exhibition.(McKnight & State Funding)
- **9)** Utilized the Minnesota State Arts Board Information System Database to track grant applicants and to report activity and track outcomes.
- **10)** Kept records of all grant activities and grant outcomes through grant file documentation.
- **11)** Evaluated all grant programs and applied needed changes to the ECAC ACH Fund grant program for FY 2011.

#### GOAL II - Provide technical workshop opportunities for artists and arts organizations.

#### Work Elements:

- 1) Distributed arts resource information as needed and requested.
- 2) Provided an arts information area in the ECRDC offices.
- 3) Provided services and technical assistance for www.mnartists.org. (McKnight funding)
- 4) Arranged five developmental workshop for artists.
- 5) Provided two organizational workshop for arts organizations.

6) Provided 45 grant workshops for artists and arts organizations.

# **GOAL III - Provide staffing for technical support and other services to artists and art organizations in the Region.**

#### Work Elements:

- 1) Provided technical assistance to applicants in all funding program areas as requested.
- 2) Continued to develop working relationships with minority artists living in the region such as the one with the Mille Lacs Band of Ojibwe Corporate Commission and arranged a grant workshop at their site in Vineland.
- 3) Continued the working relationship with the VSA MN to assist the Council in serving disabled artists and patrons in the region.
- 4) Continued to arrange for the use of the Walker Display standards and pedestals for artist/art organization use. (McKnight funding)
- **5)** Continued to work on the mail and e-mail distribution list for delivery of arts information and public service announcements.
- **6)** Continued the e-newsletter *Essential Arts*, the ECAC blog, continue to improve the social networking services for ECAC.
- **7)** Participated in the arts leadership activities including participating in meetings and activities of the Regional Arts Council Forum and the Minnesota State Arts Board.
- **8)** Completed all necessary annual reports to the Minnesota State Arts Board and The McKnight Foundation.
- 9) Continued outcome evaluation of programs via grantee assessments from final reports.
- **10)** Researched and disseminated various foundation and governmental grant opportunities for the purpose of expanding arts opportunities in the region.

# GOAL IV- Pursue feasibility of the East Central Regional Arts Council becoming an independent 501(c)3 non-profit organization, with the intent to do so by FY 2012.

#### Work Elements:

- 1) Met with other Regional Arts Council Directors who have recently made the decision to amicably leave their RDC and become 501(c)3 non-profits (Region 1, 2008, and Region 5, 2006). Regions 3 and 9 were also on the conference call with our consultant.
- 2) Researched and planned for 501(c)3 non-profit determination.
- 3) Reviewed information developed by attorney Tom Triplett on the financial, legal, physical, board, cost and staffing aspects to ensure that 501(c)3 status best serves the ECAC constituents.

- **4)** Benchmarked best practices at other Minnesota Regional Arts Councils which are 501(c)3 non-profits.
- 5) Developed new grant program guidelines and grant-making/monitoring procedures, as needed.
- **6)** Researched a comprehensive website/media destination for ECAC and entered into a contract with Dan Moriarty consulting to develop the new standalone ECAC website.
- **7)** Researched and disseminated various foundation and governmental grant opportunities for a 501(c)3 for the purpose of expanding arts opportunities in the region.
- 8) Developed a request for proposal for a private consultant to assist and advise ECAC in this process. Fieldstone Alliance originally got the contract and after the organization dissolved ECAC/ECRDC opted to continue working with attorney Tom Triplett.
- 9) Developed a new mission statement for a 501(c)3 organization because that was the structure recommended by the consultant and chosen by ECAC and ECRDC for the fiscal year starting July 1, 2011.

#### **Impact**

There were 55 Area arts organizations, schools, community groups, etc., enabled to provide new and/or additional arts programming as a result of receiving technical assistance and/or project funding provided through the ECRDC Arts Council program. Over 180 regional artists were provided opportunities to show/display their art through the IMAGE Art Show during FY 2010. Twenty-three individual artists received ECAC grant funds to either further their artistic career or for a specific arts project.

Approximately 500 artists and 1500 others interested in the arts/arts activities became more informed about local and regional arts activities and opportunities through public service announcements, e-newsletters, outreach activities, the website, the blog, the myspace page, twitter, direct mailings, and other activities of the Arts Council. The ECAC blog alone has had over 1,987 views online and it is felt this is a new tool to reach constituents. Another new social media addition this year was the East Central MN Regional Arts Council Facebook page. There are 50 fans of the page at this point.

ECAC tracks requests for Regional Arts Council information and services by staff. In FY 2010 there were a total of 2,006 e-mails requests to ECAC/ECRDC staff and another 636 phone call requests. In addition, ECAC sponsored grant workshop and networking events for individual artists and arts organization representatives. In conjunction with the Minnesota State Arts Board ECAC hosted two art grant information sessions. ECAC also had forty-three art grant information sessions throughout the Region this year. Many potential applicants were in attendance at these sessions and they learned more about potential arts funding sources. Over 200 people participated in these meetings.

From July until October the staffing position for the Regional Arts Council Forum of Minnesota was located at the East Central Regional Arts Council. ECAC's support of the Forum of Regional Arts Councils of Minnesota, with staffing time at about 8 hours per week, helping the organization get through a critical and growing time. This stable staffing service is ensured further growth of the organization, stability, and is allowing FRACM to become an even more effective statewide provider of arts resource services. In October it was decided that ECAC staff needed to focus on the growth of ECAC services.

Residents of and students in the East Central Region have benefitted by having opportunities to view/participate in additional arts programming supported by Arts Council funding.

ECAC Staff participated in 6 meetings of the East Central Regional Development Commission, and all Regional Arts Council Forum meetings plus Strategic Planning sessions with the Minnesota State Arts Board.

The East Central Regional Arts Council will become an independent 501(c)3 non-profit for FY 2012 because it was found by the Arts Council and the East Central Regional Development Commission that this would benefit the constituents of the East Central Region.

The ECAC initiative to encourage an ECRDC cash match for the arts program, (as other ECRDC programs have) had a very positive and real impact in Region 7E. There had been a stepped increase in the ECRDC match to ECAC in FY 2006 it was \$5,000 and in FY 2007 it was \$10,000. FY 2008 and FY 2010 saw the full annual match of \$15,000 and this funding was important income for the Arts Council. Unfortunately for FY 2011 the ECRDC board decided to return to a -0- cash match for the Arts Council.

#### GOAL V- Implement the ECAC Arts and Cultural Heritage Fund.

Work Elements:

- 1) Developed and implemented the new Arts and Cultural Heritage Fund grant program for organizations and individuals. ECAC will had funding available in the three general Arts and Cultural Heritage Fund areas of Arts and Arts Access, Arts Education, and Arts and Cultural Heritage.
- 2) Distribution of the Arts and Cultural Heritage Fund in Region 7E was granted exclusively with new programs and services in Region 7E. Current ECAC grant programming and services will continue to be funded out of the State General Fund or McKnight Fund allocations.
- 3) Developed and utilized the grant proposal application process for the distribution of Arts and Cultural Heritage Funds in Region 7E. Grant applicants identified which of the fund area or areas their grant will target. This grant application form was on the existing and will be on any new ECAC web page.
- **4)** Worked with groups such as the Forum of Regional Arts Councils of Minnesota, Forecast Public Art, Springboard for the Arts to provide additional arts related services in Region 7E.
- 5) Targeted distribution of the Arts and Cultural Heritage Fund in Region 7E ECAC was to proposals from individual artists, organizations, units of government, 501(c)3 non-profits, and schools. ECAC did NOT accept proposals from for profit businesses or projects, religious organizations, or organizations trying to influence public policy.
- 6) ECAC/ECRDC implemented revised grant review procedures allowing for grant review panels to be used for Arts and Cultural Heritage Fund grants. Staff trained the grant review panels and their recommendations will be used by the ECAC and the ECRDC.
- 7) Marketing for the Arts and Cultural Heritage Fund in Region 7E included public service announcements, paid ads, use of the ECAC newsletter and blog, and social networking. ECAC plans to work with a marketing specialist to ensure photographs and stories regarding Arts and Cultural Heritage Fund projects are developed and distributed to the Region 7E media.

- 8) Outcome evaluation for all grantees was required and ECAC staff is ensuring this documentation is taking place. ECAC is utilizing consultant Dr. Patricia Shifferd to assist grantees with the outcome evaluation requirement. All outcomes are being reported to ECAC and are a reporting requirement.
- 9) ECAC will revised the ECAC ACH Fund grant guidelines for Region 7E at the end of FY 2010 and will continue to use this approach and develop more specific granting programs, if necessary.

#### **ECAC ACH Work Program Goal V Outcome Evaluation Criteria**

In FY 2010 ECAC developed a base line of the number of applicants for ECAC Arts and Cultural Heritage Fund grants and services. This base line was 29 applicants. This base line number will increase by at least 20% in FY 2011. This is being measured by the ECAC grantee database.

In FY 2010 & 2011, of those receiving grants and services from ECAC, 75% will indicate that their project had artistic merit and had community impact for the target constituency. This will be measured by grantee final reports and ECAC is meeting this outcome with reports submitted thus far.

By the end of FY 2010 ECAC provided marketing and/or public awareness services for 21 ECAC Arts and Cultural Heritage grant recipients (the goal was 8.) In FY 2011 the goal ECAC will provide marketing and/or public awareness services to minimum of 12 grant recipients. This will result in and increased awareness of the arts in the ECAC region. This is being measured by staff tracking of publicity and/or social media releases.

By the end of FY 2010 ECAC will hold 1 workshop with 75% of the attendees responding that they were impacted favorably. This goal was met. By the end of FY 2011 ECAC will hold 3 workshops with 75% attendees responding that they were impacted favorably. This is being measured by an exit survey.

By the end of FY 10 there will be a minimum of 10 support meetings held with constituents interested in the ECAC Arts and Cultural Heritage Fund. This goal was exceeded. By the end of FY 2011 there will be a minimum of 15 individual support meetings held with constituents interested in the ECAC Arts and Cultural Heritage Fund. 75 % of constituents will indicate that these meetings were beneficial. This is being measured by a constituent survey.
