The Minnesota Legislature, during the 2009 Session, adopted legislation and appropriated \$500,000 each year of the 2010/2011 biennium to the Department of Employment and Economic Development (DEED) to be used as a grant to Enterprise Minnesota. Enterprise Minnesota is a non-profit organization, based in Minneapolis, serving all of Minnesota.

In December 2009 and September 2010, DEED entered into grant agreements with Enterprise Minnesota to establish and operate a small business Growth Acceleration Program (GAP). Under Minnesota Statutes 1160.115, the GAP was established to provide direct matching funds totaling \$500,000 (subsequently reduced through legislative budget reductions to \$485,000 and \$475,000, respectively, for each of the fiscal years of the biennium), to help small manufacturing companies that need assistance to stay in business, grow and compete. Funds are used to deliver Enterprise Minnesota's services to these companies.

Growth Acceleration Program funds are targeted to assist qualified firms with the following activities:

- A. Bridging the gap between standard market pricing for technology business improvements, and the amount qualified companies can afford to pay.
- B. Helping qualified companies, including manufacturing and related industries that employ up to 250 full-time workers.
- C. Awarding funds not to exceed 75% of project costs or \$25,000 for any project or \$50,000 for any company during the calendar year.
- D. Aiding eligible firms to foster business improvements, increase job creation and job potential, and contribute to the quality of life of citizens and communities throughout Minnesota.

The GAP is required to submit an annual report. Enterprise Minnesota reports that it has:

- Disbursed \$353,295, and matched it with \$263,130 provided by the assisted companies.
- Approved total projects with 64 clients for the full \$485,000 on the FY10 program, and projects with 23 clients representing \$98,000 of the \$475,000 on the FY11 program. At the end of December 2010, 79 of the GAP participants were working on or completing some portion or all of their improvement plans.

- Based on past client outreach, estimates an average return of \$15 for every \$1 invested in the program. Estimates are based on similar services and companies surveyed by an independent third party. In 2010, 184 companies surveyed by Enterprise Minnesota Inc. attributed increased sales, cost reductions, investments, and jobs created or retained totaling \$63 Million due to their assistance from the program.
- Examples of consulting services delivered by Enterprise Minnesota Inc. to GAP Clients include: Value Stream Mapping, Lean Enterprise Programming, Business Management-Financial Analysis and Budgeting, Workplace Organization, Business Management Services, Corporate Strategic Planning, Business Process Review, Strategic Planning-Situation Analysis, and Operation Excellence, Marketing and Innovation Management.
- Final report will be provided to the Legislature following the completion of the grant period, which ends June 30, 2011. That report will include an estimate of the financial effect of funds awarded to each company receiving service under the program, as prescribed by M.S. 1160.115, Subd. 6.
