SUMMARY

The following progress report, submitted to the Minnesota Legislature and prepared by the Minnesota Department of Veterans Affairs, provides a status update on the Higher Education Veterans Assistance Program for the period of January 1 to December 31, 2010. The report reflects the program's continued growth and increasing demand, due largely to increasing complexity of federal benefits as well as continued deployments of Minnesota based military units.


PROGRAM BACKGROUND AND GROWTH

The 2006 Minnesota Legislature allocated funding through June 30, 2011 to the Minnesota Department of Veterans Affairs for the creation of the Higher Education Veterans Assistance Program (commonly referred to as the "Higher Education Veterans Program"). The program is uniquely designed to serve the needs of Minnesota's students and prospective students that are impacted by military service, including Veterans, military members, and their dependents.

One statewide director and twelve regional coordinators serve colleges and students throughout Minnesota. Based out of a "host campus", coordinators work with colleges and universities throughout their defined region, providing one-on-one, comprehensive education assistance to Veterans, military members, and their dependents. Coordinators also work closely with campus administration officials to create and manage Veterans Resource Centers as well as to address the campus-level needs of student Veterans.

A novel concept when launched in July 2006, the Higher Education Veterans Program remains the only program of its kind in the country and has helped thousands of returning Minnesota Veterans transition to college. The complex nature of Veteran and military education benefits demand the services of subject matter experts who can assist Minnesota's Veteran community throughout the state. The Higher Education Veterans Program has proven to be effective, flexible, and efficient, enabling countless Veterans, military members, and their dependents access to federal and state benefits as well as other resources available to them.

Due to this, the impact of the Higher Education Veterans Program is actually higher than reflected in the graph.

2010 HIGHLIGHTS

In 2010, the impact and importance of the Higher Education Veterans Program was especially evident as confusion and difficulty accessing federal benefits led thousands of Minnesotans to seek assistance through the program. As rules change and budgets decrease for certain benefit programs, benefits are becoming increasingly interconnected and Veterans must often make choices between complex sets of benefit packages. At times, these decisions are irrevocable and mistakes can cost Veterans tens of thousands of dollars. As such, not only those who are entitled to these benefits, but also by the colleges and universities, they attend and other Veteran service providers increasingly rely upon coordinators with the Higher Education Veterans Program. The following information highlights this increased demand as well as some of the most notable achievements in 2010.

- 1. The Post 9/11 GI Bill (Chapter 33) is a federal education benefit that began in 2009. Although this new benefit offers a more generous education financing option for many, it also adds a new layer of complexity to benefits already known to be very difficult to understand and to access. The Higher Education Veterans Program was able to assist thousands of Veterans determine their eligibility for the Post 9/11 GI Bill and enroll in the VA education program best suited to their needs.
- 2. Coordinators assisted campuses in establishing three new campus Veterans Resource Centers, bringing the total number of centers in operation to sixty-two. Coordinators also

assisted an additional six campuses to increase the size and/or programming of existing centers.

- 3. Coordinators served 6,704 *new* individuals in 2010, and thousands of other individuals who returned for continued assistance. Overall, the program had a total of 57,627 contacts in 2010, a 31 % increase over 2009.
- 4. Coordinators continued to provide advice, information, and support of campus efforts aimed at creating Veterans-friendly institutions. Included are issues such as streamlined and flexible policies and procedures for students facing deployments and creating seamless transition for returning Veterans.
- 5. The director and coordinators provided a tremendous amount of training and outreach at campuses, community events, Veteran organizations and service providers, and most notably, reintegration events coordinated by the Minnesota National Guard.

2010 VETERANS RESOURCE CENTER USAGE DATA

The following numbers represent the usage of campus Veterans Resource Centers, the main route through which coordinators serve Veterans. Through these centers, coordinators provide comprehensive information and assistance regarding education benefits and resources, as well as assist students navigate through campus processes. As the following sections will show, the Higher Education Veterans Program serves thousands of additional Veterans through training and outreach efforts as well as its innovative partnership with Minnesota Online.

Veterans Resource Center Staffing

Coordinators cover wide regions and manage many campus Veterans Resource Centers. To effectively staff these centers, coordinators have developed supplemental staffing with various campus and community resources. This additional staffing not only helps to maintain consistent hours of operation, but also provides additional outreach and programming by campus and community service providers. The figures below show the total annual statewide hours worked in Veterans Resource Centers. Through these efforts, the investment in regional coordinators is multiplied to better serve Veterans in colleges and universities.

2010 PRESENTATION AND OUTREACH DATA

Throughout the year, the staff of the Higher Education Veterans Program is heavily relied upon to provide training on their area of expertise: Veteran/military education benefits and creating Veterans-friendly campuses. Training is conducted in a variety of formats and locations – from drill floor presentations at armories throughout the state and post-deployment education briefings upon the very return of National Guard and Reserve units, to faculty and staff in-service days on campuses and professional higher education associations on a national scale. 

STUDENT VETERANS IN MINNESOTA

New education benefits, the economic recession, and sustained deployments have dramatically increased the number of Veterans and military members attending college in recent years. In addition, new federal benefits have increased the number of dependents eligible for aid. The following graph shows the number of students using USVA educational benefits. While there are a number of reasons why a Veteran may not have access to USVA educational benefits, this is currently the only comprehensive source of data for student Veteran enrollment in Minnesota.


MINNESOTA STUDENTS USING VA EDUCATION BENEFITS



*The 2009 data from the USVA does not include individuals using Chapter 33 (also known as the Post 9/11 GI Bill), which began in August 2009. The actual number of Veterans attending college in 2009 is therefore much larger than reported.

Increasing numbers of Veterans attending college in Minnesota has led to an equally dramatic increase in education benefit dollars spent in Minnesota. A combination of state and federal funds make higher education possible for thousands of Minnesota Veterans, military members, and dependents each year. These benefits also make an important contribution to Minnesota's economy. The amount of federal education benefits spent in Minnesota has nearly doubled, up \$42.7 million, during the existence of the Higher Education Veterans Program. This trend is expected to continue for the foreseeable future. The following graph illustrates the expenditures of Veterans' education benefits in Minnesota.

While education benefits are available to most Veterans and military members, as well as some dependents, assistance is often needed to untangle the various eligibility requirements and enrollment processes unique to each package of benefits that these students are entitled to. Coordinators with the Higher Education Veterans Program provide this much-needed assistance as well as serve as an initial point of contact for Veterans interested in higher education. The program is therefore in a unique position to encourage and facilitate the use of these benefits.

¹ The Minnesota GI Bill began in the 2007-2008 academic year. Data reported is from Minnesota Office of Higher Education.

Federal Tuition Assistance is a program available to most reserve components in additional to the Army National Guard. The numbers Reported are for the Minnesota Army National Guard, the only data available. Both Federal Tuition Assistance and State Tuition Reimbursement data reported from Minnesota National Guard Education Office.

USVA education data not yet available for 2010. The amount listed is an estimate based on the number of individuals using VA education Benefits in 2010 at an average rate of \$6,853/student (the average rate per person for 2006 to 2008).
