

Dear Chairman Raukar, Chairman Eichorn and Fellow Commissioners:

The Annual Report of the Inspector of Mines for the year 2010 is herewith submitted.

While the mining industry in northern Minnesota was dealt an economic blow in 2009, 2010 has been a year which has brought the industry back to full or near full production. While the environmental permitting for the Polymet project at the old Erie Mining Company plant site has not been finished, the outlook for semi-precious mining still looks positive. The start of the Mesabi Nugget Project outside of Aurora, along with the continued construction of the Essar Steel Project, along with continued production at the original Magnetation Project and the proposed expansion project in Itasca County, the future of mining in St. Louis and Itasca counties holds much promise for our area and our state.

On the Public Safety side of mining, the Minnesota DNR Division of Minerals, along with other agencies is in the process of expanding the underground mine mapping project to include the western Mesabi Range. This project would then complete the mapping for the entire Mesabi Range and should prove helpful in planning future expansions of both the Mining Industry and public uses for the old mine lands.

The total employment for the year was 3,761 and these people worked a total of 7,845,824 manhours.

There were 89,581 tons of natural ore shipped and 37,907,184 tons of taconite products shipped from these mines. There were 73,090,664 tons of stripping and waste removed from these mines.

Inspections and visits for 2010 were as follows: Approximately 676\* inspections, visits and investigations were made to the operating and non-operating mines. There were 0 fatalities and 27 lost time or serious accidents reported.

Acknowledgment and appreciation is extended to both Labor and Management for their continued interest, efforts and cooperation in the field of safety and health throughout the mines and plants in St. Louis and Itasca counties.

#### Excerpts from the Law On

#### INSPECTOR OF MINES

#### CHAPTER 180

#### **MINNESOTA STATUTES**

#### **SECTION 180.02**

#### QUALIFICATIONS, SALARY, OATH, BOND

Each inspector of mines and assistant shall be at least 25 years of age, a citizen of the state, and a resident of the county wherein appointed, of good moral character and temperate habits. Previous to appointment the inspector shall have had practical experience as a miner or otherwise engaged as an employee in mines of the state at least six years, or a mining engineer having had previous to appointment at least two years of practical experience in iron mines and iron mining and having had at least one year of such experience in this state. The inspector shall not while in office in any way be interested as an owner, operator, agent, stockholder, or engineer of any mine. The inspector shall live or have an office in the mining district of the county for which appointed. The salary of each inspector of mines and assistant shall be such sum as shall be fixed by the county board not exceeding \$7,500 per annum, and shall be allowed actual traveling expenses not to exceed \$1,200 in any one year. The inspector shall file with the county auditor an itemized account of expenses every three months, verified by affidavit, showing that they have been incurred in the discharge of official duties. Before entering upon the discharge of the duties of office, the inspector shall take an oath before some person authorized by law to administer oaths to support the Constitution of the United States and the Constitution of the state of Minnesota, and that the inspector will faithfully, impartially, and to the best of ability discharge the duties of office, and file a certificate of having done so in the office of the county auditor. The inspector shall give bond, payable to the county board, in the penal sum of \$5,000, with sufficient sureties to be approved by the county board, conditioned that the inspector will faithfully discharge the duties of office and this bond shall be filed with the county auditor.

# NON-FATAL LOST-TIME AND SERIOUS ACCIDENTS

## ARCELOR MITTAL, MINORCA MINE, INC.

Lab Analyst, Date of Accident - January 28, 2010, Injured was removing a screen panel, which required pulling the screen panel towards him. When he pulled, he felt a pull in the lower left groin area. This resulted in a hernia. Days Lost - 20

Pit Maintenance, Date of Accident - June 30, 2010, Injured was stepping off the lube truck when he felt a pain in his left knee. The damage to the knee required surgical repair. Days Lost - 34

Plant Operations, Date of Accident - August 3, 2010. Injured climbed a ladder to unplug the scrubber discharge sock feeding the launder. When the material broke free, the force of the accumulated water/ material knocked him off the ladder and he fell to the ground. This resulted in a fractured heel. Days Lost - 41

Warehouse Attendant, Date of accident - August 9, 2010. Injured was boarding the forklift when she felt a pain in her right hip. This resulted in a hip strain. Days Lost - 4

# UNITED TACONITE LLC

#### MINE

Mine Operations, Date of Accident - May 7, 2010. Injured was getting into the shift change van at 10:40 P.M. While entering the van, the employee slipped and hit the door opening on the van with his shin, causing an open wound. There were wet conditions, muddy boots and it was dark outside. Days lost - 10

Mine Operations, Driller, Date of accident - December 29, 2010. Injured was exiting the drill when his footwear grippers caught on the bottom step of the drill causing him to lose balance and pitch forward. He landed on his right foot, breaking the outer metatarsal bone. Days Lost - 2 days in 2010

#### PLANT

Plant Maintenance, Date of Accident - December 30, 2009. Injured employee was in the process of grouting in a new base for a replacement pump. He was mixing up grout with a small 5 gallon portable mixer. He was finished mixing up a batch of grout and shut off the mixer. He then attempted to remove the 5 gallon pail from the mixer, but the pail was stuck. He attempted to wiggle the pail free when he inadvertently bumped the toggle start switch to "on" and the mixer started. Injured had his hand on the pail handle when the mixer started. This spun his hand around, twisting the pail handle and injuring his hand. Injured freed his hand after several revolutions. This resulted in a sprain or strain to the left hand. This resulted in a bruise to the right elbow and a bump on the head. Days Lost - 0

Plant Operations, Date of Accident - January 3, 2010. Injured was trying to close a seal water line valve. The valve was stuck and the handle was bent. While trying to turn the valve, injured felt a pop in his right wrist. Days Lost - 23

Plant Operations, Fines Crusher, Date of Accident - May 12, 2010. Injured was attempting to remove the low speed coupler guard for #10 conveyor with a partner. While moving, the guard shifted and pinched a finger between the guard and the motor. Days Lost - 1

Plant Maintenance, Concentrator, Date of Accident, September 30, 2010. Injured was lifting a ladder into position, turned, and felt a pop in his back. Days Lost - 92 in 2010

Plant Maintenance, Date of Accident - October 19, 2010. Injured was maneuvering a four-wheeled cart out of the elevator. When the wheels contacted the door channel, they caused the cart handle to strike Injured, which caused Injured to fall to the floor. This resulted in a contusion to the back. Days Lost - 5

#### HIBBING TACONITE COMPANY

Maintenance Mechanic, Date of Accident - May 27, 2010. Injured and his partners were assigned to replace the crowd cables on a BE295 electric rope shovel. The crowd cable is received from the manufacturer on a large wooden spool. HTC has fabricated and approved a metal cable stand used to hold the spool and accompanying cable. A round metal shaft (pole) is slid through the middle of the spool. The cable spool and stand are positioned to line up with the shovel. This allows for easy and efficient removal of the old cable from the shovel and spooling of the new cable onto the shovel. In this incident, a mechanic was using a boom truck and a sling to remove the cable assembly from the back of the boom truck and to position both of them on the ground in preparation to change the cable. Injured was on the ground assisting with positioning the cable assembly with his hands on the side of the stand as it was being set down. One side of the assembly had been placed on the ground. As the other side was being set down, the shaft for the cable stand shifted toward the bracket (plate which holds the shaft in place on the cable stand) pinching injured's thumb on his right hand. Injured suffered an avulsion injury; stitches were used to repair the thumb. Days Lost - 15

Maintenance Mechanic, Date of Accident - June 8, 2010. Injured and his partner were removing a shim/bracket on a 4-foot finisher to replace it with a new stabilizing bracket and drive. The drive had been removed and injured had placed the 3/8-inch hoisting sling around the stub shaft collar of the finisher, and lifted the finisher drum to allow removal of the shim/bracket. As the drum was lifted by the crane, injured's partner removed one side of the shim/bracket piece (north side). Injured went to help and remove the other side of the shim/ bracket piece (south side) when it is believed the sling shifted from the stub shaft collar and slid between the pillow block and the stub shaft, causing the drum to drop about 3 inches. When the drum shifted/dropped, it pinched injured's right index finger and right thumb between the shim and the pillow block. Injured suffered a crushed right index finger which was surgically removed just above the second joint, and a laceration to the thumb which required stitches. Days Lost - 12

# **KEEWATIN TACONITE**

Plant Hybrid, Date of Accident - March 18, 2010. Injured was assigned to close a valve in the Pellet Plant in the chip mill area. Injured was closing a 6" Dezurik valve with a manufactured compatible wrench. Injured attached the wrench to the valve and pulled the wrench toward himself. Valve was located approximately seven feet from the floor. The valve wrench has a square cast iron head and a three-foot long, one-inch diameter pipe handle. Injured proceeded to exert a pulling force on the wrench and the cast iron head of the wrench broke. As this happened, with injured's momentum the pipe handle knocked injured's hard hat off. With backward motion, injured lost his balance and fell to the floor, bumping his head and bruising his right elbow. Days Lost - 0

# NORTHSHORE MINING COMPANY

#### Babbitt Mine

Mine Railroad, Date of Accident - June 20, 2010. Injured had just finished fueling the spiker and had to climb in to the pickup bed to shut off the fuel pump. As he exited the truck box he grabbed the edge of the tailgate for support and cut his finger on a bracket on the tailgate. Days Lost - 0

Mine Railroad, Date of Accident - August 30, 2010. Injured was cutting a 4-inch piece of pipe for the bed of a pickup. When he went to reposition the pipe in the cutoff saw, the back of his hand contacted the spinning blade, cutting the back of his hand, which required medical attention. Days Lost - 8

# Silver Bay

Plant Maintenance, Date of Accident - February 8, 2010. Injured was changing bearings on the #11 furnace roll screen. Injured supported the roller shaft with a choker and removed the old bearing assembly. When injured turned to grab the new parts, the shaft slipped off the choker and fell approximately 3 inches pinching the index finger of injured's left hand. Days Lost - 3

Pellet Plant Operations, Date of Accident - February 16, 2010. Injured was using a torch to remove old bolts that were holding an angle iron frame to a wood support structure. A piece of wood started to burn from the hot slag and as injured went to tamp out the small fire, his hand came in contact with the flame from the torch. A nitrile glove on the inside of his work glove melted and burned his fingers. Days Lost - 2

Plant Maintenance, Date of Accident - May 4, 2010. Injured was changing grizzlies on the upper screen deck on the #3 Crushing line. He had crawled under the grizzlies to put nuts on the new bolts when one of the grizzlies came loose from its position and struck him in the forehead. Days Lost - 0

Fine Crusher Operations, Date of Accident - June 8, 2010. Injured was lifting an idler rack from the floor to the idler bed on the #3 south shuttle when he felt a pain in his groin. Days Lost - 38

Plant maintenance, Date of Accident - September 30, 2010. Injured was walking down the west side of the 62/162 conveyor ramp while holding on to the conduit. His left foot slipped and he twisted his ankle. Days Lost - 23

#### USS CORPORATION, MINNTAC MAINTENANCE

Maintenance Tech, Date of Accident - March 4, 2010. Injured was cutting bolts off the grate side plate for removal when he changed his body position. He lost his balance and fell from a crouch back onto the depth bed fingers. These fingers are 1/4" stainless steel rod mounted in a holder that swings from a pivot and the assembly is used to indicate the depth of green pellets that are being fed into the grate. He was crouching on the nearly flat grate casting bed working under the crossover catwalk above. He stated that while cutting, his torso weight was over his toes and when he moved, the weight was over or behind his heels. The finger support bracket had to be ground into pieces to allow Response personnel to transport him with the finger still impaled. This resulted in a puncture wound in the upper thigh. Days Lost - 0

Maintenance Tech - Electrical. Date of Accident - March 16, 2010. Injured was descending a ladder. When he stepped on the bottom rung, he felt a pain in his knee. This resulted in a torn meniscus in the knee. Days Lost - 15

Maintenance Tech - Mechanical. Date of Accident - June 2, 2010. While injured was removing a hoist drum from a shovel, the manual hoist lock injured was setting dropped unexpectedly. Injured tried to catch the lock, which caused a tear to his bicep tendon. Days Lost -18

Maintenance Tech - electrical. Date of accident August 1, 2010. Injured and his partner meggered a motor (tested the windings, etc.) and the test indicated a bad winding in the motor. While the megger was still attached, injured disconnected the test lead from the starter and received a shock. Days Lost - 2

## MAGNETATION

Supervisor, Date of Accident - May 30, 2010. Injured was using two wrenches to tighten a loose bolt on the Grizzly Hopper. One of the wrenches slipped off and struck injured in the nose. This resulted in a broken nose. Days Lost - 4 hours

Plant Operator, Date of Accident - September 18, 2010. While exiting the loader, injured's hand slipped off the handrail and due to mud on the top deck injured slipped and fell to the ground. This resulted in a sore leg and lower back. Days Lost - 20
