
Executive Summary

Laws of MN 2009, Chapter 172, Article 3, Section 3 appropriated \$12,641,000 for State Fiscal Year 2010 and \$15,140,000 for State Fiscal Year 2011 from the Constitutional Land and Legacy Amendment's "Parks and Trails Fund" to the Metropolitan Council for grants to finance projects that support the Metropolitan Regional Park System. This report describes the expenditure and use of the appropriations in compliance with Laws of MN 2009, Chapter 172, Article 3, Section 3(b). The report details the outcomes in terms of additional use of parks and trails resources, user satisfaction surveys, and other appropriate outcomes. Many projects are currently under way and consequently measurable data has yet to be collected on those projects. This report contains measurable outcomes of completed projects when data is available, and proposed measurable outcomes of projects currently under way. Future annual reports will include the results of those measurable outcomes as well as updated information on the expenditures of the appropriation.

Allocation of Appropriation

The FY 2010 appropriation included a \$40,000 earmark to plant trees along Victory Memorial Parkway. Ninety percent of the remainder was for grants to 10 regional park implementing agencies and 10% for land acquisition grants in accordance with a formula in Minnesota Statutes, section 85.53. Chart 1 illustrates how the appropriation was allocated.

Chart 1: Allocation of FY 2010-11 Parks and Trails Fund Appropriation for Metropolitan Regional Park System




Parks and Trails Legacy Plan Strategic Directions

The recently completed Parks and Trails Legacy Plan calls for investing the Parks and Trails Fund under the following strategic directions:

- Connect people to the outdoors (e.g. improved marketing, increase access)
- Acquire land (e.g. acquire land within existing park boundaries and new parks)
- Create opportunities (e.g. build new recreation and visitor support facilities)
- Take care of what we have (e.g. renovate and maintain existing infrastructure)
- Work better together (e.g. inter-agency coordination to create seamless park and trail system)

Chart 2 illustrates how the FY 2010 and FY 2011 appropriations are being expended consistent with these strategic directions.

Expenditure Status of Appropriation

Charts 3 and 4 illustrate the amount of funds from the FY 2010 and FY 2011 appropriations respectively that have been disbursed as of February 15, 2011, what remains to be spent from that appropriation by its expiration date, and what part of each appropriation may carry-over into a future fiscal year because it is for land acquisition or matching a federal grant, which have a later expiration date.






Chart 3: Expenditure Status of Fiscal Year 2010 Appropriation \$12,641,000





Figure 2 illustrates the location of FY 2011 Parks and Trails Fund financed projects other than land acquisitions for the Metropolitan Regional Park System.



Park Acquisition Opportunity Grants

In accordance with the provisions of MN Statute 85.53, Subd. 3, 10% of the FY 2010 appropriation (\$1,261,000) and the FY 2011 appropriation (\$1,513,000) was set aside for grants to regional park implementing agencies for land acquisition within Metropolitan Council approved regional park and trail master plan boundaries. The Metropolitan Council provided a match of \$2 of its own bonds for every \$3 of State funds under its park acquisition opportunity grant program. In this case \$840,000 of Council park bonds matched the FY 2010 appropriation for a total of \$2,101,000; and \$1,009,000 of Council park bonds matched the FY 2011 appropriation for a total of \$2,522,000. The park agencies who received grants provided non-state funds to finance 25% of the proposed acquisition costs. Grants are considered when park agencies submit sufficient documentation on the proposed acquisition and related costs as required by the Metropolitan Council. To date, 53 acres has been acquired in seven locations. Figure 3 illustrates the location of parks and trails where land has been acquired. \$808,510 of the FY 2011 appropriation remains for future acquisition grants until June 30, 2014.

Background on Metropolitan Regional Park System

Under the provisions of MN Statute 473.147 enacted in 1974, the Metropolitan Council is authorized to prepare a regional parks policy plan that must identify land that should be acquired and developed by cities, counties and special park districts to create a regional recreation open space system that complements State parks and trails in the seven-county Twin Cities metropolitan region.

In 1974, the Metropolitan Council designated about 31,000 acres of existing city, county and special park district lands as regional parks, park reserves, special recreation features and regional trails in its first regional parks policy plan. Today, over 54,600 acres in 39 regional parks, 12 park reserves, 7 special recreation features and 231 miles of regional trails are open for public use. The park system hosted an estimated 38 million visits in 2009 based on visitation samples taken at each park and trail unit.

Ten regional park implementing agencies own and manage portions of the Metropolitan Regional Park system within their political jurisdiction. The regional park implementing agencies as defined in MN Statute 473.351 are:

Anoka County
Carver County
Dakota County
Ramsey County
Scott County
Washington County
City of Bloomington
City of St. Paul
Minneapolis Park & Recreation Board
Three Rivers Park District

The regional park implementing agencies must prepare master plans which describe the park or trail unit boundary, generally locate recreation and visitor support facilities in the park or trail, and estimate the costs to acquire, develop and operate/maintain the park or trail unit. The Metropolitan Council reviews and approves these master plans based on their consistency with the Council's regional parks policy plan.

The Metropolitan Council provides capital grants to the regional park implementing agencies for projects that are consistent with the Council-approved park or trail master plan. Those grants have been funded traditionally with State appropriations from bonds, the Environment and Natural Resources Trust Fund, and bonds issued by the Metropolitan Council.

Distribution of FY 2010 Parks and Trails Fund Appropriation for Non-Acquisition projects in the Metropolitan Regional Park System

The Parks and Trails Fund appropriations were distributed to regional park implementing agencies in accordance with Minnesota Statutes, section 85.53, which contains a formula that determines the amount each park agency receives. To summarize the formula, 10% of the appropriation is set aside to finance land acquisition grants. The remaining 90% is split among the regional park implementing agencies based on the following factors and the weight of that factor:

- Population of each park agency's jurisdiction with adjustments for cities inside counties (35%)
- Total annual visits to each agency's regional parks and trails (20%)
- Past year operations and maintenance expenses each agency spends for its regional parks and trails (20%)
- Amount of visits to each agency's regional parks and trails by persons living outside that agency's jurisdiction [non-local visits] (15%)
- Amount of regional park and trail land managed by each agency with adjustment for 80% of lands in park reserves that are not developed with recreation facilities (10%)

In accordance with Laws of MN 2009, Chapter 172, Article 3, Section 3 and MN Statute 85.53, Subd. 3, a total of \$11,380,000 from the FY 2010 appropriation has been distributed under 26 grant agreements for 32 projects. The following table lists the grantees, the total amount they received and references other pages in this report that describe the grant project, its budget, status and measurable outcomes.



Details on Park Acquisition Opportunity Grants

In accordance with the provisions of MN Statute 85.53, Subd. 3, 10% of the FY 2010 appropriation (\$1,261,000) and the FY 2011 appropriation (\$1,513,000) was set aside for grants to regional park implementing agencies for land acquisition within Metropolitan Council approved regional park and trail master plan boundaries. The Metropolitan Council provided a match of \$2 of its own bonds for every \$3 of State funds under its park acquisition opportunity grant program. In this case \$840,000 of Council park bonds matched the FY 2010 appropriation for a total of \$2,101,000; and \$1,009,000 of Council park bonds matched the FY 2011 appropriation for a total of \$2,522,000. The park agencies who received grants provided non-state funds to finance 25% of the proposed acquisition costs.

Grants are considered when park agencies submit sufficient documentation on the proposed acquisition and related costs as required by the Metropolitan Council. To date, 53 acres has been acquired in seven locations. Chart 6 below illustrates the share of revenue sources and amounts used to finance these acquisitions. Figure 3 on page 6 of this report has a map illustrating the parks and trails where the acquisitions occurred. \$808,510 of the FY 2011 appropriation remains for future acquisition grants until June 30, 2014. Details on the Parks and Trails Fund portion of each acquisition grant are found on pages 38-44.

Distribution of FY 2011 Parks and Trails Fund Appropriation for Non-Acquisition Projects in the Metropolitan Regional Park System

The Parks and Trails Fund appropriations were distributed to regional park implementing agencies in accordance with Minnesota Statutes, section 85.53, which contains a formula that determines the amount each park agency receives. To summarize the formula, 10% of the appropriation is set aside to finance land acquisition grants. The remaining 90% is split among the regional park implementing agencies based on the following factors and the weight of that factor:

- Population of each park agency's jurisdiction with adjustments for cities inside counties (35%)
- Total annual visits to each agency's regional parks and trails (20%)
- Past year operations and maintenance expenses each agency spends for its regional parks and trails (20%)
- Amount of visits to each agency's regional parks and trails by persons living outside that agency's jurisdiction [non-local visits] (15%)
- Amount of regional park and trail land managed by each agency with adjustment for 80% of lands in park reserves that are not developed with recreation facilities (10%)

In accordance with Laws of MN 2009, Chapter 172, Article 3, Section 3 and MN Statute 85.53, Subd. 3, a total of \$13,627,000 from the FY 2011 appropriation has been distributed under grant agreements. Measurable outcomes: Service Schedule was weekends from May-Sept and weekdays June-Aug from 9:30am-6:30pm. Shuttle service was from off-site parking lots at the Minnesota State Fair or Midway Stadium to the entrance of Como Park Zoo and Conservatory to mitigate traffic and congestion in and around Como Regional Park.

The Como Shuttle offered guests 96 days, 870 hours, April - September 2010 the opportunity to conveniently park off-site and ride to the front entrance of Como Park Zoo & Conservatory. In 2010, 30,485 riders rode round trip. The average daily capture rate of guests was 5.1%, with the high seasonal rate of 11%.

With the grant, we purchased one bus in 2010 to add to the other 3 previously purchased at a cost of \$215,413.27 with delivery on Aug. 10, 2010. This is a low-emission diesel shuttle, with 28 seats from Hoglund Bus Company.

Assuming 4 riders per car, this equals on average 440 less cars within and around the Como Regional Park area driving around looking for a parking spot. Those vehicles over a course of 96 days of operation reduced their miles driven by 3 miles which would equal a total savings of 32.2 metric tons of CO2* not put into the atmosphere.

This reduction of green house emissions is equivalent to*:

- · 3,960 gallons of gas
- 81.9 barrels of oil consumed
- Enough electricity use of 4.3 homes for one year
- Carbon sequestered by 903 tree seedlings grown for 10 years
- Carbon sequestered by 7.5 acres of pine forest
- Greenhouse gas emissions avoided by recycling 11.9 tons of waste instead of sending to the landfill
