MAP seeks continued funding for its Case Management and Benefits Counseling services. Funding for these services fall within the June 29, 2011 Order referred to above and as described below.

MAP provides services that are vital to the health of people living with HIV and the public health of the state. Several MAP programs will be impacted by a state government shutdown; however MAP is seeking continued funding for two programs of critical concern: Case Management and Benefits Counseling services for people living with HIV.

## HIV Case Management services should be considered an essential function of government.

HIV Case Management serves a critical role in supporting medication and treatment adherence, prevention of infection, and care to people living with HIV. These services are critical core functions because they provide benefit and medical service support to people living with HIV (see June 29, 2011 Order, pg. 9, paragraph 27.3) and are vital to "protect the life, health, and safety of citizens". (see June 29, 2011 Order, pg. 13, paragraph 37).

- Case management services provide a path to health care for more than 390 people living with HIV. Improved access to health care means a decreased burden in medical services due to improved health outcomes.
- Case managers are often the first call a MAP client makes when they need assistance with medical care; information regarding their health; and basic needs. The absence of these support services will be devastating to people living with HIV.
- Case management services impact public health by reducing the possibility of HIV transmission. Research shows that individuals who see physicians as prescribed are less likely to engage in high risk behaviors and more likely to adhere to medications, reducing the likelihood of HIV transmission and improving public health outcomes.

## Benefits Counseling funding is subject to the Supremacy Clause of the U.S. Constitution.

Benefits Counseling services are fully funded through the Federal Government under Part B of the Ryan White Care Act. As such funding for this program should continue (*See June 9, 2011 Order, pg. 7, paragraph 24 and 25*).

- Benefits Counseling services provide critical expertise in the coordination of health care programs and drug benefits unique to people living with HIV.
- Benefits Counseling services are often the first call that an individual makes when they are unable to access medication or treatment. If this service is unavailable, the client may go without medication rather than seeking care at an emergency room or elsewhere.
- Benefits Counseling serves more than 380 clients each year. The uncertainty caused by the state shutdown only increases the need for Benefits Counseling services to individuals living with HIV.

The Minnesota AIDS Project respectfully requests that our Case Management and Benefits Counseling services be deemed as essential services that fulfill a critical need for the public health and safety of our state.
