Interim Report of the

Sunset Advisory Commission

January 1, 2012

Background

The 2011 Legislature created the Sunset Advisory Commission, which will periodically review state agencies and make recommendations on whether the agency should continue to exist. The law, called the Minnesota Sunset Act, establishes a schedule for periodic review and expiration of many state agencies (Minnesota Statutes, chapter 3D).

Most state executive branch agencies will be reviewed between 2012 and 2022, according to a schedule prescribed in law. Many agencies, including most state boards, councils, and commissions, expire automatically at the scheduled date unless a new law continues the agency.

The Sunset Advisory Commission must review agencies at the scheduled times and make recommendations to the legislature. The commission's recommendations are advisory—the commission does not have authority to extend an agency that is scheduled for automatic expiration or to abolish an agency that is not scheduled to expire automatically. These steps need to be taken through the legislative process.

The commission consists of four senators, four members of the House of Representatives, and four members appointed by the governor. No more than three of the senators and no more than three of the House members may be from the majority caucus in their respective chambers.

As provided in the Commission's statute, the Commission elected a chair and vice-chair. At its November 21, 2011 meeting, the Commission elected Representative Kiffmeyer and Senator Bonoff for these two positions, respectively.

At the same meeting, the Commission adopted rules governing its procedures.

The Commission's membership, meeting notices, meeting archives, and reports are available. The public can also subscribe to receive emailed notification of meetings.

Process

In this cycle, the commission is to review 17 Health Licensing Boards, four Councils of Color, and four other boards. A list of those agencies is included as Attachment A.

Criteria for reviewing agencies are included in the Sunset Act, Minnesota Statutes 3D.10. The Commission added elements to these criteria, which were provided to agencies so they could be included in their written reports. These criteria are included as Attachment B.

The Commission scheduled 20 hours of presentations over four meetings to receive reports from agencies under review. Those meetings were held on December 8, 9, 12 and 15. The Commission allotted approximately 20 minutes for each agency to provide an overview, and then 20 minutes for questions and discussion.

In preparation for and during these December meetings, the Commission members reviewed reports submitted by agencies. These reports addressed the criteria provided in section 3D.10, and the Commission has considered those criteria in listening to agency presentations and in asking questions of agencies. As provided in Minnesota Statutes 3D.08, the Commission will take testimony from the public in hearings planned for January 2012.

Issues and Themes

As the Commission heard from boards and council, the members raised numerous issues and themes that cut across many of the agencies:

- The use of funds generated by fees paid by licensees regulated by the Health Licensing Boards in the State Government Special Revenue Fund toward state government deficits. This practice has been employed over many years.
- Whether the Administrative Services Unit, an internal organization that provides administrative support services to many Health Licensing Boards, could be expanded.
- How other boards and councils are using the Department of Administration's Small Agency Resource Teams (SmART)
- Many of the councils have members of the legislature serving on their governing boards.
 Members are interested in understanding those members' roles, and how that affects the councils' relationship with the legislature.
- The Commission was interested in the diversity of the members of the boards and council: geographic, gender, and professional vs. public.
- Better understanding how efficiently the Health Licensing Boards respond to and resolve complaints.
- Better understanding how the Councils of Color align their work and mission to the public policy issues being addressed by the Legislature.
- Better understanding how the Councils of Color manage administrative functions.

Next steps

The Commission is planning to:

- Issue this interim report, as provided under Minnesota Statutes 3D.07
- Request additional information from agencies, based on questions raised during the Commission's review hearings
- Conduct public hearings to provide an opportunity for public input, as provided under Minnesota Statutes 3D.08.
- Make recommendations to the Legislature, as provided under Minn. Stat. 3D.09.
