#### Letter from the Director and CEO



January 15, 2013

As we near the close of the second biennium since the passage of the Legacy Amendment in November 2008, Minnesotans are preserving our past, sharing our state's stories and connecting to history like never before.

We are pleased to share our progress with you in this report, where you'll read about more than 35 statewide history programs, partnerships with more than 30 organizations across the state, and more than 500 grants awarded to organizations throughout Minnesota—all supported by the Legacy Amendment's Arts and Cultural Heritage Fund, all helping to build a priceless legacy for future generations.

A few examples of this valuable work include:

**Preserving**—For the first time, we've recorded dozens of oral histories from Dakota and settler descendants of those touched by the U.S.-Dakota War of 1862 and made them available on a comprehensive website about the war, *www.usdakotawar.org*. The descendants' voices and personal family stories are now part of the Society's permanent collection.

**Sharing**—The Minnesota History Center is sharing Minnesota stories in an exciting, new hands-on exhibit designed especially for families and students on field trips. "Then Now Wow," an interactive journey through Minnesota, supports state social studies standards and was designed in partnership with Minnesota students, teachers and parents.

Connecting — Minnesotans statewide can connect to history and each other in their own backyards through traveling exhibits and history programs that educate and entertain. Minnesotans of all ages are building relationships through community history projects like an exhibit about the Historic Holmes Theatre created by Detroit Lakes students and seniors working together.

Most importantly, Legacy funds allow us to use the power of history to transform lives. One example: these funds are bringing History Day to students across the state, inspiring one teacher to tell us:

"The competition portion of this project gives my students the opportunity to see so many other projects and what a state competition is like — for students from a rural community that is life changing."

We express sincere and deep appreciation to the Governor, the legislature and the people of Minnesota for making all of these opportunities possible, and we humbly request that the Governor and legislature continue their commitment to building a strong history and cultural heritage legacy for tomorrow's Minnesotans.

#### Introduction

On November 4, 2008, Minnesota voters approved the Clean Water, Land and Legacy Amendment to preserve and enhance some of the most important elements of our state. This amendment to the Minnesota Constitution, often referred to as the "Legacy Amendment," created four funds, one of which is the Arts and Cultural Heritage Fund (ACHF).

The Legacy Amendment mandates that a portion of the ACHF be used "to preserve Minnesota's history and cultural heritage" (Minnesota Constitution, Article XI, Sec. 15). Each January, the Minnesota Historical Society is required to submit an annual report to the Governor and legislature detailing expenditures it has made from the ACHF.

This report details all ACHF projects and programs funded through the Society during fiscal year 2012 and the first six months of fiscal year 2013.

#### **APPROPRIATIONS**

The Arts and Cultural Heritage Fund (ACHF) receives 19.75% of overall Legacy funding. For fiscal years 2012 and 2013, the legislature appropriated \$25 million from the ACHF to the Minnesota Historical Society. That appropriation breaks down to \$12,050,000 for fiscal year 2012 and \$12,950,000 for fiscal year 2013.



#### STATEWIDE OUTREACH

Since late 2008, the Minnesota Historical Society has collaborated with the public and many history-minded organizations to maximize the efficiency and effectiveness of historical projects funded by the Arts and Cultural Heritage Fund.

To date, the Minnesota Historical Society has hosted or participated in more than **70 statewide events** involving **more than 2700 people** (some map locations indicate multiple events):



Workshops and Outreach Activities: The Society solicited opinions and ideas from citizens around the state regarding history expenditures and where funding is needed most and also helped potential grantees apply for funding through the ACHF-funded Minnesota Historical and Cultural Heritage Grants Program.

**Building Financial Capacity Training:** The Society and Access Philanthropy conducted intensive training workshops with local history organizations to improve their nonprofit fundraising and grant proposal preparation abilities.

**10- and 25-year Planning:** The Society collaborated with a dozen other historical and cultural organizations to create a 10-year plan and 25-year framework for the use of ACHF funding.

Historic Resources Advisory Committee Meetings: As required by law, the Society appointed a volunteer citizen panel to guide decisions for the Minnesota Historical and Cultural Heritage Grants Program. These recommendations are reviewed and approved by the Society's governing board.

### HISTORIC RESOURCES ADVISORY COMMITTEE (HRAC)

Legislation specifies that the HRAC, a volunteer citizen panel that guides decisions for the ACHF-funded Minnesota Historical and Cultural Heritage Grants Program, have balanced statewide membership and include representatives of local, county and statewide historical and cultural organizations and programs.

It further requires that the HRAC shall include, but is not limited to, members representing the interests of historic preservation, local history, archaeology, archival programs and other cultural programs related to the history of Minnesota.

In fiscal year 2013, HRAC members committed nearly 500 hours to reviewing proposals and allocating Minnesota Historical and Cultural Heritage Grants.

#### THE MINNESOTA HISTORY COALITION

#### **ACOUNTABILITY**

The legislature has reiterated the mandate that every project and program supported by the Arts and Cultural Heritage Fund report "actual measurable outcomes, and a plan for measuring and evaluating the results."

To meet this requirement, the Minnesota Historical Society worked with Wilder Research and the University of Minnesota Extension Center for Community Vitality to measure the economic value and outcomes of the Society's ACHF investments.

Since October 2010, the Society has been working with Wilder Research to improve the Society's ability to evaluate its ACHF projects and programs. The Society's staff and partners are now strongly positioned to ensure that ACHF projects and programs use best practices, current scholarship, and when appropriate, incorporate state-of-the-art technology for demonstrating measurable outcomes.

In February 2011, the Society released results of an economic study prepared by the University of Minnesota's Extension Center for Community Vitality. Results can be found at *bit.ly/achfhistoryeconeval*. A December 2012 update of the study found that **for every \$1 invested in history and cultural heritage**, the state receives a return on investment of \$2, which directly benefits state and local economies.

In November 2011, the Office of the Legislative Auditor released a report examining how all Legacy fund recipients can best use these funds over the long term.

Within the report, the Legislative Auditor identified four "ongoing concerns." The Society addresses those concerns in the following ways:

- Supplement, Not Substitute—The Society is aware of the constitutional requirement that Legacy expenditures shall supplement and not substitute for traditional sources of funds. The Society conducts careful reviews to ensure that the constitutional provision and appropriations language are met for all Legacy expenditures.
- **2. Administrative Costs**—The Society carefully documents and limits administrative costs to only those costs that are "directly related to and

necessary for" accomplishing ACHF programs and projects as called for by legislation.

- 3. Conflict of Interest—On pages four and five of this report, the Society discloses the names of members of groups who oversee the spending of ACHF funds. To fulfill long-standing policies and practices, those members are required to sign statements forbidding conflicts of interest. In addition, the practice for both the HRAC and the Executive Council is to specifically ask members to declare conflicts before each group votes on grant allocations.
- 4. Outcomes—The Society recognizes that Arts and Cultural Heritage funds create a longterm opportunity to build a Legacy gift. We are working to ensure that ACHF history programs and projects have a clear benefit for future generations. More specifically, in their applications, grant recipients are required to explain the enduring value of their project. Society staff worked with Wilder Research to improve our ability to measure the value of our ACHF programs.

During the 2012–2013 biennium, the Society is continuing to evaluate the impact of ACHF projects and programs to ensure that they demonstrate measurable outcomes as well as economic value for citizens. These results are shared on two websites explained under the heading Transparency (right).

#### **AUDIT**

In October 2012, the Office of the Legislative Auditor released findings from an Internal Controls and Compliance Audit for the period July 2009 to December 2011. The scope of the audit included ACHF expenditures. Auditors found that the Society "generally complied with finance-related requirements, including requirements relevant to the Arts and Cultural Heritage Fund."

The Society was pleased with the overall report because the findings were relatively minor and did not have financial implications. At the same time, we take these findings very seriously and immediately clarified our policies and procedures to make sure they align with state grant guidelines and other best practices. We welcome reviews like this audit because they help us fulfill our obligation to the people of Minnesota to be transparent and accountable for all state funds.

#### **TRANSPARENCY**

The Minnesota Historical Society has an obligation to the citizens of Minnesota to ensure that ACHF funds entrusted to our care are invested in ways that are transparent and will produce the greatest measurable impact on Minnesotans, enabling our state to thrive.

To meet this goal, the Society has assisted in the building of, and has itself built, websites that inform the public about all ACHF initiatives funded through the Society.

The first, Minnesota's Legacy, www.legacy.leg.mn, was created by the Legislative Coordinating Commission and contains information on all legacy-funded projects. The second website, Minnesota History: Building a Legacy, legacy.mnhs.org, is maintained by the Society and provides more in-depth project descriptions, photos, videos and information on opportunities to participate in history-related ACHF initiatives.

Through the end of the biennium, the Society will continue to post the most current information about history-related ACHF initiatives on both websites, ensuring transparency and responsible stewardship of the funds.

### Minnesotans Experience "Wow" Moments in New, Interactive Legacy-Funded Exhibit

From the prairies in the south, to the Twin Cities, to the forests up north, every corner of the new "Then Now Wow" exhibit at the Minnesota History Center invites visitors to get active and get involved in Minnesota history—especially families with children and students on field trips.

"This is the first time we've created an exhibit specifically for children," said Lead Exhibit Developer Ellen Miller. "But there are so many compelling things to do and see in "Then Now Wow," people of all ages are going to love it and learn from it." "This exhibit is a no-brainer: if you have children or grandchildren, GO! MHS under-billed it by not putting an exclamation point on 'Wow!'"

"Then Now Wow" visitors can explode dynamite in an Iron Range mine; explore a 1870s replica sod house; enter a tipi to hear artist/poet Bobby Wilson's take on Dakota history and culture; "ride" a Soo Line boxcar through

Southwestern Minnesota while tapping their toes to an original song by musician Charlie Parr; put together a life-size buffalo puzzle while learning how American Indians used each part of the animal; and hear and see stories from people across the world who now call Minnesota home.

"Then Now Wow" opened in November 2012 and is funded primarily by \$2.5 million from the Legacy Amendment's Arts and Cultural Heritage Fund through a special appropriation made by the legislature in 2009. To date, the Minnesota Historical Society has also raised \$481,000 in corporate and foundation gifts for the exhibit. Traveling exhibits that share Minnesota's diverse regions, people and history have made stops in dozens of communities statewide. See page 70 for more information about the traveling exhibits program, "Exhibits to Go."

Minnesota teachers, parents and students played a major role in developing "Then Now Wow" through a series of focus groups Society staff held around the state. Their feedback helped shape the engaging, interactive, story-driven features that are an integral part of the exhibit. These components support state social studies standards, complement the new Northern Lights state history curriculum and encourage students to use critical-thinking and problem-solving skills.

Even after the exhibit opened in November, more "wows" are ahead. In fall 2013, the Minnesota History Center will launch an innovative new Legacy-funded mobile

application for "Then Now Wow" called "History in Our Hands." The application will be used by students visiting on field trips.

"Digital natives are the first generation to grow up with technology as an integral part of their everyday lives," said Wendy Jones, Head of Museum and Education Programs. "They learn differently, so we are taking the best of what technology has to offer and using it to really deepen students' learning."

"Then Now Wow" will remain on view at the Minnesota History Center for many years, passing on our state's rich history and cultural heritage to new generations of Minnesotans.

In addition to funding from the Legacy Amendment, major support for "Then Now Wow" is provided by Target, the 3M Foundation, the Fred C. and Katherine B. Andersen Foundation, the Katherine B. Andersen Fund of The Saint Paul Foundation and the Institute of Museum and Library Services. ### New Legacy-Funded Exhibit and Initiatives Feature Minnesota's Mark on the Civil War

Visitors to "Minnesota and the Civil War," a new exhibit opening at the Minnesota History Center March 2, will learn about Minnesota's many important contributions and connections to the war.

Minnesota was the first state to commit volunteer troops to fight for the Union and more than 25,000 Minneso-

tans fought in the war. It is their stories from the battlefield as well as stories from the homefront about immigrants, women and freed and enslaved African-Americans that spring to life in the exhibit.

"Minnesota and the Civil War" is supported by \$646,572 from the Legacy Amendment's Arts and Cultural Heritage Fund.

"A lot of people don't know how big a role Minnesota played in the war. Our soldiers were crucial at Gettysburg and

other battles. But the exhibit will also show how the war affected individuals on a very personal level."

Many stories in the exhibit come from firsthand accounts like letters, diaries and newspapers. When the war broke out in 1861, the Minnesota Historical Society had already been collecting and preserving stories and artifacts for 12 years. "Minnesota and the Civil War" showcases 170 artifacts, including the 28th Virginia Infantry battle flag captured by the First Minnesota at Gettysburg.


Legacy funds are also allowing the Minnesota Historical Society to create a broad range of opportunities to help


> students, teachers and the general public learn more about the Civil War and the role Minnesota played. Initiatives include public programs, videos and online content at www.mnhs.org/ civilwar, where visitors will find links to events, videos, Minnesota Historical Society Press publications, art, photos and artifacts from the Society's collections and other resources related to

the war. 

A direct appropriation of \$100,000 from the Arts and Cultural Heritage Fund (ACHF) is enabling the Minnesota Civil War Commemoration Task Force to commemorate the 150th anniversary of the war. In

addition, a \$7,000 Minnesota Historical and Cultural Heritage Grant (funded by the ACHF through the Society) has made it possible for the task force to create a website, mncivilwar150.com, to increase Minnesotans' awareness of the war and of community-based commemorative events.





# Legacy Funds Create New Access to Critical Chapter in Minnesota History: The U.S.-Dakota War of 1862

Many Minnesotans say that while growing up, they didn't learn much about the U.S.-Dakota War of 1862—even though it was pivotal in shaping our state and who we are today. With the help of Legacy funds, the Minnesota Historical Society has created many new, compelling ways to help students, teachers and the general public learn about the war, its causes and its aftermath, during the war's 2012 sesquicentennial and beyond.



Inside the "U.S.-Dakota War of 1862" exhibit at the Minnesota History Center, visitors examine evidence, hear heart-wrenching stories and learn about the broken treaties and promises that led to this disastrous chapter in Minnesota history. The exhibit incorporates multiple viewpoints as well as historical and contemporary voices. Visitors are encouraged to make up their own minds about what happened and why, to discuss what they are seeing and learning, and to leave comments.

"The history of the U.S.-Dakota War is complex and compelling. We hope the exhibit inspires visitors to learn more, do their own research and uncover the truth for themselves."

An interactive, multimedia-rich website, *usdakotawar.org*, reveals stories of survival, resilience and healing while using primary resources, oral histories, maps, multiple perspectives and interactives to tell the history of the war, its causes and its aftermath. The public is invited to join discussions and also to post their family history related to the war in the "Share Your Story" section of the website.




An oral history project features dozens of personal, family stories told by descendants of those touched by the war. Society staff conducted interviews in homes in the Minnesota River Valley and in tribal community centers on Dakota reservations. 

### Highlights from the Legacy-funded Minnesota Historical and Cultural Heritage Grants Program

Every grant awarded through the Legacy-funded Minnesota Historical and Cultural Heritage Grants (MHCHG) Program provides a valuable opportunity for non-profit and educational institutions, government units and tribal organizations across Minnesota to preserve and share the state's history and cultural heritage.

More than 500 of these grants have been awarded so far this biennium; more than 950 have been awarded since the Legacy Amendment passed in 2008. A map on page 20 shows where grants have been awarded and is followed by a full listing of grants awarded so far this biennium. MHCHG highlights include:

Three grants to the Isanti County Historical Society (ICHS) are helping the small staff save what's left of its collections and archives after an arsonist set fire to the ICHS's Heritage Center on July 8, 2011. The fire destroyed 75% of the ICHS's archives and collections. Police have not yet made any arrests.

"We are devastated by this senseless act," said Executive Director Kathleen McCully. "But we are working hard to get back on our feet and we wouldn't be able to recover nearly as quickly without the Minnesota Historical and Cultural Heritage Grants we've received."

The ICHS had one of the state's finest Swedish genealogical reference libraries. Legacy funds will help rebuild the library so researchers and genealogists will once again have access to materials they won't find anywhere else.

The Alex Seitaniemi house barn in Embarrass is an extremely rare building. The structure, listed in the National Register of Historic Places, is one of only three house barns in the United States known to have been built by Finns.

Funds from the Minnesota Historical and Cultural Heritage Grants Program are helping Sisu Heritage Inc., an all-volunteer non-profit, save the house barn, an important cultural landmark as well as tourism draw.

"Heritage tourism is a vital part of our rural economy," said Paul Knuti, Director of Sisu Heritage Inc. "The Alex Seitaniemi Housebarn communicates our region's rich Finnish heritage to our residents and also serves as a way to attract visitors from across Minnesota and beyond."

It may not sound like the most exciting project, but a new heating, ventilation and air conditioning (HVAC) system at the Pope County Historical Society will bring important benefits and new opportunities to the community. The single greatest impact to preserving history is controlling temperature and humidity, thereby significantly slowing decay.

The new HVAC system, funded by a Minnesota Historical and Cultural Heritage Grant, will extend the life of Pope County artifacts and archives by creating a stable environment and removing contaminants like ash and soot created by the old corn-fired heating system. As a side benefit, the new system will also save the museum money.

"In addition to greater preservation practices, shifting utility savings into our program budget allows us to serve the community even better," said Merlin Peterson, Pope County Historical Society Administrator. "We'll be able to offer more lectures, exhibits and events, bringing more visitors to the museum more often."

On May 18, 2011 a tornado devastated families, homes and businesses in North Minneapolis. A Minnesota Historical and Cultural Heritage Grant is making it possible for Grassroots Culture, a St. Paul non-profit, to record indepth oral histories of what happened.

"This project will create a detailed, primary document of

this event, one that lets residents tell their own stories in their own words about what they experienced and how they coped with this disaster," said Philip Nusbaum, Executive Director of Grassroots Culture.

Grassroots Culture is conducting a dozen interviews with North Side residents of varying ages and backgrounds. Transcripts and digital recordings will be made available to libraries, schools and community organizations.



# Legacy-funded Archaeological Surveys Find and Save Important Sites

Amanda Gronhovd is one of many archaeologists around the state working to enrich our knowledge of those who lived here in the distant past.

With Arts and Cultural Heritage funding, the Minnesota Historical Society, the Office of the State Archaeologist and the Minnesota Indian Affairs Council are awarding and overseeing archaeological survey projects around the state. Some studies examine the recent past, while others research information from much older eras. The surveys shed light on how people have lived in our state, reveal trade relations among people across North America, and they could help protect sites that haven't yet been discovered.

For instance, in fiscal year 2012, surveys of McLeod and Steele Counties looked for evidence of settlement before contact began between Europeans and American Indians. These surveys discovered more than two dozen previously unknown archaeological sites, including one from more than 10,000 years ago.

The process of surveying these counties brings together private businesses and public agencies, and requires knowledge not only of the region's ancient history but more recent developments as well. Bolton & Menk, a local firm that works with the government and private businesses on historic preservation, surveyed McLeod County. During the late-nineteenth century, much of McLeod County was drained of its wetlands. Using data from that era and with the help of geographers at Minnesota State University, Mankato, Bolton & Menk was able to predict areas where pre-contact peoples may have lived. For instance, people were more likely to settle where two rivers met or a river met a lake.

Much of Steele County too was formerly a wetland, and also like McLeod County is now mostly devoted to agriculture. Looking at recently tilled soil, archaeologists in both counties were able to discover evidence of stone tools and other markings of ancient settlement. In Steele County, Gronhovd discovered goods made in the east and west of the region, which indicated trading relations across a wide area.

Archaeological surveys are important as well because they help researchers develop predictive software to find more archaeological sites. Identifying sites is the first step to making sure development doesn't inadvertently destroy valuable finds and it's an important step in uncovering who lived here before us and the buried legacy they left behind.

# The Minnesota Digital Library Makes History More Accessible to Students, Teachers

Minnesota's teachers have a new, developing resource when they want to talk about history, social studies, math and other subjects. An advisory board to Minnesota Reflections, a project of the Minnesota Digital Library (MDL), has spent the past two years developing Teachers' Guides that allow teachers and students from kindergarten through high school to use historical resources in classes that range from math to geology to history.

The MDL is comprised of professionals from libraries, archives, historical societies and museums across Minnesota. They are all working together to preserve and share online our state's historical resources.

Minnesota Reflections, *reflections.mndigital.org*, is a continuously updated website that brings together 135,000 images, maps and documents from more than 150 of the state's cultural heritage organizations. It creates easy access to Minnesota history and geography resources for researchers, educators, students and the public.

The Teachers' Guides are one way to make the information at Minnesota Reflections available to students all over Minnesota. The guides are based on Minnesota academic standards and help teachers use the collections to meet those standards.

Teacher Ann Woell has used some of these guides in her classroom in Moorhead. The Teachers' Guides that she has written allow her and her students to think about the ways that the past is connected to their own lives. Her students especially enjoyed seeing old photographs of Clay County where they live. They liked seeing buildings that were still standing in the area and discovering the different uses for the buildings over the years.

Woell said a photo of a flood during the 1880s struck many students because of their own experience with flooding. "Many of them have been affected by rising flood waters and it was interesting to see that people of the past in Moorhead also dealt with floods," Woell said.

The Teachers' Guides for Minnesota Reflections, available at www.mndigital.org/educators/guides, are expanding teacher and student access to history and finding innovative new ways to use historical resources beyond history class.

Subd. 5 Minnesota Historical Society 12,050,000, 12,050,000 12,950,000

These amounts are appropriated to the governing board of the Minnesota Historical Society to preserve and enhance access to Minnesota's history and its cultural and historical resources. Grant agreements entered into by the Minnesota Historical Society and other recipients of appropriations in this subdivision shall ensure that these funds are used to supplement and not substitute for traditional sources of funding. Funds directly appropriated to the Minnesota Historical Society shall be used to supplement, and not substitute for, traditional sources of funding. Notwithstanding Minnesota Statutes, section 16A.28, for historic preservation projects that improve historic structures, the amounts are available until June

30, 2015.

Statewide Historic and Cultural Grants. \$5,250,000 the first year and \$5,250,000 \$5,450,000 the second year are for history programs and projects operated or conducted by or through local, county, regional, or other historical or cultural organizations; or for activities to preserve significant historic and cultural resources. Funds are to be distributed through a competitive grants process. The Minnesota Historical Society administer these funds using established grants mechanisms, with assistance from the advisory committee created under Laws 2009, chapter 172, article 4, section 2, subdivision 4, paragraph (b), item (ii).

**Programs.** \$4,800,000 the first year and \$4,800,000 \$5,200,000 the second year are for programs and purposes related to the historical and cultural heritage of the state of Minnesota, conducted by the Minnesota Historical Society.

History Partnerships. \$1,500,000 the first year and \$1,500,000 \$1,700,000 the second year are for partnerships involving multiple organizations, which may include the Minnesota Historical Society, to preserve and

enhance access to Minnesota's history and cultural heritage in all regions of the state.

Statewide Survey of Historical and Archaeological Sites. \$250,000 the first year and \$250,000 the second year are for a contract or contracts to be let on a competitive basis to conduct statewide surveys of Minnesota's sites of historical, archaeological, and cultural significance. Results of this survey must be published in a searchable form, available to the public on a cost-free basis. The Minnesota Historical Society, the Office of the State Archaeologist, and the Indian Affairs Council shall each appoint a representative to an oversight board to select contractors and direct the conduct of these surveys. The oversight board shall consult with the Departments of Transportation and Natural Resources.

Digital Library. \$250,000 the first year and \$250,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society shall cooperate with the Minitex interlibrary loan system and shall jointly share this appropriation

for these purposes.

Commemoration Activities. \$100,000 the second year is for activities that commemorate the sesquicentennial of the American Civil War and the Dakota Conflict, as recommended by the Civil War Commemoration Task Force established in Executive Order 11-15 (2011).

### Report of Minnesota Historical and Cultural Heritage Grants

The ACHF-funded Minnesota Historical and Cultural Heritage Grants Program provides a valuable opportunity for non-profit and educational institutions, government units and tribal organizations across Minnesota to preserve and share the state's history and cultural heritage.

The Minnesota Historical Society administers the Minnesota Historical and Cultural Heritage Grants Program and awards grants based on the recommendations of the Historic Resources Advisory Committee.

nnesota Historical and Cultural Heritage Grant helped the Tod papers, enabling better access to county history

Through a competitive process, more than 900 grants totaling \$17.25 million have been awarded to more than 750 history-minded organizations in every county in Minnesota since the Legacy Amendment was passed in 2008.

So far during FY12 and FY13, 501 grants, totaling \$9.7 million have been awarded in 83 counties to more than 400 organizations across Minnesota. Awards from the last grants deadline this biennium, January 11, 2013, will be announced after this report is printed.

Minnesota Historical and Cultural Heritage Grants are available in three tiers:


- Small or Structured Grants of \$7,000 or less (awarded throughout FY12 and FY13)
- Mid-Size Grants of between \$7,001 and \$50,000 (awarded in Jan. and Oct. 2012)
- Large Grants of more than \$50,001 (awarded in Jan. and Oct. 2012)

Less than 5 percent of grants funding is used to administer and ensure the success of the Minnesota Historical and Cultural Heritage Grants Program. The funds allow the Society to lead statewide grant-writing training and assist applicants with technical information critical to submitting a successful grant application as well as supporting recipients throughout the life of their project. To assure transparency and measurable outcomes of projects, grants staff also conduct onsite visits required by the Minnesota Office of Grants Management and, at the end of the fiscal year, staff closes out and accounts for all funds awarded.

### Report of Statewide History Programs



The Minnesota Historical Society has been preserving, sharing and connecting people with history since 1849. With support from the Legacy Amendment's Arts and Cultural Heritage Fund (ACHF), the Society is investing \$10 million this biennium in more than 35 programs that are bringing the power of history to Minnesotans of all ages, in all corners of the state.

**FY 12–13 APPROPRIATIONS LANGUAGE AS AMENDED DURING THE 2012 SESSION:** *Programs.* \$4,800,000 the first year and \$5,200,000 the second year are for programs and purposes related to the historical and cultural heritage of the state of Minnesota, conducted by the Minnesota Historical Society.

#### **PRESERVING**

#### 

Increasing the public's online access to the Minnesota Historical Society's permanent collections has been a major effort of the Minnesota Historical Society. During FY12 and FY13, staff focused on broadening access to items related to the U.S.-Dakota War of 1862 and the Civil War, publishing catalog records and digital images online for more than 8,000 items at *www.mnhs.org/collections* and creating a new website, Oceti Ŝakowiŋ Seven Council Fires, developed in consultation with Dakota partners.

#### **Collections Outreach**

The Minnesota Historical Society is reaching out to and working with American Indian communities throughout the state and beyond to increase their access to collections items related to their communities. In June 2012, the Society hired a part-time Native American Graves Protection and Repatriation Act (NAGPRA) Officer to facilitate compliance with this federal law. This position fields inquiries from American Indian communities, updates accession and research files and manages consultations for the American Indian artifacts in our collection.

Special outreach efforts have been extended to the Dakota community. During FY12, the Society opened its collections to nearly 250 Dakota people. In FY13, community outreach delivered collections-based information and services into Dakota communities, reaching hundreds more.

For example, Collections staff were present at the following events: the Dakota Iyuha Owanjina (Together as One) Conference in Minneapolis and Saint Paul, the Mendota Wacipi (powwow), the Winona Gathering and the Mahkato Wacipi (Mankato powwow). Society resources relating to Dakota communities were promoted through small exhibit panels and free handouts (bookmarks, genealogy resource pamphlets and USB drives loaded with links to helpful online web pages).

#### Digitization of Minnesota's

#### 

This project is moving from its final development phase to an implementation phase which will give students, teachers, researchers, genealogists and the general public access to a greater number of Minnesota newspapers from around the state on the internet.

Society staff is presenting the system to stakeholders for usability testing, working out access agreements with publishers of current newspaper content and forming new partnerships with willing partners to ingest, preserve and make available current newspaper content.

Staff will also continue digitizing existing newspaper microfilm to produce more content for the public to access. The Minnesota newspapers online project will launch to the public in 2013.

#### Historic Sites Revitalization ..... \$271,524

From large sites to small, Minnesota Historical Society staff are seeking new programs and uses to connect people to the state's most important and prominent historic sites. Audience research about each site will result in reports outlining new uses and programs to make the sites more interactive, accessible and relevant to visitors. These new uses and programs will reverse the trend of decreased visitation at some sites. Four sites now undergoing the revitalization process are:

- The Charles A. Lindbergh Historic Site, a National Historic Landmark which includes the aviator's boyhood home and farmstead. A findings report will be completed in spring 2013.
- Historic Fort Snelling, the state's first National Historic Landmark, which played a central role in the development of the state and the nation. Audience research reports were completed in fall 2012 and new programs will be launched in June 2013.
- The Oliver H. Kelley Farm, another National Historic Landmark, where visitors experience mid-19th-century Minnesota farm life. New school programs are under development and will be tested in spring 2013.
- The Alexander Ramsey House, which was home to Minnesota's first territorial governor, holds one of the most intact collections of Victorian-era artifacts in the Midwest. It was the first site to begin this revitalization process and is already seeing positive results including increased visitation and popular new programs.

#### Oliver Kelley Farm

#### Historic Structures Report ...... \$25,000

The Oliver H. Kelley farm in Elk River is a National Historic Landmark where visitors experience mid-19th-century Minnesota farm life. This historic structures report provides the foundation for future maintenance and preservation of the farmhouse while continuing to provide an important level of programming and public service. The Jeffris Family Foundation has awarded a matching grant of \$25,000 to the Minnesota Historical Society to fund half of the estimated costs of a consultant to prepare the report.

#### Jeffers Petroglyphs

#### Digital Data Storage..... \$50,724

Valuable three-dimensional images of ancient rock carvings at Jeffers Petroglyphs will be safely stored and also made accessible to the general public. ACHF funds allowed staff to catalogue the images and make them accessible at the Jeffers site and through the Minnesota Historical Society's Collections Online website. The images of individual carvings will serve as an archival record, a research and conservation resource and an educational tool.

### Preserving Language and Culture Through Stories:

#### Jeffers Petroglyphs Site ..... \$47,767

This project helps preserve and teach Dakota language and culture. Stories relating to the Jeffers Petroglyphs historic site told by Dakota elders are being transcribed, translated and made available to students, teachers and the general public. In phase one of the project, Minnesota Historical Society staff collected, recorded and interpreted the stories. The stories will now be made accessible in Dakota and in English via the internet, DVD and also at Jeffers Petroglyphs.

#### Restoration of Governors' Portraits \$29,390

In this project, completed in FY12, 16 portraits of Minnesota governors were cleaned and protected with the addition of high-quality, non-glare/UV filtering plexiglass. The portraits of Minnesota's governors grace the halls of the Minnesota State Capitol and provide an important legacy of the state's past and present leaders.

There's a natural relationship between sustainability and historic preservation, and the Minnesota Historical Society recognizes the importance of environmental stewardship as we preserve our cultural heritage for future generations.

During the third phase of this project, staff continue to implement and verify recommendations for reducing the Society's environmental impact. More focus is being placed on educating staff and visitors about sustainability through the project's "More for the Mission" campaign. In addition, staff will produce a second sustainability audit, which will feature a new set of recommendations for further savings, and report back on the measured savings from the first audit.

The Society projects that over the next five years, sustainability initiatives will save more than \$1.8 million and reduce greenhouse gas emissions by 15%.

These efforts have led to recognition by the American Alliance of Museums and international experts on sustainability. In July 2012, Society staff leveraged the ACHF funds devoted to this project to earn a \$100,680 Fidelity Foundation grant, which will support installing environmentally-friendly lighting at Mill City Museum, Split Rock Lighthouse and the Minnesota History Center.

#### U.S.-Dakota War of 1862

Sesquicentennial.....\$686,634

2012 marks the 150th year since the U.S.-Dakota War of 1862, a disastrous time in Minnesota history. This year, the Minnesota Historical Society has been offering many new ways for people to learn about the war, its causes and its aftermath and how its bitter consequences are still felt today. Commemorative programs and resources include:

- U.S.-Dakota War of 1862 Website—The Minnesota Historical Society launched a unique, comprehensive website enriched with video, audio, interactive tools and primary sources to illuminate this profoundly important time in Minnesota and U.S. history. The site, www.usdakotawar.org, is designed for teachers, students, researchers and everybody else interested in the broader national causes of the war, the war itself and its far-reaching consequences.


#### • Minnesota River Valley Scenic Byways Mobile

Tour—This new mobile tour offers intriguing stories and reflections about historic sites along the Minnesota River Valley, the people who lived there and the lasting impact of the U.S.-Dakota War of 1862. The tour can be accessed by calling 888-601-3010 from any location. Society staff matched \$46,800 in ACHF funding with \$183,000 for the mobile tour from the National Scenic Byways Discretionary Grants Program administered by the Federal Highway Administration.

- Oral History Project—Minnesota Historical Society staff members have recorded dozens of oral histories from Dakota and settler descendants of those touched by the war. Audio and transcripts are available at www.usdakotawar.org/stories. Minnesota Historical Society staff conducted interviews in homes throughout the Minnesota River Valley as well as in tribal community centers on Dakota reservations.
- Legalities Exhibit and Symposium—William Mitchell College of Law and the Society collaborated on an exhibit focusing on treaties and legal matters related to the war. The exhibit, on view through March 2012 at William Mitchell, also travelled to the Brown County Historical Society in the summer of 2012. In October 2012, William Mitchell and the Society co-sponsored a symposium at the law school titled, "The Law and the U.S.-Dakota War of 1862."
- Art Exhibit—The Society partnered with the Native American Community Development Institute (NACDI) and All My Relations Arts to sponsor an exhibition of work by 20 contemporary American Indian artists.
   Titled "Ded Unk'unpi, We Are Here," the exhibition opened in August 2012 at All My Relations Gallery and in October traveled to the James J. Hill House in St. Paul.

• New Interpretive Signage—Ten historic markers at Fort Ridgely, the Lower Sioux Agency and the Upper Sioux Agency were installed in spring 2012 to replace old signs with outdated language.

• U.S.-Dakota War of 1862 Public Programs — The Minnesota History Center invited the public to participate in programs that explored Dakota language and culture and also the history of the U.S.-Dakota War of 1862. Public programs provided multiple perspectives on the war and gave voice to Dakota history and identity through a variety of formats including lectures, films, tours and workshops.

- U.S.-Dakota War of 1862 Outreach Throughout FY12 and FY13, Minnesota Historical Society staff members have reached out to and met with many groups and individuals to gather their opinions and recommendations regarding an exhibit on and the commemoration of the U.S.-Dakota War of 1862. Staff met with Dakota tribal councils in Minnesota, Nebraska and South Dakota, individuals from tribes in Minnesota and throughout the Midwest and residents of Brown and Nicollet Counties.

In addition, the Society sponsored the "We Gather Together As One" Dakota nationwide conference in Minneapolis and St. Paul in fall 2011 and summer 2012 and also showed, at the Minnesota History Center and at Historic Fort Snelling, "38 Plus 2," a film about the mass hangings in Mankato.



• U.S.-Dakota War of 1862 Public Information and Communication—Minnesota Historical Society staff developed a campaign to raise awareness about the significance of the U.S.-Dakota War of 1862 and new Society educational initiatives related to the war to ensure that students, teachers and the general public would use and benefit from these initiatives. In addition, a comprehensive brochure about the war was distributed throughout Minnesota. Social media, advertising and extensive statewide and regional media coverage also helped raise public awareness about this critical chapter in Minnesota history.

#### U.S.-Dakota War of 1862 Exhibit . . \$329,523

This exhibit, on view at the Minnesota History Center through Sept. 8, 2013, recounts the Minnesota war that tore apart lives, families and the Dakota nation. Visitors can view documents, images and artifacts related to the war, as well as hear heart-wrenching stories and learn about the broken treaties and promises that led to this disastrous chapter in Minnesota history.

There are many, often conflicting, interpretations of events related to the war. The exhibit includes multiple viewpoints, as well as historical and contemporary voices. Descendants of people involved in the war took an active role in shaping the exhibit. See U.S.-Dakota War of 1862 Outreach project on the left side of this page.

### Minnesota and the Civil War Exhibit.....\$646,572

"Minnesota and the Civil War," a new 5,000-square-foot exhibit opening at the Minnesota History Center March 2, 2013, will reveal the words and actions of Minnesotans who lived during the war. Minnesota responded first in the nation and, fighting in almost every major battle, Minnesotans were among the most tested and honored in the Union Army. Stories of soldiers and their loved ones at home will be drawn from the Minnesota Historical Society's collections: letters, diaries, memoirs and reminiscences that capture the personal impact of this tumultuous period. The war, and Minnesota's connection to it, are of deep interest to many Minnesotans, especially during the war's 150th anniversary.

#### Statewide Civil War Outreach . . . . . \$107,579

To commemorate the 150th anniversary of the Civil War, the Minnesota Historical Society is creating a broad range of opportunities to help students, teachers and the general public learn more about the war and the role Minnesota played. Initiatives include:

- A Civil War topic page, www.mnhs.org/civilwar, with links to videos, books, art, photos, artifacts, events and other resources related to the war
- Collaboration with community partners to commemorate the Battle of Antietam and the Preliminary Emancipation Proclamation in September 2012
- A series of History Forums at the Minnesota History Center focused on different aspects of the war. The forums, presented by nationally-recognized historians, will be videotaped and posted on the Civil War topic page
- A dozen short films that will spotlight Civil War milestones and Minnesotans' experiences on the homefront

 A partnership with the Guthrie Theater to share insights about our Civil War collections with audiences of the theater's production of "Appomattox." Society staff will continue planning more initiatives with other organizations including the Minnesota Civil War Commemorative Task Force, the United States Postal Service and Civil War Roundtables.

### Civil War Public Information and Communication.....\$80,000

The Minnesota Historical Society developed a communications strategy to raise awareness of the significance of Minnesota's role in the Civil War and also the Society's educational initiatives, exhibits and programs related to the war to ensure that students, teachers and the general public would use and benefit from these initiatives.

### U.S. and Minnesota Constitutions Exhibit ...... \$65,658

The Minnesota Historical Society brought the only traveling copy of the U.S. Constitution and Bill of Rights to Minnesota in the exhibit, "We the People: The First Official Printing of the U.S. Constitution" on view at the Minnesota History Center April 3 – July 4, 2012. The exhibit featured a rare, early version of the U.S. Constitution, published in 1787, and an even more rare draft of the Bill of Rights, along with original editions of the two state of Minnesota Constitutions.

#### Then Now Wow Enhancement.... \$323,720

Arts and Cultural Heritage funds supported staff time devoted to creating "Then Now Wow," a major, new, hands-on exhibit that brings fascinating people, places and stories of our state to life. Visitors to "Then Now Wow" (the exhibit's working title was "Our Minnesota") which opened at the Minnesota History Center in late November 2012, explore the state's distinctive places and meet the diverse people who have made their homes here. #### Exhibit Development . . . . . . . . . . \$131,641

Development is underway on a number of future History Center exhibitions that will explore the rich stories of Minnesota's past. Major exhibitions will center on how Minnesotans have played, the national impact of the 18th Amendment and Prohibition, and the Vietnam War experience and its legacy. Other exhibitions will highlight the variety of communities in the state and will bring the fascinating collections of the Minnesota Historical Society to public view.

#### E-book Publishing ......\$60,500


To meet increasing demand for digital books, 136 Minnesota Historical Society Press (MHS Press) books have been converted and are available as e-books from popular e-book vendors. Six short form e-books will be released by the end of January 2013. Digital editions of more than 80 MHS Press books are available to libraries, researchers and students via Project Muse, a leading provider of digital humanities and social sciences content. In addition, an enhanced e-book about Minnesota in the 1970s is now being written and developed and will be published in fall 2013.

#### Fort Snelling Virtual Tour ...... \$40,000

Four new and unique views of Fort Snelling from various points in history will be available for students, teachers and the general public to access online. The Minnesota Historical Society has been collaborating with the Institute for Advanced Technology in the Humanities at the University of Virginia to build four computer models that illustrate a dynamic and changing Fort Snelling from 1820 to 1945. The models will be linked to a rich and interrelated set of materials from all parts of the Society's collections, including photographs and manuscripts. In spring 2013, project staff and Historic Fort Snelling staff will plan how the models can best serve the public online and at the fort.

## Innovative Training Opportunities for Minnesota Teachers . . . . . . \$287,893

The Minnesota Historical Society is removing financial and geographic barriers for Minnesota teachers who want to attend professional development courses. With these funds, the Society is making enriched, affordable Minnesota history training opportunities available to teachers around the state through a series of professional workshops, conferences and immersion experiences. Limited subsidies are available for lodging, mileage and substitute teacher reimbursement.

Examples of teacher training opportunities and locations in FY12 and FY13 include Technology, Tools and Resources (Bemidji, Mankato, St. Paul), Historic Site Immersion (North West Company Fur Post, Pine City) and U.S.-Dakota War of 1862 (St. Paul).

The Minnesota Historical Society also partnered with two institutions to provide content and skills to Minnesota teachers: Colonial Williamsburg and the Library of Congress Teaching with Primary Sources program. These partnerships resulted in two free workshops in St. Paul attended by more than 90 teachers. All training opportunities reinforce state standards for Minnesota and American history.

## MNopedia: The Minnesota Encyclopedia......\$374,559

The Minnesota Historical Society has launched and is expanding MNopedia, the first online encyclopedia about Minnesota. MNopedia is a growing digital resource that provides reliable, multimedia entries related to the state and its history. MNopedia will be tested, refined and broadened with additional content and tools, giving students, teachers, researchers and the general public greater access to information, images, documents and other historical resources relating to Minnesota.

In total, 14 sites and museums are revamping their field trip programs and developing online resources requested by teachers and parents in earlier research, so that 21st century learners can develop a stronger connection to the study of history.

#### History Day Expansion.....\$362,445

History Day, an annual program co-sponsored by the Minnesota Historical Society and the University of Minnesota, challenges young people to research a historical subject related to an annual theme and present their findings in the form of exhibits, documentaries, performances, websites and papers. It is a rigorous program used by schools to meet state graduation standards for history and applied learning. Minnesota is widely recognized as a national leader in using the History Day program to improve academic achievement in history.

With the help of the Arts and Cultural Heritage Fund, the Minnesota Historical Society is enriching services to History Day students and helping more students across the state with researching and creating their History Day projects. Services include:

- classroom visits by Society educators
- support for field trips to county and university libraries
- the assignment of undergraduate mentors from Minnesota colleges and universities to advise local students
- organizing regional professional development workshops for History Day teachers

In FY12 and FY13, ACHF funds made it possible for the Society to deliver additional History Day services to more than 430 schools in 49 Minnesota counties. More than 525 teachers used these services, benefiting approximately 30,000 students in grades 6–12.

#### History Live ......\$456,698

The award-winning History Live program served more than 5,500 Minnesota students in FY12 while creating new history lessons to deliver via video conferencing technology. New programs focus on Dred and Harriet Scott, Dakota history and Jeffers Petroglyphs. History Live staff are also developing a way to deliver content to seniors living in residential facilities and will continue building a state and nationwide audience for these unique, high-energy history programs.

History Live educators at the Minnesota History Center beam in-depth, interactive history programs into class-rooms across the state and country. In 2012, **History Live won a second award from the Center for Interactive Learning and Collaboration for outstanding educational programming through video conferencing**. The award is based exclusively on feedback from teachers who have used History Live in their classrooms.

#### History in Our Hands . . . . . . . . . . \$294,622

This groundbreaking project is creating a new model for school field trips using mobile and web technologies to capitalize on the natural behaviors and learning styles of today's students.

"History in Our Hands: the Field Trip for the 21st Century Learner," will demonstrate how museums can use technology to create self-directed, personalized, responsive field trip experiences that deepen students' connection to history while honing their critical thinking and problem-solving skills.

Launching in fall 2013 to students on field trips, "History in Our Hands" will first be used in the recently opened "Then Now Wow" exhibit. Upon entering the gallery, students will receive handheld devices pre-installed with the mobile application. The application will enhance students' experience and promote interaction with the physical exhibit by encouraging them to answer questions, solve problems and collect digital artifacts related to the exhibit and items in MHS's vast collections.

These items will be stored in a student's "digital backpack," and can be accessed online long after the field trip is over, promoting further classroom study and post-visit projects.

A "Classroom Toolkit" will also be available to help teachers incorporate the content from students' digital backpacks into future lessons and build on the fundamental strengths of field trips as supplements to classroom instruction.

Society staff leveraged the initial research involved in creating "History in Our Hands," made possible by the Arts and Cultural Heritage Fund, to earn a \$449,000 National Leadership Grant from the Institute of Museum and Library Services in the fall of 2011.

#### Intergenerational

Learning Programs . . . . . . . . . . . . . \$340,304

Minnesotans of all ages are participating in deep intergenerational learning experiences by working together to document community history and create lasting products (exhibits, documentaries, audio tours etc.) that are shared with their communities.

These intergenerational collaborations build relationships among members of older and younger generations, increase students' appreciation for Minnesota history and recognize the importance of older adults and their role in transmitting community history.

A survey of Intergenerational Learning Program participants found that:

- 100% of youth participants felt that the older adults in their community had a lot of valuable knowledge and wisdom to share.
- 95% of youth participants said that the program increased their appreciation for Minnesota history.
- 90% of youth participants would recommend the program to others.

In FY12, ten projects were held in Alexandria, Saint Paul, Detroit Lakes, the Iron Range, Minneapolis, Mora and Stillwater. Projects in FY13 are being held in Hibbing, Chisholm, Cook, Bird Island, Minneapolis and Saint Paul. #### Legacy Field Trip Support Fund .. \$164,385

The Legacy Field Trip Support Fund will help an estimated 39,000 Minnesota students experience field trips at Minnesota historic sites and museums statewide in FY12 and FY13. The high cost of transportation prohibits many Minnesota teachers from taking their students on field trips.

The Legacy Field Trip Support Fund offsets transportation costs to all of the Minnesota Historical Society's 26 museums and historic sites statewide. Eligible schools are reimbursed \$3 per student.

# Engaging Students in Minnesota History through Internships and Education ...... \$248,103

The Minnesota Historical Society strives to attract high school and college interns from underrepresented communities to encourage engagement and diversify the institution. Students are placed across the Society in various departments and sites and have the opportunity to work alongside museum professionals to enhance their skills and apply their knowledge in a professional environment.

College students participate in learning activities together over a semester-long period to enrich the internship experience and network with other interns in their cohort. The activities focus on engaging with the Society on a deeper level by discussing current issues and trends with museum staff, sharing intern experiences and building professional networks.

During FY12 and so far in FY13, Arts and Cultural Heritage funding has supported 96 college interns who have contributed more than 9,900 hours across the Society and seven high school students who have contributed more than 500 hours of service at two historic sites.

# "Hands-On" History Curriculum Supplements for Minnesota Students . . . . . . . . . . \$382,757

The Minnesota Historical Society is developing creative, hands-on learning projects for K-12 students that adhere to state social studies standards and introduce students to important aspects of Minnesota and U.S. history. For example, students will explore the role of slavery in American history by examining historical newspapers, letters and laws and by watching a series of dramatic portrayals of Dred and Harriet Scott who lived at Fort Snelling in the 1830s. These projects will be made accessible to teachers around the state and around the country in 2013.

#### 

With the help of Arts and Cultural Heritage funds, the Minnesota Historical Society is the first institution of its kind to fully digitize its entire oral history collection. This project promotes the discovery and use of the Minnesota Historical Society's oral history collection by digitizing 2,000 hours of recorded audio and making more existing oral histories available to the public on the "Becoming Minnesotan" website, *education.mnhs.org/immigration*. This collection represents a rich and unique source of history through the experiences of Minnesotans in their own words.

#### Multimedia Support . . . . . . . . . . . . . \$298,871

Multimedia support enriches the Minnesota Historical Society's programs, exhibitions and websites with innovative, high-quality multimedia productions. Through audio, video, interactive and immersive productions, the program allows the Society to capture and present the stories of Minnesotans and document the impact of Legacy history projects. Rich media content enhances students' and teachers' experiences with the Society's curricular resources, engages visitors of all ages at the Society's museums and historic sites and reaches audiences everywhere through web and mobile delivery.

## Reaching Out to the Community Through Historic Sites ......\$53,991

The Minnesota Historical Society manages 26 historic sites and museums across Minnesota. Recognizing an opportunity to work with organizations where historic sites are located, the Society is collaborating with local historical organizations around the state to assess and improve their service to the public.

Society staff are working with the Nicollet County Historical Society, the Lower Sioux community, the city of Moorhead, the Taylor's Falls Historical Society, the Mayo House Interpretive Society, the Chippewa County Historical Society, the Minnesota Transportation Museum and the communities of International Falls and Marine on St. Croix, to assess historic site operations and possibilities for improvement. Reports from this work will provide a road map for improvements in the coming years.

In addition, Society staff are working with schools and teachers to build and support History Day participation and activities around the state.

#### Statewide Traveling Exhibits:

#### "Exhibits to Go" .....\$302,986

Five traveling exhibits are making more than 45 stops in communities around the state in FY12 and FY13, giving more Minnesotans the chance to experience history in their own backyards.

The exhibits feature freestanding displays, audiovisual and interactive components, and onsite and online educational programming. They are:

- Minnesota on the Map
- · Minnesota Homefront
- Electrifying Minnesota
- Uncle Sam's New Deal
- Minnesota Disasters

Two traveling exhibits were developed working with teens. "Minnesota Remembers: the 1960s," focused on the life, music, entertainment and issues of being a teenager during that decade. From June to August of 2012, the exhibit stopped at libraries in Willmar, St. Cloud and Fergus Falls, where local teens created their own exhibit based on interviews with local residents who were teens during the 60s.

In fall 2012, ten American Indian high school students worked with the Society and the non-profit Photography at the Center to create a traveling photography exhibit. Students learned about portraiture, contemporary and historical representations of American Indians and photography while working with a local American Indian artist to create a contemporary self-portrait. The portrait exhibit will be displayed at the Minneapolis Photo Center in December 2012 and at the Minnesota History Center in January 2013.

# Support of Local History Organizations ................................\$132,329

This funding supports and ensures the success of the ACHF-funded Minnesota Historical and Cultural Heritage Grants Program. It allows Society staff to seek out potential grant applicants, lead statewide grant-writing workshops and webinars, and help applicants with technical information critical to submitting a successful grant application, as well as supporting recipients throughout the life of their projects.

To assure transparency and measurable outcomes of projects, grants staff conducts onsite visits required by the Minnesota Office of Grants Management and, at the end of the fiscal year, staff closes out and accounts for all funds awarded.

#### Technology Support.....\$564,420

This funding allows the Minnesota Historical Society to broaden access to many of its Legacy-funded programs through the internet. It supports the web development professionals who plan, build and implement digital components that are part of many Legacy-funded history projects. One example, the MNopedia website, was launched in August 2011. MNopedia provides reliable, multimedia entries about Minnesota people, places, events and things.

#### **Public Information and**

#### Communication......\$591,188

Minnesota Historical Society staff created and implemented communication strategies for FY12 and FY13 Legacy-funded history projects and programs, including the "Then Now Wow" exhibit, designed with schoolchildren in mind. Increasing public awareness of these investments ensures that students, teachers and the general public use and benefit from them, giving greater understanding of Minnesota's history and legacy for the future.

The Society reached out to potential audiences through media relations efforts, social media, digital marketing and through communications channels and events ranging from billboards and newsletters to outreach at teacher conferences and the Minnesota State Fair.

#### Administrative Expenses...... \$278,022

In order to implement its Arts and Cultural Heritage Fund (ACHF) projects, the Minnesota Historical Society employs an ACHF Manager to oversee the program administration. The Society is also supporting administration of the grants program and expanded financial management and administrative functions. The Society is diligently working to keep administrative costs low while adhering to the legislative mandate that costs be "directly related to and necessary for a specific appropriation."

#### Program Evaluation . . . . . . . . . \$148,632

To meet the expectations of the legislature and the people of Minnesota, an evaluation coordinator is measuring the outcomes and value of programs, projects and partnerships supported by the Arts and Cultural Heritage Fund (ACHF) through the Minnesota Historical Society. In October 2010, the Society worked with Wilder Research to improve the Society's ability to evaluate its ACHF projects and programs. The Society's staff and partners are now strongly positioned to ensure that ACHF projects and programs use best practices, current scholarship and when appropriate, incorporate state-of-the-art technology for demonstrating measurable outcomes.

During the 2012-2013 biennium, the Society's evaluation coordinator is tracking the impact of ACHF projects and programs to ensure these initiatives demonstrate measurable outcomes as well as economic value for citizens. These results will be shared on two websites: legacy.leg.mn and legacy.mnhs.org.

### Report of Statewide History Partnerships



Funding from the Legacy Amendment's Arts and Cultural Heritage Fund (ACHF) has resulted in partnerships between the Minnesota Historical Society and more than two dozen organizations as well as partnerships between other history-minded groups. These partnerships promote the sharing of knowledge and resources and help extend the reach of the ACHF across the state.

## Asian American Oral History Project.....\$207,778

#### **Partner: Council on Asian Pacific Minnesotans**

Many immigrant communities have few documents or artifacts that preserve and tell their stories of arrival, settlement and adjustment to life in Minnesota. Oral history is the best way to preserve this important history and to ensure that it becomes part of Minnesota's historical record.

In this project, Minnesota Historical Society staff conducted interviews with members of the Laotian, Korean, Karen, Filipino, Vietnamese, Indonesian, Malaysian and Pacific Islander communities in Baudette, Warroad, Worthington, St. Cloud and Rochester, as well as in the Twin Cities.

The interviews serve as resources for teachers and students and will be available on the Society's website, "Becoming Minnesotan: Stories of Recent Immigrants and Refugees" *education.mnhs.org/immigration*. The site features people who comment with authority on their community's composition, challenges, achievements and contribution to Minnesota's cultural landscape.

Chinese, Japanese, Thai, Indian and Cambodian immigrants have left an indelible and flavorful mark on Minnesota and on our culinary, cultural and economic history. The book "Asian Flavors" and an accompanying documentary record the story of countless men and women who made the arduous journey halfway around the world to live in Minnesota, fleeing oppression and persecution or in search of jobs and education. This project preserves and shares their stories of survival and success in our state, stories that serve as an inspiration to all.

## Chicano Latino Oral History Project.....\$59,695

#### **Partner: Chicano Latino Affairs Council**

The Chicano-Latino population in Minnesota has grown dramatically since 1980. The Minnesota Historical Society is partnering with the community to ensure their stories of arrival, settlement and adjustment to life in Minnesota are recorded and preserved for future generations.

Minnesota Historical Society staff have completed interviews in Moorhead, Willmar and the Twin Cities and produced a published book for each narrator, totaling more than 1,300 pages of transcripts as well as a video project "Latino Business Leaders Defining Success."



Minnesota Main Street Program....\$292,107
Partners: Preservation Alliance of Minnesota (primary),
University of Minnesota Extension Center for

The Minnesota Main Street Program is a proven, comprehensive strategy that helps communities create new jobs and businesses while preserving their historic downtowns.

The Minnesota Historical Society's State Historic Preservation Office is working with the partners listed above to implement Minnesota Main Street, which provides the tools, training, information and networking communities need to revitalize their business districts.

There are currently four Minnesota Main Street Designated Communities: Faribault, New Ulm, Red Wing and Willmar.

In the first three quarters of 2012, these cities gained 64 full-time jobs and 15 new businesses in their communities. Volunteers contributed more than 5,200 hours. These cities also saw 25 building rehabilitation projects completed, valued at over \$700.000.

In addition, there are more than 20 Associate Member communities that receive access to networking opportunities and discounted admissions to trainings.

For every \$1 spent on running the local Main Street Program in Minnesota in 2011, \$18.84 is reinvested in the community.

A large and important collection of Minnesota artifacts will be organized and inventoried through this partnership. Artifacts in the collection represent some of Minnesota's premier archaeological sites including the 8,000-year-old Itasca Bison Kill Site at Lake Itasca State Park and the Cooper Site, a 17th century Dakota village at Mille Lacs Kathio State Park.

Work completed through December 2012 includes a physical inventory of 1,400 boxes of artifacts, updates to more than 5,000 records in the MHS Collections Management System and development of priorities for future conservation activities.

This work will ultimately give the public better access to this collection, made up of materials collected over 70 years. This project will also improve the security of the artifacts by bringing their storage conditions and collections management data up to museum standards.

#### Building on the Legacy of the Conservation Corps . . . . . . . . . . . . \$134,479

#### **Partner: Conservation Corps of Minnesota**

The Minnesota Historical Society and the CCM are working together to keep the important legacy of the Civilian Conservation Corps (CCC) alive. During the summers of 2011 and 2012, young adult members of the CCM interned at the Forest History Center in Grand Rapids. They

- · learned about the history and legacy of the CCC
- · conducted oral history interviews with CCC alumni
- interacted with and engaged the public in historic interpretation
- implemented on-the-job forest conservation practices
- taught conservation to students and other Forest **History Center visitors**
- presented tree identification, birding and GPS programs to the public

In summer 2012, the CCM crew also completed a number of maintenance projects at the Forest History Center, created an interpretive panel for the center's walking trails and a phenology program for children.

#### 1968 History Theatre Performances. . . . . . . . . . . . . . . . . \$10,000

#### **Partner: History Theatre**

1968: The Year that Rocked the World, produced by History Theatre, was performed in front of packed houses at the Minnesota History Center from Jan. 21 to Feb. 19, 2012. The show featured some of the most explosive events and personalities of 1968: Hubert H. Humphrey and Lyndon B. Johnson, the war in Vietnam, the assassinations of Dr. Martin Luther King, Jr. and Senator Robert Kennedy, the Mexico Olympics, the election of Richard Nixon and the Apollo 8 mission broadcast on Christmas Eve.

Most performances were either sold out or very close to sold out. 1968: The Year That Rocked the World gave new audiences the opportunity to learn about Minnesota's role during this tumultuous year.

#### Geo-tagging Collections . . . . . . . . . \$32,868 **Partner: The Minnesota Geospatial Information Office**

In the spring of 2013, students and the general public will be able to choose a specific place on an online map of Minnesota and historical images and information related to that spot will automatically appear. The site will give students and the general public a deeper knowledge of the history of particular places in the state. Geo-tagging staff has been adding geographical markers to more than 300,000 of the Society's historic photographs, maps and artifacts.

#### MNopedia Collaboration . . . . . . . . . \$50,000 Partner: MinnPost

MNopedia and MinnPost, an online news organization, are working together to share content and make Minnesota history more accessible. MNopedia, www.mnopedia.org, is the first digital encyclopedia about Minnesota. All MNopedia articles are prepared by historians, consulting experts, professional writers and others vetted by the Minnesota Historical Society. Once a week, MinnPost publishes a MNopedia article on its website. In addition, twice a month for ten months, MinnPost is creating and publishing news articles that relate to historical events in Minnesota. That content will then be developed into MNopedia entries.

# I-35W Bridge Collapse Exhibit and Commemoration......\$79,000 Partners: The City of Minneapolis and the Minneapolis Foundation

A photo exhibit and commemorative event marked the fifth anniversary of a catastrophic event in Minnesota history: the collapse of the I-35W bridge. For the exhibit, local artist Vance Gellert interviewed and photographed survivors, people who lost loved ones, first responders and other helpers. The exhibit was on view at Mill City Museum in Minneapolis from Aug. 1 to Dec. 30, 2012.

A public commemorative event at Mill City Museum on Aug. 1 featured original works including a musical composition, a ten-minute play and five poems commissioned by Nautilus Music-Theater, The Playwrights' Center and Rain Taxi Review of Books, respectively.

# Minnesota History Day and Programming at the State Fair..... \$76,862 Partner: The Minnesota State Fair Foundation

The Minnesota Historical Society and the Minnesota State Fair Foundation are increasing awareness and knowledge of Minnesota history by providing quality programming for visitors to the Great Minnesota Get-Together. The partners updated content for the Minnesota State Fair History Walking Tour, added a cell phone tour component and also made tour content available to smartphone users. Fairgoers also celebrated Minnesota History Day at the State Fair Sept. 4, 2011 and Sept. 2, 2012, with live multicultural entertainment, history trivia contests, kids crafts, historical characters and more.

# "Museums Creating Community" Video Production ............\$49,350 Partners: Hennepin History Museum, Minnesota Association of Museums, Minnesota Productions of Twin Cities Public Television

Every county in Minnesota boasts at least one historical or cultural museum, often a distinct source of community pride. This video project documents and shares stories from many Minnesota museums, revealing how they inspire and foster community.

The 30-minute, Emmy-nominated video aired on all six Minnesota PBS stations, on the web and at Minnesota museums. The video will also be available for use in class-rooms, libraries and senior centers, and was shown at the American Association of Museums national conference in the spring of 2012.

# Library Outreach Programs ......\$322,212 Partner: The Minnesota Regional Public Library System

The Minnesota Historical Society and regional public libraries across Minnesota are combining resources to educate, entertain and build community among library patrons around the state.

Libraries and the Society are bringing a range of programs and events to local libraries that document and preserve community stories for future generations, educate people of all ages about the history of Minnesota and its people, and make high quality history programming accessible to all Minnesotans.

Programs, presented in dozens of communities around the state to thousands of participants so far this biennium, include:

- a Civil War interactive experience
- a scrapbooking workshop that preserves family recipes
- heritage music performances
- an interactive history mystery for teens
- History Player performances
- · a Minnesota-centered book club

To help with the challenges of scarce funding and restrictions on out-of-school training, the Minnesota Historical Society and the Minnesota Humanities Center are developing two professional development courses for teachers to access online, anywhere, anytime. The courses will reinforce the revised social studies standards and meet teachers' scheduling needs, creating greater teacher access and more cost-efficient delivery of programs.

The first online professional development offering, African-American History in Minnesota, launched in September 2012. The course, designed for grade K–12 teachers, includes national history context, Minnesota content, individual stories of Minnesota African-Americans, and classroom-ready activities using primary sources. It provides teachers with content that will help them integrate more of Minnesota's African-American history into U.S. and Minnesota history courses.

The next course, which focuses on a more general history of Minnesota, will launch in spring 2013.

# Building Financial Capacity in Local Organizations...... \$76,935 Partner: Access Philanthropy

The 500-plus historical societies and organizations throughout Minnesota have a deep passion and commitment to the work they do and the people they serve. Too often, however, these organizations lack the staff, time and skills necessary to secure ongoing financial support. Even the most experienced organizations have felt increased competition for funds in an increasingly uncertain economy.

This program creates an opportunity for local history organizations to build their financial capacity through intensive training in non-profit fundraising and grant proposal preparation. By offering this training, the Minnesota Historical Society and its partners hope to increase the capacity of local historical societies and organizations throughout Minnesota to not only apply for and receive grants, but to diversify and strengthen their funding and support base.

More than 200 volunteers and paid staff from small and medium-sized historical organizations have attended intensive training workshops offered in these communities: Andover, Duluth, Luverne, Mankato, St. Cloud, Willmar and Winona.

#### Neighborhood Leadership

#### **Partner: The Amherst H. Wilder Foundation**

The Minnesota Historical Society and the Wilder Foundation worked with new groups of existing and emerging community leaders in the fall and winter of 2011 and 2012 to enhance their ability to act on important community issues.

During each six-month program, 30 participants explored neighborhood involvement and developed leadership skills to take effective community action. Through visits to the Minnesota History Center, participants learned about the diverse history of St. Paul and also all of the resources the Minnesota Historical Society has to offer. Participants learned how understanding the history of their community will improve communication with community members, framing of community issues and goals and strategies for creating change.

#### **Summer History Immersion**

#### **Partner: University of Minnesota-Twin Cities**

Thirty high school students from diverse backgrounds participated in a college-readiness program at the University of Minnesota-Twin Cities. Students learned high-level research and presentation skills while working with various collections in the Andersen Library. Students also learned how to apply for college, spent the night in a dorm room, participated in mock lectures with professors and other activities designed to increase their confidence and comfort level with campus life.



# Education Diversity Outreach ......\$95,179 Partners: Associated Colleges of the Twin Cities (ACTC), Minnesota State Colleges and Universities (MNSCU), Minneapolis Public Schools, St. Paul Public Schools

Through this program, partners are extending the reach of Minnesota History Day while providing History Day support for students from diverse backgrounds and strengthening the mentoring skills of Minnesota college students. Undergraduate students from ACTC and MNSCU colleges are trained to become History Day mentors and work with History Day students at local schools.

In another component of the partnership, undergraduate students representing all five ACTC colleges participated in a semester-long course designed to increase knowledge about the museum field. Students interned at Minneapolis and St. Paul public schools, mentoring students participating in the History Day program. ACTC Fellows also visited leading museums in the midwest to compare and contrast the Minnesota Historical Society with other cultural institutions regarding content learned in class. Partners contributed \$42,000 to this collaboration.

#### Local History Education

### Outreach......\$134,753

#### **Partner: Southwest Minnesota State University**

Southwest Minnesota State University and the Minnesota Historical Society are teaming up to assess the needs of social studies teachers in Southwestern Minnesota, what resources are available in their community to help them teach history and how they can effectively be connected to those resources. A 2009 education outreach survey showed a significant demand for training local history educators and enhancing their direct contact with their local schools and teachers.

Three proposals for partnerships between schools and local history organizations were selected for pilot programs in the fall and winter of 2012–13:

- In Fairfax, a teacher from Prairie Lutheran School is partnering with the Fairfax Historical Depot Museum.
   Students choose an object, research how it was used in their local history, interview community members and display their findings with the object.
- In Luverne, the Rock County Historical Society and Herreid Military Museum are working with high school students to collect oral histories of veterans to be displayed with a larger exhibit at the Herreid Military Museum in 2013.
- Pipestone Public Schools are partnering with the Jeffers Petroglyphs historic site. The students have visited the site and will receive follow-up visits from Jeffers Petroglyphs staff throughout the year to continue the connections with that site.

#### History Museum Fellows

#### Program ..... \$248,146

#### Partner: The University of Minnesota-Twin Cities

Through this partnership, University of Minnesota students from diverse backgrounds explored the museum field through a semester-long course at the University of Minnesota and then a paid summer internship at the Minnesota Historical Society. The course introduced the students to issues related to diversity and museums. Students then chose from a wide range of internship positions and also interacted with professionals in the field during a museum study trip to Washington, D.C.

The History Museum Fellows Program also engages students in discussions about ways to address the underrepresentation of communities of color and American Indian nations in historical organizations and public history graduate programs.

#### Partners: Carleton College and Veblen Farmstead

Preservation work at the Thorstein Veblen Farmstead National Historic Landmark, near Nerstrand, Rice County, Minnesota, will provide urgently needed stabilization and preservation of three outbuildings at the farmstead, including the original small barn, the large hay barn and the granary.

The farmstead is a rare site that preserves and illustrates the pioneering immigrant experience on the prairie. People from across the country and from overseas have visited the property over the past several years. While visitors have limited access to the interior of the farmhouse, the barn will provide a more readily accessible site for eventual interpretation.

### Partners: Preservation Alliance of Minnesota and Thorstein Veblen Farmstead

A Thorstein Veblen Farmstead Master Plan will provide critically needed guidance in a forty-year public-private effort to preserve the Thorstein Veblen Farmstead. Now, visitors are only able to tour the restored farmhouse. Later, when the rehabilitation of the outbuildings is accomplished, visitors will finally have the opportunity to experience the character of the farmstead and the architectural and cultural setting where an interesting immigrant family lived and worked.

#### Partners: Old Highland Neighborhood

#### **Association (OHNA) and Preserve Minneapolis**

Old Highland, on the near north side of Minneapolis, is one of the oldest neighborhoods in the city. Over the last few decades, residents have replaced "old" or deteriorated features with new mass-market items, changing the exterior character of their home while removing pieces of the architectural fabric of Old Highland.

To further homeowner education and related abilities, OHNA held workshops to teach residents cost-effective ways to repair and restore parts of their homes. These workshops help conserve the remaining historic qualities of the Old Highland neighborhood, promote sensitive rehabilitation in Minneapolis and pass on traditional preservation crafts to residents.

# Environmental History Conference.....\$102,502 Partners: Carleton College and Macalester College

This grant supported a conference in June 2012 to generate new scholarship on Minnesota's environmental history. The conference and a resulting book have the potential to significantly help Minnesotans understand their relationships with the environment and how economic, social, political and natural forces have shaped the state's environmental history. With this knowledge, citizens can better appreciate their surroundings and be better prepared to influence policy that enhances environmental sustainability.

Through the conference and edited volume, professional historians will also gain a more accurate understanding of the state, its relative significance, and the range, extent and quality of the resources in the MHS archives.

#### Johann Friedrich von Schiller Sculpture: Restoration and Preservation.....\$35,000 Partners: The City of St. Paul and Public Art St. Paul

A professional conservator will restore the 1907 Schiller sculpture in St. Paul's Como Park, a part of the City of Saint Paul's public art collection. It will also provide public information about the sculpture and a strategic plan for ongoing maintenance.

The Schiller sculpture has stood as a focal point near the entry to Como Park for more than 100 years and is seen by many of the more than 3,000,000 annual park visitors. It is a major work of art by a distinguished artist, commissioned with great care by leading members of Minnesota's German-American community in the early 20th century.

Adath Jeshurun Congregation is the oldest Jewish Conservative Congregation in Minnesota. This project will ensure that 127 years of archival material will be carefully preserved, cataloged and made available for exhibits, education and scholarly research so that Minnesota Jewish ways of life will be known today and for generations to come.

Christ Church Lutheran, a National Historic Landmark in Minneapolis, is one of Minnesota's greatest Modernist landmarks. The nave, built in 1949, was designed by renowned architect Eliel Saarinen and the education wing, built in 1962, was designed by his son, Eero Saarinen. This project will bring the elevator up to code, ensuring full accessibility of the building so people of all abilities can freely participate in tours, programs and events.

# Zumbro River Watershed Environmental History Research . . . \$33,020 Partners: Olmsted County Historical Society and Zumbro Watershed Partnership

The Zumbro River in Southeastern Minnesota is an important part of America's river history. This project seeks to collect and research historical and environmental data on the river to prepare for the creation of an environmental history. The project will observe and identify how human actions and policies have affected the Zumbro and its communities, and also how the river has shaped the human landscape. What makes this river system unique are the stories of the individuals and industries that grew up along its banks, among them, international giants like the Mayo Clinic and IBM.

Current and accurate data on historic and archaeological sites is crucial to understanding our past and to preserving Minnesota's history for future generations. In fiscal years 2012 and 2013, the Minnesota Historical Society, the Office of the State Archaeologist and the Minnesota Indian Affairs Council awarded contracts for the following projects:

#### Multiple Property Documentation: 19th Century Masonry Ruins

This statewide study will look at masonry ruins as a unique type of historic property. It will create a statewide inventory of where ruins are located, classify their function (mills, factories, residences, etc.) and make recommendations on how to manage them for preservation and public interpretation.

FY 12-13 APPROPRIATIONS LANGUAGE AS AMENDED DURING THE 2012 SESSION: Statewide Survey of Historical and Archaeological Sites. \$250,000 the first year and \$250,000 the second year are for a contract or contracts to be let on a competitive basis to conduct statewide surveys of Minnesota's sites of historical, archaeological, and cultural significance. Results of this survey must be published in a searchable form, available to the public on a cost-free basis. The Minnesota Historical Society, the Office of the State Archaeologist, and the Indian Affairs Council shall each appoint a representative to an oversight board to select contractors and direct the conduct of these surveys. The oversight board shall consult with the Departments of Transportation and Natural Resources.

### Minnesota Digital Library



The Minnesota Digital Library (MDL) is a statewide, multi-institutional initiative that is making the rich historical resources of the state's public and academic libraries, archives, museums and historical societies available to students, teachers and the public via the web and is also preserving these resources for future generations.

The MDL, working with more than 150 of the state's cultural heritage organizations, has digitized more than 135,000 unique photographs and images, maps, journals, documents, letters and works of art, collected information on these images and created a searchable database to help people access and use them.

This biennium's appropriation from the Legacy Amendment's Arts and Cultural Heritage Fund is allowing the MDL to expand the number of historical resources online at *reflections.mndigital.org*, and make these resources more accessible to students and the general public through the creation of tools like User and Teachers' Guides.

FY 12-13 APPROPRIATIONS LANGUAGE: Digital Library. \$250,000 the first year and \$250,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society shall cooperate with the Minitex interlibrary loan system and shall jointly share this appropriation for these purposes.

#### Civil War Commemoration Task Force



The mission of the Minnesota Civil War Commemoration Task Force is to promote and share the rich history of the American Civil War and Minnesota's connection to it.

With support from the Legacy Amendment's Arts and Cultural Heritage Fund, the task force is overseeing the development of statewide, balanced activities commemorating the Sesquicentennial of the American Civil War and Minnesota's involvement in it and the U.S.-Dakota War of 1862. Activities are intended to result in a positive legacy, long-term public benefit and education.

The task force, created by an Executive Order from Governor Mark Dayton, is co-chaired by Secretary of State Mark Ritchie and State Representative Dean Urdahl and is comprised of state legislators, citizens and a Minnesota Historical Society staff person. FY 12-13 APPROPRIATIONS LANGUAGE: Commemoration Activities. \$100,000 the second year is for activities that commemorate the sesquicentennial of the American Civil War and the Dakota Conflict, as recommended by the Civil War Commemoration Task Force established in Executive Order 11-15 (2011).
