What The NWRDC is All About . . .

Regional Development Commissions were created by the State Legislature through the Regional Development Act of 1969. The intent of the Act was to create an option for rural units of government to supplement existing public services and coordinate specific activities of mutual concern. Although created by the State, Regional Development Commissions were left in the hands of local representatives to insure that the final design would reflect area needs and preferences.

The Northwest Regional Development Commission was created on February 2, 1973 by the joint actions of local units of government. Programs were set up to reflect priority work items of the time, and relationships were established with the state and federal agencies that could provide assistance with local projects. Programs and work priorities have changed in response to economic

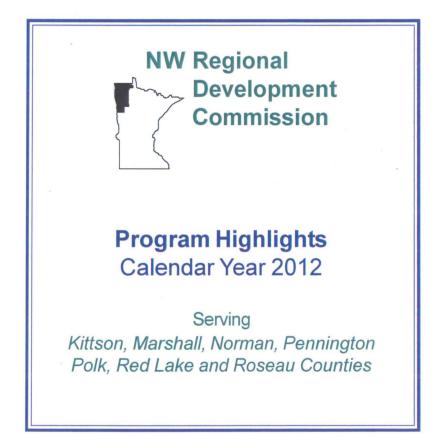

Our services include: providing advocacy and leadership in the development and support of community based services to reduce isolation, improving access to services and to help seniors remain independent and safe in their homes for as long as possible.

Aging Highlights

Year in Review •••

It has been a very busy year at Land of the Dancing Sky Area Agency on Aging. New work has begun in the area of care transitions from Hospitals and Health Care Homes under the Administration on Aging Integrated System Grant. A transition to home has continued in the Return to Community Program as individuals return home after stays in the Nursing Home. Staff has been working very hard to build capacity in the region for evidence-based/evidence-informed programs, and home and community-based services. As you can see by all the information provided in the following short articles, many things are moving forward that offer seniors and their caregivers the opportunity to manage their lives at home and in their communities. If you are interested in any of the classes or workshops, call the Senior LinkAge Line® to locate a session near you. We continue to provide federal grant funds to agencies in the region with dollars from the Older Americans Act. You may have heard Older Americans Act (OAA) program dollars mentioned on the news this year with financial struggles in Washington and cuts to

the discretionary funds. In 2013, our region will lose \$132,513 in OAA funding due to declining population. It is so important for our seniors and their families to take note of all the programs that are available, and use them to help seniors remain safe in their homes even if you have to expend some minimal dollars to do so. Spending these dollars will offset costs for you in the long run. Look into options available through the programs discussed in the article and listing in this annual report. Get curious about some of the things that may help you to stay and support you in your home.

Powerful Tools for Caregivers •••

We have committed our time and energy into supporting caregivers by participating in the evidence-based program: Powerful Tools for Caregivers (PTC). Two staff are in the process of becoming PTC Master Trainers for our region. This will help us meet our goal of developing PTC Leaders in our communities that can offer the classes for caregivers. Some of the tools taught in the class are self care, such as: exercise, relaxation, medical checkups, Management of Emotions (guilt, anger, depression), Self-Efficiency (such as increased confidence with caregiver demands) and use of community resources.

Chronic Disease Self-Management •••

Land of the Dancing Sky AAA has received a license with Stanford School of Medicine to facilitate "train the trainer" sessions on their evidenced-based Chronic

Disease Self-Management curriculum. This evidencebased curriculum provides older adults, and their caregivers with chronic conditions, with tools to manage the day to day aspects of their disease. To date, the Land of Dancing Sky AAA has two staff that have received their Master Trainer certification to facilitate these "train the trainer" workshops; and two staff that are trained leaders to teach the curriculum to older adults. AAA staff have facilitated four Chronic Disease Self-Management workshops with Older Adults living with chronic conditions. Partnerships with Minnesota Extension Services, Public Health, hospitals, clinics, Living at Home Block Nurse and Faith in Action programs will continue to expand Chronic Disease Selfmanagement workshops throughout our planning and service area.

Sustainability of Non-Profits •••

The Land of the Dancing Sky EDP staff continues to see a large increase in demand for assistance in our planning and service area; by providing technical assistance to non-profit organizations that are faced with the impossible challenge of dealing with cutbacks in funding on both a state and federal level. We have chosen to take a three tier approach in creating sustainable models of service. Tier 1 is the 1:1 technical assistance that works closely with our local partners to engage them in best practices with Board Development, finding their niche and reduction in the duplication of services. Tier 2 includes a yearly staff-coordinated Long Term Sustainability workshop targeted at our Title III grantees, LAH, Faith in Action and non-profit partners across our region. Land of the Dancing Sky collaborated with a non-profit consultant who shared valuable sustainability strategies such as: marketing and branding your name combined with social marketing strategies such as Paypal, Facebook and Twitter to engage the Baby Boomer generation, as well as the long distance caregiver. In addition, the consultant provided creative tools for organizations to lead their business into the future. A new layer that was implemented this year was a Budget 101 workshop that was co-facilitated by the NWRDC Financial Officer and Grants Manager. This helped our title III providers understand all of the parts of a budget, and how to develop their true costs of services. We are proud to say that the organizations that participated have been implementing the core strategies that we have shared such as: developing multi-funding streams, cost sharing and social marketing strategies. The strategies, combined with a better understanding of their true costs of services, are actually starting to make profits. Collaboration is the key to sustainable models of service in the future.

Matter of Balance • • •

The Land of the Dancing Sky AAA have four staff that have received their Master Trainer license to teach "Train the Trainer workshops" for coaches to facilitate MOB classes. We have facilitated four Train the Trainer sessions throughout our planning and service area in the following communities: Bagley, Thief River Falls, Perham and Fergus Falls. We have seventy-two Matter of Balance coaches in our planning and service areas, which have facilitated seventeen Matter of Balance classes for older adults that are at risk for falls. We have three new partnerships with St. Joseph Hospital, Sanford Thief River Falls Hospital, and Altru Hospital to expand Matter of Balance in their service area.

Live Well At Home • • •

Land of the Dancing Sky AAA continues to provide technical assistance to our Live Well at Home partners: Eldercare Network, Oaks LAH/BNP and Northwoods Caregivers. This project targets high risk medically frail older adults, and links them to risk management programs such as MOB & CDSMP, and home and community-based services providing them with the option to cost-share the purchase of these services. The goals of this program are to delay or avoid spending down to Medical Assistance. Although, the LWAH grant has discontinued; our partners continue to utilize the Live Well at Home rapid screen assessment, risk management strategies and web-based tools to keep older adults living independently in their home. We continue to provide training to non-profit organizations, health care systems and other aging partners on this rapid screening tool; which identifies older adults whom are at-risk, and have been adopted by multiple organizations as the initial assessment in their intake process.

Aging continued



Consultant ••• The Caregiver Coach Model is researchbased 1:1 assistance that is given to caregivers to develop a person-centered plan for their own

individual caregiver journey. This caregiver coach can walk hand and hand with the caregiver throughout this process, and provide the tools and assessments necessary to manage the day to day challenges of care giving. Land of the Dancing Sky Area Agency on Aging staff served on a Caregiver task force to develop a new curriculum for Caregiver Coaching for Professionals. We have 2 AAA staff who received their Master Training to facilitate "Train the Trainer" Caregiver Coaching workshops and provide fidelity monitoring. In April, we facilitated our first "Train the Trainer" Caregiver Coaching workshop that resulted in new caregiver coaches in our PSA.

Communities for a Lifetime •••

EDP Coordinator and staff continued to provide information and promising practices on the Minnesota 2010 Transform, which educated communities on the Baby Boomer Age Wave and encourages communities to develop comprehensive plans to accommodate the emerging needs of the number of older adults needing access to services. AAA staff have provided information to thirty aging provider networks and communities that include: Rotary Clubs, Lions Clubs, Chamber of Commerce, city planners and health care organizations on strategies that provide services to older adults through a lifetime of healthcare and housing options available within their service area. AAA staff are trained in how to administer a community assessment that provides a framework to identify gaps in services that need to be developed to make their community more elder-friendly. To date, we continue to seek opportunities in working with our local communities to assist them in achieving our goal of creating communities of a lifetime in rural Northwest Minnesota.

Senior LinkAge Line[®] Highlights



Senior LinkAge Line® Calls Received • • •

In 2012, the Senior LinkAge Line® Specialists from both the Warren and Fergus Falls offices provided

assistance to over 15,602 contacts for assistance with issues such as Medicare Part D plans, problems with accessing services, housing options, Long Term Care options counseling, etc. Over 19,749 additional contacts were made on the client's behalf by calling prescription plans, resolving issues with insurance companies and aetting them connected to the services they needed. Two new Senior LinkAge Line® Specialists were hired and trained to replace Amanda Caillier and Kristina DeFrang, who left the agency for new opportunities.

Presentations • • •

Six hundred sixty-two (662) presentations, outreach events and other events were held during 2012. Our main focus this year was to make people more aware of the increasing expenses associated with Healthcare Fraud and Abuse.

Senior LinkAge Line® Volunteers •••

In 2012, Amy Dahlman was hired to manage the volunteer program for our entire service area. Quarterly meetings and updates are held as well as recruitment presentations. Four volunteers were recruited to provide assistance during Medicare's Annual Open Enrollment Period to help with calls regarding Medicare Part D plans and enrollment in their choices for 2013. Volunteers were trained in the beginning of October, and assisted with phone calls on the Senior LinkAge Line® until the first week of December.

Senior LinkAge Line® Highlights

A legislative initiative passed during the 2009 session, known as "Return to Community", requires the Minnesota Board on Aging and its designated Area Agencies on Aging to provide long-term care options counseling to current residents of nursing homes who express a desire to return to the community.

Individuals who have low to moderate needs, have been in the nursing home less than 90 days and have expressed a desire to return to the community and/or have a supportive caregiver are connected to a Community Living Specialist. The intervention involves; assessment, care planning, service coordination, placement and ongoing monitoring of care in the community. This is a person-centered approach and engages the nursing home staff as key to an effective transition.

up services in the community which are critical to sustaining a transition back to the community.

The initiative primarily serves private pay individuals. Those individuals who are on a public program, or who have a managed care coordinator, will be connected to their county of residence or managed health care organization for assistance. Currently, there have been over 600 consumers assisted in returning to the community through this program statewide. To date, the Community Living Specialist from our service area has provided long term care counseling to 158 nursing home consumers and 123 have been assisted back into the community.

Medication Management - Provided 119 in-depth medication management sessions to 95 persons in Regions 1, 2 & 4.

LifeCare Chronic Illness Workshops - Provided 6 workshop sessions on managing chronic illness to 12 participants.

Legal Services - Provided 1,105 hours of legal services to 287 persons, and provided 21 educational sessions to 426 persons in Region 1, 2 & 4.

Clearwater Senior Transportation - Provided 303 oneway trips to 25 persons.

MN General Allocation Grant Programs •••

From January 1, 2012 - December 31, 2012, we regranted \$16,945 to 8 different schools throughout the region to purchase artistic equipment for use in their school, and by community groups and members. All these projects are aimed at children with over 2,000 youth benefitting. We granted \$20, 235 in support of nine other arts projects. An estimated 2,000 adults and over 700 youth were impacted by the grant activity. 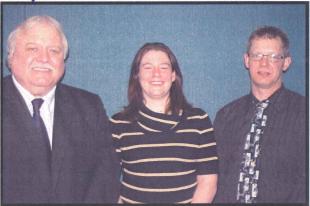

Community Development Highlights

Roseau Flood Diversion •••

The NWRDC provided technical and grantwriting assistance to the City of Roseau for federal EDA funding that would complete a flood diversion project around the city. The funding would help pay for control inlet and outlet structures and the completion of a diversion channel to finish the project. A unique combination of partners including: the US Army Corps of Engineers, the federal EDA, the State of Minnesota, and the City of Roseau have all played important roles in the project. Upon completion, the diversion channel will protect the city from flooding due to spring snowmelt and heavy rain events. The City of Roseau will also be declared to be out of the FEMA-designated flood plain at that time.

Crookston Eco-Industrial Park •••

NWRDC staff assisted with planning for a feasibility study to assess the potential for an industrial park conversion that will use local biomass to provide heat and power, and also distribute steam and heat from existing manufacturing processes throughout the park in a district energy model. The purpose of the initiative is to explore the potential for existing resources and adequate biomass feedstock to provide an increased source of renewable, sustainable energy for the industrial park, and to determine what needs to happen for that potential to be realized.

Oslo Dike Reconstruction/Recertification •••

NWRDC assisted with bringing federal EDA attention to the Oslo dike reconstruction efforts. The City of Oslo is in the process of removing the existing dike, and rebuilding it closer to the city in

order to allow more greenway space for the Red River to flow during flood events. The City proceeded with home buyouts and planned infrastructure improvements that will include: sewer and water replacement, lift station, water tower replacement, urban renewal in the downtown area of the city and business expansions.

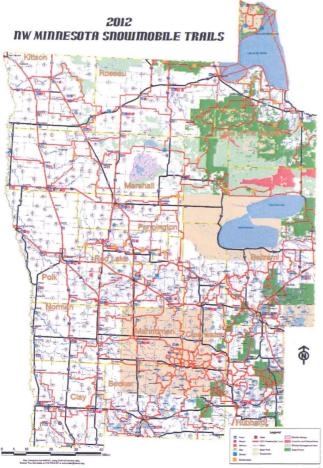
Community Development Continued

Green Step Cities •••

An on-going effort to provide coaching services to area communities interested in: implementing best practices that will cut energy use, decrease the carbon footprint and accomplish other sustainability goals that meet or exceed state regulatory requirements. The statewide program is designed to provide maximum flexibility to communities in designing practices that save money and deliver a stream of environmental, social and financial benefits. Several communities have expressed interest in the program as it is a useful tool for public awareness of ways to save money and capture energy efficiencies.

NW MN Snowmobile Map Updates •••

The NWRDC Transportation Planning Office coordinated discussion with snowmobile clubs and the DNR to get the newest trail information included in the DNR 2012 Region 1 Snowmobile map. The NWRDC created the maps with the new changes, and submitted to local club members for distribution throughout Northwest Minnesota. Scott Advertising from Bemidji publishes the maps with advertising from local business included.



Blandin Broadband/Minnesota Intelligent Rural Communities (MIRC) •••

Provided on-going assistance with marketing of the MIRC project in conjunction with Blandin Foundation and partnerships with MN Extension, MN Workforce Centers, MN Colleges and Universities, PCs for People and other partners. The goal of the program is to expand and increase use of broadband internet services in rural areas, and to grow the regional technology workforce. In a related project, statewide regional development organizations (RDOs) have also enlisted the EDA University Center at UMC to provide methods to increase the use of broadband by area small businesses.

Community Partnership • • •

Continued work with the nine community members and MN Housing Partnership to support workforce and housing development in the greater Thief River Falls area. Information was provided about available housing in Thief River Falls, Hallock, Roseau and Karlstad areas in response to hiring efforts from Northstar Agri-Industries, Mattracks, Digi-Key, Arctic Cat, Polaris and others. Information was also provided to City of Karlstad following a wildfire that destroyed several homes near the city. Updated housing studies were done by Community Research Partners, Inc., in conjunction with funding from the Community Partnership, MN Housing Partnership and the Northwest Minnesota Foundation. A later study by Maxfield Research, Inc. was also done for the City of Roseau to assess their housing situation.

Red Lake Falls Housing Development/Energy Project • • •

NWRDC provided business planning assistance to a private company that is planning a housing development and biomass energy project near the city. The housing development will provide townhomes and manufactured homes that will supply options for rapidly expanding workforce in the Thief River Falls area. The energy project is designed to use any kind of carbon-based feedstock that will be burned and provide renewable energy for the housing development, and to the electrical grid. The feedstock can include any kind of biomass, including: sewage sludge, municipal solid waste, trees or crop residues.

Economic Development

- **Purpose:** Maintain and increase the population level and job base in the seven counties of Northwest Minnesota.
- **Program Funding Sources:** United States Economic Development Administration (EDA) \$62,628; RDC Tax Levy \$69,152.
- Service Priorities: Business Development, Labor Force Development, Renewable Energy, Promotion, Planning.

Economic Development Highlights

Heating the Midwest with Biomass •••

Assisted the Agricultural Utilization & Research Institute, and a multi-state Midwest Biomass Resources Action Team with the planning for the 1st Annual "Heating the Midwest with Biomass" conference event in Wisconsin. Action Team goals included: gathering biomass data from a seven-state region to provide benchmarking for potential projects, determine infrastructure requirements for biomass industry expansion in the Midwest, and analyze potential areas of growth in the industry (harvest methods, pellet market, thermal heat systems, feedstock procurement strategies, market analysis, etc.). Future projects include the development of a Household Fuel Use Study to determine needs in the Midwest region.

Business Assistance •••

Provided more than 1,600 hours of staff assistance on business/job creation and retention-related projects including: working with more than 80 businesses on business planning, referral, financial packaging, loan applications and workout strategies. Loan Fund activity for 2012 totaled seven loans in the amount of \$665,000, leveraging \$1,100,000 in other public funding and \$6,957,912 in private investment. The businesses will provide 51 new full-time equivalent jobs within three years. The businesses provide a current employee base level of 167 for a total of 218 jobs created and retained.

Comprehensive Economic Development Strategy (CEDS) •••

Reviewed economic development strategies in 2012 CEDS, and updated the current document for the seven county region. Met with Enterprise Fund twice during 2012 to review strategies, and receive input on 2013 CEDS preparation. Major strategies were retained with emphasis on workforce training for skilled positions, "soft" skills training needs, workforce housing and technology cluster development. The 2013 CEDS was delivered in late November and approved at the Commission annual meeting.

Impact 20/20 •••

Continued participation and assistance with area businesses, educators and government partnership in an effort to grow the economy of Northwest Minnesota. Staff serves on the Education and Workforce Joint Taskforce that develops recommendations for policy advocacy, focuses on stronger career exploration and post-secondary preparation for students in K-12. Staff also serves on the Broadband Taskforce, with the goal of increasing the utilization of broadband by the region's businesses in order to increase commerce through a more robust telepresence.

Workforce Housing •••

Provided assistance and support to fast-growing area companies including: providing available housing information in the area and participating in projects that encourage home-grown talent development for highskilled professions in the region (including Impact 20/ 20 and Ingenuity Frontier/IDEA Competition). Housing information was also provided to the City of Karlstad after a wildfire disaster destroyed several homes near the city.

Renewable Energy •••

NWRDC continued work with local individuals, companies and groups interested in providing harvest, processing and burning methods for biomass. This includes identifying areas for biomass production, developing biomass feedstock options, types of biomass for production, and types of burning methods for conversion to heat and electricity.

Enterprise Loan Fund

Purpose: To strengthen and diversify the economy by providing a source of low interest financing to businesses, when credit is not otherwise available from other sources, and to ensure the successful completion of activities to be financed.

Program Funding Sources: Loan Interest and Loan Fees - \$66,282; RDC Tax Levy - \$1,745.

Loan Funding Sources: Loan Repayments and Loan Interest - \$763,000.

Service Priorities: Financing for-profit businesses which create or retain jobs, especially for the long term underemployed or unemployed.

2012 Loan Highlights

Overall business activity and action in the revolving loan fund continued to gradually build as the economic climate steadily improved during 2012. Several businesses in the region are adding employees and making significant capital investment in their operations. Many other businesses are expanding their reach internationally with increased sales through exports. Credit from area banks continues to loosen up, which is a positive factor in entrepreneurial endeavors. Entrepreneurship, especially in the development of startup businesses, remains a strong influence in the region.

During 2012, the Enterprise Loan Fund Committee approved funding for new start-ups and expansions in three economic sectors:

> Manufacturing/Processing (4) Sanitation Service (1) Restaurant (2)

Loans totaling \$665,000 were approved to the following businesses:

-Dee, Inc., (aluminum foundry) - Crookston -Harvest Restaurant & Lounge, (restaurant) - Argyle -Les's Sanitation, (garbage collection) -TRF -RS Grain LLC, (food packaging for export) - Euclid -Specialty Products & Technology, Inc., (dehydrated food processor) - Fosston -Drafts Sports Bar & Grill, (restaurant) - Crookston

The above businesses currently have a total base level of 167 full-time employees. The loan activity will assist in the creation of 51 new full-time jobs.

Attended the Governor's Conference, the Minnesota Public Safety Interoperable Communications Conference and the Association of Minnesota Emergency Managers (AMEM) Conference.

THIRA Plan Creation •••

Composed a Threat and Hazard Identification & Risk Assessment (THIRA) plan for HSEM Region 3 that incorporates a previously completed strategic plan. All 14 Counties in Northwest Minnesota also created local, valid THIRA plans.

Regional Program Support •••

Aided in the acquisition and dispersal of grant dollars to aid local, county and regional entities. This includes support of existing, regional Special Response/SWAT teams in order to sustain and enhance CBRNE (Chemical, Biological, Radiological, Nuclear & Explosive) capabilities, and building on and integrating the capabilities of local Emergency Operations Centers, sheltering and response facilities.

Regional Radio Board Meeting Attendance •••

Attended regularly scheduled Regional Radio Board and Radio Advisory Committee meetings, presenting interoperability-related grant information as requested.

Red River Valley Presentation • • •

Aided in the creation of a presentation at the AMEM Conference on the evolution of mitigation, preparedness, and response & recovery of the Red River Floods. Presented a section on the history of Red River Valley flooding.

Mass Sheltering • • •

Assessed municipal evacuation plans for all cities in Northwest Minnesota, and planned/exercised for an event that requires a regional response and multiple partners.

Transportation Highlights

The Federal Government Passed a Transportation Bill



On July 6, 2012, President Obama signed into Iaw a federal transportation bill, Moving Ahead for Progress in the 21st Century Act (MAP-21). Funding surface transportation programs at over \$105 billion for fiscal years (FY) 2013 and

2014, MAP-21 is the first long-term highway authorization enacted since SAFETEA-LU expired in 2009. MAP-21 represents a milestone for the U.S. economy. It provides needed funds, and more importantly, it transforms the policy and programmatic framework for investments to guide the growth and development of the country's vital transportation infrastructure.

MAP-21 creates a streamlined, performance-based, and multimodal program to address the many challenges facing the U.S. transportation system. These challenges include improving safety, maintaining infrastructure condition, reducing traffic congestion, improving efficiency of the system and freight movement, protecting the environment and reducing delays in project delivery.

MAP-21 builds on and refines many of the highway, transit, bike and pedestrian programs & policies established in 1991. This summary reviews the policies and programs administered by the Federal Highway Administration. The Department will continue to make progress on transportation options, which it has focused on in the past three years, working closely with stakeholders to ensure that local communities are able to build multimodal, sustainable projects ranging from passenger rail and transit to bicycle and pedestrian paths. MAP-21 expands the National Highway System (NHS) to incorporate principal arterials not previously included. Investment targets the enhanced NHS, with more than half of highway funding going to the new program devoted to preserving and improving the most important highways - the National Highway Performance Program.

Under MAP-21, performance management will transform Federal highway programs and provide a means to more efficient investment of Federal transportation funds by focusing on: national transportation goals, increasing the accountability and transparency of the Federal highway programs and improving transportation investment decision-making through performance-based planning and programming.



Transportation Continued . . .

MnDOT Hosted a Corridor Investment Management Strategy with Region One Residents

The Minnesota Department of Transportation's Corridor Investment Management Strategy (CIMS) is a corridorbased initiative that brings MnDOT together with its local, modal and state partners to identify opportunities for collaborative and innovative investment. It offers a means to share information and identify opportunities to apply MnDOT's suite of lower cost, high benefit investment strategies that address safety, access and mobility.

The public was asked to provide feedback on anticipated investment needs on three corridors:

- MN 11 (from North Dakota to International Falls)
- US 2 (from North Dakota to Bemidji)
- US 59/MN 32 (from Detroit Lakes to Karlstad)

Each corridor was discussed at a workstation where MnDOT staff walked participants through a series of maps that displayed information relating to MnDOT's investment program.

MNTH 11

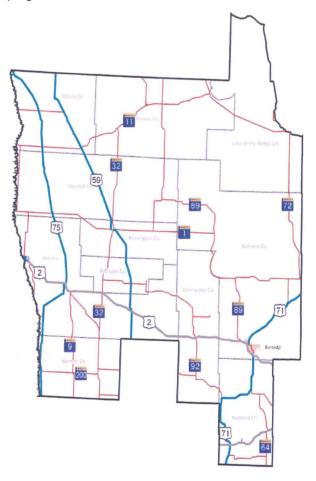
The discussion on MN 11 focused on the importance of the corridor in moving freight in the region. The corridor serves many large freight generators including: Marvin Windows, Polaris, Mattracks, Central Boiler and Northstar Agri Industries. It is the only paved east-west MN Trunk highway in the area.

US HWY 2

A much smaller group participated in a brief discussion around MnDOT's programmed investments and anticipated investment needs on US Hwy 2. Much of the discussion focused on the Grand Forks-East Grand Forks MPO area. There were questions regarding the role of US 2B in East Grand Forks. It was suggested as a potential turnback, where the state would give the road to the city. Currently, the city is not interested. The MPO's recommended "truck reliever" route and new bridge over the Red River were discussed. The role of the corridor as an important bike route was also discussed.

US 59/MN 32

The discussion on US 59/MN 32 focused primarily on the roadway condition and safety issues. MN 32 was highlighted as the better road for freight due to fewer road failures and poor road conditions on the southern end of US 59. The main safety issue discussed was



shoulder width. Participants stated shoulders should be widened due to the truck volume on the corridor and for bicycle travel. The widened shoulder would also allow for passing vehicles making left turns. Participants also agreed that rumble strips are justified due to number of lane departure crashes; but if installed, should be placed to retain adequate space for bicycles where narrow shoulders exist. Special Projects

BROADBAND PROJECT

Funding Sources: Blandin Foundation - \$15,479; Tax Levy - \$1,823.

Staff: Jennifer Olson

Provided ongoing assistance with marketing of the MIRC project in conjunction with Blandin Foundation and partnerships with MN Extension, MN Workforce Centers, MN Colleges and Universities, PCs for People and other partners. The goal of the program is to expand and increase use of broadband internet services in rural areas, increase computer literacy and to grow the regional technology workforce. In a related project, statewide regional development organizations (RDOs) have also enlisted the EDA University Center at UMC to provide methods to increase the use of broadband by area small businesses.

MN COORDINATION PLAN

Funding Sources: MN Department of Transportation - \$800; Tax Levy - \$678.

Staff: Troy Schroeder

The RDC contracted with Mn/DOT to complete a transit coordination plan. The plan will focus on a locally developed coordinated public transit human services transportation plan to identify the transportation needs of individuals with disabilities, older adults and people with low incomes. The plan provides strategies for meeting those local needs and prioritized transportation services for funding and implementation.

CITY OF OSLO COMPREHENSIVE PLAN/ZONING ORDINANCE

Staff: Cam Fanfulik

NWRDC staff is assisting the city with the development of a comprehensive plan that will provide a blueprint for future development in land use, economic development, public facilities/infrastructure, transportation and quality of place. The plan provides strategic direction and implementation strategies for elected and appointed officials in order to focus their efforts on community goals and vision. NWRDC will provide staff assistance through public meetings, mapping and plan development. Community participation will be a vital part of developing the plan, which began its initial stages in 2012 and is slated for completion in 2013.

HAZARD MITIGATION PLANNING

Funding Sources: Norman County - \$22,159; Clay County - \$31,395.

Staff: Jennifer Olson

Clay and Norman Counties received funding through the Federal Emergency Management Agency (FEMA) to perform 5-Year Updates to the All Hazard Mitigation Plans. Mitigation planning serves to identify policies and actions to reduce risk and future loss when implemented. The NWRDC acted primarily as a pass-through agency, as a private consulting firm performed the updates.

HOUSING STUDY

Funding Sources: NW MN Foundation - \$7,700; Growth Partnership - \$7,950.

Staff: Cam Fanfulik

NWRDC staff provided grant-writing assistance for the Growth Partnership to obtain funding and provide updated housing studies for the nine member communities and greater Thief River Falls area. The studies were completed in early 2012 by Community Research Partners, Inc.; through funding from the Northwest Minnesota Foundation, MN Housing Partnership and Community Growth Partnership. The updated studies were done to provide more current data, and recommendations in response to rapid employment increases and housing shortages in area communities.

Maxfield Research, Inc., was engaged by the City of Roseau to conduct a comprehensive housing study for Roseau County. The study provides recommendations on the amount, and types of housing that should be developed in order to meet the needs of current and future households in the county. An assessment of other challenges associated with housing development was included in the study.

2012 Area Plan on Aging - The Area Plan on Aging examines senior input and demographic data to establish priorities for the use of Title III Older Americans Act funds. Includes information on the unique characteristics of our region, demographics, accomplishments, program outcomes and budget information.

CY 2012 NWRDC Work Program - Details the goals and objectives of each of the program areas of the NWRDC including changes made to address emerging needs in the region, changes in funding levels and changes in program priorities.

2012 CEDS - The Comprehensive Economic Development Strategy (CEDS) for the seven-county region includes a review of statistical trends, a revision of development strategies, the identification of priority projects and review of individual county development strategies. Key revisions for 2009 included an increased concern about population loss and an emphasis on renewable energy development.

FY 2012-13 Regional Arts Plans - Goals, strategies and work activities for State Arts Funds and McKnight Arts Funds are included in these plans.

Revolving Loan Fund Plan - Describes the program elements and guidelines for the loan fund.

All Hazard Mitigation Planning - The 5 year update process for the Clay, Marshall and Norman All Hazard Mitigation Plans is still in progress. Completion will occur in 2013.

2012 Highlights Aging

Administration on Aging Integrated System Grant Utilizing this grant with hospitals and health care homes; the LDS AAA is ready and waiting to work within local and statewide efforts to reduce avoidable hospitalizations of older adults. For years, Area Agencies on Aging have developed and provided technical assistance to home and community-based service providers that help older adults remain independent at home. Many of these services are critical to the health status following a hospital stay, because what happens at home postdischarge often falls beyond the purview of the health care system. Using integrated care transitions with older adults will bridge the hospital-to-home transition, and help older adults avoid a repeat episode when hospitals and aging agencies work together.

Transportation

The passage of the new transportation bill MAP-21 is a two year bill that focuses investments primarily on the National Highway System. Region 1 has four roads classified as principle arterials that will fall under the National Highway System criteria for funding. They include MNTH 11, portions of MNTH 32, portions of USTH 59, and USTH 2. (See map below for road segments). This new federal policy will leave much of the regions highway system struggling for highway repair or improvement funds, thus you can expect a rough ride on many of the roads currently traveled. The state is researching new funding sources to help pay for the local road network. They include mileage taxes, more gas tax and higher registration fees.



Economic Development

2012 was a year of exciting events in economic and community development. One of the biggest was the grand opening in August of the \$168 million Northstar Agri Industries canola crushing plant located in Kittson County. It is a fully integrated canola processing and refining plant, is the first canola processing plant in the state of Minnesota, and the first purpose-built canola processing facility in the USA. It employs 50 people with an annual payroll of \$3.5 million. The plant will provide food-grade heart-healthy canola oil for human consumption and high protein canola meal for the animal feed markets, and will be able to process more than 1000 tons/day. The plant is operating at full capacity and pulls raw canola seed from Minnesota, North Dakota, and Canada.
