PUBLIC BUILDINGS ENHANCED ENERGY EFFICIENCY 2013 REPORT

Minnesota Statutes 16B.322, subdivision 8, states that the Commissioner of Administration shall submit a report containing, at a minimum, the following regarding projects implemented under this section:

- the total number of projects
- the amount of calculated and, if available, actual energy savings for each project
- the cost of each project
- the total amount paid for technical services provided under subdivision 3 for each project.

1.0 PROGRAM OVERVIEW

As of the end of 2013, PBEEEP has achieved its main goals:

- The Energy Efficient Operations program was developed to ensure that facility managers maintain the savings identified in the investigations and use best practices to keep their energy usage as low as possible.
- CEE's training module for the Energy Efficient Operations program was approved by State of Minnesota's Real Property Executive Committee to meet the training requirement of Executive Order 11-3, section 4.b.ii.
- The implementation of selected energy saving measures is complete or in process at all sites that have chosen to move forward with the recommended measures.
- All energy investigation projects at the 71 state government sites enrolled in the program since its inception in August of 2009 were completed in 2012.
- The total building area included in these projects exceeds 31.4 million square feet, of which 17.8 million at 44 sites had detailed investigations.
- Energy use at participating facilities is 6.3% below the weather normalized baseline according to the most recent data in the B3 database.
- The value of the actual annual energy savings (vs. B3baseline) is over \$2.3 million.
- Average energy savings of 7.1% were identified in the energy investigations.

PBEEEP, the Public Buildings Enhanced Energy Efficiency Program, provides expert services for recommissioning and retrofit projects, combined with innovative financing, to help state government buildings save energy and money. PBEEEP's primary activity, and expense, was for engineering studies of state facilities which were all completed in 2012 and reported on in the 2012 PBEEEP Annual Report.

In 2013 there were three main program activities: developing and implementing the Energy Efficient Operations program; providing expert assistance to facilities with regard to selecting measures for implementation; and performing measurement and verification of energy savings. The individual agencies are responsible for prioritizing their implementation projects. Several facilities are considering the use of guaranteed energy savings programs for financing.

A. PBEEEP ORGANIZATION

The Center for Energy and Environment (CEE) has been engaged by the State Of Minnesota, Department Of Administration to develop and administer PBEEEP. CEE is a Minnesota-based nonprofit organization

that works to promote public interest through the responsible and efficient use of natural and economic resources. CEE is the quality assurance provider and day-to-day administrator of the program. CEE developed the Energy Efficient Operations program with the assistance of Herzog-Wheeler and Associates and the University of Minnesota's Center for Sustainable Building Research.

B. PROGRAM DEVELOPMENT

A training program based on the fifth program guideline, *Sustainable Energy Efficiency Operations Process for PBEEEP Buildings* was added to the program in September 2013. The training was approved by the State's Real Property Executive Committee "for state building operators and managers to operate existing energy-consuming equipment in state owned buildings in the most efficient manner possible."

C. PROGRAM RELEASE

The State Public Building Enhanced Energy Efficiency Program was formally launched on August 6, 2009 with a Webinar jointly presented by the Center for Energy and Environment (CEE) and the Department of Administration for state agencies and the Minnesota State Colleges and Universities campuses.
