## State agency emergency management training

In compliance with Minnesota Statutes, section 12.09, subdivision 10

MINNESOTA DEPARTMENT OF PUBLIC SAFETY DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT State agencies assigned a role in the state emergency operations plan must have at least one certified emergency manager on staff (Minn. Stat., § 12.09, subd. 10). The statute also requires agencies not in compliance to file a plan with the Minnesota Department of Public Safety (DPS).

The DPS Division of Homeland Security and Emergency Management (HSEM) oversees the emergency manager certification program. Effective January 1, 2014, HSEM implemented its revised emergency management training certification curriculum. Certification as an emergency manager requires the completion of 173 training hours, which typically takes two to three years to achieve.

As shown in the table below, 20 of the 23 affected agencies are currently in compliance with the training requirement. The Board of Animal Health continues to contract with a Department of Agriculture certified emergency manager. The remaining agencies have plans on file showing projected compliance by January 31, 2015.
