## Active Living Plan: Le Sueur

Active Living communities make it easy for people to include physical activity in their daily lives. Walking to work, school, the store or just for fun would be safe and convenient in an active living community. Roads here are built for all forms of transportation, not just for vehicles. Recreational opportunities are accessible and parks, playgrounds, and sports facilities are located near people's homes and are open to all residents. Overall, the goal is to promote development of environments that offer the opportunity to integrate physical activity into daily life.



In early 2013, the Le Sueur Community Trails and Pedestrian Walkway Committee and the City of Le Sueur began working with RNDC to create an Active Living plan. The goal is to see a fully developed trail system throughout the region that would connect to the City of Le Sueur. Within the City of Le Sueur, a more walkable and bikeable community would benefit not only the residents, but also the local businesses and the Le Sueur-Henderson school district. To coincide with the Active Living plan, the City of Le Sueur has begun identifying how to address, replace and upgrade the sidewalk network within its community.



## Safe Routes to School



RNDC completed three successful applications, amounting to \$50,000, for Safe Routes to School Planning Assistance. The RNDC will facilitate and write plans for the following school districts:

- Tri-City United
- Lake Crystal Wellcome Memorial
- Le Sueur-Henderson

RNDC will work with district and school staff, city elected officials and staff, MnDOT, county public health and other key stakeholders to complete the plans in the upcoming fiscal year.

## Federal EDA Grant: Highway 169

On June 12, 2013 the U.S. Commerce Department's Economic Development Administration (EDA) announced a \$9.8 million grant to MnDOT for rebuilding portions of State Highway 169 near Mankato. The rehabilitation of the highway will support the creation of 500 new jobs in the region and attract an additional \$10 million in private investment, according to grantee estimates.

RNDC played a key role in MnDOT's application for the EDA grant. MnDOT spokeswoman Rebecca Arndt said, "MnDOT made the application but the Region Nine Development Commission especially [Transportation Planner] Ronda Allis made us aware of the dollars and helped us through the application process."

The flood mitigation projects will involve raising the southbound lanes of the highway to be above the 100 year flood mark, which would remain open to two lane traffic when the northbound lanes are flooded.

## Solid Waste Management Plan

The Minnesota Pollution Control Agency (MPCA) requires that solid waste management jurisdictions revise their solid waste management plans every 10 years to address existing and future solid waste management issues. Prairieland Solid Waste Board, a Joint Powers Board for Faribault and Martin Counties, with the help of RNDC, is revising their plan which includes strategies for waste reduction, reuse and recycling for the next 10 years. The revision of this plan also makes both counties eligible to receive their annual Select Committee on Recycling and the Environment (SCORE) dollars.



## Mapping: River Valley 100

Region Nine has Geographic Information Systems (GIS) trained staff that can provide access to thousands of demographic, health, economic, education and business data variables that can help analyze unique community characteristics for any geographic region. With this information RNDC staff can produce customizable presentation-ready reports or maps of specific location including congressional districts, block groups, census tracts or ZIP codes.

In June 2013, RNDC staff created a 100 mile bike route map to be used during the River Valley 100. The River Valley 100 is a non-supported century ride that will go through Mankato, Kasota, St. Peter, Le Sueur, Elysian, Madison Lake, Eagle Lake and St. Clair.



## Farmamerica

The Minnesota Agricultural Interpretive Center (Farmamerica) was established in 1978 to preserve Minnesota's rural agricultural heritage. In January 2013, Renewable Energy Task Force (RETF) began providing technical assistance to Farmamerica for application to Xcel Energy's 2014 Renewable Development Fund. Each year Xcel Energy transfers \$24.5 million to the fund to support development of new renewable energy technologies and renewable energy projects. Farmamerica is requesting \$600,000 from this fund. If awarded, Farmamerica will install 120 kilowatts of solar and wind capacity on their campus and achieve a net zero non-combustion based energy production system.



## Small Wind Bulk Buy Program

In December 2012, RETF completed the Small Wind Bulk Buy Program. The program was designed for small organizations, businesses and agricultural enterprises interested in small wind generation. The overall goal for this project was to minimize obstacles faced by local groups seeking to develop small wind projects in rural, southern Minnesota. The marketing efforts for this project consisted of radio interviews, appearances at the Springfield Ag &

Energy Expo, the New Ulm Farm Show, the South Central Minnesota Home and Builder Show, and several community meetings in Fairmont. This program was made possible through several different funding partners including Windustry, Southeast Clean Energy Resource Teams (CERTs), West Central CERTs and Southwest CERTs.



## Envision 2020

Envision 2020's Energy Conservation Task Force (ECTF) merged with RETF in January 2013. This merger united resources and knowledge of both task forces to advance renewable energy and promote energy conservation and sustainability in southern Minnesota. As a result of the merger, Leigh Pomeroy of ECTF has been appointed to the RETF Executive Committee.



## The Prairie House of Gaylord



The Prairie House, a unique restaurant with old fashioned home-style cooking, has served the community of Gaylord for over 30 years. RNDC's involvement with Prairie House began in 2003 when Shirley Meger decided to purchase the business with the help of a loan from RNDC.

Shirley Meger's love for cooking began at an early age. Growing up in a family of 10, she learned to cook by helping out. At the age of 15 she took all her personal experience and went to work at Ann's Café in Belle Plaine. She credits this position with teaching her how to deal with people of all ages. Later Shirley moved on to a larger volume restaurant where she learned how to manage and run a restaurant.

Shirley's vision for success in the restaurant business when she purchased Prairie House was a commitment to customer service, service to her employees, and service to her community. Today, she and her son David Waller run the restaurant based on those three principles.

In late 2009, the country was in a recession and Shirley was hit hard. Customer's weren't able to spend the money they once could. To add to the financial burden of declining sales, Shirley had recently moved from Belle Plaine to Gaylord and was paying a double mortgage. It was at this time that RNDC's loan officer, LuAnn Vanderwerf, and Shirley became very familiar with each other. Shirley kept RNDC updated on the status of her finances, and LuAnn worked with her to reduce and defer payments to keep enough cash flow to succeed in the slow economy. LuAnn says that during this process she developed a deep respect for Shirley because of her openness during the process. Shirley was happy that she could work so closely with the RNDC and keep her restaurant open during such a difficult time.

Today Shirley and David have owned Prairie House for 11 years. They have 25 employees, offer a full menu, run a catering service and feed 125 seniors a day through their Meals on Wheels delivery service. They are thankful for the support of the local community.

## Veterans Transportation & Community Living Initiative

The purpose of the Veterans Transportation and Community Living Initiative is to improve access to transportation resources for veterans, military families and other clients.

This will be done by connecting customers in one place to rides and transportation options available from a variety of transportation providers and programs in their area. The U.S. Department of Transportation awarded \$34.6 million to local government agencies for 55 projects ranging in size from \$29,000 to \$2 million to finance capital costs of implementing, expanding or increasing access to local One-Call/One-Click Transportation Resource Centers.



Finding information about rides will be easy for veterans, military families, caregivers and others.



Phase I augmented technology links between transportation providers, veterans organizations in the 27 counties of southwestern Minnesota and the existing MinnesotaHelp™ Network. The grant covered the purchase of hardware, such as computers and Voice Over IP phones, and software that ensures smooth and secure data transfer. Training for software operations is another component of Phase I. The project has connected veteran service organizations and public transit services to the Veterans Linkage Line™, Senior LinkAge Line® and the Disability Linkage Line®, all three of which are housed under the MinnesotaHelp™ Network. This secure communications network allows for the secure transmission of sensitive documents between agencies and provides opportunities for agencies to better coordinate the delivery of services. Thanks to this program 25 County Veteran Service Offices, Jefferson Bus Lines, Mankato Land to Air and eighteen public transit agencies in the 27 counties are now linked to the MinnesotaHelp™ Network.


## Volunteers are Stars: Public Service Announcements


