Background

DEED's Contamination Cleanup and Investigation Grants Program, which waslaunched in 1995, has assisted communities throughout the state in addressing contamination issues that threaten human health and economic vitality. The Programsupports city, county, port authority, housing and redevelopment authority, and economic development authority efforts to investigate contamination, develop Response Action Plans (RAPs) to identify necessary cleanup actions, andcarry out cleanup activities as prescribed in a Minnesota Pollution Control Agency (MPCA)-approved RAP. DEED's support enables communities to cleanup contaminated lands to allow for redevelopment which attracts and retains jobs, and increases property tax revenues while bringing underutilized, polluted sites back into productive use.

Both publicly and privately owned sites with known or suspected soil or groundwater contamination qualify for this program. Grant applications require a 25 percent local match, participation in the Metropolitan Council's Local Housing Incentives Programs for Twin Cities metro-area applicants, and the serious expectation that the site will be redeveloped.

Ranking criteria

Applications are ranked on the following criteria:

- Tax base increase resulting from the cleanup and redevelopment of the site.
- Social value of the cleanup, demonstrated by the number of jobs created through cleanup and redevelopment.
- An evaluation by the Minnesota Pollution Control Agency of the reduced threat to public health and the environment as a result of cleanup.
- Likelihood that the site will be cleaned up without government money.
- Cleanup cost.
- Commitment of local authorities to pay the local match.

Program results

Contamination Cleanup and Investigation Grants have been highly effective in stimulating private investment. To date, \$141,978,611 in grants will leverage almost \$4.6 billion in private investments resulting in 44,581 new and retained jobs and 13,490 new housing units.
