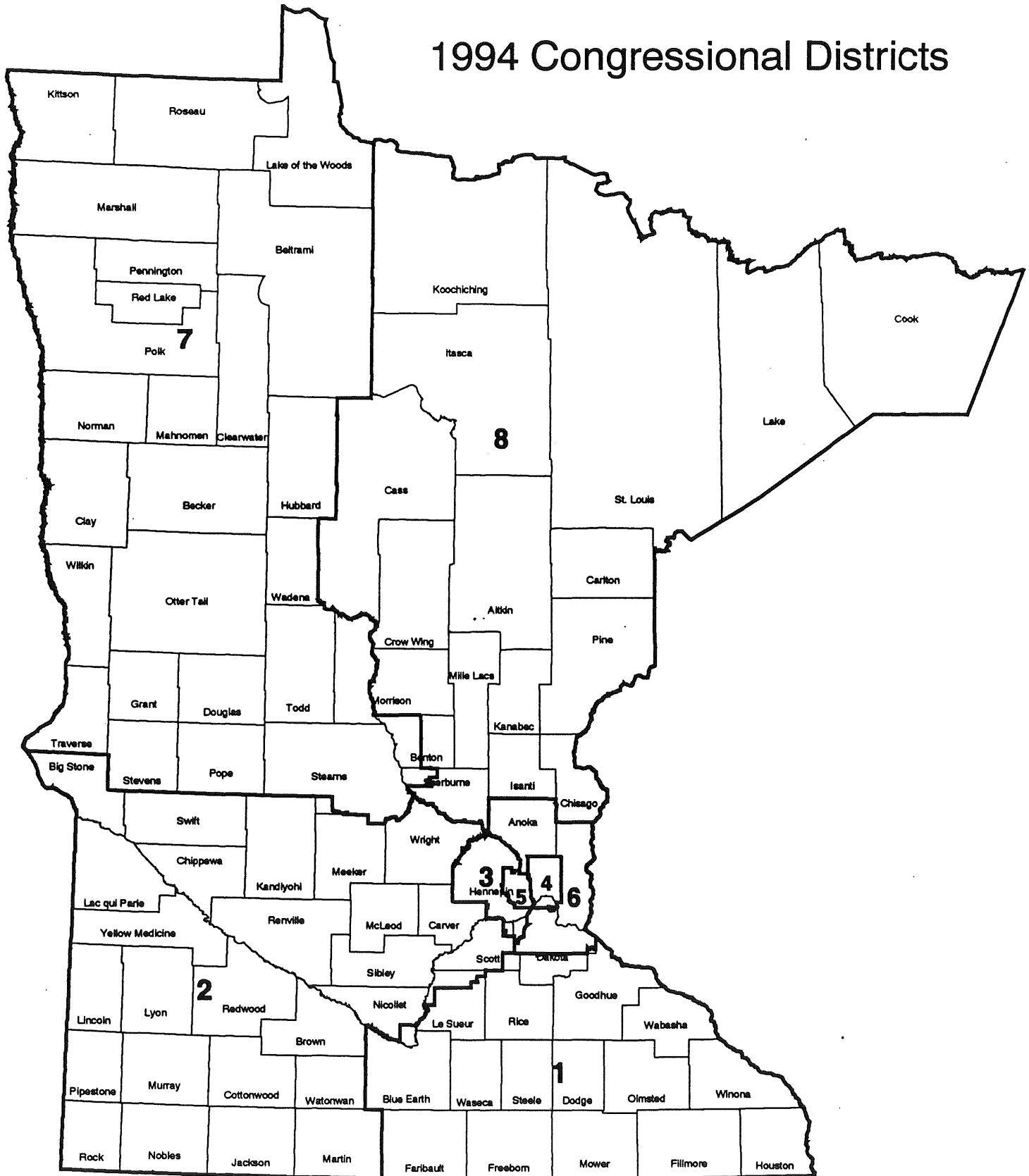

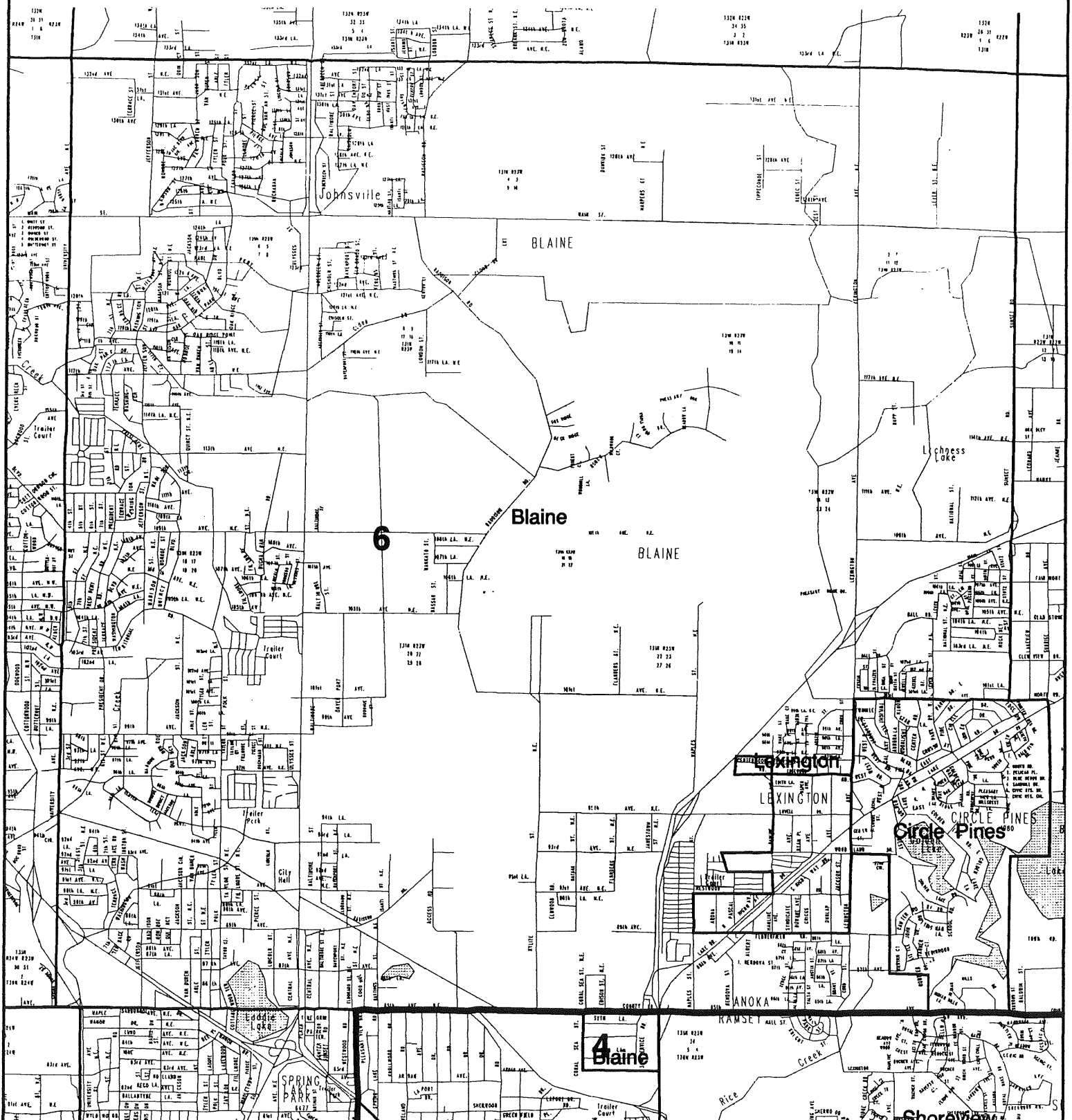

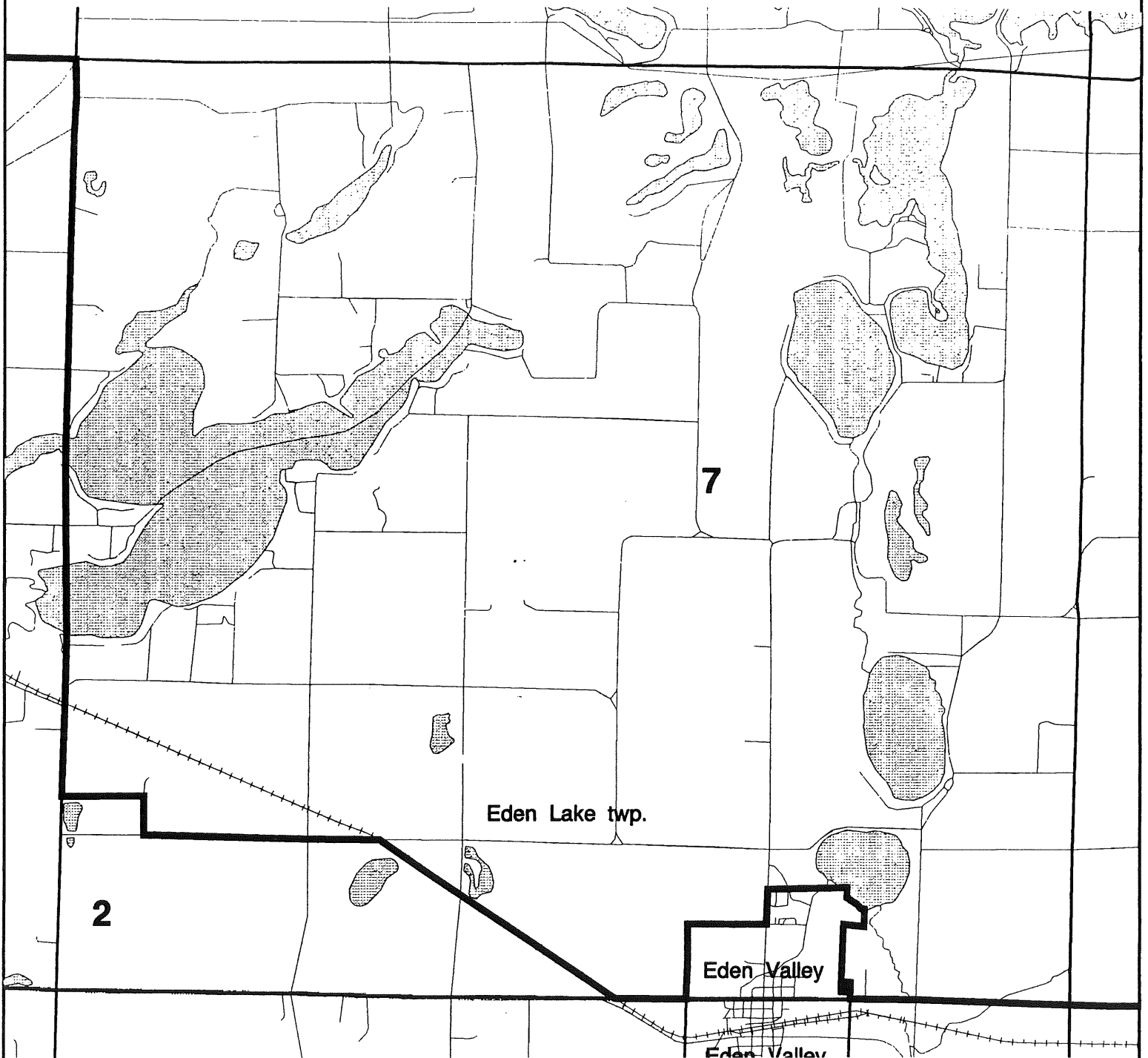
Twin Cities Metropolitan Area

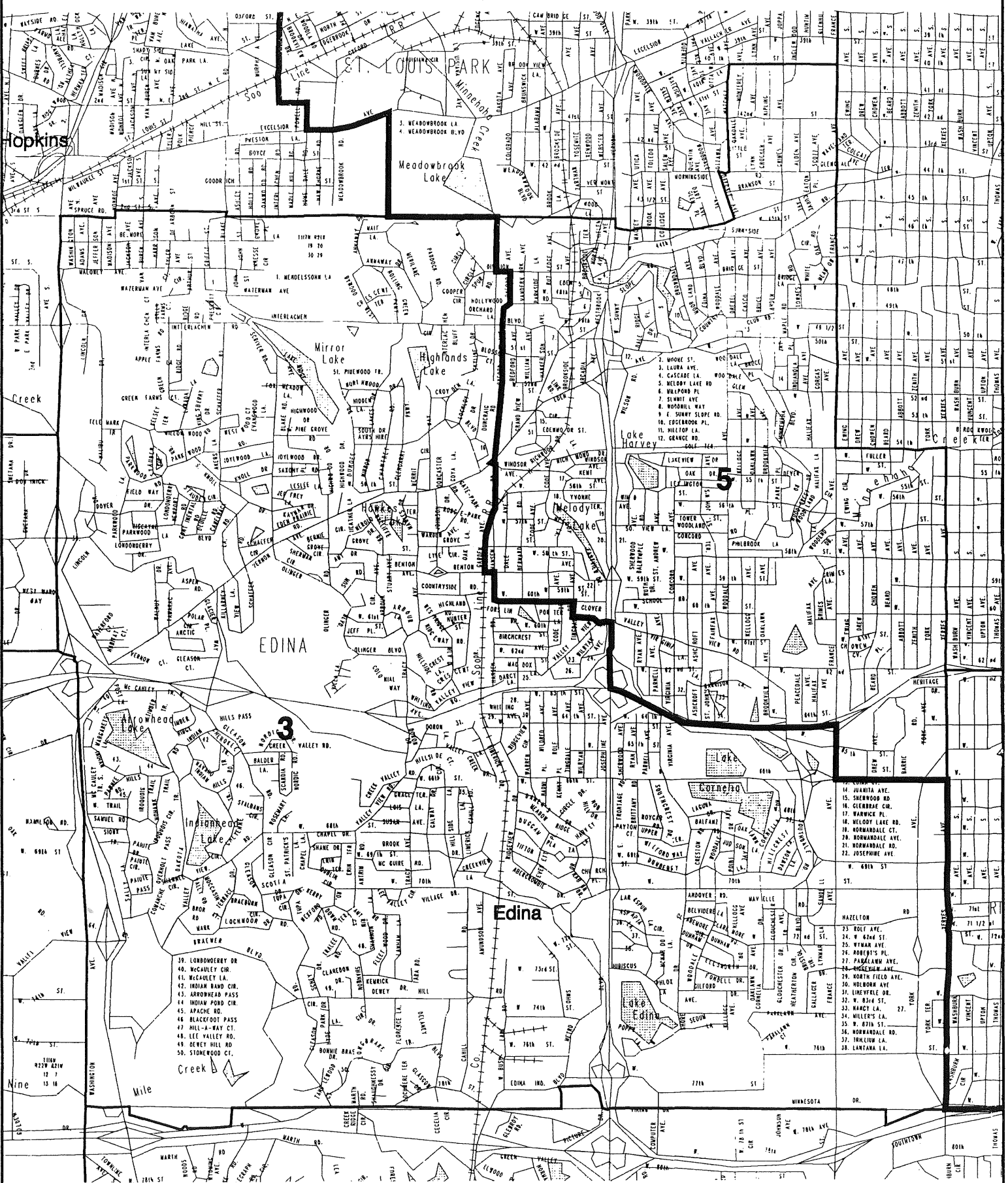

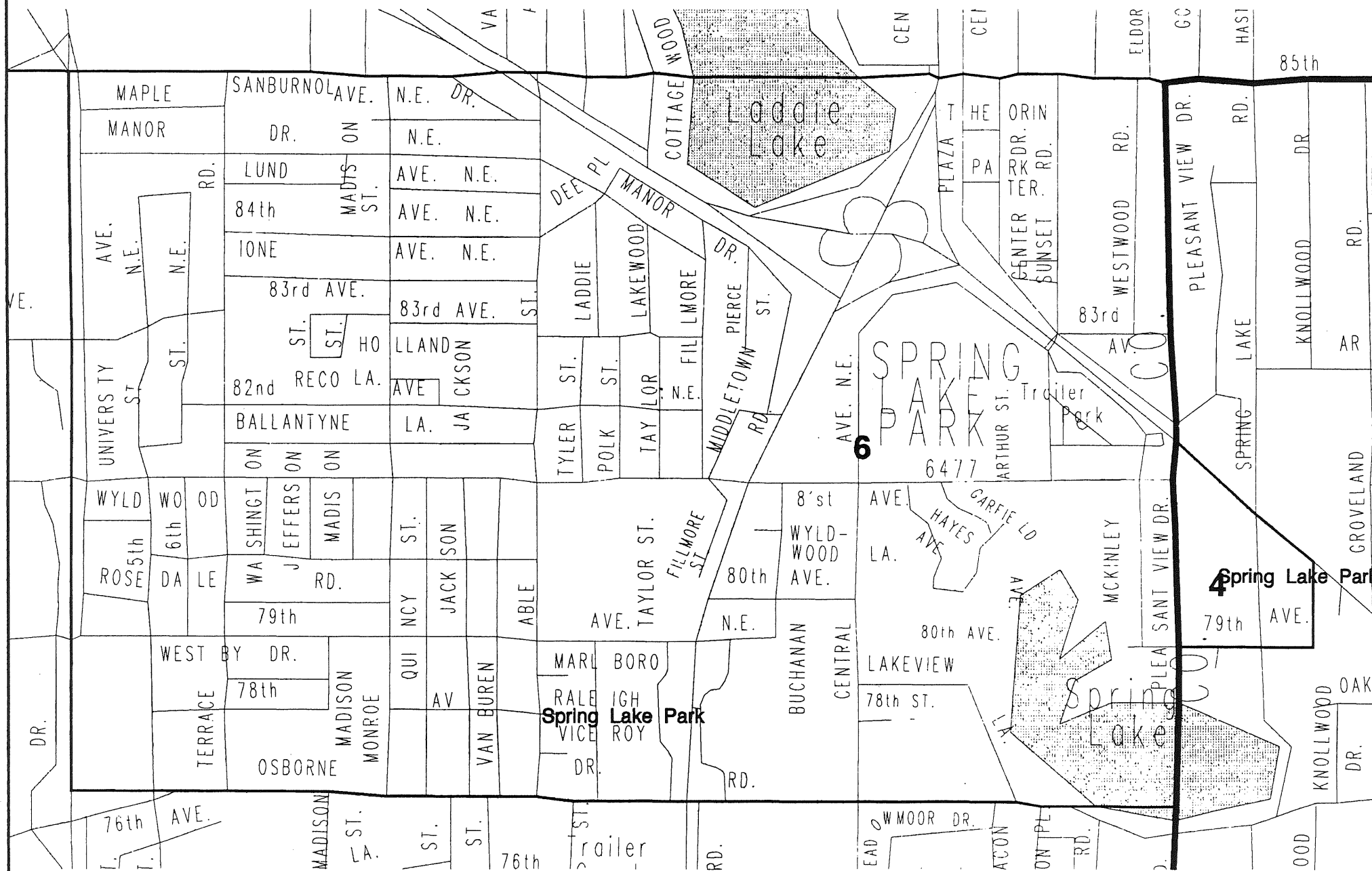

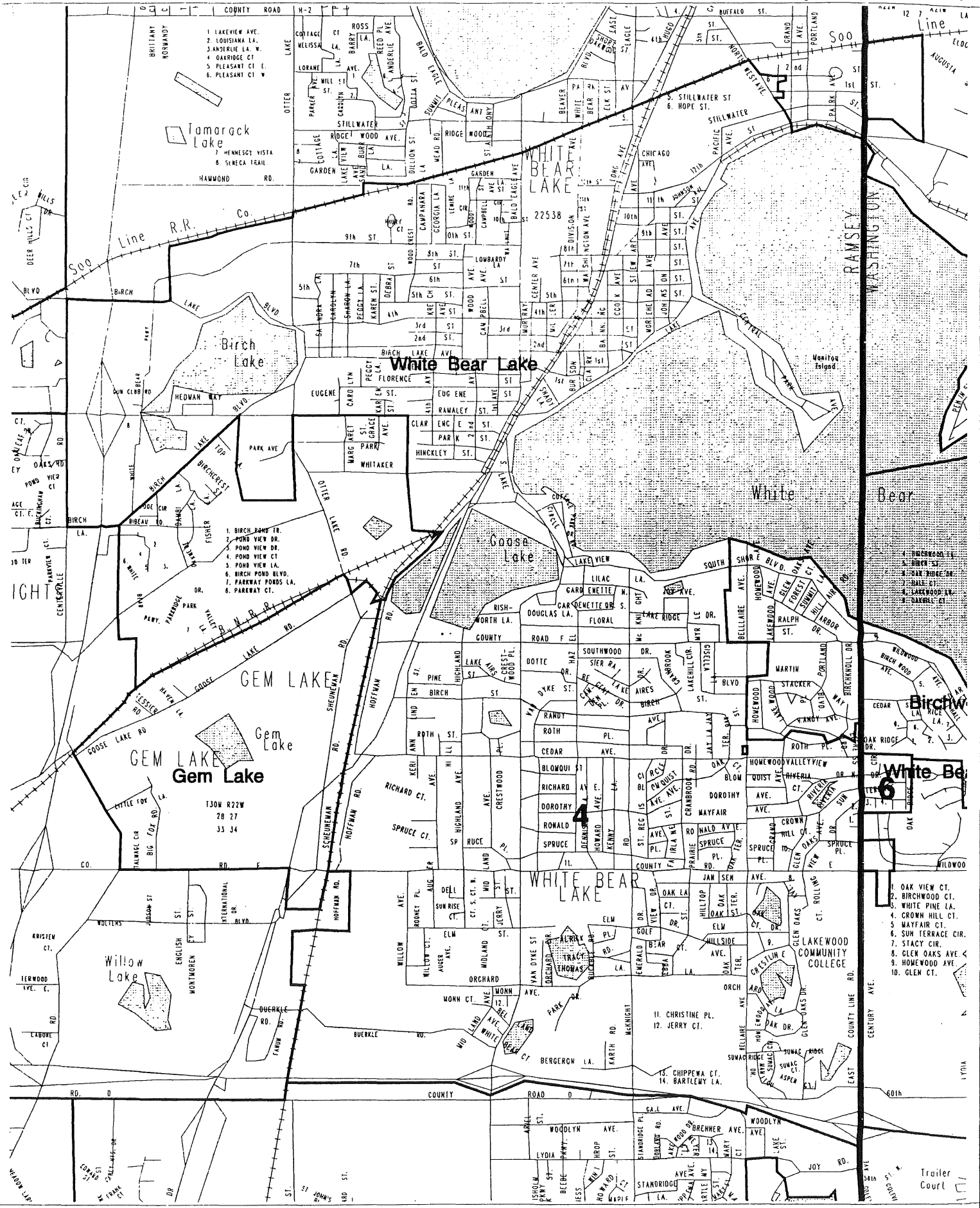
1994 Congressional Districts

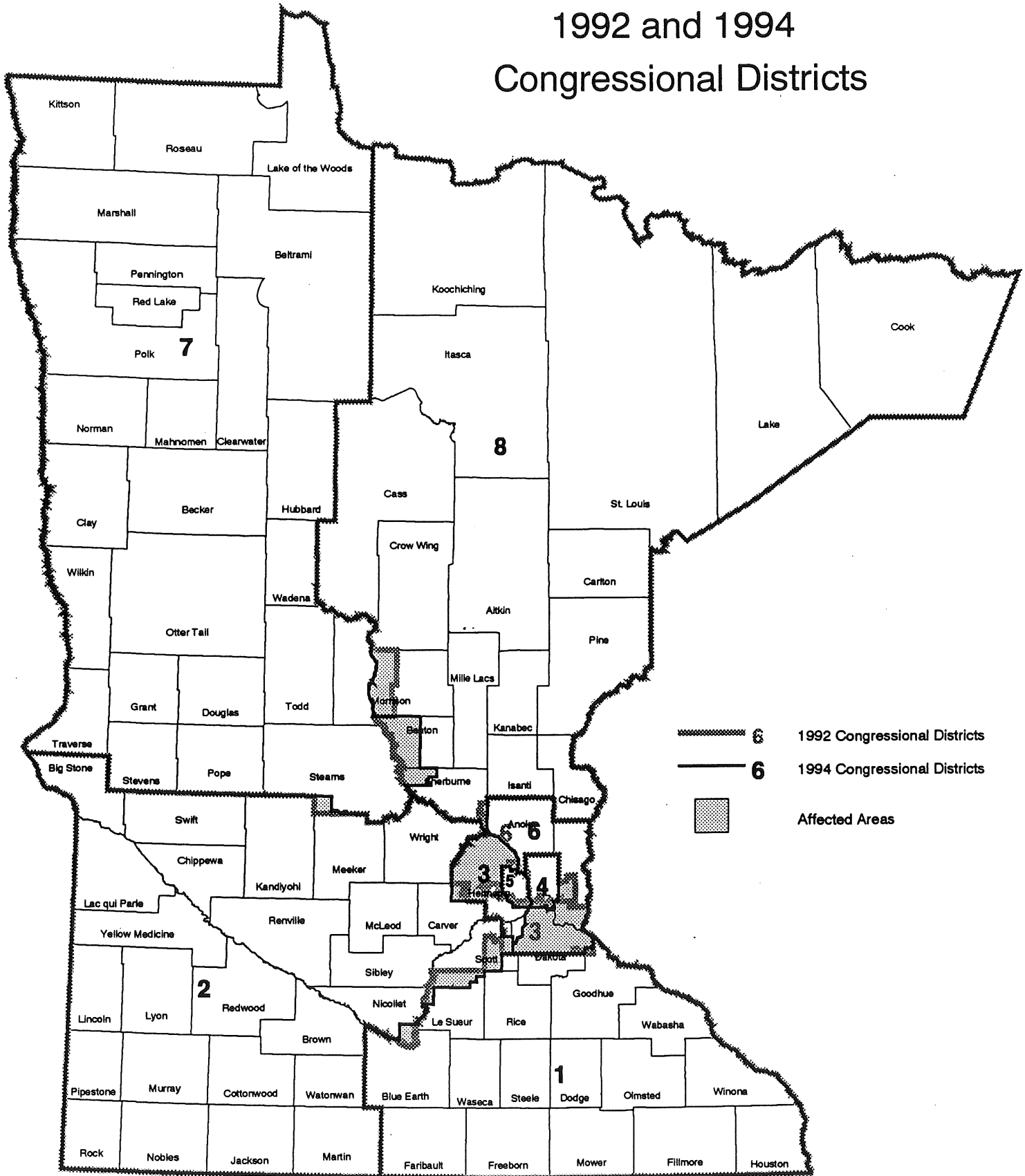
White Bear Lake

1994 Congressional Districts



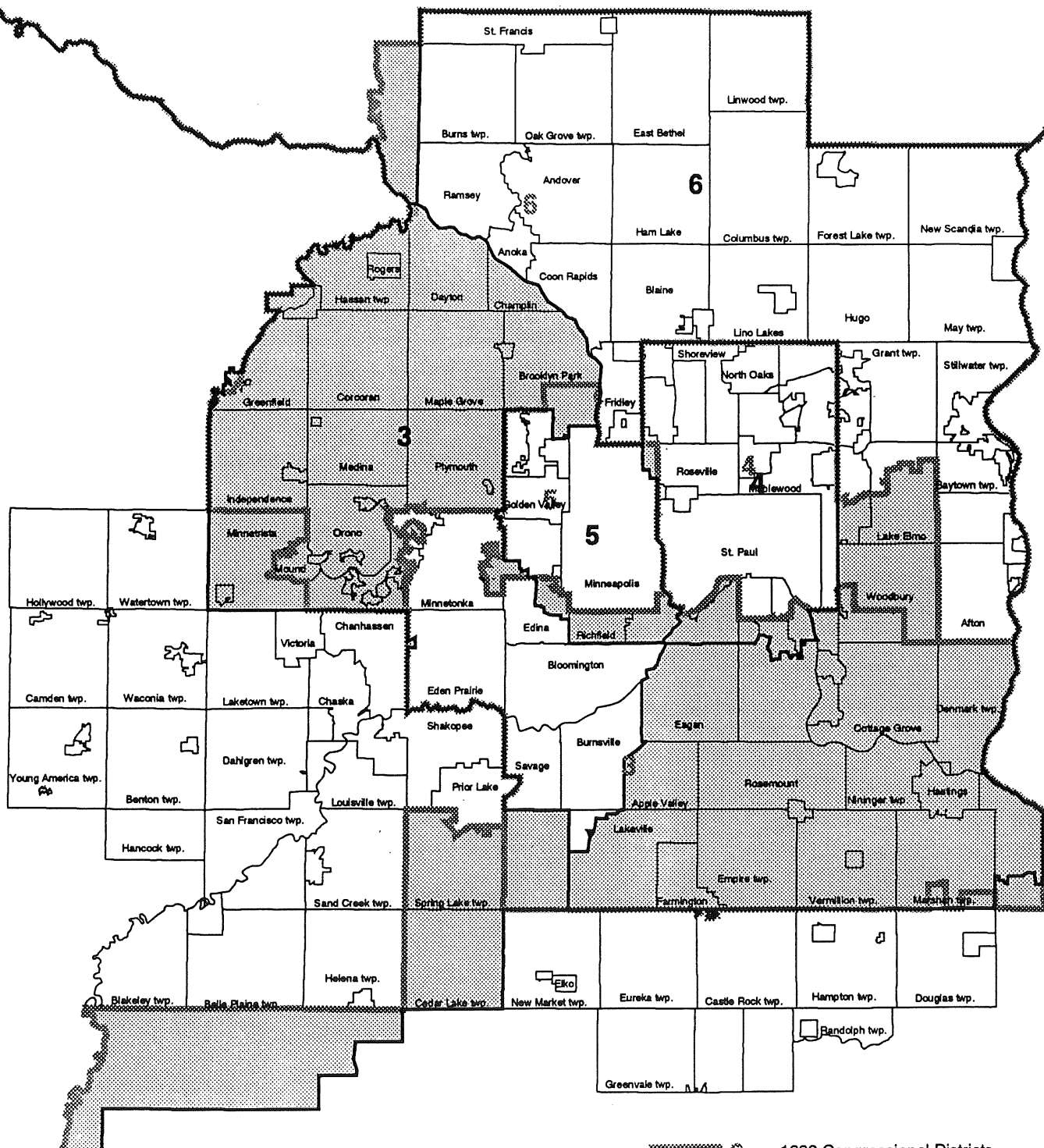
